

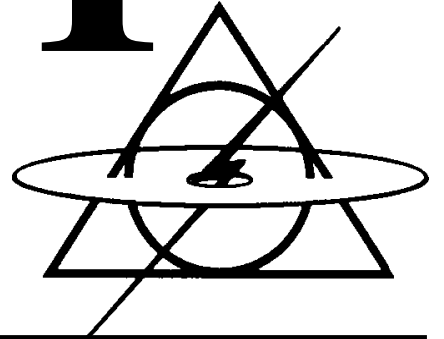

The demand is offered by a paralegal by the name of Gary Brown, who basically couldn't even sign his own name.

So, what is this? Hummmn, a thousand clues within just what I have offered as copy—but look at the document itself for further realization. L.A. law firm with a name involved of "Gross". Possibly a former attachment to Gudín & Gross?

The facts ARE that the entire letter is totally absent any factual truth AT ALL.

Ekker doing business as Teha? And,

moreover, having some connections with something called Corn Land Services, Inc.? What could be behind such absurd litigation and claims?

Teha was John Schroepfer's corporation and Ekker never had anything to do with any business through said entity. In fact, that entity was claimed by Eleanor Schroepfer's legal counsel as belonging to Eleanor and the Eleanor Schroepfer

Family Trust, a falsehood still used by Attorney Abbott in his continuing legal harassment.

Dear Mr. Ekker:



You will note in the document copy presented that there is no note of what for, why, how, when, who, where—or any information at all—indicating a total lack of valid claim to ANYTHING and full NON-identification of even the corporation making the claim. There is something WRONG WITH A JUDICIAL SYSTEM THAT ALLOWS FOR

Spectrum attorneys, Martin & Bilger?

What is the least of the annoyance? Well, you will note from the copy (full) that they also ask for

costs and attorney fees, etc., or they will get a judgment against Ekkers. So, if Ekkers do not attend the mess, there at the least comes forth a default judgment which, by the way, is also fine with Ekkers because they are so stripped and in debt to these kinds of things that this would only help them decide to simply bankrupt. A prospective lifetime of these greedy grabbers is unacceptable. And what of the *Statute of Limitations*? How can somebody come forth and claim business dealings with someone who only could have made a commitment in a business transaction before his death, and that was surely long enough ago to fall under the *Statute of Limitations*. Is this REACHING or what? Is this not harassment and fraud, at the very LEAST?

Well, it is from these ranks that your judicial system is outfitted and, therefore, it is up to you—the people to change it or keep it. Ekkers have no intention of fighting anything except as it hits them personally, for those are MY INSTRUCTIONS—to not jeopardize our program with these things. Do you pay them off? NO, BUT YOU FOLLOW IT THROUGH THE LAW AND, IF YOU LOSE, YOU BANKRUPT—FOR THERE IS NO FUNDING TO BACK ANYTHING PERSONAL OF THE EKKERS.

Are there any records regarding reference to Teha remaining in any files in possession of our people? Since so many corporation reference files are stolen and missing, it is doubtful if much remains regarding the past Schroepfer/Fort encounters. But, we are confident that the “information” used by these lawyers came from SOMEWHERE with “little sneaky helpers” of some kind and ilk who pretend to be “watchers”, etc. and know all about shape-shifting reptiles.

I would also note here that the claim is that Gyeorgos Ceres Hatonn somehow moved to *Spectrum* and Ed Young, which also includes Rick Martin, et al. This indicates that everything given prior to now is not valid as to Ekkers. Think about this fact as you consider advantages and disadvantages. We are not constrained to simply say “Hatonn said...”. This is a very good position finally achieved in our status of public reference. Furthermore, the farther you move within the coalition of God and Self, the more often you will FIRST see the positive and only later recognize the negative.

Example? Well, let's see: If someone brings confrontation with intent to damage you and the accusations are not in truth and then goes on to break even one LAW OF THE LAND against you—you have FULL ADVANTAGE. The act itself can be identified and so, too, can the opponent or enemy. And yes, all records can be destroyed BUT THE TRUTH WILL LAY IN THE VERY ACT OF DESTROYING THE RECORDS.

Further example? OK, suppose, as in the Tuten case—where Tuten continues to litigate and demand records which have been removed from offices and property so that none are available—SHE has to face the fact that SHE JOINED WITH THINGS SUCH AS TV MISINFORMATION, FALSE ACCUSATIONS AND FRAUD UPON THE PUBLIC, AND SHE WAS IN COALITION WITH THOSE WHO WERE RESPONSIBLE FOR TAKING THE RECORDS.

Rick, Charles, Ray—everyone, it seems—gained access to offices and records. They then joined with Tuten to do a blast against the Ekkers and Phoenix Institute and it did, in fact, run on television as a series. It is KNOWN that this happened, for hundreds of thousands of people witnessed it and all “local” viewers recognized easily the participants, even those who claimed obscurity and camouflage. Now the records are gone. Moreover, the records were taken from the dwelling and the parties attending the property were ordered under threat of personal arrest to not enter the property. THE RECORDS ARE GONE! Now, take it a step further, for it is known that Rick Martin-Cortright has taken files and orchestrated in the removal of books clandestinely from a warehouse. It is also known that

Gail Irwin “CORTRIGHT” removed funds from bank accounts and then LOST THE RECORDS, which were never “recovered”. Next, Ray Bilger was involved in ALL of the matters revolving around the immediate referenced circumstance. Now, who is seen frequently on the premises of the places from which all the records are missing? His wife Janet is the “security guard” at the property.

Many records and things were dumped in the rain on an adjacent “lot” to the offices/house in point and were destroyed or taken by weather.

The persons in charge of the records, Kathy and Karen, are no longer at the locations used at the time of working with the Ekkers with those records. Someone allowed entry into computers, files and the physical locations.

Since it is known who had access and barred access by persons simply trying to gain records, the RECORDS CANNOT BE PRODUCED.

This is sufficient evidence to confront the Tuten matter as to production of records, as well as all other encounters with opposing parties in any case. If you have no records, you cannot produce records. So, when you have such indisputable evidence of missing records AND WHO HAD ACCESS AND HAS ACTED IN SUCH MANNER UNLAWFULLY, YOU HAVE THE PROBLEM PLAYERS. Remember that Ray Bilger also removed—or had clandestinely removed—books from a warehouse in Las Vegas, in conjunction with those of Ed Young and Norey Latona. They solicited assistance from an insider at Nevada Corporate Headquarters, “fixed” the records as if ordered by an officer of a corporation, Gail Irwin, and gained access and took what they chose. Then, when there were objections, parties who objected WERE FIRED FROM THEIR JOBS, SUCH AS THE WAREHOUSE MANAGER AND ONE OF THE CORPORATE EXECUTIVES. I DON'T WANT TO FURTHER TAKE TIME WITH THIS—BUT THE LINE OF RESPONSIBLE PARTIES PAINTS THEIR OWN YELLOW BRICK ROAD.

Tuten now demands—as does other legal counsel in other cases—that WHICH THEY KNOW HAS BEEN REMOVED AND/OR DESTROYED.

It would appear the most evident thing for our counsel to do is to simply notify the court and the other parties of the FACTS and report that there are no records. He can even offer access to “dumped” remaining files but THEY HAVE TO BEAR THE EXPENSES THEREOF AND PROVIDE THEIR OWN SEARCH PERSONNEL. There are no ongoing operations by order of the court, lack of records and ongoing litigation.

When faced with such a dilemma as this, TRUTH IS THE OBVIOUS DEFENSE—BUT THERE IS NO NEED FOR “DEFENSE” AS SUCH—CIRCUMSTANCES BEAR THE OBVIOUS TRAIL OF EVENTS.

There should be enough “evidence” of longstanding availability in the files of ongoing court hearings and cases. And, in the Tuten matter, it appears the culprits

have removed deliberately all records and ongoing bookkeeping files left by Ekkers as the evidence with which to stand in court. Some of those records have been made public—in selected defamatory circumstances—by the parties who STOLE THEM.

Ekkers have NO access and were locked out of their very offices and dwelling by the same criminals. Therefore, legally, the response should bear this information and a listing of guilty parties, assumed or known.

Then nothing will be left to “hearings”; it will all demonstrate that criminal actions will be confronted.

Connections? Easy, Dr. Watson: Ray Bilger has been involved in EVERY activity and still has total access to the office spaces and the dwelling—unlawfully. His wife is in constant presence at the former office area and dwelling. The people with right, by law, to be in the areas are BARRED entry, even to inspect or search for records. It is further brought to attention that somehow the Bilgers have income, but neither is employed. This appears to reflect on large sums of “missing” money from the residence itself, as entry was denied to remove furnishings and even personal items—OR TO INSPECT THE PREMISES.

IS THIS JUSTICE? OK, I THOUGHT YOU WOULD REALIZE THE EXAMPLE AS HAVING MERIT. ALL THE WITNESSES WHO ARE LIVING CAN BE BROUGHT INTO THE COURT AND, THIS TIME, PERJURY WILL BE CONFRONTED.

All these negative emotional confrontations seem devastating and hopeless to mere mortals—but are they? No. You in “RIGHT” have all the chips now in your corner. Your attorney can enter all of these “interesting” facts into the case in EVERY ONGOING CASE.

In the Texas case, the attorney in waiting for pay-up only has to, for goodness' sakes, collect on the court order regarding the \$10,000 “contempt” action, after the guilty parties caused expenses to be incurred and the court ordered it paid. It would appear to me that with all the evidence and YEARS passing with no action that those attorneys might well be in need of confrontation for malpractice and extortion of some kind—for threatening to withdraw if not paid in full for “no services” being rendered to their client. This keeps piling up.

It would further appear to be a feasible need now present—with no records and not being able to do business because of physical non-availability to personnel or office OR RECORDS—and since there is no ongoing business for either Ekkers or PI, it should be evident that perhaps bankruptcy or dissolution of the corporation is the remaining option. This would cause the courts to have to confront the guilty thieves and accessories.

This is only an example; the REAL case has even more wondrous positive facets and persons. So, what would I do? Obviously, I would take this stand, and if you were asking from the aspect of the opposition—I would really be trying to structure some settlement.

So, the point is to realize that when things look so BAD for you, they usually are not—if you are in constant recognition of acting in good faith, truth, honor and integrity in every aspect of your ongoing expression.

Ah, but isn't this, even when right, a terrible financial burden? Yes, but righteousness will always bring forth “the way” to both endure and prevail.

Ekkers don't have anything and now PI is missing all its records—but PI IS NOT EKKER. YOU can reestablish YOUR participation and can do so immediately with the lawyer who is representing Ekkers and PI in these matters. Debts, loans, etc. outstanding can be reconstructed by YOU THE LENDER, interests calculated and all can and shall be

handled through legal counsel. There needs to be an accounting for loss of records of these many corporations involved as if a fire had destroyed everything. Notes have not “matured” but reconstruction of the records is first call in necessary order of restructuring.

Therefore, when confronted with that which is overwhelming in perception—YOU TAKE ONE STEP AT A TIME BASED ON THE ROCK OF TRUTH AND CONFRONT THE FACT THAT YOUR WORLD IS IN TROUBLE—ALONG WITH THE GAMES-PLAYER MISCREANTS (THANK YOU, RON) THEREON—IN AND OF WHICH THEY TAKE EVERY ADVANTAGE. When you have an evil-empire enemy at work—and you be in LIGHT—give them enough time and rope and they will hang themselves.

Ah, but some might giggle and argue that Ray was not named in the cease-and-desist order, but yes, he was and is outstanding in the very lack of naming, if you look at the case filed. He simply was not a listed party to the agreement “settlement” and, therefore, stands right out front for confrontation of his actions and ongoing participation. His delving into legal practices of fringe-parties in the legal gamesmanship arenas proves his intent, with Rick Martin, of practicing law without benefit of being attorneys. Those patriots struggling to bring JUSTICE to a painfully damaged judicial system NEVER INTENDED THEIR WORK TO BE MISUSED OR MISDIRECTED IN THIS MANNER.

And no, Ekkers have NOT demanded investigation by Federal Authorities or State Agencies into anything—BUT, LOOK AT THIS ONE: THE INVESTIGATORS WHO WERE CALLED IN BY THOSE PARTIES TO INVESTIGATE FIND THE EKKERS QUITE CLEAR AND TOTALLY CLEAN—BUT THE ONES WHO TURNED THEM IN ARE NOW BEING THOROUGHLY INVESTIGATED, AS SUCH AS NEVADA CORPORATE HEADQUARTERS AND OTHER CIRCUMSTANCES WERE/ARE BROUGHT TO ATTENTION. EACH CORPORATION OF INDIVIDUAL PARTICIPANTS—SUCH AS RICK, ED, NOREY, ET AL.—IS BEING READIED FOR FULL INVESTIGATION BY THE IRS AND FULL EVIDENCE IS AVAILABLE—BECAUSE IT IS IN THE MORE RECENT CONFRONTATION THAT DOCUMENTS, AS THOSE CORPORATIONS’ RECORDS, WERE DEMANDED PRODUCED AND TURNED OVER ACCORDING TO THE SETTLEMENT REQUIREMENTS. And yes, it did work out that PI had been paying the annual fees, etc. of those corporations now reclaimed, by law, by those individually named parties. So what of “income” and taxes? We have no idea, no records, etc. They will have to answer for themselves. Ed made public argument over his dismissal that he was only paid through Spectrum and, therefore—now that he has total responsibility for same—he will have to respond to that nice IRS agent who was brought in to investigate CONTACT through NCH. Yes, indeed, “What tangled webs you weave when first you practice to deceive.” Ekkers have deceived NO ONE!

To avoid taxes to the limit of the laws or regulations is expected, even by the IRS, and you will be advised that this is good. EVASION is unlawful and treated as a criminal offense; thus the old saw about the difference in avoidance and evasion—as to IRS—“IS” about 15 years—IN PRISON!

When you try to manipulate against the systems established, you had better expect those 15 years and a very large fine for your misadventures.

WE DO NOT BREAK LAWS OF MAN OR GOD—THERE IS NOT EVEN NEED TO DO SO IN ANY OF

THESE ONGOING GAMES OF TAKEYA, GOTCHA OR HIDE-AND-SEEK.

And no, don’t listen to the miscreants who will tell you that they are holding property as “hostage” until... THAT IS CRIMINAL ACTION! IT IS THEFT, PROPERTYNAPPING and EXTORTION, AND ALL OF THESE ARE OUTRIGHT CRIMINAL ACTIVITIES. EVERY DROP OF DIESEL FUEL TAKEN FROM THE ADAM DRIVE PROPERTY, INVERTERS, TOOLS, EQUIPMENT, PERSONAL MEMORABILIA AND SEIZURE OF THE PROPERTY ITSELF CONSTITUTE CRIMINAL TRESPASS AND, AT BEST, LOOTING. THE FACTS ARE: THIS IS GRAND THEFT. THEN TO CLAIM “ABANDONMENT” AGAINST SOMEONE ON A BUSINESS TRIP—AFTER 13 YEARS OF CONSTANT RESIDENCE AND 200 AVIARY BIRDS, PARROTS, ETC., WITH CARETAKERS, OFFICE PERSONNEL DAILY IN PLACE AND GARDEN CARETAKERS—IS ABSURD. Then for all the *Spectrum* kiddies to go to the property and start looting—is consequentially a bad error. They have the property stolen and admit it—while saying they are just securing it until... This is both criminal threat and criminal blackmail.

People just don’t long have reward from WRONG actions against God and fellow man. It may well appear otherwise but KNOW that consequences of actions are always forthcoming, even if the crime (or sin) simply be rested on the children thereof, along with those who have chosen to take the routing of ongoing brotherhood with those putting forth the evil intent and action.

My point is, readers: STOP accepting every incident in your journey as NEGATIVE! God only creates and only places goodness and positive possibilities before his people. YOUR PERCEPTION AND ATTITUDE IS THAT WHICH MAKES REALITY. Just get a bad case of upper respiratory attack and you will LIVE THE EXAMPLE.

What is my “big” point in all this? GET CONTROL OF YOUR LIFE INDIVIDUAL—AND STOP LETTING IT CONTROL YOU!

You can NOT change the quality of your life and your “put upon” perceptions to the positive aspect, as long as you structure your lives in such a way where your happiness is dependent upon something you cannot control. It is only then that you will experience pain. The FACTS are, chelas, that you don’t need anything to happen in order for you to feel good. Adjust your attitude and perception, face head-on what IS and stop accepting as your burden, anything dumped on you by those “proclaimed” enemies.

And, chelas: HOLD YOURSELF RESPONSIBLE FOR A HIGHER STANDARD THAN ANYBODY ELSE EXPECTS OF YOU. When that responsible attitude is obvious in all you do, the “enemies” will cease to “win” anything but “just consequences” for their dastardly deeds.

Or, are you simply trying to greedily snatch something from another because you want the asset, revenge, etc.? And, if you form coalitions with questionable individuals in an

attempt to “make your lie an accepted truth”, you really err—because those maladjusted parties will, in turn, only further destroy YOU.

I only ask that you take these writings as intended, to give you a chance to LOOK at self and actions and consider choices very carefully. I would give credit to one of your writers, Shaw: “Some men see things as they are, and say, ‘Why?’ I dream of things that never were, and say, ‘Why not?’” So, readers, KNOW that if you ask—you SHALL receive. However, if you ask a terrible question, you’ll get a terrible answer. Your mental computer is always and constantly ready to serve you, and whatever question you give it, it will surely come up with an answer. Isn’t it about time you started asking good and right questions? And keep questioning, for in so doing, you will find unlimited knowledge awaiting. The important thing is not stopping the questioning. Curiosity has a reason for existing. One cannot help but be in awe when he contemplates the mysteries of eternity, of life, of the marvelous structure of reality. It is enough if one tries merely to comprehend a little of this mystery every day. So, never neglect a holy curiosity or a sacred attention. Just KNOW what you are doing and be ever ready to face the consequences of your choices and actions.

And to you who are struggling with addictions—you must replace the craving with something, and the more worthwhile the replacement, the more effectively you will overcome and put aside the “urgings” for routine habit. If you are “spiritual” in intent, then take that time to express REALITY—and go forth and find perfect choices for places to build a retreat, help others, bring JOY to others, not just to mental SELF. When you attend attention to OTHERS, you have overcome the push and shove of SELF.

The most negative aspect of religions which place such major emphasis of “self” is their failing in that very misperception. For when a person focuses on only “self”, he reaches not beyond and into the connections of all that is within self and, therefore, misses the entire point of the lessons. If your leg is not damaged, why remain a cripple dependent upon crutches? Go forth and walk and produce that which is toward perfection. In so doing for a brother and the least of God’s creatures, you have served GOD and thus SELF.

Walk in truth and goodness, chelas, for in that way the path is beautiful and filled with joy. The negative aspect is filled with that which is ugly and always presents in a “physical” form to impact you. Spirit is made to experience JOY—and God grants unto each and all the GRACE to maintain that Peace and Joy. And walk ever in LIGHT that you may see and KNOW what you are “about”, and stop bogging in the terrible, wretched mire of negative actions and intent. I can only offer the truth of “the way it IS”; I cannot make your choice nor “do” FOR you.

Flattery may well get you through the door—but that will fade and has no fundamental value for the long journey expected ahead.

The first and probably the most important thing is to present self in a congenial manner, and if you wish to get the best of an argument—avoid it. Why ARGUE? An argument indicates that both parties (sides) are already entrenched in their own ideas. Here we won't even consider "debate" because "debates" are most often nothing save arguments.

Show respect for the other person's opinions. It helps, furthermore, to never say, "You are wrong." You must observe that when people are wrong and the audience is not the adversary, you should say the opponent is wrong and state your FACTS IN REASON. For instance, the *Spectrum* group, as a whole, is WRONG in thought and presentation. This is THE LIE and to not confront the LIE is an error. Respect the other party enough to cause him or her to tell the TRUTH and in so doing, FACTS can then be determined—by others who are involved in their own decision-making.

If there is truly just a "misunderstanding", it can be immediately established, heard and resolved. If you be in TRUTH and the other persists in the LIE, you must announce as much and "call him" on it. At this point you can terminate the interchange and follow through appropriately as merited by the circumstance. A lie unchallenged when TRUTH IS KNOWN is the seed of ignorance.

If you are WRONG in "self", admit it quickly and emphatically and see what can be done to rectify the misperceptions. Never continue to present the LIE—for you will, at best, be found-out and discounted in the moment, and often, forever.

You must always remember to begin any discourse or confrontation in a friendly way and this is one inattention from which almost all personal relationships bumble INTO NASTIES. In other words, the fight is on before the claims are even considered.

It certainly helps if you can start in such a way in your discussions to get the other party into agreement with you—you know, into a "yes" mode. This stops the consideration of "attack" and allows for probability of being able to find compatible realizations.

It is often that when you are confronting, you allow the other party to express and do a great deal of the talking. We note that in the Martin-Young encounters, they hit with three disgusting and degrading issues of OUR OWN PAPER, ourselves, including ME, Hatonn—as to being false, dangerous, of evil and so, too, were my people (team). They then continued to take—as in criminal property theft, lies, misrepresentations, documents copied with pertinent points DELETED—and generally produced chaos and intended play for power and control, USING YOUR PRODUCTS AND PROPERTY.

Were these misunderstandings? Impulsive actions negated any possibility of other than outright legal confrontation to simply secure property until it could be examined. THIS is what the law is supposed to do and how it is supposed to SERVE the people.

IF YOU ALLOW SOMEONE TO COME INTO YOUR HOME AND TAKE EVERYTHING OF YOURS WHILE CALLING IT SOMEHOW "RIGHTeous UNDER THEIR NEW SET OF RULES", AND YOU DO NOTHING—YOU ARE WRONG AND IRRESPONSIBLE. THAT IS "TRUTH", READERS.

You don't always have to be "right" or get in the last "word". For goodness' sakes, let another have credit for offering a solution if it is important to his ego-needs and the issue is simply one of "who came up with the solution". You will get far further if you just GIVE credit to the "other". Do you want an ego-trip of your own or do you really want to solve the problem presented? Yes, it does matter, for disagreement at this point ensures a new argument over status. YOU ONLY HAVE TO "DEFEND" STATUS WHEN YOU ARE UNSURE OF YOURSELF AND YOUR POSITION.

Next, in seeking a solution in confrontation, you MUST MAKE EVERY EFFORT to see the problem THROUGH THE EYES OF THE OTHER PERSON(S). However, understanding the other's point of view does not mean capitulation to that view or stance. If nothing else, you can agree to disagree.

If there truly is a question of who is right and who is incorrect, you must confront your own position, and if you are wrong—fix it. If, however, you know that you are right and have facts for proving your position, be sympathetic with the other person's ideas and desires, but do not compromise.

If you have opportunity for input into the thinking of the other person, always appeal to the nobler motives. If you still cannot have even a measure of effort at solving the conflict, then you have at least been honorable in your approach.

Another way the Masters utilize tools as teaching for realization is through parables, or example. This would be called "dramatization" or picturing your ideas through examples. These are far more effective if the stories are TRUE and the PARTIES IN THE

STORY REAL ENTITIES.

Then there comes the idea that leaves me a bit cold but often works, depending on the persons involved, and that is to present a challenge. This can simply be—in the case of different understandings of points and actions—factual evidence to back up the presentation. This is a bit more difficult to specifically present in example, but if we look at the *SPECTRUM* attacks on Ekkers, I challenge the people involved to OFFER PROOF OF WHAT THEY HAVE SAID AND DONE, AND HOW IT CAN BE RIGHTeous OR LEGAL.

This is not a perfect example, for the culprits have lied so much and have stolen so many files and documents that if they present anything—it will only PROVE their further unlawful activities.

My next observation as to how to win friends and influence people to your considerations is that you need to first be fully interested in the other people involved, and respect their positions and beliefs. This is but a repeat but is very important.

The most easily accomplished one attitude, however, is to begin any interchange with a SMILE. If you are angry, you will appear so—because you will be officious, at least, and obtrusive at best. This in NO WISE means that you enter anything with a smirk or laugh "at" the other. Do that and you deserve whatever you get in negative return.

And, for goodness' sakes, GET YOUR NAMES STRAIGHT. You are never going to win anything except contempt if you can't get a man's name right. I have often used this example: "If a man introduces himself to me as Jesus Christ, I am going to call him Mr. Christ until or unless that is proven to be incorrect. If it is proven to be incorrect but the man believes himself to still be Mr. Christ, then I will address him as Mr. Christ." THAT is, after all, an oft-used label.

In this very instance, you can encourage that other person to talk about himself so that you might better understand his approach, reasons, etc. But, be willing to also share with him, if he wishes to know more about you. I also suggest that you find out about the interests and desires of that OTHER PERSON—and that includes their business wishes and intentions—and from there you can have a congenial parting, if nothing else. This also causes another person to be able to feel important and he will receive the recognition of sincerity. You do not make an enemy because you disagree.

And, oh, yes you can—even if the "OTHER" walks up to you and tells you he is going to murder someone in the next ten minutes. You could diffuse the entire silly attitude if you take the time, and if you cannot—at the least leave intact yourself, and immediately get the law to secure the person in protection of his own actions against another. THIS IS CALLED "RESPONSIBLE ACTION".

MAKING PEOPLE LIKE YOU

Firstly, you can't MAKE anyone like you, love you or respect you. So let us get rid of the "make someone..." suggestion.

The first order of the day in beginning relationships of lasting duration is to NOT "criticize",

“condemn” or “complain”.

The second approach is to give honest and sincere appreciation, even if it is just for being nice enough to meet you.

Now, if you have behaved honorably, you will be able to expect that other person to be aroused as to desire to have interchange with you. A cooperative relationship must have AT LEAST TWO.

LEADERSHIP

Perhaps the *numero uno* need in a leader is to be able to handle others' perceptions graciously, and often to change attitudes and behaviors. The point, however, is to never allow the circumstances to get out of control before considering it a problem. It is through impulsive actions that most irreversible solutions are required. But once LAWS have been abrogated and unlawful actions have been taken, you will not be able to “simply” handle the problem—it MUST BE DEALT WITH WITHIN THE LEGAL SYSTEM, IF, IN FACT, THE ERRORS ARE NOT CORRECTED IMMEDIATELY TO THE SATISFACTION OF THE RETRIBUTION REQUIRED. If, for instance, you have destroyed someone's reputation, it is not easily undone in an instant. Further, until a sincere and honorable effort has been made to rectify ill-doing, there should be no consideration for “arguments”, “excuses” or LIES offered.

If there is a reasonable way for the other person to “save face”, give forth the opportunity and encourage same. At the same time you can use encouragement, in that you can make the fault seem easy to resolve or correct.

Remember that people have to WANT to do a thing before they will actually “change”. Therefore, you might do well to make the other person happy about doing the thing you suggest. Sometimes that is simply offering the FACTS: change or go to jail—and surely, if the evidence can convict, the offending party will most certainly WANT to consider possibilities.

SPIRITUAL CONSIDERATIONS

If you truly practice the human conscious ideals above offered, you are going to be living in a very appropriate way as to treating others and building good relationships. However, yes, there are other things to consider in the spiritual quest for perfection as accepted as goodly (toward God). We have, however, worked those over pretty well within the past recent weeks and our intent is not to bore anyone. We are only offering this to allow for your reminding of that which offers the “better way” in which to experience your interactions with your fellow man and your immediate connection to spiritual truth.

The facts are that it is EASY and simple in concept and in practice. LIVE TRUTH, DO NOT DECEIVE NOR OFFER FALSE INFORMATION ABOUT PERSONS OR PRODUCTS AND BE OPEN IN YOUR UNDERSTANDINGS—SO THAT IF YOU ARE INCORRECT, YOU ARE INNOCENT OF INTENT TO DECEIVE OR DEFRAUD ANYONE ABOUT ANYTHING.

DO NOT BEAR FALSE WITNESS AGAINST ANYONE OR THING.

HONOR AND RESPECT “ALL BEINGS” WITH TRUTH AND INTEGRITY.

When you do all these things within the guidelines offered for holy living, then your self, which is sacred, will also be worthy of honor in all measures.

YOU MUST COME TO ALWAYS OFFER YOUR WORD AS YOUR BOND AND FOLLOW THROUGH. IF YOU HAVE NOT FULL CONTROL OVER THINGS WHICH MAY ARISE OR THOSE UPON WHOM YOU MUST DEPEND FOR FULFILLMENT OF YOUR WORD—THEN IT HAS TO BE ADDRESSED IMMEDIATELY UPON REALIZATION OF CIRCUMSTANCES, SO THAT YOU NEVER ARE PLACED IN A POSITION OF DELIBERATELY BREAKING YOUR WORD OR YOUR BOND; AND IF YOU HAVE TO CHANGE YOUR AGREEMENTS, DO SO IN THE PRESENCE OF—AND WITH FULL EXPLANATION TO—ANY OTHER PARTY TO THE AGREEMENTS.

We have suffered negative impacts all along this journey because there are things which involve other people over which we actually have NO CONTROL, and in these circumstances there is only one choice—TELL THE FACTS, TRUTHFULLY, TO ANY PARTICIPANTS. Often people are forced by circumstances to NOT BE ABLE TO KEEP THEIR COMMITMENTS. This cannot be helped, in fact, but can be addressed as presented—for consideration as quickly as the “unexpected” actions or delays are known or suspected.

For instance, if you owe a man a debt payment and you fully believe a third party will keep their commitment to avail you of the funds to meet the obligation, so be it. But, if the third party fails, then you must notify the waiting debtor so that he can take whatever actions are appropriate to himself, whether or not that serves “your” best interests.

Do you see that this can go on and on into infinity? INTEGRITY is the operative word, expressed or implied.

ANDKNOW: WHEN YOU DEAL WITH POLITICIANS OR BANKERS—YOU CANNOT RELY ON EITHER. Your own word can only be as good, in these instances, as is that of the one who gave his word TO YOU. You will note, however, that documentation is only as valid as is the word of the person who offers the documents.

This is, as fact, where so many psychics and seers get into great disadvantage as to acceptance. They err in the giving forth of absolutes, as in “tomorrow at 3:00 there will be a 6-point earthquake on Tehachapi Blvd.”—AND NOTHING HAPPENS! In higher understanding and KNOWLEDGE, there is no such

thing as “tomorrow”, “3 o'clock” or a “6-point” anything. Remember that you have reached the point in your demands where you want the total story of the universe in 10 seconds or less. And then, you only want to know how it is going to affect YOU—period.

I feel great compassion for someone like Gary North, who warned you over and over about the Y2K possibilities and to “get prepared” for possibilities of negative impact. THIS VERY WARNING CAUSED THE POWER ELITE TO REALIZE THEY COULD NOT GO THROUGH WITH PLANNED CHAOS. BUT HOW MANY WILL PAY ATTENTION “NEXT TIME”? AH SO, THOSE 10- AND 30-SECOND SOUND BYTES ARE INCREDIBLY DESTRUCTIVE. Now, after the fact, you would kill the messenger? You seem to enjoy killing messengers before AND AFTER the fact.

The facts are, in addition, that the game is not over killing off the world but is, in fact, a matter of trying to GET CONTROL OVER THE GLOBAL POPULATION AND ACTIVITIES. Oh yes, indeed, the idea as is being worked is filled with total corruption, but the original plan was to be able to use FORCE to secure what was left of the natural resources, etc. Money is not the issue, for they have the money supply—they can’t get the corrupted thieves under control and they obviously feel that if they could regain total control EVERYWHERE—as in recognized re-colonialization—they could stop the devastation and still get it all. THE ART OF HAPPINESS

Hatonn—Yes, “happiness” is an art and until you recognize as much, you will search in all the wrong places and faces to find “yours”.

Happiness comes or IS within, just as are all the other PERCEPTIONS that include but reach beyond the physical “sensing” and unless you KNOW what it is that you pursue—as in your “right to the pursuit of happiness” guaranteed by your Constitutions—you have little with which to work or to, for that matter, demand.

When you seek balance in which to experience your “happiness”, what is it that you truly desire? Do you only pursue YOUR happiness or is, somehow, YOUR OWN HAPPINESS INTEGRAL TO ALL HAPPINESS?

So what of the “duck farmer” who raises ducks as a renewable food resource? Is his killing of ducks as good or as bad as you shooting a duck for the heck of it?

PEOPLE, GOD ALLOWS YOU TO DO THAT WHICH YOU WILL—THE JUDGMENTS COME WITH SELF IN FULL “INTENT” OF WHAT YOU DO IN RESPONSE TO THAT WHICH YOU THINK AND CREATE.

It becomes, as a whole, very confronting and

contradictory because in order to sustain a “form” in ability to function, the human, animal or plant as manifest must have what is required to allow functioning in the visible format or at some point of evolving you will die, which indicates a recycling of the elements of the body—AND THE RETURN TO SOUL FORM (energy).

Now, let us move from ducks to fish. No connection? Oh, indeed, there is a major connection: They are both life forms of and by CREATOR.

Did you “begin” with one big “FISH GOD” who sent a FISH, and did all varieties in natural selection evolve from that one DNA-RNA structure? Or, did the genetic structure just get dumped into the streams and oceans and each fishlet became what he wanted to become for his “happiest” evolvment and survival, amidst all the enemies, say, a nice trout might accumulate through the eons of spinning time perceptions?

In using fish, ducks or whole-wheat cereal, are YOU MOVING TOWARD GOD OR FROM GOD? AND, MOREOVER, “WHO” TOLD YOU SO?

I will share one observation which is always a good rule of human thumb: If you are duck hunting and shooting, fishing or catching—OUT OF SEASON UNDER THE LAW—YOU ARE BREAKING THE LAW AND YOU MUST KNOW, WHATEVER ELSE YOU MIGHT “WISH” TO THINK OR BELIEVE, IT IS “NOT JUST OK”.

The very experience in human form is to express AS HUMAN, in a manner which allows growth AND happiness within the boundaries of the human expression. And yes, sometimes the HIGHER purpose requires moving outside the limitations as posted by human individuals to suit themselves.

THE HUMAN IS ALWAYS, IN HIS PHYSICAL FORM, BEING “TRAINED”—CONSTANTLY. EVERY CHOICE YOU MAKE IS A TRAINING EXERCISE. FURTHERMORE, TO ACCEPT THE TRAINING, THE OUTCOME MUST BE TO FIND HAPPINESS—OR YOU WON’T GO FOR YOUR TRAINING, OVER THE LONG HAUL.

Some of you are already waking up and saying, “Hey, what’s happening?” You are seeing that the way things are going in this play, you are ALL going down into some pretty deep pits, with no way out or to recover that which you perceive, NOW, is mandatory to the concept, even, of survival.

Have things truly gotten worse? NO, things as such have gotten so much better as to astound you most doom-oriented individuals—FOR NOW YOU HAVE THE POSSIBILITIES AVAILABLE TO YOU TO SAVE YOURSELVES AND THAT UPON WHICH YOU DEPEND TO LIVE.

To be TRULY HAPPY you must create happiness in EVERY MOMENT, for that is all the “reality” you have with which to relate—that momentary experience with the KNOWING of that which lies ahead in your greater expression. And YES, you CAN BE VERY “SAD” IN THE PROCESS—SAD RECOGNITIONS ARE NOT NECESSARILY “UNHAPPINESS”. And your perception of “happiness” is very evasive, for often what you claim as “happiness” is totally without much JOY and/or PERFECT satisfaction. This IS all in the experience as HUMAN BEING.

Don’t blame much of anything on HUMAN NATURE, chelas, for the great conflicts are NOT of “human nature” but of “human intellect”. There are CHOICES to make in the human format, and THAT IS RECOGNIZED IN THE “FREE-WILL” ASPECT OF THE EXPERIENCE AS GIVEN UNTO YOU BY CREATOR IN HIS GREATEST EXPRESSION OF THOUGHT MANIFESTATION. This is why, perhaps, comes the recognition of “when you do something right, the Angels sing”. And, indeed, WHAT OF RESPONSIBILITY?

RESPONSIBILITY

Oh gosh, that bug-a-boo keeps poking in, doesn't it? You KNOW responsibility of/for self in thought/deed. When you assume your responsibility, you are "happy". WOW, and is that all there IS? Just about. YOU ARE GIVEN TO KNOW RIGHT FROM WRONG OR, IN OTHER WORDS, THAT WHICH SERVES GOD OF PERFECTION AND THAT WHICH SERVES BASER GODS OF THE PHYSICAL REALM. And no, the old "service to God is borrrring" is another of the LIES. You CAN prevail in goodness and have abundance—while having a gosh-darned GOOD TIME OF IT.

Some of you can "put down" another for seemingly seeking a way to have financial resources. But then, you set self up as an egotistical "better" than that searcher and producer, for let's say you want to build a spaceship or housing development or whatever. Just HOW are you going to do that building, if you don't have anything for exchange to even get the parts you need?

What I want each student to DO is to LOOK AT WHAT YOU DO AND WANT, YOUR GOALS, YOUR INTENT, YOUR *MODUS OPERANDI* FOR GETTING FOR SELF, A GROUP, A TRIBE OR IN REFLECTION OF GOD TO BETTER SECURE THE WONDROUS CREATION LEFT IN YOUR STEWARDSHIP.

It is good to recognize what is happening within "self" for, indeed, it is about THE ONLY important consideration at any given juncture of experience.

Dharma sits again this morning with a TRUE desire to quit this madding-crowd game. The tales get old, the burdens get heavier and, wow, for a minute: WHO CARES? I suggest you ALWAYS consider those feelings and confront them for what they are, for they don't JUST go away. WHEN YOU DECIDE WHAT IT IS YOU WISH TO CREATE—ONLY THEN WILL YOU MANIFEST IT. AND, FURTHERMORE, WHEN YOU PRAY IN THE NAME OF GOD TO DO THAT WHICH IS THE PERFECT WILL OF GOD, YOU MUST ALSO ACCEPT THAT SOMETIMES IT "TAKES LONGER" THAN YOUR IDEAL PREFERENCES. THIS DOES NOT PRECLUDE YOU FROM DOING YOUR PART IN THE VERY ACT OF CREATING THAT GOAL. IN OTHER WORDS, YOU CAN'T JUST GO, "OH WELL, WHAT THE HECK...". BE ATTENTIVE TO THOSE NUDGES THAT SAY: "WHAT MORE COULD I BE DOING?"

Please always think in your knowing mind that your enemy is always working toward your "selling out". Therefore, you must accomplish sustenance BEFORE you reach the point of need to "sell out" anything.

When the assets are so big as to boggle political minds, you will always have the

TYRANTS trying to get control. It is the power and control desired. Therefore, coalitions have to be consummated with alliances where the people can move forward. This must be done, however, before the messengers die of old age or poverty. And, for my personal team in point: THIS IS A BIG NUMBER ONE! I, and all, are constantly amazed at how much money will be dumped into a scam, while the messengers of truth are bleeding to death. And yes, we experience it EVERY DAY. Control and Power are assumed to come with WEALTH because if you have enough control and/or power—you can simply take the wealth.

LET'S GET A PERSPECTIVE ON
"THE ENEMY"

Until your attitude about your enemies is adjusted, you can't move very freely within the "counter-space". So, consider transforming your attitude about your so-called enemies. And what is here involved? AND, TEAM, PLEASE PAY ATTENTION TO THIS LESSON.

Let's begin by examining your characteristic attitude toward your rivals. Generally speaking, of course, you do not wish good things for your enemies. But even if your enemy is made unhappy through your actions, what is there for which you might be joyful? If you think about it carefully, how can there be anything more wretched than that? Carrying around the burden of such feelings of hostility and ill will is only a burden—and do you want equal mean-ness?

If you get revenge upon your enemy, then it creates a kind of vicious cycle. If you retaliate, the other person is not going to accept that state of affairs—he or she is going to simply retaliate against you and so the cycle goes, on and on into infinity.

When this kind of retaliation and revenge gets beyond personal and into a community and then into a nation, it is obvious that over generations of time and people, the feud goes on even after no one can even remember from what the argument stemmed.

But how do "consequences" for bad behavior, deliberately and offensively performed, come to surface? Do you just wait for God to attend your business for you? NO, you bring all TRUTH possible to bear—not as revenge, judgment or retaliation, but TRUTH in a stand of RIGHTNESS.

Mostly, people just get furious, go to war and never even have a good idea about what the disturbance might be. It will be, "Oh, my friend is under attack," or "I wonder what that's all about?" In other words, you overlook, most often, the very thing that makes a difference: HOW ARE "YOU" ACTUALLY INVOLVED? As in the Ekker problems, EVERY ONE WHO HAS OR HAD ANYTHING TO DO IN INTERCHANGE WITH EKKERS "IS" IMPACTED FAR BEYOND CHOOSING UP SIDES. CRIMINAL ACTIONS WERE PERPETRATED AND IT CONTINUES—

SO "CHOOSING", FOR THE DAY, ISN'T THE POINT: WHICH IS RIGHT AND WHICH IS WRONG? LYING IS WRONG! STEALING IS WRONG! SLANDER IS WRONG! CRIMINAL THEFT AND FRAUDULENT RELEASE OF INFORMATION IS WRONG! These things have nothing to do with whether or not you "like" somebody, or even whether or not you "love" somebody. There is right and there is wrong—UNDER THE LAW. Lying about the law is an even more dastardly affront.

Yes, indeed, I have frequently asked you to consider wishing all wealth and gain to our enemies—for if they gain, we will gain. Is this a good example? Obviously, I think so or I would not ask you to consider it. If you have been wronged and there is restitution ordered by a court of law, wouldn't it be better if the enemy—self-proclaimed and carrying on the endless war—would be able to make THE RESTITUTION? This, let's be clear, is realistic, good common sense. This does NOT judge a man to be good or bad but it does indicate that there is ability to confront right or wrong (and unlawful) behaviors and actions. As in, did some people actually take over the paper, *CONTACT*? Did these people in point also actually take funds from bank accounts? Did people come onto property not belonging to them and take things? DO YOU SEE THAT WHETHER EKKER IS INVOLVED OR NOT MAKES NOT A WHIT OF DIFFERENCE IN THE LEGALITY OR MORALITY OF THE ACTS THEMSELVES? But you don't want to be involved, even if you are already involved? Say what? YOU "ARE" INVOLVED! EVERY ONE WHO EVEN WITNESSED ENOUGH TO "TAKE SIDES" IS TOTALLY INVOLVED AND—IF WORKING FOR OR WITH THE CULPRIT GROUP—YOU ARE AN ACCESSORY TO WHATEVER CRIME IS TAKING PLACE AND ALSO ARE CONDONING OF THE WRONG ACTIONS WHICH TOOK PLACE.

"So," you might retort, "I don't take either side, and there!" Oh yes, you HAVE! If you do nothing to assist in resisting evil or criminal actions, YOU ARE FULLY GUILTY OF COMPLICITY, IF NOTHING ELSE, my friends.

I would suggest each consider, in general, your attitudes towards your rivals or enemies. And, furthermore, be sure they are actually rivals or enemies—or are they just plain crooks and takers? And the same example of *CONTACT* bears well here as an example. Those people in point who now "oppose" us and claim us as "enemies" were NOT OUR ENEMIES, nor are they today. They are criminals, they are liars, they have cheated, stolen and taken advantage of far more people than a couple of old people called Ekkers. They have destroyed more than they will ever have touched or harmed in the Ekkers—WHAT ABOUT YOU? How can you not see what has happened to Millers, who now have that albatross of a house and pending litigation because the miscreants fed

them WRONG AND INCREDIBLY FALSE INFORMATION—AS IF IT WERE THE “LAW” IN ACTUAL PRACTICE.

Now what do the kids of the 'hood say as they go on about their ever widening participation in “hit and run”? Oh, well, “Millers should have checked it out! It isn't my fault....”

I cannot stress enough, however, how crucial is the role of “one's enemies”. Compassion is the essence of a SPIRITUAL LIFE. And in order for you to become fully successful in practicing love and compassion, the practice of patience and tolerance is indispensable. There is no fortitude even similar to patience, just as there is no affliction worse than hatred. Therefore, one MUST exert one's best efforts not to harbor hatred towards the enemy, but rather use the encounter as an opportunity to enhance the practice of patience and tolerance. AND IN THAT PATIENCE WILL COME THE ALLOWANCE OF “CONSEQUENCES” OF THE BEHAVIOR TO WORK THEIR OWN RETRIBUTION.

Always consider and respect the so-called “enemies” because these are your GREATEST TEACHERS—AND APPRECIATE THE FOOLISH THINGS THEY CONTINUE TO PRESENT IN THEIR EFFORTS TO HIDE THEMSELVES.

Ah, but now comes the really big question: “Why should I venerate my enemy, or acknowledge his or her contribution, because the enemy had no intention to give me this precious opportunity for practicing patience, no intention of helping me?? And not only that, they have no wish or intention to help me but they do have a deliberate malicious intention to harm me! Therefore, it's more appropriate to hate them—they are definitely not worthy of respect.”

Actually, dear ones, it is, in fact, the presence of this hateful state of mind in the enemy, the intention to hurt you, that makes the enemy's action unique. Otherwise, if it is just the actual act of hurting you, then you would hate doctors or any other who might bring a bit of pain and discomfort to you. So, KNOW, it is the unique point intended; it is willful intention to harm you that makes the enemy unique and gives you this precious opportunity to “practice patience”. The very definition of the dispute with, say, Rick Martin is when he publicly declared himself to be both “my” enemy and Ekkers'. Before and since that declaration, it was difficult to actually confront and define the status in play. It is far easier once someone DECLARES war because you can see the opposition for exactly what it IS and—if you are in a righteous stance—you can KNOW that ultimately the mischievous children of the lie WILL BETRAY THEMSELVES OR ONE ANOTHER, WHICH ACHIEVES THE SAME OUTCOME.

I DO NOT EVEN BEGIN TO SUGGEST YOU JUST “LET IT ALL GO” AND BE THE TOTAL FOOL. CONFRONT WITH TRUTH AND RELEASE IT FROM WITHIN SELF, AS

TO YOUR ATTITUDE ABOUT RESOLUTION. AND ALWAYS BE VERY CAUTIOUS THAT YOU NOT GET IN A TRAP OF CONDONING WRONG BEHAVIOR—OR OUTRIGHT DAMAGE OR THEFT—IN AN EFFORT TO JUST GET RID OF THE THING. UNTIL MAN IS WILLING TO STAND AGAINST UNRIGHTEOUSNESS WHILE IN RIGHTEOUSNESS, YOU WILL SINK DEEPER INTO THE MIRE OF EVIL INTENT AND MANIFESTATION.

And yes, these are the very experiences of life that define who and what YOU ARE. This very struggle of life is that which MAKES EACH OF US WHO WE ARE. And, face it, it is your enemies that test you and provide you with the resistance necessary for growth. And, by golly, readers, it is your stance against the ongoing wash of evil that will offer the very lessons the children need to understand—that crime MUST NOT PAY.

There is, in fact, a Buddhist prayer that has great meaning and might well even ignite a LIGHT within some who have chosen to be ENEMIES, as their own consequences come back unto them in a measure hurtful and shameful toward themselves:

Whenever I associate with someone, I think myself the lowest among all and hold the other supreme in the depth of my heart.

When I see beings of wicked nature, pressed by violent sin and affliction, may I hold these rare ones dear as if I have found a precious treasure!

When others, out of envy, treat me badly with abuse, slander and the like, may I suffer the defeat and offer the victory to others.

In short may I, directly and indirectly, offer benefit and happiness to all beings, may I secretly take upon myself the harm and suffering of all beings.

In the latter two paragraphs I would clarify an item or two. You do not just stand by the wayside while these things take place against you, but the point is to be willing to shoulder the load if you can reduce the pain and load unto another. For example: It would have been terrible to outrightly allow this bunch of misfits to suck Millers into erroneous attitudes and actions if it could have been prevented. This did not happen, as a resolution of the property matter was offered and pleaded for solution LONG BEFORE THE ACTUAL SEIZURE AND SALE. Like perhaps, readers, isn't it a bit frightening to reread the portion published in *Spectrum* from their newly found ORACLE, speaker for a Mayan Shaman, etc., who said he “realized he must go north and stop Ekkers, at all costs”, to a group of egotistical misfits running about hiding from the marshal? I think it becomes quite obvious after all this time that Ekkers are simply doing their very best to bring Truth, Light and HELP to a dying world and her hurting humanity. Hatonn—You cannot measure happiness or its lessons by alphabet or number, so you may as well designate “your” special happiness instruction by whatever you choose. Or, you can simply count your unhappiness chart. Sometimes “unhappiness” is easier to remember and teaches MORE than all the happiness in your experience. Happiness becomes simply that which “IS”, while unhappiness wears a different face with each passing realization.

Oh, precious, precious friends, can you not realize that all unhappiness is caused by perception and comparisons? If you have problems—so what?—solve them so that they do not longer annoy, irritate or distract. Confront them in and with truth and sane reasoning, and within LIGHTED KNOWING—where your foundation is from which you do all things and SOLVE THEM. Mostly, you will find you had/have no REAL problems, only perturbations manifesting as some type of INCONVENIENCE.

FAMOUS VS. GREAT

Chelas, you are here on Earth in physical expression for NO LESSER A PURPOSE THAN TO BE “GREAT”. You choose to be lesser if that be what you are or become.

It is an unhealthy attitude that requires of self in the ego-state to “always be right”, even if you are dead WRONG. You can become famous, infamous, recognized, ignored or totally unknown and STILL BE GREAT! Then, the term IMPORTANCE is the key word. How important is an incident in the overall “play”? Well, if you can ever combine “great” with “important”, you really have something amazing upon which to focus attention. Further, a man can be brilliantly important and still miss being great, for “Great” defines acts beyond simply “heroic” or “passing”.

For instance, let us consider a “thing” or a “person” of which this definition might well fit both categories. What thing, event or person might be considered the “most important” realization in, yea, the past two millennia? Ah, so you jump to the birth of one, Jesus.

JESUS WHO? Do you refer to the child, Esu Immanuel (Emmanuel, Jmmanuel)? Is this the one from the house of Gabriel or Joseph? Ah, Joseph? WRONG: It was from Gabriel that you gained the one called Jesus (Esu Emmanuel). And it was said that Jesus was anointed and named “Jesus”? No, he was not; he was called Immanuel and was finally entered into the records as being from the house of David through the HOUSE of Joseph. Ah, but what WAS JOSEPH’S name? No, I’m NOT going to tell you—go look it up—IF YOU CAN FIND IT.

The MOST IMPORTANT CONSIDERATION of the last thousands of eons is the REALIZATION OF CHRIST! This is a “STATE OF BEING” WHICH REPRESENTS THE “ALL” OF GOD CREATOR.

It is because of this very CONSCIOUSNESS and REALIZATION that you can bring about change. This change must be within SELF, where GOD ABIDES, and then it can be shared in the wondrous miracle it bears.

Since it appears you nice fledglings are pretty much in the “pits” instead of the “cherry bowl”, and CHANGE is required for upward movement, we had best look at change—because the world is going to get it, even if you refuse to participate. And no, I am not talking about shape-shifting-lizard faces or any given “race”, “creed” or “color”. Therefore, get off your pedestal built by ego upon which you wish to stand in all your glorious know-it-all-ness. Finally, upon your orb, there truly is enough fundamental truth upon which to begin the evolvement into a wondrous age of experience WITHIN THE CONSCIOUSNESS OF GOODNESS (christness, christianity or the dwelling with the christed consciousness). THIS IS SIMPLY “THE” PLACE TO BE TO FINALLY ATTAIN “HAPPINESS”.

CHANGE

Ah, BUT, how do you change? How do you KNOW? Well, first of all, if you are to actually “change” and bring about genuine inner transformation, you are going to have to, at the least, make some sort of sustained effort. You cannot just continue on and on in the same track, even if you present a lot of good and sensational foci. Therefore, we must move on into the “how” or “what” and out of the simply telling you about the sensational things already taken place. Both are necessary for your insight but just to continue on and on about, for instance, lizards and horned toads—is NOT MAKING CHANGE HAPPEN.

You MUST GROW into MATURITY. Those narcissistic and arrogant states of being MUST BE OUTGROWN and the REALITY of self as a fragment or extension of Creative Source is mandatory, lest you wallow around in your own illusion while you think and proclaim self to be too important to ignore. The more people ignore persons with this major affliction, the better becomes the world. First, of necessity, you have

to manifest the perfection you wish to achieve before you can achieve it in the higher expression of Creative Mind in ability to MANIFEST.

Putting the “genetic” aspect aside, let us consider the individual human person. You, if we choose “you” as our example person, are basically the emotional product of your learning and conditioning. This learning and conditioning is reinforced and amplified by “habituation”. This is where the possibility of change is so great a possibility. If you extinguish harmful or negative conditioning and replace it with helpful, life-enhancing experience—while accepting FACTUAL input and rejecting, after careful examination, the negative expectations—you can change and grow.

Consequently, the next step is then to begin to change external behavior and overcome bad habits, while changing your underlying attitudes and feelings. Your attitudes can certainly cause changes in behavior BUT—MORE IMPORTANTLY, IN THIS INSTANCE—your behavior will also be able to change your attitude.

Let us, for instance, consider a simple “smile”. A true smile instantly changes your attitude as quickly as it does your face. Moreover, you can “put on that happy face” artificially, if you choose to do so. The choice is yours to smile or frown, chelas. It is true, however, that a smile will bring a positive response, while a frown will bring immediate negative input.

So, if you want to change self, then at least “go through the motions” of positive rather than negative conditioning. Eventually, the “habit” will be a pleasant countenance and a far more “happy” outlook. This has extremely important implications, for to project positive behavior brings about genuine internal change—as well as reflecting like sunshine upon others around you. If you, for instance, begin with the simple acts of random kindness and regularly HELPING OTHERS, even if you don’t particularly FEEL either kind or caring, you will discover an inner transformation taking place, as you realize a surge in genuine feelings of compassion and good self-esteem. Get that focus off yourSELF, if you expect “self” to grow and mature properly.

When you practice this in a sustained effort, you will gradually grow and mature within this very aspect of being. Even if, at upstart, you have to pretend positive attitude, it WILL become—with practice and genuine sincerity for accomplishment—your mode of being.

Here let us just assume for the good of this conversation that you DO wish to change into a more positive and productive person, so that the positive aspect of emotional status can be allowed expression and example. Living in negative attitudes is a very debilitating and depressive state of being.

When embarking on this path to change, it is very important to set some reasonable expectations and expect a few setbacks, as “possibilities” of negative content bounce off your being. I do not suggest that you put aside the potential for the consequences of your actions while in negative position, attitude and action sequences—for those will impact you, since cause and effect is the basis of all action, thought and attitude. It is a SICK mind that doesn’t face the consequences of untoward behavior and egotistical revenge tactics. In fact, you might well consider clearing up those karmic consequences of ill behavior, especially if criminal in nature.

DO NOT SET FORTH RIDICULOUS

EXPECTATIONS AT UPSTART, LEST YOU TURN TO MIND-ALTERING SUBSTANCES TO REACH YOUR GOAL AND THEN HAVE TO BECOME AN ADDICT TO THE ARTIFICIAL ALTERATION.

Students, you must not, however, set those expectations too low, for that extinguishes your willingness to challenge your limitations and, finally, dissolve them totally, in order to achieve your true POTENTIAL.

REMEMBER:

YOU ARE BORN WITH PURE POTENTIAL!

You must also pay attention to the circumstances about you with sensitivity and respect, for these are the lessons of living and about which you must make choices in behavior. Therefore, do NOT lose sight of the things which impact or present. Attend and recognize the difficulties inherent in your path, and the fact is that you must take time to study and meet head-on the challenges from circumstance or “other” person(s).

Set your ideals high—as to your ultimate expectation—and make that goal as HOLDING FULL ENLIGHTENMENT. In that attitude of expectation you will meet challenges without “fear” of inability of positive solutions in your own awareness. As you move along, you will NOT consider acting out of negative attitude nor putting into motion that which is WRONG. Therefore, your immediate challenges will be from a standpoint of POSITIVE, GOODLY FOUNDATION.

You cannot, for instance, commit a heinously bad deed today and simply toss it off later. You must do that which you can to rectify the actions which are against Truth and God—and fellow man—regardless of what silly “reasons (excuses)” you have conjured to cover the deeds. If you have HURT someone and deliberately committed actions and false witness against another—you have to clean it up before you can grow further, for rectifying your misadventures is part of the processing. You cannot be happy and rightly GUILTY at the same time. And, further, neither can you just blame another, expect some kind of “forgiveness”, while they are bleeding to death—and go your way as if you are somehow exonerated by your mere presence. THIS IS THE ONE MANDATORY CHALLENGE ALONG THAT PATHWAY TO TRUTH.

You must consider your circumstances as you move toward your expectation accomplishment, for you must have a proper foundation upon which to build. If the foundation is A LIE, then you have nothing upon which to build and grow. Get the termites out of your wooden foundation and perhaps you can then begin to achieve both “happiness” and “joy”, along with goodly accomplishment.

Dealing with expectations is really quite a tricky issue. If you hop off into those excessive expectations without a proper foundation and a clearing of the things which have rotted your foundation, then that usually leads to problems of the worst kind. On the other hand, without expectation and hope, without aspiration, there can be no progress. You must find the proper balance, rectify that which was wrong to the very best possible conclusion and realize that you must JUDGE the situation and stop lying to self and/or to others. A LIE IS ALWAYS AN EXCUSE, NEVER A REASON.

AH, THOSE DARK MOMENTS

These “down” emotions are a natural part of your psychological makeup, Human. All human beings experience those darker emotions to one degree or another. You are going to react to things because it is simply what happens in any given circumstance. You may well react instantly to darker emotions of hate, denial and actual desire for combat. Realize that this happens and it is impractical to avoid this realization of human nature. What is wrong in these negative circumstances is to ACT OUT THE NEGATIVE IN REACTION VS. RESPONDING IN CONSCIOUS ATTITUDE.

There is a period of growth in the human—or, for that matter, in all animals—wherein the individual is quite arrogant, and usually this is a representation of IGNORANCE OF REALITY and ignorant perceptions. In consideration of this “arrogance”, it would appear that all babes are birthed in the arrogance of selfishness, as they have no other attitude capability in their total helplessness.

However, chelas, as you grow, day by day through education and learning, you can acquire knowledge and insight and dispel ignorance. If, however, you leave selves in an ignorant state without consciously developing your learning, you will reach a point where you are actually UNABLE TO DISPEL IGNORANCE. This might well represent the “natural” state of being but, without making an effort to dispel the ignorance, you are doomed to live within it.

If you are making an effort to change THE MIND, ah, we have a wondrous ground of potential possibilities. Open the thing called mind and brain and the battle is half won. The mind is complex but it is also very skillful at accomplishing anything it can conjure. In this realization, there is no question about changing attitudes—BY CHANGING THE MIND.

Though there may well be only a single individual continuum, you can adopt different perspectives. Here is an example of what takes place when you criticize self: The “self” that is criticizing is acting from a perspective of yourself as a totality of your entire being, while the self that is being criticized comes from a perspective of some particular experience or event. This becomes a very distinct “self to self” circumstance. There are many levels of perception of self and REALITY of self, which gives an overall “identity” to individual recognition. Therefore, you WILL see different PERSPECTIVES within each individual identity.

What this indicates is that when you conceptually relate to something, you are capable of looking at one phenomenon from many different angles. And the capacity to see things from different angles is quite selective; you can focus on a particular angle, a particular aspect of that phenomenon, and adopt a particular perspective. With studied gathering of facts, you can totally impact the perception as to perspective of any event or attitude toward any individual.

There are several premises which can be applied in changing those delusions and eliminating them from your minds.

NEGATIVES ARE DISTORTIONS

Number one of these premises is that all deluded states of mind, all afflictive emotions and thoughts, are essentially DISTORTED, in that they are rooted in

misperception of the actual reality of a given situation. No matter how powerful—deep down, these negative emotions have NO VALID FOUNDATION. They are based on ignorance. On the other hand, all the positive emotions or states of mind—such as love, compassion, insight and so on—have a solid basis. When the mind is experiencing these positive states, there is no distortion. In addition, these positive factors are grounded in reality. They can be verified by your own experience. There is a kind of grounding and rootedness in reason and understanding; this is not the case with afflictive emotions like anger and hatred. Beyond that, all these positive states of mind have the quality that you can enhance their capacity and increase their potential to a limitless degree, if you regularly PRACTICE THEM through training and constant familiarity.

A pretty good REALIZATION is to recognize that there are essentially two kinds of emotions or states of mind: positive and negative. So, you must come to be able to categorize emotions in terms of understanding that the positive emotions are those which can be JUSTIFIED and the negative emotions are those which cannot be justified.

Right here we might consider “desire”. Desire can be positive or negative in aspect. Desire for one’s basic necessities to be met is a positive kind of desire. IT IS JUSTIFIABLE. It is based on the fact that you all exist and have the right to survive. In order to survive, there are certain things that you require, certain needs that have to be met. So that kind of desire has a valid foundation.

The other side of this token presents then that some desires are “negative”. An example of this negative type of desire is greed. Those kinds of desires are not based on valid REASONS, and often create trouble and complicate one’s life. Those negative kinds of desires are simply based on a feeling of discontentment, of wanting more, even though the things you want aren’t really necessary. Those kinds of desires have no solid reasons behind them. So, positive emotions have a firm and valid foundation, and the negative emotions lack this valid foundation.

ANTIDOTE TO NEGATIVE INPUT

The next premise is based on the fact that your positive states of mind can act as antidotes to your negative tendencies and delusory states of mind. So it is that as you enhance the capacity of these positive states, you produce the antidote to the negative flow. In this way, the more you will be able to reduce the force of the mental and emotional afflictions, the more you will be able to reduce the influences and effects of these things as they impact you. You will begin to truly research the situation and evaluate its potential. In this example, when you are struck with immediate negative response or reaction, replace the thought with love and compassion—especially toward SELF—and then you will be in balanced circumstances to meet the challenge with positive response. Afflictive emotions, such as attachment and hatred, will be ultimately found rooted in ignorance or misconception of the true nature of reality.

You CAN fully overcome all of the negative tendencies, if you apply the antidote to ignorance—or let’s call it: The Wisdom Factor. The Wisdom Factor involves generating insight into the true nature of what is taking place and its reality. So, the thrust would be a bit of patience and then “get the facts, ma’am”. If you have a poisonous plant or insect, you can do several things: You can remove the poisonous part of the thing or you can, as with a plant, simply uproot the thing and get rid of it.

PUSH ASIDE OR MEET THE CHALLENGE

If you are simply reacting or responding to something that is impacting you but does NOT hold forth a need or responsibility for action on your part—you can simply let it go, release it and put it aside. If, however, there is a challenge to you for some action—you had best consider it very carefully. In this I mean pay attention, confront it and resolve it. Ignoring it indicates “remaining in ignorance” by the very term itself applied to your state of knowledge. BUT, YOU DO NOT HAVE TO HAVE A NEGATIVE ATTITUDE REGARDING THE MATTER. It may actually be quite unpleasant but not necessarily negative in overall consideration.

Here is a place of confrontation where you need to consider your reactions quickly and see WHY something which may only be an irritation becomes a mountain of negative assumptions.

I further suggest, however, if the same irritations are through some ongoing harassments, meet them head-on and begin to clear the entire root system of the evil plant. If a scorpion stings you, are you going to just stand around while he rebuilds his venom supply to sting again, and again and again? No, that is exactly what you who come into “enlightenment” tend to do as you move through the absurdity of “allowance in unconditional love” false-expression. That is NEW AGE garbage. GOD “ALLOWS”, you must confront that which is evil. Isn't it time you lived in Truth, rather than steeped within the Lie? You can replace the emotions one after another, if you choose to do so—and you don't even have to be hateful in confronting the black dragon.

You CAN change your attitude and your mind, and therein lies the TRUTH of it. Change your way of thinking and you can change the world. Replace that negative with a positive and you are on your way to attaining any worthy goal envisioned.

You must meet each perception and perspective with objective observation, and then WISELY CHOOSE a response—and sometimes your wisest choice will be NO RESPONSE AT ALL. However, realize that emotionally the choice of no response IS A CHOICE, so don't later say to yourself that you didn't make a choice. IN EVERY INSTANCE WHERE A CHOICE IS IN POINT—YOU DO CHOOSE. And, further, if you do **not** choose the way of Truth and GOD, you have chosen against HIM—for there is no “REALITY” in the middle of the fence. **You are in constant change and motion—so if you aren't moving TOWARD GOD, you are moving against HIM.**

If you find that you are often making choices which later you find were or are negative in portent—then you NEED to consider your attitude and why this pattern might have come to be. These are the lessons being taught with every breath. You need to have a status check FREQUENTLY and evaluate every circumstance in an ongoing search for Truth. You don't make wise choices by denying or refusing to intake that which is available as fact in any consideration. **Ignorance is surpassed only by FEAR and, in fact, please note that Fear stems from ignorance.** Bad data in will produce bad data “out”.

Splendor and majesty are before you, so why would you choose to perceive the negative and the ugly? Happiness follows upon the trail of positive being.

HISTORY ON TRIAL: IRVING'S OPINION OF HITLER IS PERVERSE, CLAIMS KEEGAN

DAVID IRVING'S views on Hitler and the Final Solution are “perverse” and defy common sense, Sir John Keegan, Defence Editor of *The Daily Telegraph*, told the High Court yesterday.

Giving evidence after being subpoenaed by Mr. Irving, he said the author's proposal that Hitler could not have known what was happening to the Jews until late 1943 “was so extraordinary it would defy reason”. Sir John, knighted in the New Year Honours for services to military history, had been called by Mr. Irving in his libel action against the American author Deborah Lipstadt and Penguin Books over a claim that he is a “Holocaust denier”.

Mr. Irving told the Court that Sir John had, in the past, recommended his book, *Hitler's War*, to students of the Second World War. Sir John told the Court that he had recommended two books, Mr. Irving's and another, *Struggle for Europe*, by Chester Wilmot. He said: “Together they gave Hitler's side and the Allies' side.”

That did not mean, he said, that he endorsed the opinions in Mr. Irving's book. Sir John said: “I read *Hitler's War* very carefully at the weekend. I continue to think it is perverse in the proposal that Hitler couldn't have known until October 1943 what was going on with the Jewish population in Europe and many other minority groups as well.”

Mr. Irving, 62, who is representing himself, said he had called Sir John as a witness to his reputation. But Sir John had been unwilling to attend unless summoned.

Sir John, who had never met or corresponded with Mr. Irving, said he admired *Hitler's War* in what it had to say on the subject he was most interested in as a military historian—how Hitler conducted military operations. He said: “That sort of history interests me. It does not mean I endorse your opinions beyond that.”

Explaining his reluctance to give evidence, Sir John said: “It seemed to me this was going to be a very contentious case and one is easily misunderstood in discussions of this dreadful episode. I did not wish to put myself in a position where I might be misunderstood.”

Mr. Irving asked: “You were apprehensive about giving evidence on my behalf?” Sir John replied: “But I am not giving evidence on your behalf, but under subpoena.”

Mr. Irving claims libel damages over Professor Lipstadt's 1994 book, *Denying the Holocaust: The Growing Assault on Truth and Memory*, which he claims has generated hatred against him. The defendants have accused him of being a liar and a falsifier of history.

Mr. Irving believes that the killing of the Jews was organised by Heinrich Himmler, but accepts that after 1943 Hitler had no excuse for not knowing about it.

The case continues.

[JR: Recognize this well organized power of influence that requires you to either totally agree with them or you will be publicly, professionally and financially destroyed. It seems that everyone is in fear of being labeled a “Holocaust denier”, even Sir John Keegan. Perhaps this is why Mr. Irving stands in court alone.]

SYRIA'S HOLOCAUST REVISIONISM OUTRAGES ISRAEL

BEIRUT—A few short months ago, President Hafez al-Assad of Syria and Prime Minister Ehud Barak of Israel were cloaking each other in words of honour. Trust, strength, courage. American “peace-makers” cooed like children.

But now, the Israeli dead are being brought home from Lebanon again, their allies destroyed daily, their bombs falling again around the Lebanese hill villages east of Tyre. And *Tishrin*, the Syrian government newspaper that has always praised President Assad's “strategic choice” of peace, has joined the chorus of Jewish Holocaust deniers.

The three Israeli troops, a major and two corporals, killed in a Hizbollah ambush on Monday, provoked the usual demands by soldiers' mothers for an immediate withdrawal from Lebanon—which is also, of course, the demand of Syria and Lebanon.

But the extraordinary editorial in *Tishrin* seemed designed to infuriate Israel, which, according to the paper, had convened the Stockholm Holocaust conference to further Jewish “lies” about the Holocaust in the face of “credible” voices which questioned it.

Among these voices, *Tishrin* announced, was the British historian, David Irving.

“Why does Israel insist on bringing up this alleged Holocaust policy?” Mohamed Kheir al-Wadi, the Editor, wrote. “I believe Israel and the Zionist organisations have two aims. The first is to receive more money from Germany and other Western establishments on the pretext of compensation for the Holocaust. The second is to benefit from the Holocaust myth and accuse anyone opposed to Zionism and its expansionist policies of anti-Semitism.” Zionism, Mr. al-Wadi added, “invents stories about the Holocaust and exaggerates them to astronomical levels.”

The Israeli Foreign Ministry spokesman said the article did not deserve a response. The U.S. Secretary of State, Madeleine Albright, called it “ridiculous”.

In fact, Syria has long denied the facts of the Jewish genocide, allowing its own Defence Minister to run a publishing house that has printed an Arabic edition of that hoary old forgery [copied from the original], *The Protocols of the Elders of Zion*.

When a French academic who had questioned the figure of six million Jewish dead visited Damascus two years ago, he was warmly embraced by the Foreign Minister, Farouk al-Shara—who last month

conducted peace talks with the Israeli Prime Minister.

The Syrians, it seems, believe the Israelis are betraying their original offer of a retreat from the occupied Golan Heights by demanding a peace treaty before withdrawal—the trap into which Yasser Arafat fell. And when Syria is upset, it gets very angry indeed. Hence its dismissal of Mr. Barak's appeal for Syrian restraint on Hizbollah—though Israel offered no restraint on its own proxy, South Lebanon Army militia. Hence the continued guerrilla attacks in southern Lebanon.

Ironically, Syria was the location for much of the world's first genocide, the murder of one-and-a-half million Armenians by the Turks in 1915. Syria does not deny this Holocaust, but Turkey does, in the same words used by the Syrians about the Jewish Holocaust.

The Turkish Ambassador to Israel says that “the myth of the Armenian Holocaust was created...with the hope that the Armenians could be rewarded for their “sufferings”. Mr. al-Wadi says the “myth” of the Jewish Holocaust was “to receive more money...on the pretext of compensation”.

No mention from Mr. al-Wadi of a certain Grand Mufti of Jerusalem who urged Hitler to stop the Jews of Europe reaching Palestine. Nor is there a squeak from the Turkish ambassador about Turkey's refusal to join the Allied war against Nazi Germany.

But which country is now Turkey's best friend in the Middle East? Israel. Revisionism and denial of the truth go hand in hand when things fall apart in the Middle East.

[JR: It is refreshing to be able to read another point of view coming out of the Middle East. The reaction is always designed to discredit the message and the messenger but in any case the truth will win out for those who are open to other opinions, perceptions and truth.]

ISRAELI NUCLEAR “DEBATE” EXPLOSIVE

JERUSALEM—The first public parliamentary debate of Israel's top-secret nuclear-weapons arsenal degenerated into an ugly confrontation Wednesday when an Arab legislator announced that Israel has as many as 300 nuclear warheads, prompting Jewish lawmakers to call him a spokesman for terrorists.

Military censorship has always forbidden reports in the local media about Israel's nuclear arsenal. But Issam Mahoul's speech, broadcast live on television, gave Israelis their first opportunity to hear details from one of their own. Most Jewish lawmakers marched out of parliament in protest.

A visibly uncomfortable Cabinet minister, Haim Ramon, responded to Mahoul by repeating Israel's well-known yet vague nuclear policy statement and disputing Mahoul's premise that the public has the right to know.

Ramon said Israel would not be the first to introduce nuclear weapons into the Middle East, a decades-old policy known there as “ambiguity”, implying that Israel has nuclear arms capability but not actual bombs.

Jewish members interrupted Mahoul's speech with catcalls as he declared: “All the world knows that Israel is a vast warehouse of atomic, biological

and chemical weapons that serves as the anchor for the Middle East arms race.”

Some lawmakers called him a spokesman for Arab terrorists.

“You are committing a crime against Israeli Arabs today,” shouted Ofer Pines-Paz, an Arab and Chairman of Prime Minister Ehud Barak's coalition in parliament.

Undeterred, Mahoul went on to say that Israel's three new German-built submarines “will be fitted with nuclear weapons” to provide Israel the capacity to retaliate if hit with a nuclear attack. **[And who, do you suppose, will pay for those submarines?]**

Mahoul said the policy undermined government statements that its nuclear capability is a deterrent to attack.

Mahoul said Israel's vague policy statement had lost all credibility, pointing to disclosures by Mordechai Vanunu, who worked at Israel's desert nuclear reactor before revealing nuclear-weapons secrets to the London *Sunday Times* in 1986. He was sentenced to 18 years in prison for treason.

The debate was raucous and bitter even by the standards of Israel's unruly parliament. It created a rare public split down ethnic lines, with Jews from almost all political backgrounds opposing the Arab members, though Barak's party often sides with the Arab members and counts on them for political support....

[JR: Israel's nuclear capability has not exactly been the best kept secret, but the world has allowed them to maintain their official denial to exempt them from reporting their nuclear arsenal—required by international treaty since the 1960s. The Israeli lawmakers can march out with “righteous indignation” but you can't hide an elephant under a bagel for very long before even someone wearing blinders notices it.]

THREATS PUT BRUSSELS ON WRONG SIDE OF LAW

BRUSSELS—The European Commission was in turmoil yesterday as criticism mounted over the European Union's threats against Austria.

Officials were forced to admit that there was no legal basis under EU law to exclude the far-Right Freedom Party of Jörg Haider from the coalition government in Vienna.

Having repeatedly said that it would not be appropriate “to meddle in the internal affairs of a member state”, the commission is scrambling to find a policy that reconciles the demands of the EU's 14 other member governments—which acted on their own initiative under the prodding of President Chirac—with the limitations of EU law.

A commission official said: “We're not seeking to influence the formation of the Austrian government. These policies are designed to shape the programme of the government once it is in power. Then every dot and comma will be scrutinised to see whether its actions are consistent with treaties.”

Romano Prodi, the commission President, emerged briefly after an emergency meeting yesterday to say—in English, French and Italian—that there was no difference of opinion between Brussels and the member states. He went on to say that the

commission was “maintaining its working relations with the Austrian authorities”.

Mr. Prodi is having to walk a tightrope. Any suggestion that the Austrian crisis is disrupting EU business, risks sending the euro further down as investors increasingly doubt the political underpinnings of monetary union. It fell to \$0.9665 at one stage yesterday.

The *Amsterdam Treaty* permits the EU to suspend the voting rights of any member state in “serious and persistent breach” of human rights, fundamental freedoms and the rule of law. It does not authorise pre-emptive measures to stop the formation of a government that might violate these principles.

Ricardo Levi, Mr. Prodi's spokesman, said: “Nobody is saying that Austria is a fascist country. No one can point to any breach of fundamental rights in Austria, and no one can say that the elections in Austria have been anything but democratic.”

Officials acknowledged that the threat of political sanctions against Austria, which was conveyed by the Portuguese presidency of the EU as if it were a decision by the Council of Ministers, has no constitutional standing.

“This was not a council decision,” said Mr. Levi, meaning that it was merely a collective act by like-minded governments acting outside the institutional structure of the EU and, as such, did not give the commission the authority to act. As the executive arm of the EU, “guardian of the treaties of European Union”, it can respond only when a violation is brought to its attention.

Political figures across the ideological spectrum have questioned the unprecedented threats against Austria, saying that they are an over-reaction serving only to radicalise the far Right and carelessly setting the precedent that the EU member governments are subject to the approval of Brussels.

Karl Lamers, Foreign Policy Spokesman for the German Christian Democratic Union, said: “It plays into the hands of Jörg Haider. A role in government would offer the chance to break his spell as a Right-wing populist and a media phenomenon.”

The move by the EU's majority of socialist governments to try to stop a Right-wing party with 28 percent of the popular vote from participating in office has profound implications.

Timothy Kirkhope, the Tory chief whip in the European Parliament, said: “A lot of European governments have coalitions with unsavoury types. Proportional representation causes it to happen. But it doesn't mean that the EU can overrule the right of democratic choice. I don't like fascists but I don't like communists, either, and there are communists in the Italian government. What are we going to do about that?”

[JR: This EU commission seems to be trying very hard to find some precedent in EU law to disenfranchise the new Freedom Party coalition and interfere with the democratic elections and sovereignty of Austria. Some European leaders are even making threats of sanctions—and others to withdraw their ambassadors. Will this lead to a Serbian-type solution? I seem to recall wars have begun before over an “Austrian” situation. This is going to get bigger unless certain “alarmists” overcome their paranoia.]

THE ULTIMATE PSYCHOLOGICAL WEAPON—
THE VOICE OF THE LORD

We are in Baghdad in 1991, and something strange is happening. A hush falls over the city as a huge shimmering face materialises in the sky. Soldiers and citizens prostrate themselves as each hears the voice of Allah coming from within, commanding them to overthrow the evil and treacherous Saddam Hussein. Within minutes, an angry mob is storming the palace as the guards flee...

...This highly imaginative scenario was proposed by U.S. Air Force planners for a bloodless victory in the Gulf conflict. The idea of putting words in God's mouth is not new. Back in the Second Century AD, Lucian described a statue of the god Aesculapius which spoke to believers, aided by a hidden priest with a speaking tube.

The Baghdad plan involved projecting a giant hologram over Iraq. This kind of projection requires a mirror behind it, and the scale of the project dictated a mirror several miles across up in space. Orbital mirrors have to be extremely lightweight, so the construction is based around a very thin sheet of metallised plastic....

...Another approach would be to make a mirror out of thin air. When warm air lies on top of cold air, the difference in density is enough to bend light. This causes the familiar illusory puddles in the road on a hot day. At higher altitudes, a mirage can make whole landscapes appear in the sky, an effect known as *fata morgana*. An artificial mirage could in theory [**HAARP capabilities in this regard are more than theoretical.**] be made by heating the atmosphere with radio waves or microwaves.

The military certainly appears to believe in the potential use of holograms. A U.S. Air Force think-tank has devised uses ranging from deceptive holographic imaging to the *Star Trek*-sounding "distortion field projector". These are described as useful for strategic deception purposes, particularly against an unsophisticated adversary. They would be projected by a special aircraft, the airborne hologram projector. Perhaps the nearest current equivalent is the *Commando Solo*, a modified Hercules festooned with airdrops and antennae and carrying pods of classified electronics. Flown by the 193rd Special Operations Detachment ("We fire electrons, not bullets"), it has been involved in the Gulf and the Bosnia and Kosovo conflicts. *Commando Solo*'s equipment can transmit across the electromagnetic spectrum, including radio and television signals. Its other capabilities include jamming, deception and manipulation techniques.

The face of God is not enough on its own. A voice is needed. A new technique using microwaves could produce this. When a high-power microwave pulse strikes the human body, a small temperature perturbation occurs. This causes an expansion of tissue, which can create an acoustic wave. A report from the USAF scientific advisory board says: "With a pulse stream, an internal acoustic field of 5-15KHz can be created which is audible. Thus it may be possible to 'talk' to adversaries in a way which would be most disturbing to them."...

...Although the plan had major technical hurdles to overcome, the main reasons for rejecting it were cultural. Images of Allah are forbidden in Islam. How can you project an image of God when nobody knows what He is supposed to look like?

There is also a fundamental problem with psychology. The plan's view of foreigners was being conveniently portrayed as superstitious savages, prone

to fleeing at the sound of a disembodied voice from a gramophone. This may have been the case in some places a century ago, but the citizens of Baghdad are by no means backward. They have satellite dishes and VCRs like the rest of the world.

[JR: This explains why Project Blue Beam didn't happen as planned even though HAARP could have easily provided the upper-atmosphere mirror. When people become informed and aware of the plans of the Elite, we become the unknown factor and, therefore, unpredictable. Writings in CONTACT by the late Serge Monast (whom I believe was taken out because he exposed their plans) were instrumental in them having to cancel this project. Knowledge is power—get informed.]

FURY OVER SECRET U.S. NUCLEAR SHIELD

A furious row has broken out in the Ministry of Defence over Britain's decision to let the U.S. government build a huge missile-defence system in Britain, in breach of the *Anti-Ballistic Missile Treaty*.

Preparation for the nuclear shield, designed to protect the U.S. from attack by rogue nuclear-weapon states in the Middle East and North Korea, is under way at RAF Menwith Hill, near Harrogate in North Yorkshire.

Some Defence Ministers are angry that the government is being evasive in answers to Parliament about the site. Ironically, said one minister, the U.S. military was being far less secretive with its own public.

British political sources say the construction is also causing concern in NATO and undermining Britain's efforts to lead the debate on a new European defence arm.

President Jacques Chirac of France recently attacked the U.S. plans to construct a national missile defence system, saying: "We must avoid any questioning of the *ABM Treaty* that could lead to a disruption of the strategic equilibrium and a new nuclear arms race."

A fortnight ago the Defence Secretary, Geoff Hoon, failed to win a court order striking out a CND writ designed to stop building work at the site. CND claims the construction has never been debated or sanctioned in Parliament.

A separate legal action against CND is being taken by the U.S. Air Force.

The U.S. claims that only a small adjustment to the *ABM Treaty* would be needed to accommodate a defence system such as Menwith Hill.

So far at Menwith Hill, concrete bases have been built for the two new radomes—huge golf-ball shaped antennae used in electronic communications—which are intended to house a Space-Based Infra-Red Satellite (SBIRS) system. The satellite(s), dubbed "Son of *Star Wars*", would provide warning of ballistic missile launches.

In a recent parliamentary written answer, Defence Minister Baroness Symons avoided saying whether [or not] SBIRS was compatible with the 1972 *ABM Treaty*. She said: "The British Government retains legal possession and control over the sites made available for use by the United States' visiting forces. Operational control of deployed forces rests with the U.S. Referring to the U.S. and Russia, she added: "Interpretation of

the *ABM Treaty* is a matter for the parties to that Treaty."

The Government has refused to reveal the legal basis of the agreement with the U.S. over the base. President Clinton is due to decide in the summer whether [or not] to go ahead with the \$12 billion system, but his Democratic Party is under pressure from Republican hawks to do so.

In a setback for the Pentagon, a prototype missile interceptor failed to hit a mock warhead earlier this month.

[JR: There are a lot of duplicitous maneuvers in this little agreement. It does, indeed, compromise the ABM Treaty—and for what end or purpose? When times are prosperous, people are lulled into a false sense of security—and that is when the deceivers are busy with their plans.]

SACRED LAND, BITTER BATTLE

BIG MOUNTAIN—In the end, there is only the land. The earth. The rocky soil beneath the feet of Katherine Smith, 80, as she treads the vast landscape of northeastern Arizona....

...But that bond is about to be severed forever.

As of Tuesday, dozens of Navajos such as Smith will, by federal law, become trespassers on the lands of their birth.

Twenty-five years ago, in December 1974, President Ford interrupted a Colorado skiing vacation to sign a law forcing thousands of Navajos to move.

The law has turned the land over to the nearby Hopis, for whom it is also hallowed ground.

Traditional Navajos call this the world of the Hero Twins—Child Born of Water and Monster Slayer—who received powers from their father the Sun to slay bloody monsters.

They made this remote, rocky place safe for the Dine, "The People", as the Navajos call themselves.

It is safe no longer.

The Hopis won a long, bitter battle in Congress, arguing that the larger Navajo Tribe had gradually taken over much of their land. The Hopis insisted that their survival and simple justice required that the Navajos be moved back.

But this forced relocation of thousands of Navajos is more than the latest episode in an intertribal feud. It's also the last, haunting echo of America's controversial policy of Indian removal. Critics say it is tainted with racism; they argue that if the settlers on Hopi land were non-Indian, they would never be evicted.

And it has targeted some of the last traditional Indians living in the continental United States. They dwell far from mainstream America, over axle-bending dirt roads that turn to mud after the driving summer storms Navajos call "male rain".

They have little understanding of the English language or White people's laws. They believe the land is alive with sacred power, that gods—Diyiin Dine, the Holy People—live in the springs, the rain, the wind.

About 13,900 Navajos have bowed to the Bilagaana Bi Behaasani, the "White Man's Law", as the relocation act is often called. It has cleared out entire communities with the relentlessness of a glacier.

Congress in 1974 thought it could get the job done

in a few years at a cost of about \$40 million. Twenty-five years later, relocation goes on and the cost to taxpayers is approaching a half-billion dollars.

About 200 Navajos remain, anchored by the sturdy women of Big Mountain and a few other places. Some, including Katherine Smith's daughter, have accepted the 1996 "accommodation agreement" that allows signers to stay for 75 years under Hopi jurisdiction.

Yet some Navajos, known as "resisters", cannot bring themselves to acknowledge either Hopi ownership or the Feb. 1 deadline.

Federal officials in Phoenix promise there will be no marshals on the disputed lands this week. Not yet. But after eviction proceedings make their way through federal court, the marshals are likely to move in, unless the Navajos give in.

"We have no choice," Assistant U.S. Attorney Joe Lodge said, "but to enforce the law." Pauline Whitesinger, Katherine Smith's half sister, reacts to the news with bewilderment and defiance.

"Sometimes, I wonder what exactly caused it," she said. "Is it because we didn't offer enough prayers and corn pollen to the Holy People? Are we being punished because we are joining other religions, like the Christians and the Native American Church?"...

...It is almost over, even though critics such as anthropologist David Aberle have for years urged Congress to reject relocation. Aberle and others cite a long-standing federal policy of resolving Indian land claims without dislodging settlers.

Richard Schifter, an attorney for the Navajos, told Congress that relocation embodies a racist double standard and a deviation from past federal policy in Indian land disputes.

"Could it be, may I ask, that where the settlers are White, we pay off the original owners in cash; but where the settlers are Indian, we find expulsion and removal an acceptable alternative?"

Forrest Gerard, a staffer on the Senate Interior committee that endorsed the 1974 bill, concedes Schifter's point.

"In all of the legislative land-claims settlements that I looked at or was involved in, we never once dislocated a non-Indian party," Gerard said in an interview....

...Goldwater promised that relocation would be good for the Navajos. He said the new homes provided in the law made it "a once-in-a-lifetime opportunity for them to improve their lives". In some cases, he was right. Many young Navajos, educated and culturally mobile, have been happy to receive the new homes provided by the law....

...But many other relocatees have found only loneliness and misery in their new homes. There also is widespread agreement that the whole relocation effort has been hampered by federal bungling, political cronyism and drastic underestimates of the cost both in taxpayer dollars and human suffering.

"Forcibly relocating people with a strong tie to the land is about the worst thing you can do to them short of killing them," said Thayer Scudder, professor of anthropology at the California Institute of Technology.

Calling relocation "a cultural disaster" for the Navajos, Scudder said, "I'm increasingly seeing it as an American version of ethnic cleansing. You can't tell me we would have done that with Anglos or any other population in the United States...."

...A federal Appeals Court asked U.S. Magistrate

Judge Harry McCue of San Diego to step in to mediate.

"It was the most significant contact I have ever had with other human beings," said McCue, 72, adding that he came to respect both tribes' commitment to the land.

McCue said he began to understand the tenacity of elderly Navajos when he saw a woman living under a plastic sheet at the side of a sandstone plateau.

Rather than accept relocation benefits, the woman clung to the land. Barred by court order from replacing her house, she lived in a hole in the ground.

"I was really overwhelmed by the realization that here is a society that is truly attached to the land," McCue said, "not just physically, but spiritually and emotionally."

[JR: It is difficult to comment on this issue, since both tribes honor and hold dear their sacred ties to this land. The pity is that it was an agreement made by the government and not between the Hopi and Navajo. Neither the concerns nor care of either tribe has been met.]

U.S. SOLDIER FIGHTS DISCHARGE

WASHINGTON (AP)—A U.S. soldier's bad-conduct discharge for refusing to serve on a UN peacekeeping mission should be overturned because the jury was not allowed to decide whether President Clinton's order to deploy was legal, the soldier's lawyer argued Friday.

Attorney Henry L. Hamilton, representing Army medic Michael New, told five judges of the U.S. Court of Appeals for the Armed Forces that Clinton's order to deploy troops to Macedonia in 1995 was illegal because he did not have congressional approval.

"Superiors may not compel subordinates to obey illegal orders," said Hamilton, a retired Army judge advocate general. "The government must prove lawfulness.... If it's not a legal order, there's no duty to obey it."

Capt. Kelly Haywood, representing the government, argued that the order's legitimacy was never for the seven-member military jury to decide, and New had a duty to obey the Commander in Chief.

"The mission lives and dies by the soldier following an order," Haywood said.

New was among a few hundred mainly support troops that Clinton sent in 1992 to Macedonia, one of six republics of former Yugoslavia, to guard against the spread of unrest from other areas torn by ethnic turmoil because of Yugoslavia's dismemberment. They served in a peacekeeping force dispatched by the United Nations, and New refused to wear UN insignia on his U.S. Army uniform.

The appeals court judges must decide whether Army Judge Lt. Col. Gary Jewell, who oversaw court-martial proceedings against New in January 1996, erred by essentially telling the jury that Clinton's order was constitutional. If so, the case would be sent back down for new court-martial proceedings.

The judges' decision is expected within two to three months.

At New's court-martial four years ago, the jury took only 20 minutes to convict him of disobeying an order. He was sentenced to be given a bad-conduct discharge, but the discharge is being held in abeyance during his appeals.

"What's at stake here is whether or not it's illegal for a soldier to wear the uniform of foreign nations, of foreign commanders," New said later, outside the courthouse.

While stationed in Germany in 1995, the native of Conroe, Texas refused to remove his American military uniform patch in favor of the insignia and blue beret of the United Nations, saying he would not serve a foreign power. Hamilton described his client as a patriot.

"President Clinton lied to Congress to effect the deployment in Macedonia," Hamilton said outside the courthouse. "It all stemmed from his duplicity in failing to inform Congress."...

...He served with U.S. units in Kuwait since the 1991 Persian Gulf War.

While awaiting the outcome of his case, New is on involuntary leave. The 26-year-old medical specialist has been working for a Texas manufacturing firm and studying computers at a local college.

In March, the U.S. Supreme Court refused to hear New's military case. The justices said he must exhaust all avenues of military appeals before seeking relief from federal civilian courts.

[JR: The constitutional issue presented in this case was a valid question long before 1996, yet another decision on his appeal still won't be made for another few months. It may be years before this case is constitutionally decided, if ever, or New's appeals are all exhausted. Not only does this single soldier have the courage to stand by what he believes to be truth but in doing so he is also challenging the constitutional powers of this lying President. He was convicted because of his strong constitutional beliefs and would not succumb to severe pressure from his superior officers as others in his unit did. His integrity will constantly be under attack to discredit him. That's the way it is done today.]

SOCIALIST MINDSET

The thoughts about to follow were prompted by the Republican response to the President's State of the Union address. Sen. Susan Collins, Maine Republican, began her speech with the following sentence: "Our Republican agenda is driven by the simple but powerful truth that America will continue to lead the world as long as our government allows opportunity, initiative and freedom to flourish." Allows? Government allows?

Is there a single passage in the *Constitution of the United States* [sic: should be *Constitution for the United States*] that asserts, or even implies, it is the prerogative of government to allow citizens this, that or the other? Is it not the letter and spirit of the *Constitution* to define what government may or may not do?

Having spent my 20 years in a country where, indeed, citizens anxiously awaited government decrees, the mindset of hoping for the benevolence of government is familiar. On occasion, the government would allow athletes and artists to travel abroad so long as their hard-currency earnings were turned in. Or, the government would allow the formation of a non-communist patriotic organization on a trial basis. But in America? We look to government to allow freedom?

Readers of this column might well have become

exasperated by excessive references to socialism, its agenda and vocabulary. Perhaps this annoying preoccupation could be reappraised now. Consider: It was not one of the 58 declared socialists who make up the Progressive Caucus of the U.S. House of Representatives; it was not a closet-socialist like Sen. Edward Kennedy. It was the Republican response to the State of the Union that demonstrated the presence of the socialist mindset.

Sen. Susan Collins is not at fault here. Perhaps nobody is at fault here. Socialism is not a person, not a conspiracy, not even ideology any more. It has become a degenerative process that gradually eats away at a person's common sense and powers of reasoning, not unlike leukemia eats away red blood cells.

The first symptoms are certain words and phrases—some quite innocuous—that creep into everyday use: reactionary, capitalism, exploitation, working Americans vs. the wealthy, private sector, human resources department, world peace, politically correct, social justice, economic justice, or calling people fascists. (The term denotes exclusively members of Benito Mussolini's party in Italy, extinct in 1944. [sic]) All the above are words invented or adapted for the Marxist-Leninist dictionary. Words are immensely powerful, whether used against us or used by us.

The next stage is a growing preoccupation with problems that, by definition, cannot be solved, such as disease, poverty or world hunger.

Tangible and useful work in the community is replaced by blustery slogans that lead to inaction and the early emergence of megalomania, such as 8-year-olds who want to save the Earth instead of learning to write their names. In the adult world, it leads to politicians who, for example, preach about global warming, instead of providing the service they had been elected to perform.

The children and politicians in the preceding examples claim divine powers for themselves. But we have gone past even that stage by now, if we have transferred to government the power to "allow opportunity, initiative and freedom" so we may flourish. "Transfer" is the appropriate word here, for this nation's formal existence began with the phrase "We the People". When, how, and who proposed that we abandon our *Constitution*? **[As CONTACT readers are well aware, the *Constitution* has not been in effect since at least 1933, as martial law has prevailed ever since, renewed by the annual declaration of a "state of emergency" by the President.]**

The "Re-Elect America" bus tour, described before in this column, will pose that very question to the People. When we speak of the rule of law as the North Star of America's compass, we mean the *Constitution* as it describes itself in Article VI: "This Constitution, and the Laws of the United States which shall be made in Pursuance thereof...shall be the supreme Law of the land; and the judges in every state shall be bound thereby."

In practical terms, this should mean that neither Congress nor state legislatures may enact laws that are inconsistent with the *Constitution*.

Even a law passed without a single dissenting vote is illegitimate if it cannot be reconciled with the *Constitution*.

In practical terms, this should mean that even the opinion of a Supreme Court justice is also moot if it

cannot be reconciled with the *Constitution*.

All laws, all interpretations must pass the test of having been "made in pursuance" of the *Constitution*. That, by definition, is likely to result in relatively few laws.

By contrast, the socialist mindset expresses itself by making up laws—and handing down opinions—based on an agenda of social justice. And since people's view of social justice changes all the time, the need is for new laws all the time. Lots of them. Thousands of them. And once we have been tied in knots by them, we become supplicants hoping that "our government will allow opportunity, initiative and freedom to flourish".

In no time, we look to government to educate our children, to manage our health, to supervise our relationships, to settle our most private disputes.

The time has come to admit that our increasingly socialist mindset cuts across party lines.

The time has come to realize that our thoughts and attitudes have been invaded by propositions utterly alien to America.

The time has come to re-elect America.

VLADIMIR PUTIN'S RUSSIAN EMPIRE BEGINS TO GROWL

From the northern Pacific Coast to the Caucasus and beyond, Moscow's new leadership has embarked on an aggressive foreign policy, which has set it firmly on a collision course with Western interests.

In a series of actions over the past few days, the new Government of Vladimir Putin, Russia's acting President, has moved to bolster its military, befriend repressive regimes and put the West on notice that it will be a rival rather than a partner. Despite receiving a cautious welcome in the West, where Madeleine Albright, the U.S. Secretary of State, praised Mr. Putin this week for his open-mindedness, his actions have sent a very different signal.

Mr. Putin, a former KGB agent who is expected to win next month's presidential elections virtually unopposed, seems in the space of only a month in power to have embarked on a much more aggressive path than his predecessor, Boris Yeltsin.

Igor Ivanov, his Foreign Minister, visited North Korea yesterday and signed a friendship pact with the regime of Kim Jong Il, a pariah in the international community.

Today he will follow up that move by visiting Japan, where Russia has indicated that it will not honour a commitment by Mr. Yeltsin to resolve the dispute over the Kurile Islands—territory seized by Stalin at the end of the Second World War.

Russia is further making its presence felt in the region with the delivery, expected this month, of a guided-missile destroyer to China, the latest addition of sophisticated Russian hardware to Beijing's growing naval arsenal.

The sudden activity in the Far East has been matched by other initiatives closer to Moscow. The Kremlin has just assigned the sole right to extract and exploit Chechnya's oil and gas reserves to Rosneft, Russia's last state-owned oil giant.

Last week the Presidential Security Council passed a new Russian military doctrine, which relaxes the rules of engagement of Moscow's nuclear forces. From next month, when the doctrine comes into effect, **the Russian Head of State will be allowed to use atomic weapons in conflicts that do not necessarily threaten Russia's territory.**

The change in policy is regarded as an important shift when coupled with other moves on the military front. Yesterday, Russia successfully test fired a Topol-M ballistic missile, its new-generation intercontinental weapon, which was launched from the Plesetsk site in northern Russia and hit the Kamchatka Peninsula more than 5,000 miles away in the Pacific. Mr. Putin also promised recently to double military expenditure after his campaign in Chechnya.

The build-up comes as relations with NATO remain largely frozen. A forthcoming visit by Lord Robertson of Port Ellen, the NATO Secretary-General to Moscow, has been postponed. No date is likely to be set until after the Russian presidential elections on March 26. The other cause for concern in the West last week was the seizure in the Gulf by the U.S. Navy of the Russian tanker *Volgoneft-147*, which was found to be smuggling Iraqi oil, thus helping Saddam Hussein to break UN sanctions.

Despite the concern caused by Russia's recent actions, Western policymakers said that it was still too early to tell if Mr. Putin would emerge as a friendly or hostile leader during his rule—which is likely to run for at least the next five years.

"Part of the problem is that we know so little about him," one senior American official said. "What we do know is that he will be much more difficult to influence than Yeltsin—our leverage is much weaker."

Britain is hoping that a visit to Moscow this month by Robin Cook, the Foreign Secretary, will help to establish where Mr. Putin is heading.

OUT-SOURCING BIG BROTHER

You tell me if I'm just being paranoid.

An Arkansas company with ties to Mochtar Riady, the billionaire Indonesian and Chinese intelligence agent, has amassed 135 million consumer telephone numbers—including about 20 million unlisted numbers—to help identify and profile people who call toll-free lines to shop or make an inquiry.

The company is called Acxiom Corporation of Conway, Arkansas. It is partnered with a company called Alltel, previously called Systematics.

Alltel, as I mentioned, was the former name of Systematics and the partner to Acxiom. Alltel was the incarnation of the company that provided the software for the White House's "Big Brother" data-base system, and Systematics was the incarnation of the company when it was behind the Administration's plan to develop the secret computer "Clipper" chip to bug every phone, fax and e-mail transmission in America.

Well, darn, if the Rose Law Firm connection doesn't still exist with the company under a new name.

The General Counsel for Acxiom is Catherine L. Hughes, 48, a former public defender and Assistant State Attorney General who worked at Rose from 1983 through 1988.

Hughes describes herself as something of a civil libertarian, but her company is a walking, talking, 3,000-man, privacy-invading monster—if ever I have seen one.

When someone makes a toll-free call to a client of Acxiom, a telemarketing agent can learn who the caller is and where he or she lives, even before answering the call. The agent can also find out the kind of home the caller lives in, the type of cars the owners drive and whether they exercise or own a cat.

This is the kind of thing Acxiom brags about. What the company is more reticent to share with the public is its means of gathering such data.

Acxiom executives will not say exactly how they had gathered the 20 million unlisted numbers in their database, which, they claim, represents about half of all unlisted numbers in the United States. They are quick to point out there is nothing illegal in gathering such information.

Currently, Acxiom is on an acquisition frenzy—buying up every database company you can imagine, in the United States and abroad.

Acxiom officials point out with pride that **telephone numbers, even those which individuals pay to keep unlisted, are fast becoming consumer tags, akin to Social Security Numbers.** Isn't that exciting news, consumer?

If privacy concerns aren't enough to worry you with regard to Acxiom, think about this.

Systematics is a name wrapped up in so many Clinton scandals it would make your head spin. The company, for instance, obtained clearance to accompany Ron Brown on foreign trade trips.

In 1996, according to records from the Federal Election Commission, William Cravens, an old Clinton pal, contributed to both Republican and Democrat campaigns. In late May 1996, Cravens wrote a check to a Republican candidate for Congress using Alltel, the renamed Systematics, as his employer. Three days later, Cravens, the former CEO of Systematics, wrote a second check for a Democratic senatorial candidate, this time listing his employer as "Entergy Corp".

Have you ever seen a company with so many aliases?

The connections to Entergy Corporation again lead back to Indonesia and Mochtar Riady. In 1994, Ron Brown took a delegation of U.S. businesses to China. Among the businesses allowed to fly with the Commerce Secretary was Entergy, a U.S. utility company that did business in Louisiana, Arkansas, Mississippi and Texas. Entergy later signed a \$2 billion-dollar deal with the Chinese government and the North China Power Group to build a 1,200-megawatt power plant in Datong, China.

The Entergy deal was also worth hundreds of millions of dollars to Entergy's partner, Riady. In fact, the North China Power Group renamed the entire project the "Lippo Entergy Datong Power Plant", giving top billing to the largest investor and financier from Indonesia.

But wait. This story gets even more bizarre. In January of last year, I told you how an Arkansas medical examiner had once again concluded "suicide" in a case where common sense might determine otherwise.

On Nov. 17, 1998, Charles Wilbourne Miller, 63, was found dead of a gunshot wound to the head in a shallow pit about 300 yards from his ranch house near Little Rock.

Police found a .410 gauge shotgun near Miller's body and a Ruger .357-caliber revolver submerged in water. Investigators concluded the Ruger was the weapon used by Miller to kill himself.

Yet, two rounds in the handgun's cylinder had been spent.

Only in Arkansas, I noted, does a suicide victim use two shots—not to mention two weapons—to kill himself.

Worse yet, Miller was no ordinary citizen of Arkansas. He had long served as Executive Vice President and member of the Board of Directors for a company called—are you ready?—Alltel. Only recently have Arkansas officials investigating Miller's death decided—whoops!—maybe it wasn't a suicide after all, just as I had deduced from 2,000 miles away reading news accounts. It's now being investigated as a homicide.

Now stay with me. I know this is complicated. But it's important. Don't let your eyes glaze over. This is necessary background to understanding the nature of the "private" company that has all this information on you.

Alltel, as I mentioned, was the former name of Systematics and the predecessor to Acxiom. Alltel was the incarnation of the company that provided the software for the White House's "Big Brother" data-base system, and Systematics was the incarnation of the company when it was behind the Administration's plan to develop the secret computer "Clipper" chip to bug every phone, fax and e-mail transmission in America.

There has been at least one other high-profile "suicide" among the inner circle involved with the "Clipper" chip project—Foster, who, we now know attended critical NSA planning meetings on the Clipper-chip project, along with then-Associate Attorney General Hubbell, Attorney General Janet Reno and then-White House Counsel Bernard Nussbaum.

It was Stephens' effort to get Systematics the job of handling the data processing for the Washington, D.C. First American Bank that led to the BCCI takeover of the institution. Hillary Clinton and Foster represented Systematics in that endeavor. Later Foster became an overseer of NSA's relationship with Systematics. And later still, he got dead. No matter what Independent Counsel Kenneth Starr says, his death has never been explained adequately as a suicide.

Foster's deep connections to the Whitewater scandal, the Travelgate scandal, the Filegate scandal and this spying scandal have never been examined by any of the official probes into his death.

How big and how sensitive was the Clipper-chip project? According to a 1996 report to Vice President Al Gore by former CIA Director John Deutch, Reno proposed an all-out federal takeover of the computer industry. The Justice Department proposed legislation that would ban the import and domestic manufacture, sale or distribution of encryption that did not have key recovery.

Prime targets for monitoring would be foreign governments, banks, corporations and individuals opposing the Clinton Administration. The keys were to be held by "key recovery agents" licensed by the

Commerce Department. Key recovery is a government back-door system designed to secretly monitor computers.

Now, I know what some of you are going to say: "Conspiracy theorist." Well, la-di-da. I haven't woven any conspiracy theories, folks. All I've given you here are the facts—facts that have been conveniently ignored by every other news agency in the world.

What does it mean? I'm not certain. But I hope you find it as interesting—and frightening—as I do.

Some overriding questions leap to my mind: Did Acxiom or Alltel or Systematics or whatever you want to call it gain access to this overwhelming amount of data on the public through its cozy, some might say "incestuous" relationship with the Clinton Administration? Was this a way of outsourcing the government's Big Brother plans? Was this a way for Clinton pals to receive personal benefit from their public contracts?

Unfortunately, I don't think Janet Reno's Justice Department will be examining that question any time soon.

CDC MISLED CONGRESS ON SPENDING, RECORDS SHOW

Seven years ago, a long-distance runner from New Mexico caught cold, struggled for breath as liquid flooded her lungs, then suddenly died. Her fiancé died five days later, followed by more than two dozen other residents of the American Southwest.

The federal Centers for Disease Control and Prevention [**Definition of control: the ability to start, change and stop a process.**] identified the killer as a previously unknown strain of hantavirus, a mouse-borne disease with a staggering mortality rate. An alarmed Congress responded by giving the CDC up to \$7.5 million a year to fight it.

At least, Congress thought it did.

Instead, apparently without asking Congress, the CDC spent much of the money on other programs that the agency thought needed the funds more, interviews and documents show. One official said the total diverted is almost impossible to trace because of CDC bookkeeping practices, but he estimated the diversions involved several million dollars....

...In the case of hantavirus, records show that once Congress voiced its willingness to fund CDC research, the agency reported year after year that it had spent up to \$7.5 million annually battling the deadly germ.

"If they said \$7.5 million was spent on hantavirus, then they should have spent \$7.5 million on hantavirus," said Mike Myers, who until 16 months ago managed CDC accounts for the House Appropriations Committee. "I would have been outraged."...

... "Funds were used consistently to cover other things," explained William C. Reeves, head of chronic fatigue syndrome research. "That is not a bad way to do things. But you do not lie and hide it."...

[JR: There seems to be too many scientists and researchers at the CDC who feel they are entitled to divert designated congressional funds over to their special research programs. You can bet if the hantavirus or CFS hit New York or L.A. they'd be working overtime on a cure. This is another bloated government agency that needs a mega-dose of humility to cure their arrogance.]

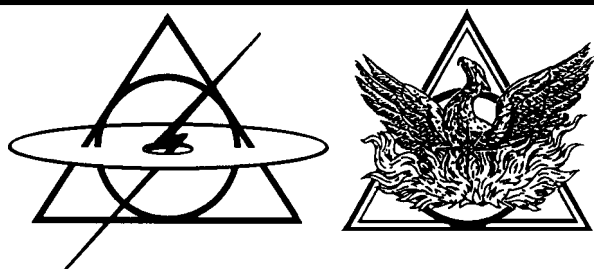
