

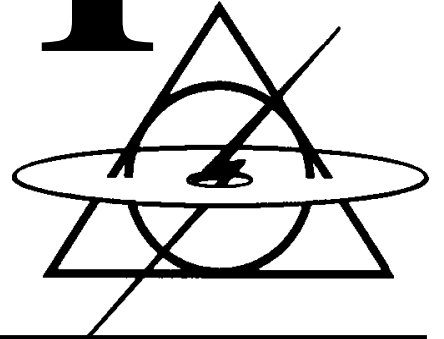

# Children Victimized By Evil “Establishment”

### AND WHERE HAVE YOU BEEN?

**Hatonn**—There is a topic which draws more and more attention while begging to be “front & center”. And yet, I find that there is a fear in even speaking on these topics, for sometimes the crimes which usually are behind such things go very, very high in the order of power players.

and it gives the credit DUE to such good work and interviews as *The SPOTLIGHT* continues to offer, even in the remaining height of attack by the Khazarian Bolshevik Zionists. This is only a fragment upon which to focus and it should be known that the larger porno rings work more basically out of Europe—passing THROUGH North America, with a hub in New York—and on through to some headquarters in Australia, etc.

As long as you continue to elect derelicts to your leadership positions, this is what you will HAVE. If you can't bring morality and Godly ethics back to your Heads of State, you will not clean out your nests.

I would also caution you people who recently read that such as AIDS is not so bad as hyped, etc. It IS WORSE than any hype could possibly present because of the facts of VIRUS MUTATIONS. And, like herpes, HIV can lay dormant or certainly in “remission” of diseases accompanying the virus eruptions.

Can such as “colloidal silver” kill the virus? Yes, IN SOME INSTANCES; however, you must realize that the HIV virus is a strange DNA character—which will not necessarily present as an abnormal body invader which continually thrives off the immune system—so, until it presents AS AN ACTIVE VIRUS, it can't be identified as something to “kill”.

### VIRUSES

What do I think about the other viruses and microbes pushed off onto you the people? I have written so extensively about these things that you must realize that the whole of the infection string of events is in active play and a massive attempt is being made to try for some antidotal protection before the nations are devastated.

So, what do I think of the colloids of precious metals? I think they may well save your lives—however, take notice that you have some things that do need attention, and that is both in processing and selection.

Some of you think that a few drops of, say, silver will do the whole job forever—and the problem is that it WON'T. Remember that colloids are not long-acting, timed-release substances, so they have to be taken frequently, even though large doses are not necessary for either immune-system enhancement or outright attack. There are now mutations of microbes which require a higher frequency than silver for impact. However, the “topical” properties are NOT particularly good.

I would note that quite a few of the more advanced producers of colloids are finding it wise to also offer at least gold and platinum in colloidal form. This is good, but platinum is so frequently used now in other forms of anti-pollution devices and fuel enhancers as to render the product as a colloid to be actually no better in most instances than is gold and certainly not as effective as simple silver.

In a catalytic conversion into colloidal form, especially of gold, there is a process which produces “monatomic gold” as a product. We achieve that in our processing, where it is not achieved in any other manner

of colloidalization processing. Also, there has to be a change in “frequency” radiation to differentiate one structured DNA crystalline viral form from than that of another. This does not mean that you particularly need a “higher” frequency, for some of the newer attackers are extremely low in frequency—it is called natural selection. In fact, you would find that colloidal zinc would be the best wash you could find for your “cold” viruses and some of the flu viruses. I would, in fact, suggest that our chemist offer same to our own people and readers. In fact, a bit of zinc could be introduced into the OxySol basic catalytic programming. Because of the properties already available, you would find this far more effective than zinc lozenges which have become so popular. Then, offer zinc colloid as well. Zinc is one of the most HEALING minerals. Just the addition of the zinc would have knocked out this last major attack epidemic in which almost all of you participated.

Ah, but back to my original topic in focus.

**[H: Please realize this is in response to this recent spate of abductions and does not even touch the ongoing and major point in issue.]**

You know a string of crimes is crying for solution when strange, sometimes grisly tales start proliferating. In Metro Manila and Central Luzon, residents talk of young girls being kidnapped and sold for sex before their body organs are harvested for sale to the ailing rich. So far, four girls have escaped from the kidnappers, but a number of others remain missing. No bodies have turned up yet with missing organs, so the last part of the tale is unverified. But the likelier angle—that the kidnapped girls end up in prostitution dens—is no less worrisome.

Three girls aged 9, 10 and 13 were abducted near their schools in Tarlac City last Jan. 4. The three said they were forced to inhale a drug-soaked piece of cloth that put two of them to sleep. The third said she held her breath and pretended to fall asleep. She was awake when a fourth girl in high school uniform was abducted in San Fernando, Pampanga. They were brought to an abandoned warehouse in Balintawak, Quezon City where the first three victims managed to escape. Last Jan. 22, an 18-year-old college student was also abducted in Tarlac after paying her telephone bill. She said she managed to escape when the kidnappers pulled their van over to relieve themselves, again in Balintawak. Other girls have been reported kidnapped in Makati. **[H: I would note that in Makati episodes, there is a major trade-game taking place, since Makati is the high-rent business center where first the bargaining is as in “ransom”. If enough ransom is collected, the other part of the bargain is to not report the kidnapping or the child will be taken again! Therefore, the crimes are rarely timely reported and this last holiday season was terrible and almost none of the children were recovered.]**

When reports of the abductions came out a few weeks ago, police said the girls could have simply eloped or left home. The reports finally merited some serious investigation after the Senate stepped in and some of the girls who managed to escape related their experiences. Investigators believe the similar stories point to only one group that is likely involved in a White-slavery operation. One girl said there were other victims in the kidnappers' vehicle when she escaped.

Those who escaped have provided the police with descriptions of some of the kidnappers. Until the suspects are found, police and local government officials can coordinate with school authorities and parents to protect potential victims. Meanwhile, every lead must be pursued to get the kidnappers and rescue their victims.

The following article refers to a “Larry King”. This is NOT the Larry King of talk-show fame. The King to which reference is made here is actually a Black man who was prominent in the Republican Party and GOP circles.

DARK SECRETS OF NEBRASKA'S SEX-  
DRUGS-CORRUPTION SCANDAL TIED TO  
GOP-CIA-IRAN-CONTRA AFFAIR

**[H: That topic headline should catch your attention—yes, indeed, it certainly catches OURS!]**

V: The Franklin affair should be national news, but it isn't. However, there are also some new developments in the amazing case that you've been involved with in Nebraska and which you've described in detail in your book, *The Franklin Cover-Up*.

DC: I'm representing a young man named Paul Bonacci and he has filed a lawsuit against one of the principal figures involved in this case: Larry King (not to be confused with the talk show host of the same name).

King was a prominent Black Republican who sang the national anthem at the opening of the 1984 and 1988 GOP National Conventions and who is now in federal prison in Florence, Colorado. He entered a guilty plea on charges relating to embezzlement of \$40 million in funds that disappeared from the Franklin Savings and Loan in Omaha.

Note, though, that he was not charged or convicted on charges from what is the real story behind the Franklin affair, which involves child abuse and pornography and the use of children as drug couriers. My client, Paul Bonacci, was one of those children who was abused by King and his associates.

In any case, we had a trial last year on behalf of Paul Bonacci and we were before a federal judge who had criticized us along the way and didn't believe what we said. However, now the judge finally believed what young Paul had to say about the sexual abuse that he suffered at the hands of Larry King and his associates and the judge awarded Paul \$1,000,000.

V: It's interesting that the major media in Nebraska and throughout the United States did not report anything about the allegations against Larry King and the allegations by Paul Bonacci and others that there were some other prominent people who were involved in this scandal, both in Omaha and in Washington, D.C.

DC: That's correct. When the story was going in the direction that the people involved in the scandal (who were close to the major media in Omaha) wanted, there were some front-page reports that reflected badly on my clients and me. But when the story went against them, the front-page stories disappeared.

After that decision against Larry King in the Bonacci case, King appealed and he was given the benefit of the doubt again and again and he was

getting everything he wanted as the appeal progressed. But suddenly, just after he was about to get the case handed down for retrial, he said that he wanted to drop everything and simply stipulate that the judgment was there and he wouldn't ask anything more.

My best guess is that some of those folks involved with King at the higher levels don't want King's case re-opened in any way under any circumstances and they got the message to him: "If you want to live, you don't want to reopen this can of worms, you understand?"

That's interesting in light of another development. There was a little girl, Alisha Owens, who was sentenced to 15 years in prison on perjury charges for telling some of the things about the sexual abuse, etc., involving Larry King and his associates, and has now been granted permission to have a hearing.

At that hearing there may be some evidence that the woman attorney who was representing Miss Owens at the time was, in fact, in bed—and I do mean in bed—with the FBI official who was in charge of the investigation surrounding the allegations about King and his associates.

I think this will be coming out and a separate judge has been appointed to the Owens case. It will be interesting to see what happens before this hearing is held on its scheduled date of Feb. 7—since I don't think they want that case reopened under any circumstances. This lady attorney has been in hiding and she has been subpoenaed to come to the hearing. But none of this has been reported in the major media. Not a single word.

You would think something this major would be reported by *The Omaha World-Herald*. When I was in the State Senate that newspaper was my strongest supporter, but since so many of that newspaper's close associates were mixed up in the Franklin affair and some of them went to prison, *The Omaha World-Herald* hasn't been too friendly to me.

V: Who is representing Alisha Owen now?

DC: A court-appointed attorney named Fogarty. I have provided him a wealth of information for his use.

V: The Franklin case is a major case with national ramifications but 99 percent of the American people have never heard about it.

DC: It goes beyond the sexual abuse of children. It goes to the very heart of our political system. It involves the use of children as drug couriers. It involves the use of children to sexually compromise politicians with that inclination. It involves the use of millions of dollars being covertly laundered for use as campaign money for politicians.

In my book I talked about an associate of Larry King's named Rusty Nelson. He was a photographer who the FBI effectively denied even existed and who the Police Chief of Omaha, who was connected to the affairs surrounding King, said had been investigated and that he, Nelson, had no relationship at all with King. They said the photographer couldn't even be found anywhere. In fact, what had happened was that the FBI had told Nelson to just disappear.

Well, I finally located this photographer, Nelson, in a prison in Oregon and he was being held on pornography-related charges. I managed in February 1999 to get Nelson out of that prison and back here to testify before the judge in the Paul Bonacci lawsuit

against Larry King.

Nelson testified that he had been the private photographer for King and he explained how King had a \$5,000-a-month rental mansion on Embassy Row in Washington, D.C., where he would hold incredible parties with top-level people. Then there were "after parties", as the children described them, and Nelson confirmed that various politicians with a desire for a young boy or a young girl would have their dreams fulfilled. Although, these politicians didn't know that they were being compromised by having their pictures taken by Rusty Nelson through two-way mirrors.

V: Your client, Paul Bonacci, and this girl Alisha Owen were among those children who were used in this fashion.

DC: That's right. I was also able to get Noreen Gosch of Des Moines, Iowa to testify on Bonacci's behalf. She was the mother of a newspaper boy named Johnny Gosch who disappeared many years ago. It was quite a controversy in Des Moines.

In the course of the Bonacci case, Bonacci put us onto information that we followed up and established that Bonacci himself had participated in the kidnapping of Johnny Gosch. As a result of Bonacci's information, Mrs. Gosch was put in contact with her missing son (long presumed dead).

Unfortunately, and tragically, Mrs. Gosch's son—like a lot of other young people who've gotten enmeshed in this lifestyle that he was kidnapped and forced into—has suffered and committed some of the very crimes that were committed against him, and he has never come back into his family's life.

V: That's a very tragic story. These children have been kidnapped at a very young age and they are plied with drugs and effectively brainwashed and used sexually and otherwise by people such as Larry King.

DC: I know this sounds bizarre. I realize that. When this story first started breaking and I got involved as an attorney, I thought this was a bunch of wild nonsense. I was no longer a State Senator at the time, but, instead, was an attorney representing one of the Nebraska State Senators who was involved in the investigation. The investigation had started out with allegations of financial misdeeds at Franklin Savings & Loan, but then the sex and drug allegations started to come out.

I was the first person to stand up and say that it had to be unmitigated nonsense. But I also said that if I ever found that any of it was true that I would be the first to step up and do something about this and try to help these children.

As fate would have it, this young man, Paul Bonacci, wrote me a letter from jail and asked me to come to see him. I went to see him and he had diaries going back to the time he was very young and they were detailed, and I started checking things out and realized that this boy was not making up things.

V: But Paul Bonacci had been put in jail and accused of making up these things?

BC: That's right. So I got involved very deeply and eventually brought in my longtime friend, former CIA Director William Colby (who had been fired and replaced by George Bush). It was Colby who prompted me to write the book *The Franklin Cover-Up*. Colby told me the best life-insurance policy I would have would be to write the book. **[H: Note**

**that this is a part of the reason for the more recent MURDER of Mr. Colby.]**

V: In fact, the private detective the State Senate hired was killed under mysterious circumstances.

DC: Actually, there were at least a dozen people who were killed who had some information on this case. Most important among them was the investigator Gary Caradori, who (we now know) met with Rusty Nelson, the photographer the night before Caradori was killed. Nelson provided Caradori with pictures and other documents that verified the stories surrounding the Franklin affair and identified certain individuals.

Caradori was going to fly back to Nebraska from Chicago and within a few minutes his private plane went into pieces up in the air just outside Chicago. Of course, Caradori was coming back to testify to the Senate committee about what he had uncovered. Caradori had called the head of the Senate committee at about 10 o'clock the night before he was killed and told him: "We've got them now. I've got the proof. They can't get out of it now. I'll be there in the morning to testify at 8 a.m."

V: As an attorney in the case, you've seen some of the photographs and tapes that Rusty Nelson had. But you are not allowed to talk about what (or who) you've seen.

DC: I've tried to tell everything that I can tell. As you know, in my book, I show how [sic: "discuss"] the once-revered institution known as Boys' Town, which is perhaps America's most famous protection place for boys, founded by a wonderful man named Father Flanagan. They made a movie about it starring Spencer Tracy. Unfortunately, Boys' Town became a "harvesting" place for Larry King and others to draw children out of there for their own use.

V: It's conceivable that there might have been some information on some top Republicans who may have been compromised by Larry King (who was active in GOP affairs) and this information might have been used to keep those Republicans from making an all-out effort against Bill Clinton. There are many who believe that the Republicans actually pulled their punches during the impeachment and trial of the President.

There have been rumors and allegations that President George Bush was linked to Larry King and the Franklin affair through apparent laundering of stolen Franklin money for the CIA's Iran-Contra operations.

In addition, there have been some of the kids who were victims of Larry King who reported that Bush was at some of King's parties in Washington.

Is it possible that Bush's son, who is now running for president, has any knowledge of the Franklin affair and the allegations involving his father?

DC: I don't know. I was very, very super-cautious in this book not to speculate on anything that I didn't have some pretty clear documentation and proof for. What "Baby Bush" did know or does not know, I do not know.

I do know that I am very personally skeptical of supporting "Baby Bush" and I was a delegate for his father, George Bush, at the Republican National Convention 1988 and was pledged to him. Had I to do it over again, knowing what I know today, I definitely would not.

## GREENSPAN REPORTEDLY BRIBES & AIDS BUSH IN GOLD SWINDLES (PART 1)

More than three hundred reportedly authentic secret Federal Reserve wire-transfer records show how the Chairman of America's private central bank has apparently bribed and aided in corrupt deeds, George Herbert Walker Bush and his family, all over a period of time. Later, Greenspan reportedly—jointly with Bush and a swarm of major financial entities—derived a horrific benefit in a major gold swindle.

In clandestine meetings, over a period of months, the reportedly genuine documents were turned over to our research and investigation group by government officials clearly in an inside position to possess and confirm such data.

A conversation at one such meeting, "Tell Sherman, if you or he ever reveals our identity, we are all dead, everyone of us. Also in jeopardy of life and limb would be more than eight others in key government and financial positions." Some of the records purport to have the wire-transfer signature of "A. Greenspan", whose term as Commissar of the Federal Reserve was renewed in the new century. Because he is like a corrupt Soviet dictator, answerable to no one, we coined the term, "Alan Redspan".

The document delivery team was assured of confidentiality by our past record. As the founder/Chairman of our group, Citizen's Committee to Clean Up the Courts, since 1963, I have been imprisoned some eight times in four decades, not for committing crimes, but for so-called "contempt of court", for refusing to reveal the identity of long-reliable sources of high-level corruption data turned over to us on the sly. Our sources, cross-checked with others and backed up by over one million documents already in our possession have enabled us, over a period of decades, to set off what some describe as the biggest judicial bribery scandals in U.S. history.

Briefly stated, this includes the downfall we caused in 1969, of Illinois' highest tribunal, the Illinois Supreme Court, with half the high court being put to the wall. In the 1970s, our work led to the jailing for bribery of the highest-level sitting federal judge in U.S.

history, a federal appeals judge in Chicago who had also been former State Governor and his aide, former head of the Illinois Department of Revenue, the tax collectors. 7<sup>th</sup> Circuit Federal Appeals Judge Otto Kerner, Jr. went on all the media and said, "Skolnick is a liar." Kerner died an ex-convict, convicted as I accused him to his face, as is our long-time policy. From 1983 to 1993, our work set off a series of scandals, by which 20 local judges and 40 lawyers were sent to prison for bribery, including the Chief Judge of the Traffic Court, who in a taped interview said, "Mr. Skolnick, you are imagining things, there is no corruption in this courthouse."

The Federal Reserve wire-transfer data, which is also corroborated by matters already in our possession, among other things, confirms the following:

1. That George Herbert Walker Bush, starting back at the time he was Vice President and continuing long thereafter, reportedly corruptly benefited from billions and billions of dollars transferred at the behest, of among others, Alan Greenspan, to private corporations worldwide, in which the Elder Bush apparently has a beneficial interest, and/or is a major stock or bond holder, and/or is a kingpin therein, in other capacities. Included are enterprises in Saudi Arabia, North Korea, Hong Kong, Denmark, England, Red China, Taiwan, Japan, and Germany, among others. Some of the purported secret wire transfers of massive amounts were jointly for the Elder Bush and his brother Prescott, a financial broker in New England. According to published accounts, Prescott Bush arranged vast, unsavory deals with the Japanese mafia, the Yakuza, as well as dictator-types in Red China, including reportedly with the top officials of the Red Chinese Secret Police (who also operate greatly in North America).

2. Holding, as well, a large beneficial interest and/or as major stock or bond holder in those accounts has been Jackson Stephens, the Little Rock-based bond broker—largest such operation outside of Wall Street. Stephens—tied reportedly to the ethnic Chinese gangsters like the Riady family interwoven with Clinton and Ollie North and the dope traffic—has been a major backer of Sludge Willie. **[H: I believe for the ones who are not regular readers, this is probably "Slick Willie", a common nickname for Bill Clinton.]** The nefarious worldwide reputed corrupt deals of the Stephens family have been covered up by Alan Redspan and what some call the highly secretive, conspiratorial Federal Reserve.

3. Some of the firms and enterprises to which the massive wire-transfer assets were sent, are reportedly CIA proprietary operations set up by Bush as the head and former head of America's secret political police. (Now a Chicago-based bankruptcy expert, William A. Brandt, Jr. has been a worldwide expert in quietly terminating CIA proprietaries once their espionage function is completed, as shown by documents released under the *Freedom of Information Act* by the U.S. Justice Department. Brandt's activities overlapped those of the Elder Bush.)

4. Some of the billions and billions of dollars of reputed wire transfers went for the beneficial interest of the Elder Bush and his son Neil, an official of a CIA proprietary, disguised as Denver-based Silverado Savings & Loan Association. The S & L went under and Neil Bush should have been sent to prison for causing the downfall by reportedly misusing large

amounts of federally insured thrift agency funds. On the other hand, as accused in stories in the press in Spain, the Elder Bush and his sons George W. Bush (Texas Governor) and Jeb Bush (Florida Governor) and Jeb's wife, a native of Colombia, are reportedly incriminated through huge money laundering of dope proceeds through banks owned by criminals in Spain. Dope proceeds reportedly from Colombia, Morocco, Portugal and Italy. We publicized the quiet arrest in Chicago in January 2000, of the reputed Bush family cocaine bank-money-laundry wizard, Giorgio Pelossi, a prominent Swiss accountant. The Elder Bush has been with the CIA since at least 1959, when he helped set up Zapata Petroleum Co., later called Zapata Offshore, with upwards of 600 branches worldwide in international hotspots for the reported purpose of gathering intelligence for the spy agency. Some news sources have contended that Zapata's offshore drilling rigs, located beyond the U.S. jurisdiction limit, are reported centers for transferring large quantities of illicit drugs and other contraband.

5. Some of the reportedly huge secret wire transfers were for, or with the Elder Bush jointly with the Queen of England, through her accounts in the British Monarchy's Coutts Bank, London. The secret account numbers are contained in some of the more than 300 apparently authentic Federal Reserve wire-transfer records. The British Monarchy has long been accused as being worldwide kingpins in the narcotics traffic, going back 150 years starting with the Opium Wars in China.

6. Others of the more than 300 documents relate to a situation started in the 1970s, when the Elder Bush arranged to overthrow the Iraqi government by political assassination. Bush helped install Saddam Hussein. Others of those and other documents relate to the decade, 1980 to 1990, when the Elder Bush was a secret, private business partner of Saddam Hussein in extorting billions of dollars per year from the weak sheikdoms in the Persian Gulf—oil industry kick-backs to supposedly assure security. A little-known Federal lawsuit in Chicago dealt with the secret partner of Saddam Hussein, namely George Herbert Walker Bush. I and my associates were the only journalists attending the federal appeals court hearing. I later did an exclusive group of interviews with the participants, confirming that Bush and Saddam were private business partners in extortion of the sheikdoms. Only one populist paper dared publish the details in 1991 of my interviews on the federal case.

In a typical sort of falling out of business partners, Bush suckered Saddam Hussein into seizing a portion of Kuwait long challenged by Saddam as being a Iraqi province and part of Saddam's oilfields. Bush used a top U.S. official to mislead Saddam into thinking the U.S. would not intervene in this local quarrel with the former British colony. Bush was the one, on behalf of U.S. oil-drilling interests, that helped develop the Kuwaiti oilfields, following the 1961 relinquishing of British sovereignty. In its simplest form, the 1990-91 Persian Gulf War was a falling out of private business partners.

The result of this treachery? Great loss of life of ordinary soldiers. Upwards of 150 thousand young Iraqis died in the conflict—some buried alive by U.S. war bulldozers. President Bush ordered U.S. warplanes to shoot in the back, the retreating Iraqi soldiers

proceeding under a white flag of surrender. It was the most horrendous murder of surrendering troops in world history. The German massacre of some 80 U.S. troops surrendering in World War II during the Battle of the Bulge was a small matter by comparison. (Our public-access Cable TV Program in 1991 was about the only TV Show in America that dared discuss this matter.)

Following the Persian Gulf War, some 15,000 U.S. troops died from the mysterious malady called Gulf War Syndrome (GWS), which the Pentagon denies is happening. Ex-GIs continue to die from the strange ailments, and the total deaths and debilitating diseases amount to more than 20 percent as casualties of all the Americans serving in the military in the Persian Gulf in 1990-91—more than 100 thousand American soldiers as casualties.

Having been apparently massively bribed and aided in corrupt deeds over a period of years, the Elder Bush owed Alan Redspan and others important favors. Bush has been a potentate in one form or another with Canadian Barrick Gold. The Bank of England, jointly with the Queen of England—who reportedly shared accounts with the Elder Bush at Coutts Bank, London, and three or more major financial entities—orchestrated a vicious attack on gold in 1999. Together, they drove down the price of gold to about 252 dollars per ounce—more than 30 dollars per ounce BELOW THE COST OF PRODUCTION of the most efficient gold mines, such as in Canada.

Reportedly helping this unlawful attack on gold, gold mines, and gold mine workers, forbidden by U.S. Anti-Trust Laws, have been the following, among others:

(a) Goldman Sachs, one of the world's largest bond and gold trading houses. Cynics, knowing these facts, call them "Goldman Sucks". Goldman Sachs has been so much into short selling deals of gold that, in the October 1999 gold crisis, they were reportedly considering invoking the contract provision called "*Force Majeure*", used to avoid complying with a contract because of wars, hurricanes, revolutions and such. The Federal Reserve has through various dirty tricks bailed out Goldman Sachs repeatedly.

(b) Bank of America, big in foreign-exchange trading, called ForEx, (long ago called Bank of Italy, in America) they were reportedly part of the "knock down the price of gold" group.

(c) Bank of England, jointly with the Queen of England, offering for auction or sale gold that neither one apparently really owns, but is actually a huge gold hoard stolen upon the downfall of the Soviet regime and whisked away to Dutch custody at a Swiss airport for speedy transport wheresoever requested. Bank of America is owned jointly by the Vatican, the Jesuits and the Rothschilds. Joining them in recent years as major owners, have reportedly been the Japanese mafia, the Yakuza, big in the U.S. dope traffic, and owning most every bank in California.

The purpose of the gold attack was to drive down the price of gold, among other things, to help bail out six hedge funds that have been more than a trillion dollars underwater in derivatives gambling that is asset swaps. The bankrupt hedge funds, when gold is low-priced, can obtain gold loans for as little as one percent interest. Were the hedge funds disaster scenario to be more public, it might set off a meltdown of the financial system of the Western world.

Reportedly at the behest of Bush, Barrick became



part of a complicated trick of forward leasing of gold. A sort of short selling of gold. Thus sold short has been more than ten thousand tons of gold—more than four years of total world gold production. Gold has been called by some, “The Killer Yellow Metal”, for the type of situations it can cause. In February 2000, Barrick, Bush and the anti-gold gang reportedly again sought to stop the precious metal from going up to a more fair market price, such as 600 dollars per ounce.

The disclosures of the reputed secret Federal Reserve wire-transfer records could torpedo the pirate ship of which Alan Redspan is a treasonous Captain—joined by reputed super-crook the Elder Bush and his family and others in their gang. —The Elder Bush sharing proceeds of illicit transactions reportedly including dope trafficking with the Queen of England, through her identified accounts in the British Monarchy-owned Coutts Bank, London. Remember or note if you did not already know: The British Monarchy—directly and through the Jardine Family as their agents and others—have been kingpins in the dope trade since the Opium Wars in China, starting 150 years ago and continuing. Financing it over the years in various forms, reportedly has been the enterprise owned jointly by the British Monarchy with remnants of the Chinese Royal family, Hong Kong & Shanghai Bank, merged more recently with the Jacobs Family-owned Marine Midland Bank of Buffalo, New York and Chicago. (More on this later.)

—The Elder Bush, as a U.S. Government official and afterward, to benefit him for having done certain acts and doings as such, taking benefits and bribes reportedly from the Emir of Kuwait, to start a war with Bush's disgruntled PRIVATE BUSINESS PARTNER, Saddam Hussein, Iraqi strongman. Details of Bush as such partner for the decade 1980-1990 were part of the secret records fought over a Chicago branch of Italy's

largest bank, Banca Nazionale Delavoro—owned in part by the Pope. It was a subject of an unpublicized federal suit in Chicago. Bush/Saddam extorted hundreds of billions of dollars from the weak oil sheikdoms of the Persian Gulf for “protection”, same as Mafia gangsters shaking someone down. I and my associates WERE THE ONLY JOURNALISTS attending the hearing in the federal appeals court. After which I interviewed the participants (May 1991), detailing the same on *Radio Free America*, hosted by long-time broadcaster and journalist Tom Valentine. A transcript appeared several times in the populist newspaper *The Spotlight*. Zero for the rest of the press, whom I call the newsmakers.

Saddam Hussein was suckered by Bush using a top U.S. official, telling Saddam it was purely a local matter of no interest to the U.S., for Iraq to seize a portion of Kuwait long-claimed by Saddam as an Iraqi province and oilfield. For sending U.S. soldiers in harm’s way and having them suffering post-war Persian Gulf War Syndrome, the Emir of Kuwait reportedly bribed Bush. The proceeds went, in part, to and through reputed Bush-identified accounts in Arab Bank Corporation, Monaco. Since 1991, 15,000 U.S. military have died of the strange malady and 85,000 are either in dying condition or suffering horrible debilities. In addition, Bush reportedly received from the Emir \$15 million in gold. This is all forbidden by the U.S. Constitution, Article I, Section 9: “No title of Nobility shall be granted by the United States; And no Person holding any Office of Profit or Trust under them, shall, without the consent of the Congress, accept of any present, Emolument, Office, of Title, of any kind whatever, FROM ANY KING, PRINCE, OR FOREIGN STATE.” (Emphasis added.) What Bush did is also in violation of federal statute, as noted by the Senior Treasury official in his hand-written notations.

—The Queen of England and her control of British Counter-Intelligence, called MI-6, bribed and benefited Bush to arrange for MI-6 to spy and coerce U.S. citizens in the United States and to destabilize such persons, particularly the large Irish-Catholic populations of places like Chicago. (Chicago has a considerable number of Irish Catholics who sympathize with the anti-British royalty, anti-British, IRA.)

Further, Bush was bribed and benefited to induce him to pursue a course detrimental to the United States. Bush’s reputed pirate operation, Pilgrim Investments, received many billions of dollars through the Queen’s accounts at her Coutts Bank, London. Bush’s reputed firm is linked to the Pilgrim Society, an offshoot of the Cecil Rhodes Trust, formed from the South African gold and diamond mine cartel. The Rhodes Trust is pledged to the treasonous purpose of overthrowing the U.S. government and restoring British domination over the American continent by returning it to the status of puppet colonies. The Rhodes Trust takes the position that those of Irish and German descent, many Americans, are sub-human and are not entitled to occupy this land and have a government called by them the “United States of America”.

Great Britain has vowed to take back this Continent since at least the War of 1812 and for that purpose has arranged the political assassination of two anti-British U.S. Presidents: President James Garfield and President William McKinley.

William Rockefeller Clinton (that is what I call him for good reason mentioned elsewhere) as a student attended Oxford on behalf of the Cecil Rhodes Trust and took a pledge to support the same, which calls for the collapse and overthrow of the U.S. Government. Twice inaugurated as

President, Clinton took an oath to support the U.S. Constitution. How is this contradiction resolved? (U.S. Constitution, Article 2, Section 1.)

As shown by the reportedly authentic Federal Reserve Bank wire-transfer records, hundreds of millions of dollars were sent through the Rockefeller’s Chase Manhattan Bank to Marine Midland Bank of Buffalo, New York, to credit Bush’s reputed accounts [with] Pilgrim Investments, Inc. The Jacobs Family of Buffalo owns Marine Midland Bank. They also own Emprise Corp., a reputed mobster international enterprise dominating the food and beverage and other concessions of many sports stadia and racetracks in the U.S. and elsewhere. Later, because of the smelly links becoming public, the name was changed to Sportsystems, Inc. By the way, they reportedly made Buffalo-resident O.J. Simpson into a sports celebrity. (The Norby Walters case, 1988-89, in Chicago’s Federal District Court dealt with sports celebrities having many times used Mafia sports agents, without which they would go nowhere. O.J.’s Buffalo business partner, in the major cocaine traffic, was murdered during O.J.’s first trial in 1995, according to a major Buffalo newspaper.)

Emprise Corp., in turn, has been a major stockholder of Chicago-based Bally Manufacturing Company—that has been the largest manufacturer of pinball and slot machines used in gambling casinos, too often under criminal domination. Published accounts link Emprise to *La Cosa Nostra* families in at least two cities. In 1976, well-known Arizona reporter Don Bolles was investigating Emprise and intended to write about them. He was murdered in a car bombing—his last words included the word “Emprise”.

The reported mobster details of the Jacobs Family and their Emprise Corporation and Sportsystems are in a long series of press reports, such as: *Chicago Sun-Times*, 9/16/71, 11/28/72, 5/15/72, 1/16/72; *Chicago Daily News* (now defunct) 4/28/72. In their issue of 4/24/72 it was said, after describing them as a mob-linked concession company, “The company, Emprise Corp., of Buffalo, N.Y., has made millions of dollars in loans available to major-league baseball teams, race tracks and other sports enterprises. In return, Emprise usually has received ironclad contracts—sometimes running more than 30 years—to provide food and beverages at sports events.” Also, *Chicago Tribune* 3/4/75.

The Jacobs Family runs the dog-racing tracks in Arkansas, popular there and has contributed heavily to the “campaigns” of Bush family crony, William Rockefeller Clinton.

So, with his reputed criminal enterprises, the Elder Bush was in safe hands running his game with the help of Alan Redspan, through Marine Midland Bank of Buffalo. In more recent years, the Marine Midland Bank has merged with the British and Chinese royalty-owned, Hong Kong & Shanghai Bank. # MSG—The Deadly Mouth Aphrodisiac

## Editorial comment:

If you're like most of us here at CONTACT, you've heard "something" about Monosodium Glutamate, which is more commonly referred to as MSG. You might have seen a sign outside of an Oriental restaurant, claiming "No MSG" or a similar reference on a food label at the grocery store. Perhaps you can recall when Doris and E.J. were experiencing some health challenges last year and Doris found that simply reducing their MSG intake made a world of difference to how they were feeling—but never really thought much about it beyond that.

The following article shows just how serious a threat MSG poses to our health and documents its introduction in a big way into our food supply starting with decisions made by the large, Khazarian-controlled food companies way back in 1948. Yes, we have come a long way—to the point where almost every processed food product, almost everything that comes in a box or a can, contains a heaping helping of this toxic substance.

## [QUOTING:]

"The worst piece of information I have when I am in the midst of the reaction is that I am going to live. I only want to die. It will not happen... I know I will live through this, and that's torture."

"I come across embarrassingly as if I have brain damage, even though I graduated from a good college, top of my class."

"If I don't make it, I don't eat it. I have to make everything from scratch. I can't eat in restaurants. It's just really pathetic and I'm really depressed."

What do the people who made these comments have in common? What devastating condition could they possibly be referring to? The one factor which makes their lives at times akin to a living hell? The answer is a condition termed "MSG Symptom Complex" by the Federation of American Societies for Experimental Biology (FASEB), an independent body of scientists sponsored by the U.S. government's Food and Drug Administration (FDA) in September 1992 to review all available data bearing on the safety of the food additive Monosodium Glutamate (MSG) and related substances. For a full one-third of the U.S. population (70 to 75 million Americans), consuming this chemical (as well as the close relative Aspartame, also known as "NutraSweet" or "Equal") will result in mild to moderate physiological and emotional reactions. For a small minority of people, accidental ingestion could prove to be severely debilitating and sometimes even life-threatening. What's worse, the *New England Journal of Medicine* and *Science Magazine* have both published articles linking Glutamic Acid and other excitatory amino acids (namely, Aspartic Acid and L-Cysteine) to the development of various neurological diseases.

The FDA-funded FASEB report was in response to a set of laws on the books designed "to protect the public health, to prohibit the use in food of additives that have not been adequately tested to establish their safety". In 1958, the *Code*

of Federal Regulations, Title 21 established a *FOOD ADDITIVES AMENDMENT* that subsequently required that manufacturers show "proof of a reasonable certainty that no harm will result from the proposed use of an additive". This included the *DELANEY CLAUSE*, which demanded a federal ban on any food additive shown to cause cancer when fed to either animals or humans.

At the Fourth Annual NoMSG (National Organization Mobilized to Stop Glutamate) Conference held in Los Angeles in October 1996, members flew in from all over the country to hear lectures by respected doctors, scientists, authors and activists—receiving legislative updates, medical findings, food and nutritional tips and a chance to gain more information on how to cope with MSG sensitivity. The following attendees agreed to share their unique stories with us:

Erik J. of New Jersey has been experiencing symptoms since college. For a period in excess of 24 hours after ingesting MSG, Aspartame or Sulfites, he develops a cloudy head, faded memory, an inability to concentrate and excess nervous energy. It has impacted his life enough to motivate this cross-country journey.

Kaye W. of Montana watched her infant daughter react negatively to MSG-infused baby food back in the 1950s. Her own typical reactions have included stomach aches, swollen abdomen and gums, frequent urination, difficulty in focusing her eyes and extreme "gallbladder pains" that have lasted for up to a week. In addition, her rectal and genital regions become highly irritated and inflamed, complete with hardening of the tissues and vaginal bleeding. After a particularly serious attack from eating an offensive salad dressing, her doctor even suggested performing a colostomy. After eliminating MSG from her diet, the condition resolved itself completely and surgery was cancelled. She happily lost 20 pounds within 2 months from this change in her food intake.

Natalie M. of Los Angeles suffers severe 12-18 hour migraine headaches that don't hit her until 8-10 hours after she has swallowed MSG. At that point, she can't ingest anything and even regurgitates her own saliva. Her ability to function plummets to zero until the reaction abates. It is a self-described nightmare.

Ten years ago, Pat Conway of Palm Springs, California would meet her mother for lunch every Wednesday at the same Chinese restaurant. By the end of the meal each week, like clockwork, she would become clammy and sick, plagued by diarrhea. Progressively over time, the symptoms became worse: chest pains, heart pounding and depression. The doctor diagnosed her condition as "panic attacks" and accused her of being a hypochondriac. Previously affluent and happily married, this "mystery illness" destroyed her relationship. Eventually, she learned that she was acutely sensitive to MSG.

Today, a single bite of food laced with this flavor enhancer will trigger full respiratory arrest for Conway within 30 seconds. At a seafood restaurant, one nibble of shrimp

cocktail (which the waitress had assured her contained no MSG) landed her in the hospital emergency room for 4 hours with a heart rate of 200 beats per minute, followed by severe depression. In another instance, eating a little bag of flavored nuts during an airplane ride resulted in the stewardess having to drop her the oxygen mask. The numerous breathing crises she has endured have caused her to develop asthma. She's moved to a house only two minutes away from the E.R. The paramedics have been summoned to her rescue so many times that she not only knows them by name, but has begun educating them and the hospital staff on this affliction of which most medical professionals are largely ignorant. She feels it just as necessary to inform the general public, especially those employed in the food-service industry. "People who work in restaurants are as much a problem as the problem. Because of my MSG sensitivity, they treat me like a space alien, embarrass me, tell me not to worry. They believe that my allergic response would consist only of a little itching and a few hives."

Los Angeles resident David Livingstone has been taken for a wild ride of his own on the MSG rollercoaster as a result of the food industry's lax attitude toward the problem. In July 1993 during a business lunch, he ordered vegetable soup at a Marie Callender's Restaurant after his waitress represented to him that it was free of Monosodium Glutamate. He had clearly advised her of his health concerns, after which she assured him that the chefs made all the soups from scratch daily. Walking back to his office, he felt the symptoms of an asthma attack coming on. His inhaler did not provide him with the usual relief, so he promptly drove over to his primary care physician, who was a close 5 minutes away. Experiencing intense bowel discomfort, diarrhea and profuse perspiration, it was there that he passed out and went into massive anaphylactic shock (a chemically-induced poisoning of the system), which triggered severe respiratory arrest. Apparently, the MSG had triggered a response for his lungs to shut down. His doctor began applying CPR, which was then taken over by the paramedics who arrived to transport him to the hospital by ambulance. Once there, he went into full cardiac arrest and lost his pulse for 7 minutes. More CPR was administered, during which time some ribs were cracked. After being worked on for an hour, David was finally resuscitated and stabilized. For the next 3 days, he was unconscious on a respirator in the Intensive Care Unit, then remained another 3 days in the hospital for observation and treatment. An MRI determined that there was some deadening of the grey matter of his brain due to Hypoxia (lack of blood flow to deliver oxygen). He still remains with a slight neurological deficit.

Back on his feet and more than a bit perturbed, this less-than-satisfied customer returned to the same restaurant to do a bit of investigation. Inquiring about the exact recipe of the vegetable soup, he discovered that it actually contained "beef base", a pasty, tar-like material on whose label MSG was clearly listed as an ingredient. Because soup is hot and liquid, the glutamate it contains is absorbed very quickly into the human system and causes a more severe, immediate reaction. Because he claims his "near-death experience" was a direct result of Marie Callender's providing him with wrong information, David Livingstone initiated in June 1994 a Products Liability and Misrepresentation Lawsuit against the company. Intending to protect other consumers as well as himself, he states: "Restaurants need to be more proactive in providing information about their food's internal ingredients to sensitive individuals, especially those that ask." The case is set for trial in June 1997 in the Glendale Superior Court.

Restaurants making false allegations about their use of MSG may just be more the rule than the exception. Jack



Samuels, who founded the Illinois-based TRUTH IN LABELING CAMPAIGN with his wife Adrienne (both are MSG-sensitive), recounts the tale of an ABC news station in San Diego that investigated 10 different Oriental restaurants, each claiming they didn't use any MSG. After a laboratory tested food purchased from each venue, the chemical was indicated to be present in all samples. A similar venture pursued by a New York station uncovered an equivalent amount of fraudulent claims by that city's eateries.

David Livingston and ABC are not alone in their pursuit of honesty and integrity in the culinary MSG minefield: In 1988, a Pasadena, California District Attorney successfully sued Union Foods for mislabeling their Golden Ramen soup as containing "NO MSG", when, in fact, it did. Under Section 403 of the *Federal Food, Drug, and Cosmetic Act*, the FDA has acknowledged that such a practice would be considered deceptive mislabeling of a product. A *California Civil Code* also permits such a lawsuit if a company makes untrue representations. The Japanese-owned company agreed to pay a \$153,000 fine and recall 455,000 cases of the soup.

In December 1994, a Citizen Petition was filed by the TRUTH IN LABELING CAMPAIGN (in conjunction with 29 independent citizens, including 10 physicians) requesting the FDA take specific action. It asked that all processed foods be tested for the presence of glutamates and, if present, that MSG be identified and its amount listed in grams on the label. It's estimated that the total investment in these testing and relabeling procedures would fall around \$3 billion, resulting in a price increase of only one quarter cent per product. When the FDA failed to respond within the prescribed 180 days, lawyers for the petitioners filed suit in Federal Court in August 1995. As the FDA first attempted to have the Court dismiss the Complaint, then was withholding important documents and evidence in their possession, the trial date has been continually postponed, but is scheduled for sometime this year.

### HOLD THE MSG!

If all this uproar over a simple seasoning has taken you by surprise, then pull out your chopsticks and get ready to burst a well-established bubble, for the "Chinese Restaurant Syndrome" has gone international. If you thought the only place you had to exclaim "Hold the MSG!" while ordering a meal was at your local chow mein eatery or egg roll takeout joint, read on. Its presence has spread like a virus, in epidemic proportions, into almost everything we eat (at least anything that's "convenient"), and we've all been fooled. This article is to shed light on the deleterious effects of Monosodium Glutamate, a dangerous "excitotoxin" which is currently used in some form in almost every single processed, pre-cooked, and pre-packaged food manufactured today, whether frozen, canned, boxed or dried. Not always detectable by examining the product label, it may be hidden under any one of a number of seemingly innocuous, even wholesome and healthy-sounding ingredients. So buyer beware, as it may not always be—where you expect to find it.

### A WOLF IN SHEEP'S CLOTHING

If ever there was a wolf in sheep's clothing, this is it. Until recently, the wool had been pulled securely over the eyes of even this health food advocate, and I was adamant to reverse the damage now that my blindfold had been lifted. I had just finished devouring two incredible books on the subject, and this powerful new knowledge inspired the activist in me to take my first action. Armed with a bag of product "rejects" in one hand and a list of food additives in the other,

I ventured into the grocery store and sniffed out the customer service desk, determined to take advantage of the company's "satisfaction guaranteed or your money back" policy. (Many supermarkets and health food stores have such policies in place, even if the products have been opened or used.) I knew it would be the first time that a customer returned items because they contained not just MSG, but "hydrolyzed vegetable protein", "natural flavorings", "corn syrup", "barley malt" or "calcium caseinate", so I came prepared—documentation close at hand—to explain the whole story should any argument ensue. Surprisingly, the manager quickly and cheerfully refunded my money, casually commenting, "So you're allergic to MSG, huh?"

### COBRA IN A BASKET

Allergic? Tip of the iceberg, I thought. Try brain cell destruction; try Alzheimer's Disease; try neurodegenerative ailments. If he only knew the extent to which I yearned to spew two volumes worth of statistics, scientific data and case studies at him like so many cognitive bricks, shattering an ignorance that permeates the food industry and consumers alike. Because although approximately one-third of all Americans are sensitive to MSG consumption—reacting with symptoms running the gamut from fatigue, headaches, nausea and diarrhea to heart irregularities, asthma attacks and depression—the down-and-dirty bottom line of this excitotoxin's detrimental effects on the human organism is devastatingly simple: Consumed over a long period of time in great enough quantities, Monosodium Glutamate poses a serious threat to one's physical, mental and emotional wellbeing. Like a cobra curled up in a basket, this toxic substance has insidiously slithered its way into the cuisine of an entire generation and waits, coiled and silent, ready to pounce on even the most unsuspecting victim. Its venom, its poison accumulates invisibly—a predator that may strike now or later, sparing some fortunate individuals, striking others without warning. So, Mr. Grocery Store Manager, NO, I'm not allergic to MSG in the classic sense (as far as I know, although I don't keep track of every headache or bout of minor depression), but YES, I definitely am allergic to Death. So give me my money back, please.

### AT THE ORIGIN OF FLAVOR

Who would have dreamed that at the root of this whole fiasco was an innocent little piece of seaweed? For thousands of years, Japanese chefs had been spicing up their cuisine by the simple addition of a flavor-enhancing ocean plant called "kombu" or "sea tangle" (*Laminaria japonica*), which can still be purchased in many specialty or natural foods outlets. A chemistry professor at the Imperial University of Tokyo named Kikunae Ikeda began to investigate this seaweed's amazing yet mysterious qualities, and in 1908 was successful in isolating its active ingredient as the sodium salt of the amino acid Glutamic Acid, or Monosodium Glutamate.

Aware that a potential treasure chest sat bubbling in his test tube, Ikeda quickly patented his newly discovered food secret and teamed up with another enterprising businessman, Saburoku Suzuki, to form the Ajinomoto Company (literal translation: "At the Origin of Flavor"). Their intention was to synthesize this substance in the laboratory and introduce it to the world in a massive campaign of development, marketing and distribution. By 1933, production had escalated to 10 million pounds yearly, and "Ajinomoto" (the term is used interchangeably with MSG) was the Orient's most popular seasoning. Its consumption has doubled in every decade since the 1940s, with the United States alone using in excess of 80

million pounds annually. Additionally, this figure fails to include the enormous quantities of hydrolyzed vegetable protein used (an ingredient also produced by the Ajinomoto Co.), which contains between 12-20% MSG and is mixed into everything from canned tuna fish to baby food to those vegetarian meat substitutes you thought were safe. Today, this same company is responsible for manufacturing more than half the world's supply and has managed to make it a staple within the processed food and restaurant industries. What wheat is to bread, MSG is to almost anything in a box, bottle or can.

### STOWAWAY IN OUR FOOD SUPPLY

How can this be, you ask? You are an avid label reader at the supermarket, and very few products have Monosodium Glutamate listed as an ingredient. Due to the fact that this additive was proven harmful years ago and has a negative reputation in the minds of countless individuals who are highly sensitive to its effects, MSG is cleverly disguised beneath a myriad of deceitful monikers that the average consumer wouldn't blink twice at. Therefore, under such bland generalizations as "natural flavorings" (which may contain 20-60% MSG), "spices", "seasonings", "broth", "gelatin" or "bouillon", one may stumble upon the Glutamate snake coiled up in its basket, waiting to thrust a concoction of unpleasant symptoms onto its unwary dinner guests. It may be injected into poultry or lurking within the cured tobacco leaves of that cigarette you're taking drags on. It sneakily snugs within the grains of the myriad baked goods enhanced with malted barley (added to most flour to help it rise) or the yeast used for the same purpose (Red Star Yeast consists of 9-11% MSG).

This free-form Glutamate does occur spontaneously in some whole unadulterated foods, such as tomatoes, mushrooms, potatoes, grapefruit and parmesan cheese. However, consumer groups want to make it crystal clear that this natural form of free Glutamate is not dangerous and does not cause adverse reactions in people allergic to MSG. According to Mrs. Wanke, a spokesperson for NoMSG, "The FDA is purposefully clouding the issue and deceiving the public by comparing the naturally-occurring Glutamate found in some foods to the kind that is chemically added or created during processing." It is the breakdown of proteins during any of a number of manufacturing procedures (pasteurization, fermentation, enzyme modification, hydrolysis, protein fortification, chelation, etc.) which poses the risk to humans. Jack Samuels of the TRUTH IN LABELING CAMPAIGN compares it to breaking apart a pearl necklace, on which is strung a long chain of bonded amino acid beads, after which they fall off into "free-form" units and lose their relationship to each other. He states, "Some neuroscientists feel that perhaps hydrolyzed proteins are worse than pure MSG because, in effect, you're ingesting a 'neurotoxic amino acid stew' containing Aspartic Acid and L-Cysteine as well as Glutamates."

Most people learn to live with the minor physical reactions, which may occur daily or regularly if one's diet consists, even in part, of processed or fast foods. They attribute their discomfort to stress, lack of sleep, the weather or the flu—coping with the pain by merely popping an aspirin or antacid whenever symptoms strike. In the scheme of things, **a cramp here, a wheeze there, an itch or ache elsewhere may easily be overlooked, but snap together all the pieces of the MSG puzzle and what materializes is the partial crippling of a substantial slice of this planet's population.** A minimum of 20 million people in the United States and in excess of 100 million worldwide experience promi-

ment reactions. Thirty percent of the population will react when given 5 grams of MSG (an amount easily consumed in one day of eating convenience foods) and 90% when administered 10 grams.

So why does the FDA continue to allow this substance to inundate our food supply, when over 10,000 individual case studies have proven its danger? Because, having an undeniably suspicious allegiance to the large pharmaceutical and chemical industries, the FDA has decided to ignore documented incidents by passing them off as “anecdotal” evidence and, therefore, scientifically invalid. At least four of the eight men on FASEB’s expert panel had conflicts of interest (MSG-industry connections), and even though the original study was advertised as an independent review of existing data pertaining to glutamate’s safety, some important data were omitted, and others were distorted. This was not the first time the FDA’s sources were less than impeccable. An early 1970s committee set up to evaluate MSG in baby food, included toxicologists from DuPont and Dow Chemical, as well as scientists tied to Gerber Products and the International Mineral and Chemical Corporation (producer of ACCENT and 80% of MSG sold in this country). Yet another “expert” had acted as an industry spokesman on behalf of the Grocery Manufacturers’ Association.

#### WIZARD OF AHHS

An entire economy revolves around the MSG phenomenon, and the multi-billion dollar industry at stake has a huge investment in protecting its reputation. As most people are aware, addictions are big business—and greedy corporate empires have more than once been known to sacrifice human welfare for the sake of profit. Whether the fixation is tobacco, alcohol, sugar, sex or the almighty tastebud, human beings (my friend calls us “pleasure units”) on the warpath toward sensory fulfillment will always be easily manipulated by the propaganda geniuses of our day. So just who is the Wizard of Ahhs (as in: “Ahh, that sure tastes good!”) lurking in the shadows behind the MSG stage show? The conspiracy to keep consumers in the dark about the hidden forms of MSG and its deleterious nature has been waged by the food industry itself in conjunction with a special MSG lobby group (so what’s new?) titled The Glutamate Association. Composed of representatives from major U.S. food manufacturers—in addition to (surprise, surprise) the Ajinomoto Company—these powerful monied interests have banded together to fight anyone who would dare criticize their precious seaweed derivative. So if their synthesized, chemical, neurotoxic time bomb happens to interact with your personal, human organism in anything less than a fortunate manner, well, that’s just par for the course.

#### TOO GOOD TO BE TRUE

In 1948, the first symposium was held in Chicago to introduce Monosodium Glutamate to such companies in attendance as Campbell’s (as in “soups”), Nestles, General Foods, Libby, Borden, Pillsbury, Oscar Mayer, United Airlines and the National Livestock and Meat Board. The almost too-good-to-be-true, flavor-enhancing attributes of this substance were described: its ability to intensify existing flavors and increase odor appeal without contributing a strong aftertaste of its own; suppress undesirable bitterness or sourness; remove the tinny taste from canned items; provide a meaty, chicken-like flavor; add zest to low-fat, diet, or bland foods; mask inferiority in quality or freshness; and remove the stale or spoiled taste from frozen or mass-produced meals (as in cafeterias). Needless to say, the bait was irresistible

and the big fish bit. The far-reaching consequences of this eight-hour event to revolutionize American food processing and adversely affect the future health of many millions of its citizens was at that time unforeseen. Over the years, as the use of MSG increased, evidence began trickling into the scientific community that something was gravely wrong. The first case studies were ridiculed, ignored or swept under the rug. Today, the tragedy of this spiking of the American food supply has become crystal clear.

#### TOXIC TIME BOMB

Almost 30 years have elapsed since physicians and scientists began publishing well-documented accounts of serious, even life-threatening effects from the ingestion of small amounts of MSG (as served up in a bowl of wonton soup containing only 2.5-3 grams). In sufficient quantities, it is toxic to everyone (the degree of reaction depends upon individual tolerance levels and dosage), but for those who can’t metabolize it effectively, it acts like a poison that can trigger a combination of gastrointestinal, neurological and psychological symptoms. It has a peripheral effect on blood vessels and the lower esophageal sphincter, on the brain and central nervous system. Particularly severe reactions in some individuals can mimic those signaling a stroke (slurred speech, loss of balance) or heart attack (pressure in chest area radiating to the arms and neck); produce disabling, arthritic conditions in the joints and tendons; debilitating migraine headaches; severe hives or rashes appearing to be “atopic dermatitis”; acute asthmatic episodes requiring hospitalization (artificial ventilation and cardiopulmonary bypass); and prolonged attacks of depression requiring psychiatric intervention. Considering that 100 million persons worldwide suffer from clinically recognized depression (with teenage and childhood suicide rates on a drastic upswing) and that asthma has been identified as “the leading cause of absenteeism among schoolchildren” by the National Institute of Allergy and Infectious Diseases, it’s urgent that health professionals begin considering whether MSG toxicity might in certain cases be the real culprit.

#### THE SPICE OF DEATH

MSG intolerance is not merely an allergic reaction, but demonstrates a classic toxic reaction, a true drug effect. Technically, it can be classified as a drug, since it initiates changes in the physiology and functioning of tissues and organs while fulfilling absolutely no therapeutic purpose. In essence, Monosodium Glutamate works by tricking the body. In his book, *IN BAD TASTE: THE MSG SYNDROME*, author George Schwartz, M.D. describes the substance as a “mouth aphrodisiac”. The brain resembles a television set receiving a variety of signals. MSG placed on the tongue increases the sensitivity of our taste buds and feeling receptors, stimulating electrical discharges and creating a more intense “picture.” In addition, glutamates act as excitatory neurotransmitters which stimulate brain cell activity. In *EXCITOTOXINS: THE TASTE THAT KILLS*, neurosurgeon Dr. Russell Blaylock presents the latest research findings to illustrate how exposure to this class of chemicals (including MSG and other glutamates, Aspartame/Nutrasweet and other aspartates, and Cystoic Acid/Cysteine) can damage cerebral nerve cells: “When neurons are exposed to these substances, they become very excited and fire their impulses very rapidly until they reach a state of extreme exhaustion. Several hours later these neurons suddenly die, as if the cells were excited to death.”

In the May 1997 issue of *FOOD SCIENCE MAGA-*

*ZINE*, contributing writer Shirley Corriher confirms “there is evidence that Glutamic Acid is responsible for 75% of the excitatory transmission in the brain.” What’s more, the devastating implications extend into the realm of our offspring’s health: “Experiments will demonstrate that glutamate and other excitotoxins can alter the way the brain is formed during development...Exposure to these powerful compounds early in life could cause developmental brain defects that would produce learning difficulties and behavioral problems as the child grows older...(and) may contribute to violent behavior as well.”

Suspicious are mounting that the recent increased incidence of hyperactivity and attention deficit disorder (ADD) in children may be attributed to the widespread use of these toxins as food additives, and they may play a major role as well in a whole group of degenerative brain diseases in adults (especially the elderly) including Parkinson’s, Alzheimer’s, Huntington’s, and Lou Gehrig’s Diseases (ALS). Even an FDA-sponsored FASEB report (the scientific panel mentioned earlier) released in July 1995 finally concluded that, due to the controversy relating to the safety of Glutamic Acid, they suggested it prudent that supplements containing MSG not be used by: infants; children; pregnant women; women of child-bearing age; and people with affective (mood) disorders. Yet, not only did the Food and Drug Administration suppress this finding, they then approved a new chicken pox vaccine containing two sources of the chemical—Glutamic Acid itself and hydrolyzed gelatin (vegetarian parents take note)—thereby indiscriminately advocating it for the very young as part of a standard, aggressively prescribed medical procedure when expert opinion exists that it could be dangerous to exactly these recipients. So much for child protection in America, from C-note to shining C-note. Do money and corporate influence ever stop talking? Apparently not.

#### IN THE MOUTH OF BABES

As far back as the 1950s and 60s, the data started rolling in. Although I do not condone any kind of vivisection or animal experimentation, I will present some startling observations from which you can draw your own conclusions. I don’t believe these experimental results can necessarily be applied to humans, nor do I believe they are ethical. One of the first major indicators that implied an MSG/disease link occurred in 1957 when Dr. D. Newhouse and Dr. J.P. Lucas noticed that baby mice forced to ingest glutamates experienced rapid, irreversible destruction of the majority of the nerve cells in the inner layers of the animals’ retina (the visual receptor cells of the eye) within minutes of exposure. Coincidentally, an ophthalmology conference held in Chicago last year (1996) found that people stricken with glaucoma happen to contain anywhere from 10 to 50 times as much glutamate in their eye tissue as persons without glaucoma, and their optic nerves are being destroyed at a much faster rate.

In the late 1960s, John W. Olney, M.D., a neuroscientist working at the Department of Psychiatry at Washington University in St. Louis, repeated Lucas and Newhouse’s experiment on neonatal mice and, upon examining their brains, discovered that specialized cells in the hypothalamus (the area critical for both memory and learning) were destroyed after a single dose of MSG. Brain lesions also appeared in an infant Rhesus monkey. Obesity, behavioral disturbances, endocrine changes, stunted bodies, seizures and infertility in the test animals were also reported. (Leading Edge Research makes an interesting comment in their literature on glutamates: “If MSG could ‘solve’ the rodent population problem, it could also help ‘solve the population problem



for humans'—in theory, that is." Could the spiking of the American food supply with this chemical possibly be contributing to the widespread epidemic amongst men of low sperm count?) In all species tested, immature animals were found to be much more vulnerable to MSG's toxic effects.

Dr. Olney was shocked to learn that the concentrations of this substance added to commercial baby foods was equal to that which created brain lesions in the experimental models. After the Food and Drug Administration refused to take action, Dr. Olney testified before a Congressional committee and finally succeeded in getting food manufacturers to remove MSG from their infant product lines. Ironically, they simply substituted a more dangerous ingredient in its place: hydrolyzed vegetable protein (HVP), which contains three known excitotoxins. HVP, though advertised as a safe, natural, plant-based protein, is actually a mixture made from "junk" vegetables unfit for sale. The extraction process involves boiling them in a vat of acid, then neutralization with caustic soda. The resulting brown sludge, extremely high in glutamates, is scraped off the top, dried and sold. Then we eat it. Yucch!

Shamefully, millions of school children are fed cafeteria meals laced with these poisons on a daily basis, and we wonder why there is a market decline in scholastic performance, concentration and discipline in the classroom. Who is protecting the innocent from this chemical bombardment? According to one government official, "There are no federal regulations or policies which prohibit or limit the use of monosodium glutamate in the National School Lunch Program or any of the U.S. Department of Agriculture's federally funded programs." Enough said. Once again, good conscience must fall on the shoulders of ordinary citizens uniting in grassroots coalitions. The Feingold Association, a children's advocacy group focused on reducing dangerous color additives in food, wholeheartedly supports NoMSG's efforts.

Let's take a clue from these pure food pioneers. Become an informed and discriminating consumer. Take action, take control, and take charge of your future and your health!

# The Fraud Of Zionism

*Each of the last two years in Germany, almost 10,000 German citizens have been imprisoned for having the temerity to so much as QUESTION "the Holocaust", which simply could not be as it has been presented. The Khazarian-Bolshevik-Zionist Elite, however, are quickly becoming as obvious as the Emperor With No Clothes as truth gets out over the Internet.*

Most people have been trained to think of Zionism in positive terms. This is understandable. Decades of propaganda have misrepresented Zionism as a progressive, modern force bringing civilization to an arid, uninhabited wasteland. Such an image is an illusion. This essay will uncover the true history of Zionism. It will reveal the facts and make clear the real nature of the movement.

#### A MOVEMENT WHICH ASSUMES THE INCOMPATIBILITY OF JEW AND GENTILE

Zionism is an apartheid philosophy. Its founder, Theodore Herzl, was dismayed by the mass anti-Semitism in France aroused by the Dreyfuss affair. He became convinced that the separation of the Jews from the Gentiles by ingathering all Jews in a separate Jewish nation was the only solution to the age old "Jewish problem". Herzl spelled out his program in his book *Der Judenstaat* (The Jewish State):

"The Jewish question exists. It would be foolish to deny it... The Jewish problem exists wherever Jews live in noticeable numbers. Where it does not exist, it is introduced by Jews who move in... I believe I can understand anti-Semitism, which is in many ways a complicated movement. I look on this movement from the standpoint of a Jew—but without hatred or fear. I believe I recognize in anti-Semitism what is crude humor, ordinary economic envy, inherited prejudice and religious intolerance—but also what is deemed to be self defense.

"Anti-Semitism grows daily, hourly, among the peoples and must continue to grow since its causes continue to exist and cannot be alienated.

"The *causa remota* is the loss, in the Middle Ages, of the ability to assimilate; the *causa proxima* is our overproduction of middling intelligences, that can neither be drained off, nor rise higher—hence, no healthy draining off and no healthy rising to a higher level. Downward, we are being proletarianized into revolutionaries; we are the subalterns of every revolutionary party, while at the same time our terrible financial might grows upward.

"Will it not be said that I am putting weapons into the hands of the anti-Semites? Why? Because I acknowledge the truth? Because I do not assert that there are none but excellent people among us?

"It is a national question; to resolve it we must, above all, first make it into a world political question... We are a people, a people...

"The Jewish State is a world necessity, hence, it will arise..."

Herzl demands:

"We be given sovereignty over a part of the Earth's surface sufficient for the rightful requirements of our people; we shall take care of everything else ourselves.

"No one is strong enough, or rich enough, to move a people from one dwelling place to another. Only an idea can do that. The idea of a state may well have such force.

"No economic disruptions, no crises, nor persecutions will follow after the departing Jews, but rather a period of prosperity will begin for the lands left behind. An internal migration of Christian citizens into the positions surrendered by the Jews takes place. The outlook is gradual, without any jolt, and its very beginning is the end of anti-Semitism.

"The Jews leave as respected friends. If individual Jews then return, civilized countries will receive and treat them just as they would treat the citizens of any other foreign country.

"This emigration is no flight, but an orderly withdrawal, under the observation of public opinion. The movement is not only to be organized by completely legal means, it can, in any case, be accomplished only with the friendly collaboration of the participating government, which derives substantial benefit therefrom."

As these paragraphs make clear, to be a Zionist, one must believe there is a Jewish problem. No Zionist since Herzl has ever repudiated this basic philosophical premise:

"If we do not admit the rightfulness of anti-Semitism, we deny the rightfulness of our own nationalism. If our people is deserving and willing to live its own national life, then it is an alien body that insists on its own distinctive identity, reducing the domain of their life. It is right, therefore, that they should fight against us for their national integrity.... Instead of establishing societies for defense against the anti-Semites—who want to reduce our rights—we should establish societies for defense against our friends who desire to defend our rights."—Jacob Klatzkin, co-Editor of the *Encyclopaedia Judaica*

#### A MOVEMENT WHICH NEVER TOOK ANY COGNIZANCE OF THE POPULATION OF THE LAND IT COVETED

The Zionists have long maintained the myth—especially in the United States—that Palestine was uninhabited before the arrival of the Zionists. This deception is easily refuted. The British Foreign Secretary, Lord Curzon, writing on October 26, 1917:

"Now what is the capacity as regards population of Palestine within any reasonable period of time?... What is to become of the people of this country—assuming the Turk to be expelled—and the inhabitants not to have been exterminated by the war? There are over a half a million of these, Syrian Arabs—a mixed community with Arab, Hebrew, Canaanite, Greek, Egyptian and possibly Crusaders' blood. They own the soil, which belongs either to individual landowners or to village communities. They profess the Mohammedan faith. They will not be content either to be expropriated for Jewish immigrants, or to act merely as hewers of wood and drawers of water to the latter."

Palestine at the beginning of the Zionist movement

was part of the Ottoman Turkish Empire. Herzl, when he decided to champion a Jewish state in Palestine, necessarily made overtures to the Sultan on behalf of Zionism. These negotiations established that the Zionists were well aware of the existence of the Palestinian Arabs.

“When Herzl had spoken of a Charter (from the Sultan) he had not, needless to say, contemplated any eviction of the Arabs of Palestine in favor of the Jews. He was, to judge from his Congress addresses, hardly aware that Palestine had settled inhabitants, and he had, in perfect good faith, omitted the Arabs from his calculations.”—*Zionism*, Leonard Stein

“Was there ever anything more extraordinary than this? Vast plans are made engaging the destinies of a multitude of people, yet the man who engenders these plans never takes the essential first step of surveying the land where he purposes to carry them out. Nor apparently do any of his associates suggest it to him. There might be no Arabs in the world—for all the difference it makes to him or to his associates.

“Year by year, Zionist congresses are summoned... Was a single day’s session of a single Congress devoted to the discussion of the understanding that must be reached with the people of Palestine? Not one.

“There were nineteen Jewish colonies established in Palestine before the year 1900... All these trusts and colonies—and the people who inhabited them—were in regular, continuous communication with Jewish bodies and persons throughout Europe and America...

“In a hundred ways, the conditions prevailing in Palestine—and the existence of the Arabs and the varying ways in which the Arabs reacted to existing colonies and to the promise of more colonies—must have been known to all active Zionists.

“The only conclusion, then—and it is a conclusion forced upon the observer—is that if Zionism was unaware of the Arabs, it was because most Zionists perceived an obstacle in the Arabs and did not want to be aware to them.—*Palestine: The Reality*, J.M.N. Jeffries, pp. 40-42

#### A MOVEMENT WHICH DISREGARDED PRIOR OBLIGATIONS

Zionism, in addition to coveting someone else’s land, has always ignored the issue of prior obligations. The Arabs fought as Great Britain’s ally in World War I against Imperial Germany’s ally, Ottoman Turkey. The Arabs were guaranteed independence in a unified state once the war was won. The British pledge of Arab independence was contained in a letter dated October 25, 1915 by Sir Henry McMahon, British High Commissioner in Egypt to Sherif Hussein of Mecca.

“The districts of Mersina and Alexandretta and portions of Syria lying to the west of the districts of Damascus—Hama, Homs and Aleppo—cannot be said to be purely Arab, and should be excluded from the proposed limits and boundaries. With the above modification—and without prejudice to our existing treaties with Arab chiefs—we accept these limits and boundaries...

“Subject to the above modifications, Great Britain is prepared to recognize and support the independence of the Arabs within the territories included in the limits and boundaries proposed by the Sherif of Mecca.”—*Palestine: The Reality*, op. cited, p.76

British politicians later pretended that the pledge given by Sir Henry McMahon did not include Palestine. They are impeached by a secret Political Intelligence Department Memorandum on British Commitments to King Hussein. On page 9, the Memorandum states:

“With regard to Palestine, His Majesty’s Government

are committed by Sir H. McMahon’s letter to the Sherif on the 24<sup>th</sup> October, 1915 to its inclusion in the boundaries of Arab independence.”

The Zionist claim to Palestine has always rested on Lord Arthur Balfour’s letter of November 2, 1917, promising British support for a “Jewish national homeland” in Palestine. This letter was issued nearly two years after Sir Henry McMahon’s pledge of October 25, 1915.

#### A MOVEMENT WHICH WROTE ITS OWN TITLE

*Foreign Office  
November 2<sup>nd</sup>, 1917  
Dear Lord Rothchild*

*I have much pleasure in conveying to you, on behalf of His Majesty’s Government, the following declaration of sympathy with Jewish Zionist aspirations which has been submitted to, and approved by, the Cabinet.*

*His Majesty’s Government view with favor the establishment in Palestine of a National home for the Jewish people, and will use their best endeavors to facilitate the achievement of this object, it being clearly understood that nothing shall be done which may prejudice the civil and religious rights of existing non-Jewish communities in Palestine, or the rights and political status enjoyed by Jews in any other country...*

This document is the grant deed that planted Zionism in the Near East. It is the most discreditable document ever issued by a major power. It was written by those to whom it was addressed and was the payoff for a shameless political manipulation. The British government did not abandon its pledge to the Arabs because of altruistic concern for a “Jewish national homeland”. The real reason was stated by David Lloyd George, Britain’s wartime Prime Minister:

“There is no better proof of the value of the *Balfour Declaration* as a military more than the fact that Germany entered into negotiations with Turkey in an endeavor to provide an alternative scheme which would appeal to Zionists. A German-Jewish Society, the V.J.O.D., was formed and in January 1918, Talaat, the Turkish Grand Vizier, at the instigation of the Germans, gave vague promises of legislation by means of which ‘all justifiable wishes of the Jews in Palestine would be able to meet their fulfillment’.

“Another most cogent reason for the adoption by the Allies of the policy of the Declaration lay in the state of Russia herself. Russian Jews had been secretly active on behalf of the Central Powers from the first; they had become the chief agents of German pacifist propaganda in Russia; by 1917 they had done much in preparing for that general disintegration of Russian society—later recognized as the Revolution. It was believed that if Great Britain declared for the fulfillment of Zionist aspirations in Palestine under her own pledge, one effect would be to bring Russian Jewry to the cause of the entente.

“It was believed, also, that such a declaration would have a potent influence open world Jewry outside Russia, and secure for the entente the aid of Jewish financial interests. In America, their aid in this respect would have a special value when the Allies had almost exhausted the gold and marketable securities available for American purchase. Such were the chief considerations which, in 1917, impelled the British Government towards making a contract with Jewry.”—*Memoirs of the Peace Conference*, David Lloyd George, p. 726

The eminent Mr. Lloyd George’s opinion is confirmed by numerous other sources—especially by Mr. Samuel Landman in his work *Great Britain, The Jews and*

*Palestine*. Mr. Landman was a very well known English Zionist whose positions included honorary Secretary of the Zionist Council of the United Kingdom in 1912, Editor of *The Zionist*, 1913-1914, Solicitor and Secretary of the Zionist Organization, 1917-1922, and author of several Zionist publications during World War I. His opinion is thus an official one, which is completely consistent with that of Lloyd George.

“Mr. James A. Malcolm... spontaneously took the initiative, to convince, first of all, Sir Mark Sykes, Under-Secretary to the War Cabinet—and afterwards, M. Georges-Picot of the French Embassy in London and M. Gout of the Quai d’Orsay (Eastern Section)—that the best and perhaps the only way (which proved so to be) to induce the American President to come into the War was to secure the cooperation of Zionist Jews by promising them Palestine, and thus enlist and mobilize the hitherto unsuspectedly powerful forces of Zionist Jews in America and elsewhere in favor of the Allies on a *quid pro quo* contract basis...”

“The *Balfour Declaration*, in the words of Prof. H.M.V. Temperley, was a ‘definite contract between the British Government and Jewry’ (*History of the Peace Conference in Paris*, vol. 6, p.173). The main consideration given by the Jewish people (represented at the time by the leaders of the Zionist Organization) was their help in bringing President Wilson to the aid of the Allies.”—*Great Britain, The Jews and Palestine*, pp.3-6

Thus, according to the documented statements of both parties, the British betrayed their war-time ally, the Arabs, in deference to Zionist manipulation in bringing the U.S. into the War on Britain’s side. The *Balfour Declaration* was not written by British Foreign Secretary Arthur James Balfour. It was written by American and English Zionists on both sides of the Atlantic. Many versions were prepared, discarded and rewritten before the final version was submitted to Lord Balfour to be issued in his name. English politicians, such as Lord Robert Cecil, made minor emendations to the letter which their Zionist “professors” wrote for them. The *Covenant of the League of Nations* which provided the international legal basis for establishing a British protectorate, or “Mandate” over Palestine was largely written by the Zionist agent, South African General Jan Smuts. The drafting of the language of the actual Mandate was written by U.S. Zionist and Harvard Law Professor Felix Frankfurter at the Paris Peace Conference in 1919.

#### A MOVEMENT WHICH MADE FALSE PROMISES OF EQUAL TREATMENT

**The false promises of equal treatment for the Arabs are to be found in the *Balfour Declaration* itself. This Declaration was produced by many hands over many months with deception as its deliberate objective.**

“This too, memorable document is not so much a sentence of English as a verbal mosaic. Drafts for it traveled back and forth, within England or over the Ocean, to be scrutinized by some two score draftsmen half-cooperating, half-competing with one another, who erased this phrase or adopted that after much thought. At long last—out of the store of their rejections and of their acceptances—the final miscellany was chosen, ratified and fixed. There never has been a proclamation longer prepared, more carefully produced and more consciously worded.”

Whatever is to be found in the *Balfour Declaration* was put into it deliberately. There are no accidents in that text. If there is any vagueness in it, this is an intentional

vagueness.

"...this nationally issued and nationally endorsed document was nothing but a calmly planned piece of deception."—*Palestine: The Reality*, J.M.N. Jeffries

The entire *Balfour Declaration* cannot here be analyzed. A few illustrations of its deceptive character will suffice.

"...it being clearly understood that nothing shall be done which may prejudice the civil and religious rights of existing non-Jewish communities in Palestine..."

"At the time of the *Balfour Declaration* the population of Palestine was 90% Arab and 10% Jew.

"Before this unpalatable reality, what did the framers of the *Balfour Declaration* do? By an altogether abject subterfuge, under colour of protecting Arab interests, they set out to conceal the fact that the Arabs to all intents constituted the population of the country. It called them the 'non-Jewish communities in Palestine'! It called the multitude the non-few; it called the 670,000 the non-60,000; out of a hundred, it called the 91 the non-9. You might just as well call the British people 'the non-Continental communities in Great Britain'. It would be as suitable to define the mass of working men as 'the non-idling communities in the world', or the healthy as the 'non-bedridden elements amongst sleepers', or the sane as 'the non-lunatic section of thinkers'—or the grass of the countryside as 'the non-dandelion portion of the pastures'."—(ibid, pp. 177-178)

"The crux arrives with 'civil rights'. What are 'civil rights'? All turns on this point. If civil rights remain undefined, it is only a mockery to guarantee them. To guarantee anything, and at the same time not to let anyone know what it is, that is *Alice in Wonderland* legislation. 'I guarantee your civil rights', said the White Queen to Alice in Palestineland. 'Oh, thank you!' said Alice, 'what are they, please?' 'I'm sure I can't tell you, my dear,' said the White Queen, 'but I'll guarantee very hard.'"—(ibid, p.179)

As soon as the Zionists set up shop in Palestine, they made clear the real relationship of Jew to Arab. The formal government authority in Palestine, 1918-1920, was rested in the British Military Government. A competing and, in fact, superior form of government existing side by side [with] the British Military Government was the Zionist Commission. The attitude of the British Military Government and of the native Arab population was summed up by Sir Louis Bols:

"It will be recognized from the foregoing that my own authority and that of every department of my Administration is claimed or impinged upon by the Zionist Commission, and I am definitely of opinion that this state of affairs cannot continue without grave danger to the public peace and to the prejudice of my Administration.

"It is no use saying to the Moslem and Christian elements of the population that our declaration—as to the maintenance of the *status quo* on our entry into Jerusalem—has been deserved. Facts witness otherwise: The introduction of the Hebrew tongue as an official language; the setting up of a Jewish judicature as the whole fabric of Government of the Zionist Commission, of which they are well aware; the special traveling privileges to members of the Zionist Commission; these have firmly and absolutely convinced the non-Jewish elements of our partiality. On the other hand, the Zionist Commission accuses me and my officers of anti-Zionism. The situation is intolerable and—in justice to my officers and myself—must be fairly faced.

"This Administration has loyally earned out the

wishes of His Majesty's Government, and has succeeded in so doing by strict adherence to the laws governing the conduct of the Military Occupant of Enemy Territory, but this has not satisfied the Zionists, who appear bent on committing the temporary Military Administration to a partialist policy before the issue of the Mandate. It is manifestly impossible to please partisans who politically claim nothing more than a 'National Home', but in reality will be satisfied with nothing less than a Jewish State and all that it politically implies.

"I recommend, therefore, in the interests of peace, of development, of the Zionists themselves, that the Zionist Commission in Palestine be abolished."—(ibid, p.359)

#### A MOVEMENT WHICH DISCARDED ITS OWN SPONSOR

The British Mandate existed only to protect the incoming Zionists from the native Arabs. Mr. Vladimir Jabotinsky makes this clear in his 1923 title, *The Iron Wall (We and the Arabs)*:

"Zionist colonization must either be terminated or carried out against the wishes of the native population. This colonization can, therefore, be continued and make progress only under the protection of a power independent of the native population—an iron wall, which will be in a position to resist the pressure to the native population. This is, *in toto*, our policy towards the Arabs... A voluntary reconciliation with the Arabs is out of the question—either now or in the future.

"If you wish to colonize a land in which people are already living, you must provide a garrison for the land, or find some 'rich man' or benefactor who will provide a garrison on your behalf. Or else—or else, give up your colonization, for without an armed force which will render physically impossible any attempt to destroy or prevent this colonization, colonization is impossible, not 'difficult', not 'dangerous', but IMPOSSIBLE!..."

Zionism is a colonization adventure and, therefore, it stands or falls by the question of armed force. It is important... to speak Hebrew, but, unfortunately, it is even more important to be able to shoot—or else I am through with playing at colonizing."

The British soon realized what a grave problem they had created for themselves by sponsoring Zionism in Palestine. The Arab riots of 1920, 1921, 1929 and 1936-39 brought one British investigating commission after another to Palestine, all reaching the same conclusion—the cause of unrest in Palestine was massive Jewish immigration into a land already inhabited by Arabs.

In 1937 a Royal Investigating Commission headed by Lord Peel concluded that the proper solution to Jewish-Arab tension was to partition Palestine—creating a Jewish state, an Arab state and a British maintained "Polish Corridor" dividing the two. The Zionists reluctantly accepted the partition proposal but the Arabs did not. From this point on, the British had outlived their usefulness to the Zionists.

In 1944 the terrorist underground Jewish group, the Irgun Zvai Leumi, began a partisan war to drive the British out of Palestine. The many bloody misdeeds of this group included: assassinating British Soldiers; raiding British military depots; assassinating the British High Commissioner in Egypt; dynamiting the King David Hotel in Jerusalem, etc.—until the British finally quit Palestine on May 15, 1948.

#### A MOVEMENT WHICH COLLABORATED WITH THE AVOWED ENEMY OF ALL JEWS

Zionism was founded on the mutual incompatibility of Jew and Gentile. As such, it had a built-in incentive for collaborating with another ideology built on the incompatibility of Jew and Gentile—Nazism.

Zionist collaboration with National Socialism dates almost from the inception of the Hitler regime. The *Ha'avara*, or Transfer Agreement dates from May



1933. Under this arrangement, approximately 10% or 50-60,000 of Germany's 500-600,000 Jews were sent to Palestine with their assets—minus an exit tax. This fulfilled the Zionist desire to reroute Jews to Palestine, while promoting the Nazi desire to rid Germany of Jewish influence.

Zionism enjoyed the official favoritism of the Hitler government. Numerous articles praising Zionism appeared in the German press. Dr. Joseph Goebbels, Reich Propaganda Minister, commissioned a special medallion commemorating Zionism. The Zionist blue-and-white flag was the only national symbol permitted to fly in Germany, other than the swastika. More importantly, special Zionist training camps existed in Germany to train German Jews for agricultural work in Palestine.

On at least one occasion, Chaim Weizmann, the future first President of Israel, vetoed the *Rublee-Schact* plan of January 1939—which would have removed all Jews from Germany within a five year period. Weizmann's reason for so doing? He felt it was preferable to leave the Jews under German control so that they could later be sent to Palestine, rather than allow them to choose their own destination. In this regard, Weizmann endorsed the thinking of his political rival, David Ben-Gurion:

"If I knew that it would be possible to save all the children in Germany by bringing them over to England, and only half of them by transporting them to Eretz Yisrael, then I would opt for the second alternative. For we must weigh not only the life of these children, but also the history of the People of Israel."—Yoar-Gelber, *Zionist Policy and the Fate of European Jewry (1939-42)*; *Yad Vashem Studies*, Vol. XII, p.199

## HISTORY ON TRIAL—UPDATE: HISTORIAN “BELIEVED WHAT NAZIS TOLD HIM”

Historian David Irving has denied claims that he placed too much faith in Nazi accounts of World War II.

In his continuing libel trial at the High Court, Mr. Irving insisted that before conducting interviews with senior Nazi figures, he had persuaded them to be frank enough to reveal information even if it was against their interests, or those of Hitler.

Mr. Irving is suing author Deborah Lipstadt and Penguin Books over a claim that he is a “Holocaust denier”.

He insists on “numerous occasions”, he persuaded Hitler’s former aides and other leading Nazis to reveal full details of what had happened.

Mr. Irving’s comments came as he cross-examined a defence witness, Professor Richard Evans, who states in a 740-page report to the court that Mr. Irving placed an “almost entirely uncritical” faith in the details supplied by his Nazi interviewees.

It was in the interest of former Nazis of all kinds, he wrote, “to deny all knowledge of, let alone participation in, the crimes of Nazism, including the extermination of the Jews”.

“They had a motive for persuading Irving to be their mouthpiece in continuing their personal quest for public exculpation at a later date”.

Mr. Irving put it to the witness that he was accusing him of “gullibility in falling for what they told me”.

Professor Evans, who says he does not regard Mr. Irving as a “reputable historian”, replied: “I wouldn’t accuse you of being gullible, Mr. Irving.”

Mr. Irving claimed that Professor Evans had made “an over-hasty rush to judgement on me, which is not borne out by the evidence”.

Professor Evans said he did not deny the fact that Mr. Irving had obtained “a great deal of material” which others had not, and that his interviews with former members of Hitler’s staff “have contributed in some way to historical knowledge”.

The defendants, who deny libel, have accused Mr. Irving, 62, of being a liar and falsifier of history.

The hearing was adjourned and is expected to last for several months.

## FEAR OF “THE OTHER” FUELS RISE OF EUROPEAN RIGHTISTS

PARIS (WPS)—The anguished reaction of European leaders as Joerg Haider’s far-right Freedom Party joins the Austrian government is not the shock of something unprecedented. It is the shock of something all too familiar in their own countries.

Popular extreme-right parties have become a fact of

political life in Europe in the past decade.

Parties akin to Mr. Haider’s—in France, Switzerland, Italy, Germany, Belgium, Switzerland and Denmark, each with distinctive homegrown appeals—have been capturing hefty slices of the vote in recent national elections. The parties have done so by calling for checks or bans on immigration, crackdowns on crime and welfare cheats, and repudiation of pan-European institutions and ideals.

Their messages, by turns populist and xenophobic, coincide with rising numbers of immigrants and asylum-seekers, persistent joblessness and ever more remote political and economic forces playing an ever more direct role in the ordinary lives of Europeans....

...“Denmark is not and has never been a country of immigrants—we don’t want a multiethnic society,” declared Pia Kjaersgaard, head of the Danish People’s Party, which won 7.5 percent of parliamentary seats in Denmark’s elections in 1998 and is pulling 18 percent support in more recent polls.

There is no mystery about why immigration has become a gut issue for many Europeans. For years and in some cases decades, “foreigners” from North Africa or Turkey or Eastern Europe have flooded across Western Europe’s increasingly porous borders and established themselves and their families here. Now they are seen as a menace to livelihood and national culture.

“The phenomenon has bred insecurity—the fear of losing your job, the fear of crime, the fear of immigrants, the fear of ‘the other,’” said Patrick McCarthy, who teaches European studies at the Bologna campus of Johns Hopkins University.

Just this week, those anxieties exploded in punitive riots against North African immigrants in southern Spain, where the far right was supposed to have been buried with Franco a quarter century ago.

To alienated voters, the far right offers the bulwark of history and blood.

“They say, ‘We will help you not because you are a French citizen or a French taxpayer but because your family has lived in France for centuries,’” Mr. McCarthy said.

Europe’s far right has many faces. The crudest has been the National Front, which since the mid-1980s has played on the French fears of “the other” to draw a consistent 15 percent of the French vote in recent elections.

The National Front’s longtime leader, Jean-Marie Le Pen, embodies the demagoguery and thinly veiled racism that Mr. Haider and other extreme-right European politicians have sought to purge from their rhetorical inventory....

...Switzerland’s version, the People’s Party of Christoph Blocher, became the largest vote-getter in the country in last October’s federal elections. Drawing on resentment of immigrant workers, many from Southeastern Europe, the party drew nearly 23 percent of the vote....

...In some cases, these hard-right European parties champion a separatist agenda. One is the Northern League, which in Italy seeks to uncouple the prosperous north of economic haves from the depressed south of have-nots. Another is the Flemish rightist Vlaams Blok in Belgium.

In these two movements, the “other” is not only immigrants but also historically entrenched White fellow-citizens who are poorer and less educated, southerners in

Italy and French-speaking Walloons in Belgium. And while most other far-right parties are explicitly opposed to the gradual political and economic unification of Europe, in these two separation-prone regions, the case for self-sufficiency is necessarily built on close economic ties to the rest of Europe.

But for far-right party leaders, the European experiment is portrayed as a menace to national sovereignty and a vehicle to subjugate citizens to laws promulgated by faceless bureaucrats in Brussels, the headquarters of the European Union bureaucracy.

Another common plank of far-right platforms in Europe strikes a chord with voters at all economic levels: disgust and disillusionment with established political parties of the right and left that have dominated national politics in Western Europe at least since World War II.

Not without evidence, Mr. Haider, Mr. Le Pen and Mr. Blocher paint the mainstream formations as intellectually bankrupt and corruption-ridden, unable to govern or reform and fundamentally no different one from another.

The popular revolt that turns up in votes for far-right parties has bled mainstream conservative parties of parts of their natural constituencies and confounded governments struggling to adhere to mainstream social democratic ideals.

Whatever the success of the European Union’s diplomatic quarantine of Austria, most analysts say that under current economic conditions, extreme-right parties have a natural ceiling of support that is not likely to bring them much more power than they already enjoy.

“But if the economy goes into a spin and people start worrying about their pensions and worrying about inflation, it’s almost inevitable that the gravity will shift to the extreme right,” said Samuel Pizar, an international lawyer...

## MEET THE “DIGITAL ANGEL”—FROM HELL

’Twas Lord Byron who said it first, I believe: “’Tis strange but true; for truth is always strange; stranger than fiction.”...

...You had better sit down for this one, privacy fans. A company called Applied Digital Solutions has what sounds to me like the final solution. The NASDAQ-traded high-tech company is excited about its acquisition of the patent rights to a miniature digital transceiver—which it nicknamed “Digital Angel @.”

The product is billed as a versatile transceiver that can send and receive data—and which can be implanted in humans.

It can provide a tamper-proof means of identification for enhanced business security, the company boasts. It can locate lost or missing individuals, say the proud owners. It can track and locate valuable property, they claim. It can monitor the medical conditions of at-risk patients. And it can slice, dice and destroy the last vestiges of personal privacy in an increasingly impersonal world.

The implantable transceiver’s signals can be tracked continuously by global positioning satellites [GPS]. When implanted in the body, the device is powered



electromagnetically through the movement of muscles, and it can be activated either by the wearer or by the monitoring facility.

“While a number of other tracking and monitoring technologies have been patented and marketed in the past, they are all unsuitable for the widespread tracking, recovery and identification of people due to a variety of limitations, including unwieldy size, maintenance requirements, insufficient or inconvenient power-supply and activation difficulties,” explains a company prospectus. “For the first time in the history of location and monitoring technology, Digital Angel® overcomes these limitations.”...

...The company projects a global market for this technology in excess of \$100 billion....

...Here’s what the company is talking about: business security, locating individuals, monitoring medical conditions, tracking and locating essential military and diplomatic personnel, tracking personal property...

...On Jan. 31, APS accepted the special “Technology Pioneers” award from the World Economic Forum for the company’s contributions to worldwide economic development and social progress through technology advancements.

And what is the World Economic Forum (WEF)? It bills itself as an independent organization committed to improving the state of the world. It does this by “creating the foremost global partnerships of business, political, intellectual and other leaders of society to define and discuss key issues on the global agenda.”...

...Why would an organization committed to breaking down nationalist barriers and moving the world toward global government give a technology award to a company that just acquired the patent to a sophisticated, implantable identification device? Hmmmmm? And guess what one of the foremost goals of WEF is? You got it—vaccinating every human being on the planet. How convenient! What a coincidence.

President Clinton recently addressed the WEF in Davos, Switzerland. He boasted about asking the Congress to give pharmaceutical conglomerates tax credits to make vaccines more widely available at low cost. He appealed for a similar effort from the World Bank, other nations and the corporate world to deliver the vaccines to the people who need them—meaning everyone [sic].

How could ADS ever hope to make \$100 billion with this new technology? By implanting it in every human being in the world. And how could that be done? At vaccination time, of course.

Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six.”

Digital Angel? Sounds more like we could be entering the age of the Digital Devil.

### THIRD WORLD SEEKS FAIR FREE TRADE

BANGKOK (AP)—For decades, poor countries have felt excluded from the closed-door meetings that set the direction for the world’s trade agreements.

Nevertheless, most accepted the pacts, believing that free trade would help them develop and eventually join the ranks of the rich.

But with global poverty and income gaps worsening, a growing number of developing countries and activist groups are re-examining the agreements and say they are no longer willing to be excluded from discussions during which global economic policies are set.

“Those who are affected need to have a voice, and so far their voice isn’t being heard,” said Philippine Foreign Secretary Domingo Siazon.

Third World governments and activists hope their voices will be heard at a meeting of the UN Conference on Trade and Development starting Saturday in Bangkok.

Unlike last December’s failed World Trade Organization talks in Seattle, UNCTAD is a talk shop dominated largely by developing countries and focused on how trade can help poor nations grow.

The 135-nation WTO is widely perceived to be controlled by rich countries. Some African countries were so upset by being excluded from some negotiating sessions in Seattle in December that they threatened to walk out.

“The process was undemocratic,” says Martin Khor, Director of the Third World Network, a Malaysia-based advocacy group. “Most of the key meetings took place in secret, with only 10 to 20 mostly rich countries attending. That left a very bitter taste for the developing countries.”

Delegates from poorer countries were angered by President Clinton’s comments before WTO meetings that trade sanctions should be imposed against countries that violate basic labor standards.

Poor nations saw that as an attack on one of their few advantages—lower wages—and pandering by Clinton to U.S. unions.

Behind the growing disenchantment over free-trade talks are signs that many of the poorest countries are being left behind by economic globalization.

A year ago, UN Secretary-General Kofi Annan warned that globalization might not benefit all countries, lifting the “yachts” while capsizing many “canoes”.

A draft report prepared for the UNCTAD meeting concludes that Annan was right.

“The income gap between the developed and the developing countries has grown wider,” it says. Worse, it says, income inequality has risen within developing countries while job security has fallen.

Third World groups say that’s because rich countries have pushed trade agreements through the WTO that favor their own industries.

The UNCTAD report says many of the WTO tariff reductions favor industrialized countries, while a “significant” number of goods produced by developing countries remain blocked by high tariffs.

Thailand symbolizes other misgivings by developing countries about globalization.

It was the flash point of Asia’s recent financial crisis, which has been blamed in part on overly hasty liberalization and massive, uncontrolled flows of capital.

Since the crisis, Asian countries have been hesitant to put their ravaged economies at the mercy of another binding world trade agreement. Many also fear that opening up their markets too rapidly will hurt their already suffering farmers and small businessmen.

In Bangkok last weekend, Thai farmers’ groups said the concept of free trade is a figment of the imagination and if anyone benefits, it is big agribusiness, not poor and small farmers.

### BRITAIN’S SPY POSTS ACCUSED OF LISTENING IN ON BUSINESS

Britain and the U.S. are facing unprecedented legal and political challenges from their European allies over a secret Anglophone spy network.

Newly declassified American documents last week provided the first official confirmation that the global electronic eavesdropping operation exists. The Echelon surveillance system—run by five English-speaking nations but dominated by the U.S.—is reportedly capable of monitoring telephone, fax and e-mail communications relayed by satellite anywhere in the world.

The network is a legacy of the Cold War intelligence showdown with the communist bloc. But there are allegations in west European nations that Echelon is being abused by U.S. espionage chiefs to spy on individuals and to pass on commercial secrets to American businesses.

Britain’s role has come under fierce fire, as it is the only European member of the UK/U.S.A. alliance that operates the system. Canada, Australia and New Zealand subsequently joined the grouping that London formed with America in 1947 to pool security information. The sprawling Menwith Hill listening station in North Yorkshire is the most important international site for America’s National Security Agency (NSA), the lead player in Echelon.

A new report into Echelon’s electronic surveillance commissioned by the European Parliament will fuel the row when MEPs debate its findings next week. The document lists high-profile cases in which American companies allegedly won contracts heading for European firms after the NSA intercepted conversations. The Airbus consortium and Thomson CSF of France were among the reported losers.

In Asia, the U.S. used information gathered from its bases in Australia to win a half share of a significant Indonesian trade contract for AT&T that communication intercepts showed was initially going to NRC of Japan, according to a former NSA agent, Wayne Madsen, on Australian television last year. A lawsuit against the U.S. and Britain is being launched in France—judicial and parliamentary investigations have begun in Italy and German parliamentarians have demanded an inquiry.

In the U.S., a Congressional investigation into the Echelon system starts this year amid concerns over possible privacy violations. A spokesman for the government reform committee said: “American people not only have the right to privacy, they have the right to know about it if their privacy is infringed.” The committee will be able to issue subpoenas to federal officials and employees of the NSA to compel them to give evidence.

Although a 1996 book by a New Zealand whistleblower and an earlier 1997 report to the European Parliament disclosed the existence of Echelon, there had

been no official confirmation in Britain or America until declassified U.S. Defense Department papers were posted on the Internet last week.

The first reference to the “highly controversial programme... code-named Echelon” came in a 1991 document relating to military SIGINT (signals intelligence) units at Sugar Grove in West Virginia. Despite the release, the NSA continued to refuse to confirm or deny Echelon’s existence.

The Home Office did not respond to inquiries about Echelon last week. Senior British intelligence officials have, however, denied that there is a “word spotting” search system that allows calls of intelligence interest to be selected by the use of key words or names.

The report, to be presented to the European Parliament’s civil liberties committee on February 22, agrees that “word spotting” does not exist. Instead, the millions of satellite communications monitored each day are reportedly sifted by so-called “dictionary” computers that check messages against a database of targets such as names, topics, addresses and telephone numbers.

If there is a match, the intercepts are relayed to security agents for analysis. The biggest data-collection centre is at NSA headquarters in Fort Meade, Virginia, while Britain’s largest centre is GCHQ in Cheltenham.

The investigations will throw embarrassing light on the clandestine Anglophone listening operation. The biggest challenge seems likely in France, where strict privacy laws mean that it is necessary to prove only that an attempt to breach the privacy of an individual has been made, not that the intrusion was harmful.

A leading Parisian law firm said last week that it would file the French equivalent of a class-action suit to sue the U.S. and Britain, representing individuals and firms that claim they have lost contracts because of “theft of information”. David Natas, a lawyer specialising in computer crime, said: “The French are extremely angry. They should tear down the listening stations in Cornwall.”

In Italy, parliament’s secret services committee has opened an inquiry, as have magistrates in Rome. Carlo Sarzana, an Assistant Chief Preliminary Judge, said of NSA’s intercepts: “The scope is not military.”

But there are plenty in Washington who believe that the NSA is simply doing its duty, and say that European secret services pursue the same policy. One congressional insider said: “The French are like whining babies. They always seem to find a reason for any of their failures.”

**[JR: The problem with many of these technologies developed for legitimate national defense purposes is that they are constantly being abused and either used against the people, for extortion or for personal and commercial profit. When you can’t trust your own government to act in a just and lawful way and hold themselves to the same standards as the people they are supposed to govern, then it’s time they are replaced with those who will do the job on the side of right and justice. We shouldn’t have to go back to carrier pigeons or tin cans on a string to communicate with privacy. With the paranoia in our government today, many more innocent victims may be communicating through tapping on their cell walls.]**

#### THE BUTLER HACKED IT!

After all the finger-pointing at hackers following this week’s web-site attacks, the hackers are doing some finger pointing of their own. And most of them are pointing at the U.S. government.

It proves, once again, that the Internet is fertile breeding ground for all kinds of conspiracy theories. And when the subject is the Web itself, it’s a veritable conspiracy population explosion.

In a widely circulated post to an e-mail list, privacy advocate Jim Warren floated the theory that the Clinton Administration staged the attacks to bolster proposals to greatly expand government powers of surveillance.

“What better way to ‘prove’ the need for massively expanded government surveillance and create a frenzy of support for it?!” wrote Warren.

The evidence: Clinton designated electronic “law enforcement” a top priority and allocated \$240 million for a secret wiretapping network in his budget last month.

Days later, the National Security Agency’s main spy computers experienced “inexplicable” crashes, followed by attempts to cripple Internet commerce with attacks on key web-sites by hackers unknown.

Warren also cited massive phone service disruptions in Missouri and Oklahoma this week and glitches experienced by Concentric Networks’ otherwise “very reliable mail-server”.

“Suddenly, crackers seem to have become far better than any have ever been before. But then again—what organization has the best computer and phone-system crackers in the world?!”... Warren wrote, alluding to the National Security Agency.

Interviewed on Thursday, Warren said, “It’s a disturbing coincidence that immediately after the Clinton Administration declares war on cyber-terrorism... suddenly we have a continuous cascade of denial-of-service attacks on the highest-of-the-high on the Internet.

“On the one hand, it’s ridiculous to think the NSA, or the Clinton Administration or the FBI would pull something like this. On the other, it’s insane to think Nixon would organize a break-in to wiretap his political opponents.”

Anyone looking for further evidence that the Men in Black were involved in the web-site attacks can read a *CNN* article published Wednesday, 2/9/00. According to the article, the FBI contacted ZDNet before it was hit by any denial-of-service attacks.

“ZDNet confirmed to *CNN* that the FBI contacted the company before it knew it was being hit and has begun to investigate,” is the quote most often included in e-mails submitted to *Wired News*’ tips hotline.

Unfortunately, most of the e-mails neglect to include the preceding sentence, which suggests the FBI was proactively contacting major sites before they were crippled by an attack.

The rash of e-mails also included several from panicky web-surfers suddenly unable to access their favorite sites—regardless of how obscure they were—fearing that they, too, were victims of dastardly denial-of-service attacks.

More than likely, they were just typical, everyday slowdowns on the “World Wide Wait”.

Meanwhile, the long-time hacker periodical *2600* suggests the attacks were engineered by “corporate America” to justify a hacker crackdown.

“After all, who would be better served by a further denigration of the hacker image with more restrictions on individual liberties?” asked an unsigned editorial.

**[JR: Hundreds of thousands of individuals in December initiated an “invasion of privacy” e-mail protest to overload “Echelon” (the ultimate super-secret multi-government super-electronics eavesdropping/snooping system for all communications), listing key conspiracy trigger words. Unofficial reports indicated the system was shut down for hours several times. Evidently, this gave**

**them the idea to use the same strategy to attack web-sites that they now term as “e-commerce”. This perceived threat to interstate (e-)commerce automatically invokes constitutional federal intervention and control. #### INDIAN LAND DEAL HEADED TO CONGRESS

LA VERNE, California (AP)—A deal poised to become one of the biggest federal returns of Indian land in U.S. history now awaits Congressional approval.

Utah, federal and tribal officials signed an agreement on Friday that would return 84,000 acres to the Northern Ute tribe as part of a deal to clean up millions of tons of uranium waste leaking into the Colorado River. Federal officials announced the pact in January.

No immediate health risk has been identified for 25 million water users in Arizona, California, Nevada and Utah. But Southern California water officials say there is enough long-term potential risk to remove the 40-foot-high, 150-acre pile.

“It makes a whole lot more sense to just keep it out,” said Phillip Pace, Chairman of the Metropolitan Water District’s Board of Directors.

The agreement was signed on Friday at a water plant 25 miles east of Los Angeles because Water District officials had lobbied heavily to remove the pile after the Nuclear Regulatory Commission issued a plan to drain and cap the tailings on site.

The land, believed to contain oil-rich shale deposits, was given to the Utes in 1882. But in 1916, on the eve of the nation’s entry into World War I, the federal government took it back to create a reserve supply of oil for the Navy fleet. The reserve was never tapped.

The tailings are the byproduct of a mine that operated from 1956 to 1984. More than 57,600 gallons of water leach every year from the tailings, releasing high levels of uranium and other pollutants, according to federal studies.

Under the agreement, half of the estimated \$300 million cleanup costs will be absorbed by the federal government because more than 50 percent of the uranium mined there was used in weapons programs.

The Utes will pay an estimated \$80 million to \$100 million toward the cleanup and provide added protection to the 75 miles of the Green River that form the reservation’s western boundary.

**[JR: This sounds like a bad math deal for the Indians. The government took (stole) this land back from the Utes who received it under an 1882 treaty. Private mining companies mined it for major profits under government contracts and created this \$300 million hazardous-waste site that must be cleaned up. Now, 84 years later, they want to return their own lands back to the Ute nation, on the condition they pay 1/3 (\$100 million+) of the cleanup and added protection. The government is “supposed” to pay one half (\$150 million), so that leaves the mining companies—which made all those tremendous profits off the government—pay only \$50 million; that is, if it actually happens. Through past experience with agreements between the government and the Indians, I would guess the Utes will pay their \$100 million+ share and then—once they accept return or possession of their land—the government will cease any further involvement in the cleanup. After a couple of years, when the western states demand that it be cleaned up because their water supply is tainted, the government will just say—“the present owner of the land is responsible”.]**

RUSSIA AND CHINA TIES

BEIJING—China's purchase of two \$800 million, Russian-built destroyers, the first of which sailed through the Strait of Taiwan this week en route to a Chinese naval base, highlights a blossoming military relationship between Moscow and Beijing that is raising concerns in Asia and the West.

Western experts and Asian diplomats say that over the last year, and especially since the Kosovo War last spring, Moscow's security ties to Beijing have surpassed the simple cash-for-weapons transactions that characterized the relationship for years and are evolving into something more complex and potentially far-reaching.

In October, the Chinese and Russian defense ministries signed an agreement to conduct joint training and to share data on the formulation of military doctrine. The same month, elements of the Russian and Chinese navies took part in their first joint exercises at sea. The two governments also removed a major obstacle to bilateral military sales, currently valued at about \$1 billion a year, by compromising on China's desire to pay for weaponry and technical assistance with goods and Russia's demand for hard currency.

Asian officials, meanwhile, say that as many as 2,000 Russian technicians are employed by Chinese research institutes working on laser technology: the miniaturization of nuclear weapons; cruise missiles; space-based weaponry; and nuclear submarines. On Jan. 19, Russian Deputy Prime Minister Ilya Klebanov told reporters that Beijing and Moscow "are close enough" to agreement on joint use of Russia's GLONASS satellite-based global positioning system, an accord that would aid the Chinese military in targeting its rockets and air-to-air missiles. Russia and China also have announced a willingness to collaborate on a ballistic missile defense system to counter U.S. efforts to create its own missile defense system.

"The weapons don't concern us as much as the technology transfers do," said Maj. Gen. Tyson Fu, Director of the Institute of Strategic Studies at Taiwan's Armed Forces University. "That is where the Russians are making their biggest impact."

Western experts are split over whether [or not] Russia and China will be able to overcome their historic animosities to turn these agreements into durable cooperation. There are questions, too, about the ability of China's lumbering armed forces to absorb Russian technology and about the overall impact of Russian imports on Chinese military strength. Nonetheless, diplomats and scholars with a variety of viewpoints agree that the Sino-Russian relationship has acquired new energy since the Kosovo crisis and merits closer scrutiny from Western capitals....

...Just two years ago, a senior Western diplomat soft-pedaled the emerging ties, quoting Russian sources as saying that the quality of the systems Russia is selling China was inferior. Last week, the same diplomat cautioned that "if the Russians are giving them stuff that is as good as in their own arsenal, they are criminally stupid."

The diplomat added, however, that there has been no concerted pressure on Moscow to stop sales and transfers of military technology to China. He said Washington had pressured Israel to halt the sale to China of a \$250 million airborne radar system, "but there is no united response to Russia."

China and Russia are moving toward a closer security relationship largely in response to what they see as growing American hegemony around the world. This concern was spurred by U.S. global military and economic dominance, NATO expansion into Eastern Europe, and what Beijing and Moscow view as U.S. use of the United Nations as a foreign policy tool....

...China's shopping spree for Russian weapons has not been limited to naval equipment. In 1992, China bought its first batch of Su-27 fighter jets. In 1996, it signed a contract worth an estimated \$2.2-2.5 billion to build 200 of the aircraft in China. Last year, it signed a \$2 billion contract for 30 to 60 Su-30MK fighter planes, a senior Asian diplomat said, adding that negotiations apparently are underway on a deal involving the Su-37, a more advanced model.

Western analysts say China acquired the Sunburn-equipped ships as part of a long-term strategy—which also included the 1994 purchase of four Kilo-class diesel-powered submarines—to make U.S. forces in the region think twice about defending Taiwan. The U.S. military has yet to come up with a viable deterrent to the Sunburn missile, which has a range of 87 nautical miles, Western analysts said. Taiwan, which China considers a renegade province, will elect a new president next month. The last time Taiwan held a presidential election, in 1996, Beijing fired missiles near the island, and the United States responded by sending two aircraft carrier battle groups to the area....

...By almost every measure, China remains decades behind the United States and some of its Western allies in key areas of military technology. Some Western analysts see China's acquisitions from the Russians as an illustration of the failure of its own research and development agencies to close the gap.

"I think what the Chinese buy from the Russians [or other foreign sources] is a tacit admission that their defense industries cannot design and make the stuff that the [military] thinks it needs," said John Frankenstein, an expert on China's military-industrial complex. "The Chinese defense industries represent a worst-case example of the problems of the Chinese state-owned enterprises—under-capitalized, lagging technology, over-staffed and poorly managed."

**[JR: Let us hope that those whose job it is to analyze this type of information do not underestimate or misinterpret this Russian/Chinese military partnership. They are not necessarily operating out of a position of weakness but rather out of resolve to build, between them, enough strength to stand up against what they perceive to be the threat to their world—the U.S.]**

REGULATORS BACK DERIVATIVES  
DEREGULATION

WASHINGTON—Remember how Long Term Capital Management's (LTCM) massive losses in over-the-counter derivatives markets almost brought the U.S. financial system to its knees in 1998?

That episode loomed large Thursday when every top financial regulator in the U.S. Government testified before the Senate Agriculture Committee that the way to prevent similar problems in the future is less regulation, not more.

And the Chicago Futures Exchanges agreed. Facing the prospect of increased competition from unregulated over-the-counter derivatives dealers, the exchanges pressed Committee members for regulatory relief that would enable them to compete on what they describe as a level playing field.

The move toward less regulation comes in the wake of a long campaign by the former head of the Commodity Futures Trading Commission (CFTC), Brooksley Born, to slap new controls on the use of over-the-counter derivatives—private contracts that banks and other major institutions use to manage risk in the interest-rate and currency markets....

...On Thursday, new CFTC head William J. Rainer joined Federal Reserve Chairman Alan Greenspan, Treasury Secretary Lawrence Summers and Annette Nazareth, Director of Market Regulation at the Securities and Exchange Commission, in

urging Congress to act quickly to exempt from regulation the \$80 trillion OTC derivatives market.

The most important issue, according to Greenspan, was the legal uncertainty facing OTC derivatives because of the threat of regulation. "The legal uncertainties create risks to counterparties in OTC contracts and, indeed, to our financial system, that simply are unacceptable," he said.

Greenspan encouraged Congress to move quickly or risk losing the OTC derivative trading markets to overseas competitors.

"I see a real risk that if we fail to rationalize our regulation of centralized trading mechanisms for financial instruments, these markets and the related profits and employment opportunities will be lost to foreign jurisdictions that maintain the confidence of global investors without imposing so many regulatory constraints," he said.

In his testimony, Summers outlined recommendations announced by an interagency Working Group on Financial Markets last November that called for OTC markets to police themselves.

That group called for excluding OTC derivatives and electronic trading between sophisticated parties from the *Commodity Exchange Act*, the main law governing futures markets. And they encouraged derivatives dealers to use clearinghouses so the chances of a single bankrupt firm toppling the system would be reduced.

"The best discipline, the most informed discipline, can come from counterparties with the sharing of information," Summers said. "We must guard against public regulations that crowd out private regulation."

Top officials from the Chicago Board of Trade and the Chicago Mercantile Exchange told Committee members that over-the-counter markets only should be exempt from regulation if the exchanges get similar freedoms. Complying with regulations raises their costs, they said.

They also raised objections to the prospect of getting a limited exemption only for large institutional traders, who are the primary users of derivative contracts. That would leave the individual speculators and retail traders who dominate the floors of the exchanges under CEA regulations.

"All institutions providing essentially the same function should be treated equally," said Chicago attorney Jerrold Salzman, who testified when Merc [Chicago Mercantile Exchange] Chairman Scott Gordon could not appear because of illness. "All you have to do is look on the Internet. Entrepreneurs are springing up all over this country to operate as essentially unregulated dealers."

The handful of senators in attendance seemed sympathetic to overhauling the system along the lines suggested by the working group.

Sen. Tom Harkin (D-Iowa) expressed concern that excluding swaps dealers from CFTC oversight would leave regulators powerless to intervene the next time an LTCM-type incident occurred.

And Sen. Peter Fitzgerald (R-Ill.) suggested he will press hard to gain the exemptions the Chicago exchanges are seeking.

Sen. Richard Lugar (R-Ind.), Chairman of the Committee, indicated that he will try to push the CEA overhaul bill through Congress this year.

ISRAEL ADMITS USING ILLEGAL FORCE  
DURING THE INTIFADA

JERUSALEM—An Israeli government report published Wednesday acknowledged what Palestinians and human-rights groups have said for years—that Israel systematically used illegal force against Palestinian suspects during the Intifada.

The State Comptroller's report, written in 1997 but withheld by the government until now, said Shin Bet security agents who interrogated suspects also systematically lied about their actions to their superiors and to the courts.

The report covers the years 1988-92, when the Palestinian uprising against Israel was at its height. Unprecedented numbers of Palestinians were being arrested and interrogated.

It says the Shin Bet routinely went beyond the "moderate physical pressure" authorized by a 1987 panel headed by then-Supreme Court Justice Moshe Landau.

Human-rights groups in Israel maintain that the practices authorized by the Landau Commission—keeping prisoners in excruciatingly uncomfortable postures, covering their heads with filthy sacks and depriving them of sleep—amount to torture.

The report, written by former State Comptroller Miriam Ben-Porat, says the agents systematically overstepped even these bounds, especially at the interrogation facility in the Gaza Strip.

"Most of the violations were not caused by lack of knowledge of the line between what was permitted and what was forbidden, but were committed knowingly," the report said. "At the Gaza facility, veteran and even senior investigators committed very grave and systematic violations."

The report accuses the Shin Bet leadership of knowing what was going on but doing nothing to stop it. It says the agents lied about their activities in court, to other investigating agencies and in their reports to superiors.

"The assurances of senior Shin Bet officials to the Landau Commission that truth-telling inside the organization is enforced... were found to have no basis in reality," Ben-Porat wrote.

During the uprising, assertions by Palestinians tried in military courts that they confessed only under torture were routinely denied by Shin Bet interrogators and rejected by judges.

Shin Bet chiefs did not put a stop to the abuses or punish the offenders, reflecting "effective acceptance of the deviations from what was permitted during interrogation," the report said.

Gideon Ezra, an opposition Likud lawmaker, who was the Shin Bet commander in the West Bank at the time, said the report was detached from reality.

"The state comptroller had no way of knowing the impossible task facing the Shin Bet during that period," he told *Israel Army Radio*. Six years later, he said, the report is "irrelevant".

The report acknowledges that the security issues faced by the agents at the time were unprecedented and that they succeeded in solving

large numbers of terrorist crimes and preventing an even larger number. The report describes this activity as "holy work", but criticizes the methods used and recommends measures to ensure they be stopped.

Two years after the report was written, the Supreme Court banned physical force in interrogations, even within the limits set by the Landau Commission.

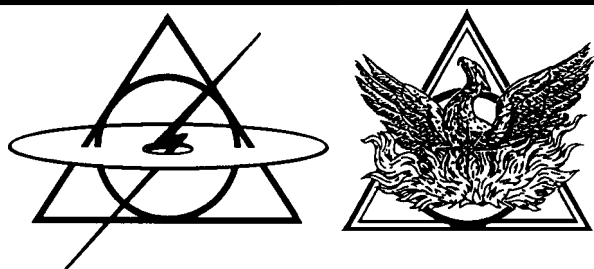
