

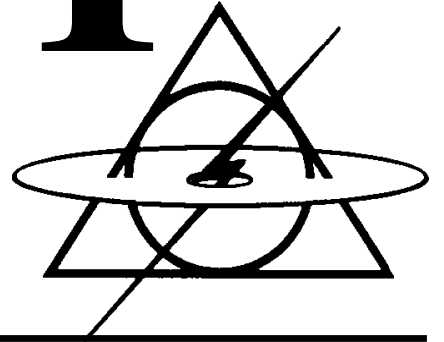

I was thoroughly familiar with all of the well known secret societies such as the Royal Institute for International Affairs (RIIA), the Council on Foreign Relations (CFR), the Bilderbergers, Trilaterals, the Zionists, Freemasonry, Bolshevism, Rosicrucianism and all of the spin-offs of these secret societies. As an intelligence officer, and even before that as a young student in the course of my studies at the British Museum in London, I had cut my eye teeth on all of them, plus a good number of others with which I imagined Americans were familiar.

But when I came to the United States in 1969, I found that names like the Order of St. John of Jerusalem, Club of Rome, German Marshall Fund, the Cini Foundation, the Round Table, the Fabianists, the Venetian Black Nobility, the Mont Pelerin Society, Hellfire Clubs and many others were either totally unknown here, or else their true functions were at best but poorly understood, if at all.

In 1969-1970 I set about remedying the situation in a series of monographs and cassette tapes. Much to my surprise I soon found plenty of people willing to quote these names as if they had known of them all of their writing careers, but who were not in the least bit knowledgeable about the subjects, yet quite unwilling to state the source of their lately acquired information. I consoled myself with the thought that imitation is the sincerest form of flattery.

I pursued my investigations, pressing on in the face of severe risks, attacks on myself and my wife, financial losses, continual harassment, threats and calumny, all part of a carefully crafted and orchestrated program to discredit me, run by Government agents and informers, embedded in the so-called Christian rightwing, the "Identity Movement" and rightwing "patriotic" groups. These agents operated, and still operate, under cover of strong and fearless outspoken opposition to Judaism—their main enemy, they would have us believe. These agent-informers are led and controlled by a group of homosexuals who are well-liked and well-respected by political and religious conservatives all across the United States.

Their program of calumny, lies and hatred, disinformation about my work, even lately attributing it to other writers, continues unabated but it has not had the desired effect. I shall carry on with my task until I have finally ripped off the mask of the entire secret upper-level parallel government that runs Britain and the U.S. This book is a part of that ongoing effort.—Dr. John Coleman

### BETRAYAL OF THE PHILIPPINES

By Dr. John Coleman

That the Philippines is engaged in a life-and-death struggle, similar to that which Iran went through, cannot be doubted. The same people who planned the downfall of Iran are the principal players in the Philippines drama. In accordance with my decision to date all of my material, this message is being prepared in late July 1985. The first step in the battle to turn the

Philippines over to the control of the communists was taken by Cyrus Vance, Philip Klutznick, Sol Linowitz, Professor Richard Falck and Ramsey Clark back in 1974, at the Inter-Religious Peace Colloquy, held at Bellagio, Italy. The countries targeted at that conference, chaired by Vance and paid for by David Rockefeller's German Marshall Fund, were Iran, Nicaragua, the Philippines, South Africa and South Korea. Those chosen to lead the attack ON THE PHILIPPINES WERE SIN, RED CARDINAL OF THE PHILIPPINES, RAMSEY CLARK, HENRY KISSINGER AND REPRESENTATIVE (U.S.) STEPHEN SOLARZ.

The first concrete step in destabilizing the Philippines was to appoint Henry Kissinger as the spokesman for the CFR-Trilateral conspirators. Kissinger knew that he would never be accepted by the Philippines in any official capacity, so working from behind the scenes, he had his protege, Steven Bosworth, appointed as Ambassador to the Philippines on March 9, 1984. Perhaps I am starting ahead of the PLANNING STAGE, BLUEPRINTED NINE YEARS EARLIER, but time does not permit me to delve into that period. Although Ramsey Clark, Sloan Coffin and Richard Falck had gone to work at least five years prior to the arrival of Bosworth, I am certain that the real push to topple Marcos began with the appointment of Bosworth, AND HIS JOINING FORCES WITH RED CARDINAL SIN from the first day of Bosworth's arrival in Manila.

Let us take a look at Bosworth, and then pass on to Red Cardinal Sin, and see if we can throw some light onto this unholy alliance. Bosworth was appointed by Kissinger to the Policy Planning Council of the State Department. It is interesting to note that this is where Alger Hiss and Brzezinski began their careers. It is the proving ground for traitors. They are sent there on the orders of the CFR and if they prove their devotion to the cause of betraying the U.S.A. in favor of a One World Government, they go on to bigger and better things. It was also the department in which the man who wrote the United Nations Charter started his nefarious operations in the U.S.A. on behalf of his masters in the KGB. I am referring to Dr. Pasvolsky, the Russian-born traitor, whose parents were both active members of Lenin's Bolshevik "peoples' committees" and the man who trained Alger Hiss for his treacherous role. So Bosworth went to the right "school", as any good protege-pupil of Kissinger's would be expected to do.

Bosworth arrived in the Philippines just in time to join forces with Sin in disrupting the legislative election scheduled in May, which, following the destructive work of the World Council of Churches, Richard Falck, Solarz and Ramsey Clark, was being talked of as "the finish of Marcos". This line was slavishly followed by the jackal press of the West, notably the *Washington Post* and the *New York Times*, plus the Rockefeller rags, *Time* and *Newsweek*. The people of America were conditioned, softened-up and brainwashed to a degree not seen since the Tavistock-planned Watergate conspiracy that destroyed President Nixon and cowed most of our representatives in Washington, which is what it was supposed to do. NOW IT IS THE TURN OF MARCOS TO BE "WATERGATED" AND HOW SUCCESSFUL THIS PLOT WILL BE! I AM NOT A PROPHET, BUT I VENTURE TO SUGGEST THAT BY JUNE OF 1986, MARCOS WILL BE

OVERTHROWN. More on that later, as we proceed.

In order to make a place for Bosworth in Manila, Ambassador Armacost was recalled, supposedly to replace Undersecretary of State Eagleburger, another Kissinger protege, who was going into private practice, where else, but Kissinger Associates. You can see, with this sort of thing going on all over our "conservative" administration, why I say emphatically that your vote no longer counts. Let me ask you: Did any of you vote for Kissinger, Eagleburger, Armacost or Bosworth? Yet, these are the people who were shifted around so that the full force and fury of Kissinger's venom could be directed against our oldest ally in the Pacific. Bosworth, more than anyone else, is going to play a key role in destabilizing the Government of President Marcos.

[CONTINUING with DR. COLEMAN's monograph:]

Some years ago when I visited the Philippines, I stood among the graves of young U.S. soldiers and Filipinos who had been cut down in the prime of their lives, and I wondered "Why did these men die?" I thought they died needlessly, since I realized that the Pacific War was organized by a traitor of the worst kind, Owen Lattimore, aided and abetted by the vile vermin that infest the filthy Augean stable of the State Department, acting out the scenario laid down for them by the Council on Foreign Relations. I wondered how I could get this message across to the American people and warn them of the dangers to come. I knew that with little backing, no money and no forum, I could not hope to get the truth about the Philippines into the hands of the American people. It was like David and Goliath, except that I didn't even have a slingshot!

I HAVE IT ON THE VERY BEST AUTHORITY, MY PRIME SOURCE IN WASHINGTON, WHO HAS NEVER ONCE STEERED ME WRONG, THAT BOSWORTH'S JOB IS TO FORCE A PULLOUT OF U.S. MILITARY FORCES FROM THEIR VITAL BASES IN THE PHILIPPINES. IN HIS SPEECH BEFORE THE ROYAL INSTITUTE FOR INTERNATIONAL AFFAIRS IN LONDON, KISSINGER BOASTED THAT HE WOULD SEE TO IT THAT THE UNITED STATES WAS FORCED OUT OF THE PACIFIC. HE PROMISED

HIS AUDIENCE THAT THE U.S. WOULD BECOME A SECOND-RATE POWER, AND BELIEVE ME, IF WE PULL OUT OF CLARK AIR FORCE BASE AND SUBIC BAY NAVAL BASE, THAT WILL BE THE END OF U.S. POWER IN THE PACIFIC. WITH NEW ZEALAND'S LANGE SOLD OUT TO THE CFR-TRILATERALS, THE U.S. MILITARY FORCES HAVE NOWHERE TO GO. THE NAVY WILL HAVE TO FALL BACK TO THE U.S. MAINLAND, PROBABLY SEATTLE. JAPAN WILL BE LEFT NAKED AND EXPOSED [BY] THE CFR'S (COUNCIL ON FOREIGN RELATIONS) BLACKMAIL. AT THE SAME TIME, MRS. AQUINO, THAT PATHETIC FIGURE, SO POLITICALLY NAIVE THAT SHE ACTUALLY BELIEVES MARCOS ORDERED THE ASSASSINATION OF HER HUSBAND, AND THAT SHE ACTUALLY HAS THE EXPERIENCE AND THE CAPACITY TO STEP INTO THE SHOES OF A MAN OF THE STATURE OF FERDINAND MARCOS, IS MAKING IT KNOWN THAT SHE WILL TERMINATE U.S. OCCUPANCY OF THE VITAL BASES I HAVE JUST MENTIONED, BY 1990. I CAN TELL YOU THAT WHEN MRS. AQUINO SUCCEEDS MARCOS, BY 1988 U.S. MILITARY FORCES WILL HAVE DEPARTED THE PHILIPPINES. A COMMUNIST GOVERNMENT WILL BE INSTALLED, AND THE CFR WILL PAT ITSELF ON THE BACK FOR ANOTHER SUCCESSFUL CUBA AND NICARAGUA. OH, HOW I PRAY TO GOD THAT THE EYES OF THE AMERICAN PEOPLE WILL SOON BE OPENED, SO THAT THEY WILL CLEARLY SEE THAT THE GREATEST DANGER WE FACE IS NOT SO MUCH FROM MOSCOW, BUT FROM WASHINGTON AND NEW YORK. If I had the power to do so, I would destroy the Harold Pratt House, raze it to the ground, and order the arrest of every member of the CFR-Trilateral secret government. Then I would flush out every sold-out communist prostitute in the State Department. Only by such drastic action can we hope to save the countries next on the CFR's "hit list", South Africa and South Korea, in that order. As far as I am concerned, it is already too late to save the Philippines. [Ed. note: ???!!! Look around you.]

Bosworth has assured his partner-in-crime, Cardinal Sin, that he will put a spanner in the works of the refinancing package worked out by President Marcos and tentatively adopted by the brigands of the IMF (International Monetary Fund). Let me say that I hope you will not overlook the use of "religion" in destabilizing CFR-targeted countries. We first saw that tactic worked to perfection in South Vietnam. Then Iran was "religionized" out of existence. The game plan continued in Nicaragua. IT IS BEING USED IN THE PHILIPPINES, WITH RED CARDINAL SIN AS THE CUTTING EDGE. It is being used in South Africa, where stooges like "Bishop" Tutu, Beyers Naude and Boesak are in the forefront of the "religious-political" conflict.

Cardinal Sin is a political pro-communist priest cast in the mold of the Red Bishop of Mexico. He is an avid Jesuit and a great friend and admirer of Daniel Ortega, and the Jesuit Sandanista Government that brought "democracy" to Nicaragua. Let me tell you that I have an impeccable source of information in the Vatican, and the Vatican has one of the best

international "desk" information networks in the world today. Recently, I received a report from my Vatican source on the influence of Henry Kissinger on Ronald Reagan's thinking and decision-making in Central America and the Philippines. IT IS A DEVASTATING DOCUMENT. I would put my life on the line if I made it public. Suffice to say that Henry Kissinger wields more power in the Reagan Administration, albeit it indirectly, than he ever did in the Nixon Administration. In the Philippines, his policy of destroying U.S. influence and withdrawing our military from the Pacific is being carried out on the ground by Steven Bosworth and Cardinal Sin. My Vatican source said that in spite of the fact that President Reagan knows all about Kissinger's role in Watergate and his betrayal of Nixon (including joining Nixon in prayer—an act of blasphemy, since Kissinger does not believe in God anyway) the Vatican is convinced that Reagan believes he needs Kissinger's prestige to help push through some of his programs. LADIES AND GENTLEMEN, I SUBMIT TO YOU THAT THE PRESIDENT OF THE U.S.A. HAS BEEN BRAINWASHED BY THE TAVISTOCK INSTITUTE. OUR PRESIDENT IS A VICTIM OF JOHN RAWLINGS REESE! KISSINGER IS DESPERATELY HUNGRY FOR POWER, AND FOR THE MOMENT IS CONTENT TO PLAY A BACK-ROOM ROLE ON BEHALF OF HIS MASTERS IN THE CFR. THE DANGEROUS SNAKE MUST BE SQUASHED, BEFORE IT IS TOO LATE.

[Ed. Note: Too late? Look at some of the things that have happened in this interim time, including the KNIGHTING by Queen Elizabeth of now SIR KISSINGER, SIR BUSH, SIR GENERAL SCHWARZKOPF, SIR POWELL, ETC. KISSINGER RUNS AROUND TO THE RACES AT ASCOT WITH SUCH AS LIZ THE QUEEN AND SQUIRED AROUND PRINCESS DIANA—AND GOT HER NICELY DEADED IN THE PROCESS. The false belief that Benigno Aquino was murdered on the orders of President Marcos was transmitted by Cardinal Sin to the Vatican representative at the UN, Archbishop Cheli. "Why didn't Sin send his lying message directly to the Vatican," you ask? The answer lies in the fact that Sin was counting on the support of that counterfeit conservative, Mrs. Jeane Kirkpatrick, to back up his story, and it worked. When Cheli approached Mrs. Kirkpatrick for her views, she gravely informed him that Sin's suspicions were correct. Thereupon, Cheli transmitted the message on telex number VVOUN 429502, to the Vatican. But Sin reckoned without the astuteness of Pope John Paul, who frankly discounted the idea that Marcos would commit political suicide by ordering the murder of Aquino. The strategy is really very simple; make the American public believe that Marcos is a criminal and that the elections he has called for in February of 1986 will be rigged in his favor. The newspapers and television media started a concerted campaign to impress on the minds of Americans that Marcos could not possibly win, and that if he did, it would be as a result of blatantly rigged election fraud. Three months before the elections begin, the jackals of the American press and television media have begun a daily bombardment claiming that Mrs. Aquino is sure to win the election, knowing this to be false. Unbiased opinion polls at this time show that Marcos will come out a clear winner. The jackal media praise Mrs. Aquino, this politically naive woman, and make out that she has the qualities and experience to lead the Philippine nation, a patently absurd claim.

[Ed. note: In the Philippines TODAY, there is concerted effort being perpetrated on this nation—of unprecedented foundation—for destabilizing THE CURRENT GOVERNMENT AND ADMINISTRATION. This destabilization is directly seen in every MEDIA form, the press as the journalists and publishers do their Opinions and President Estrada is methodically destroyed in every manner possible. The Government as it is now structured is within hours of folding in total collapse—economically and politically. And who is heading up this incredible march to collapse? CARDINAL SIN AND CORY AQUINO.

Is Joseph Estrada strong enough to thwart this movement? Apparently not, if you consider his actions to date but, God willing, he will WAKE UP and take control, for at this point, like it or not, HE IS THE ONLY "ONE" PERSON WHO CAN DO SO. Will he? I have it from my source in Washington that the traitor and betrayer of Nicaragua, Senator Richard Lugar of the CFR, will be sent to Manila to "supervise" the elections and set up a massive "oversight" voting check that will ensure a proper count, in favor of Mrs. Aquino, of course. On the ground in New York, I am reliably informed that the spoiler of Rhodesia, friend and confidant of the "300", Solarz, WILL LAUNCH A SMEAR ATTACK ON THE MARCOS FAMILY, ACCUSING IT OF WHOLESALe THEFT OF MONEY BELONGING TO THE MANILA GOVERNMENT. THUS THE STAGE IS SET TO

UNDERMINE THE AUTHORITY AND PRESTIGE OF PRESIDENT MARCOS, AND UNDERCUT HIS GOVERNMENT, LONG BEFORE THE ELECTIONS EVEN BEGIN. In choosing Lugar and Solarz, the CFR chose wisely. Apart from Senator Robert Dole, I cannot think of any two men in Congress who are so willing to sell out American interests, at home and abroad, on such a massive scale. These are not the kind of men you can turn your back to! I want to assure you that the deck has been stacked against Marcos, not by the Kremlin, but by the traitors within our gates in Washington. The Moro Liberation Front and other communist guerrilla groups will not have to lift a finger to bring down Marcos; it is all being done for them by the CFR and our internal enemies, the U.S. press and television media, Solarz, Lugar, Kissinger, Clark and scores of traitors scuttling around the State Department, like the rats they are! I say that the election has already been stacked against Marcos. What right does a sold-out traitor like Lugar (Israel FIRST) have to go and interfere in the election process of an independent country? I would like to see the election of Lugar supervised very closely, if ever this CFR stooge has the nerve to run for the Senate again. Personally, I don't think he will. Having done his dirty work, betraying American interests, not to mention the conservative electorate who gave him his place in Washington, I think the CFR will "retire" Lugar and find a very high, well-paid post for him in "private life", where he can sit back and contemplate the destruction and havoc he has wrought against the country he is supposed to be serving. I would like to see Lugar impeached immediately and kicked out of the Senate.

So the die is cast. The American public is going to be force-fed a diet that the Philippines is unstable and the Government of President Marcos corrupt and unreliable. The story then will go out that we should no longer risk stationing our military in a country ripe for overthrow by the communists, so either Mrs. Aquino is elected, or we must pull our military out of their base in the Philippines. It is strictly a no-win situation, and such is the might and power of our secret government, the cursed CFR-Trilateralists, that President Reagan is powerless to stop the plan. He has already lost control of the situation. The Philippines policy is being run by Lugar and Donald Regan and arch-traitor, George Shultz. The President of the U.S.A. is sitting back, all confused, listening to the raspy voice of Herr Kissinger, agent of doom. I am almost as certain as I can be that in the final show down, Shultz will persuade the President to ABANDON MARCOS, just as he is presently attempting to persuade President Reagan to abandon South Africa. A statesman who is not sitting back all confused is POPE JOHN PAUL II. On receipt of the telex from Cheli in New York, Pope John Paul called his Manila desk for an update. He was immediately informed that the majority of the Filipino people did not believe Marcos was responsible for the death of Aquino. He was told that Senator Edward Kennedy was loudly telling the opposition forces in Manila that Marcos was behind the murder, while not offering any proof to support such an assertion. He was told that Kennedy had joined forces with Cardinal Sin in condemning the Marcos Government. Sin told his followers never to refer to the Government but always to use the word "regime". Even more astounding, the Pope learned of a recent CIA profile on Marcos which portrayed Marcos as physically ill and mentally disturbed. This was prepared by CIA Deputy Chief George McMahon. McMahon's "profile" said that Marcos was unpredictable and could no longer be relied upon. I hope that someone in authority will boot this subversive out of the CIA as

soon as possible. Any man holding McMahon's title who can go around spreading lies of this nature is unfit to be employed in the service of the U.S.A. Write to President Reagan and ask him to get rid of McMahon as soon as possible. The Pope was informed that Sin has been particularly shrill in his denunciations of the Marcos family. In the opinion of the Manila desk, Sin had exceeded by far his authority and should be reined-in. The Pope privately expressed the view that he thought the 300-CFR was behind the situation and was exploiting it with its customary deviousness and double crossings, for which the Pope knows the CFR is famous.

But before he could do anything, a secretly prepared broadcast was rapidly beamed by the Vatican Radio Station's communist sympathizer, Clarissa McNair, a weirdo who keeps pet turtles, and when they die, buries them in flower pots in her Rome apartment. McNair enjoys the protection of certain pro-communist factions inside the Vatican, and as of this date has not yet been fired, although the Pope was on the point of dismissing her recently. McNair's pro-communist broadcast sharply criticized the way Marcos was treating the Catholic Church in the Philippines, which, as events prove, was an utterly false and baseless claim.

Pope John Paul called for an immediate report from Sin on his behavior. Sin responded by sending a biased and unfounded report that two witnesses had come forward to tell him, Sin, that the Marcos-appointed commission into the death of Aquino was WITHHOLDING VITAL EVIDENCE THAT WOULD DIRECTLY IMPLICATE MARCOS IN THE KILLING. These two witnesses were, however, never found. [Ed. Note: Is this not simply a "rerun" of those "Holocaust" witnesses, et al.? WHEN WILL WE EVER LEARN?] It would appear that Sin had received some help from an intelligence agency in drafting his response to the Pope's demand for an explanation of this behavior. THE POPE KNOWS THAT SIN HAS EXTENSIVE LINKS WITH THE CHINESE COMMUNISTS AND HAS DEVELOPED A DEEP MISTRUST OF SIN, whom he is said to ACTIVELY DISLIKE. The Pope sent off a letter to Sin in which he expressed strong disapproval of Sin's leftist activities in Manila. The Pope feels that Sin is more Asiatic than Catholic and intends to stress this in the upcoming Extraordinary Synod scheduled for November 1985.

The struggle in the Philippines may, for the sake of convenience, be divided into two distinct areas: (1) The U.S.A. must not and cannot afford to lose Clark and Subic bases, unless we are to withdraw from the Pacific Basin altogether (the Kissinger plan) and (2) an ideological battle that the U.S.A. cannot and must not lose. With regard to the second item, it is difficult for me to see how we cannot but lose. In fact, we started to lose as far back as January 5, 1967, when President Johnson issued Executive Order 11322, imposing sanctions against Rhodesia. Similar sanctions have since been imposed against another faithful and loyal ally, the Republic of South Africa, not by Jimmy Carter but by "conservative" President Reagan! Johnson's Executive Order reads: "by virtue of my authority under Section 5 of the *United Nations Participation Act* of 1945... etc." I wonder how many of you conservatives realize that we in the U.S.A. are SUBJECT to the demands of the UNITED NATIONS, which gives PREFERENCE OVER THE PROVISIONS OF OUR CONSTITUTION? Is this really true? Get a copy of the Congressional Record which contains this Executive Order and see for yourself that the U.S. was OBLIGED by the United Nations to impose sanctions against Rhodesia. The point is that if

Mrs. Aquino is not elected, President Reagan will be forced by his advisors (and he is a prisoner of the Palace Guard in the White House) to sign an Executive Order imposing sanctions against the Marcos Government. How can we have military bases in a country subject to United Nations-imposed sanctions? Clearly, we are no longer masters of our own house. The secret government, the CFR, has us by the throat in much the same way as the Bolsheviks seized Russia by the hair of its head. The only difference is that we have not yet awakened to this reality! All the shocking developments in Africa, Angola, Rhodesia and South Africa sprang from Johnson's dastardly Executive Order. The same weapon will be used against the Philippines, if Marcos does not artificially lose the election next year. This is in violation of the U.S. *Constitution*, but the enemies within our gates are not at all concerned about the *Constitution*. It has got to such a pass in Washington that our elected representatives creep around whispering in corridors and engaging in back-door meetings with conservatives. That is how far we have fallen to today. Our representatives dare not stand up for what is right, and if you still believe that they will do the right thing by the Philippines, then I am sorry to have to tell you that you are hopelessly wrong!

The Philippines is important because for the first time since 1913, we have a vocal conservative majority, a well-informed majority that sees behind the news media and television anti-Marcos blitz presently being carried out. It is interesting that the profilers of public opinion, paid by the CFR, always manage to come up with a catchy phrase or trigger word. In the Philippines, it is "Marcos is corrupt". In Africa, it is "White minority rule". Please note that nothing is ever said about Black minority rule, Rhodesia being a case in point, where one man, Mugabe, is the minority ruler of the country. IF WE CANNOT STOP THE PLANS OF THE CFR TO OVERTHROW MARCOS AND INSTALL AN INTERIM GOVERNMENT UNDER THE INSIPID LEADERSHIP OF MRS. AQUINO, UNTIL RED CHINA'S TAKE OVER, IF WE CANNOT DEFEAT THE CFR PLANS NOW, WHEN WE HAVE A LARGE, WELL-INFORMED AND VOCAL CONSERVATIVE MAJORITY, WHEN, I ASK YOU, WILL WE EVER BE ABLE TO STOP THE CFR? Therefore, from an ideological point of view, the Philippines is a much bigger struggle than saving our military bases, as important as this is.

Ranged against us is the wily, devious and treacherous Stephen Solarz (Israel FIRST). At the Sixth Supreme Legislative Assembly of the World Council of Churches held in August 1983, Solarz was proposed as the most experienced U.S. lawmaker to "deal" with the Philippines situation. The same Committee nominated Cardinal Sin to do all in his power to undermine President Marcos. (The Catholic Church is NOT a member of the WCC), but Jesuit Bishop Francisco Claver was deputized to act as a liaison between Sin and the WCC, a move deeply deplored by Pope John Paul II. Thereupon Solarz, grossly abusing his congressional privileges, used the House of Representatives as a forum to viciously attack the Government of President Marcos. Not one single conservative lawmaker had the courage to put a stop to the daily abuse of Congress by the snake from Brooklyn. In October 1983, Solarz, emboldened by lack of opposition from conservative lawmakers, drew up a blatantly false and misleading resolution. I say that Solarz misused his position as Chairman of the House Subcommittee on Asian and Pacific Affairs to present a false and misleading resolution stating

that “the conduct of U.S. policy toward the Philippines should take into account the conduct of the Philippines’ investigation into the murder of Aquino and the failures of the 1984 National Assembly elections”. Notice how Solarz set the stage for casting doubt upon the 1986 election, almost two years BEFORE the election is to take place. The American public was already a victim of CFR propaganda as far back as October 12, 1984! How can Marcos remain in power, even when it is clear that he will have a majority of the 1986 election?

Earlier, following his CFR-WCC instructions, Solarz, on March 15, 1984, pressed his Committee to draft and successfully pass a resolution, FY85 Foreign Aid Bill, which demanded a reduction in payment for military bases in the Philippines by a whopping \$50 million dollars per annum! If this isn’t sabotage of U.S. interests, then I would like to know what is! This disgraceful resolution WAS adopted by Solarz’s Committee, the same Committee that approved \$80 million dollars in aid for the communist dictator in Zimbabwe! No wonder I say that your vote has become meaningless!

Let me say that by this single action Solarz demonstrated his contempt for the *Constitution*. Solarz does NOT have the power to make or break international treaties, and payments to the Philippines Government comes under international treaty law. By slashing payments to the Philippines, Solarz took it upon himself to, in effect, abrogate our treaty obligations with the Philippines, in much the same way as Mrs. Thatcher abrogated the 1842 treaty with Argentina when she invaded the Falkland Islands, on behalf of the Carrington-owned Falkland Islands Company, Ltd. I have looked into this provision and I am convinced that Solarz is a LAW BREAKER and NOT A LAW MAKER. Solarz does not have the right to abrogate international treaties. But where was our well-informed and vocal majority when this took place? As far as I have been able to ascertain, there was no protest raised in the House. This is where we have already lost the ideological battle for the Philippines, and next will come South Africa and South Korea, unless we marshal our conservative forces and drive men like Solarz and Lugar from Congress by impeaching them. WHILE ON THE SUBJECT, WE SHOULD IMPEACH THOSE CONGRESSMEN WHO SUPPORT THE IMF, WHICH HAS JOINED THE BATTLE TO UNSEAT PRESIDENT MARCOS. I am talking about those who supported the April 16<sup>th</sup> resolution signed by 33 congressional traitors, including Stephen Solarz, Barbara Mikulski, Charles Schumer, Parren Mitchell and Ron Dellums. THE RESOLUTION ASKED DONALD REGAN NOT TO GO ALONG WITH THE PHILIPPINES’ REQUEST TO THE IMF FOR A 90-DAY MORATORIUM ON ITS LOANS. Toss these pro-communist traitors out of Congress, the sooner the better. Here we have a very ugly situation where the State Department skunks are saying to Marcos, “Either you meet our conditions (which would be political suicide for Marcos) or we are going to tell the IMF not to grant the 90-day moratorium on your outstanding liabilities.” Now, mark you, no such pressure is put on nations like East Germany. The State Department is shortly going to announce the formation of a special new department that will be responsible for developing “friendly ties” with East European nations, meaning that the State Department will look with favor on loans to communist countries, while cutting off the legs of our loyal anti-communist allies. If we are unable to recognize the fact alone that we have a secret ENEMY GOVERNMENT within our gates, then we

do not deserve to survive as a free and independent nation. As I mentioned earlier, Stephen Bosworth will be in the Philippines to take sides with the IMF against President Marcos. Bosworth has some experience in this dirty double-dealing, having learned his trade from another Kissinger protege, Thomas Enders, the man who stood by while the murderous Pol Pot wiped out half the Cambodian population. Again I stress the fact that nobody voted for Enders, Kissinger or Bosworth, yet these men are playing a key role in destroying President Marcos. When, oh when are we Americans going to realize that the enemy within our gates is a greater danger to our freedom than the men in the Kremlin? Are we going to wake up when it is too late to do anything about it? The ballot box has failed us; our salvation lies in calling for a National Convention, so that we can get to grips with the traitors who are subverting the will of the people—traitors who are doing more damage to the U.S.A. than the USSR has done since its inception. Yes, I consider the State Department, the CFR and the Trilaterals a far greater danger to our country than the Russians, and I have all of the facts to prove my assertion! Another CFR servant who needs to be arrested for treason is William Sullivan, who was a member of the oversight committee that destroyed the Shah of Iran. Sullivan is using almost the same language to inflame Americans and, indeed, the rest of the world against Marcos, as he used to help bring down the Shah, words like “human-rights violations” and “brutality”. Sullivan went before the Solarz subcommittee in February of this year and demanded that Congress suspend all payments for the Subic Bay and Clark bases, until Marcos “returns to honest democracy”. This evil servant of the CFR-World Revolutionary force was allowed to get away with his vile, inflammatory statements. I want to know what happened to our vocal and well-informed conservatives? Why was there not a concerted effort to utterly discredit Sullivan? He should have been tarred and feathered and run out of Washington. Instead, the silence from the right is deafening! What are we waiting for? Unless we smash liars like William Sullivan, we shall certainly lose the ideological battle for the Philippines! Where are the leaders of the right wing in America, why was Sullivan not tackled head-on and confronted with his role in bringing down the Shah? It seems to me that the right wing in America has never been as leaderless as it is today!

We cannot afford to lose this ideological struggle for the Philippines. We must not allow victory to go to the State Department-CFR-World Revolutionary forces! If we do, our military will lose its invaluable bases. The first struggle is to win the minds and hearts of the American people, so that they will support President Marcos in his upcoming struggle against the forces of darkness. This is one battle we dare not lose! Ideologically, it is a benchmark battle for the right wing in America. Lose that battle and we can say farewell to the Clark and Subic Bay bases, and wave a sad goodbye as we leave the Pacific Basin forever. It will not be long after the fall of Marcos that Soviet [or Chinese] naval units will sail into Subic Bay, their work having been done for them by Bosworth, William Sullivan, Kissinger, Solarz, Shultz and the U.S. State Department. Red China’s Navy will take over Subic Bay Naval Base without having to fire a shot, just as they took over Cam Rahn Bay in Vietnam, **[H: And where, exactly, did the wharves and docks from Subic Bay go? Ah, indeed, floated right up to Vietnam’s facilities run by these same thugs. And what of the Chinese threat to the Spratley Island fishing islands and grounds? And what of the virtual takeover of the**

**Philippines by the Chinese Taipans? Oh my, readers, you have a lot of catching up to do, don’t you? No offense intended here, readers, but these are referred to as the “Chinese Jews”, without any mention of “anti-Semitism”.]**

WHILE THE VILE SULLIVAN WAS DEMANDING THAT PRESIDENT REAGAN ABANDON MARCOS, HIS EQUALLY VILE COHORTS WERE PLANNING TO MURDER AQUINO IN THE FINAL DRIVE TO DESTABILIZE THE PHILIPPINES. MRS. AQUINO IS ONLY A PUPPET. One should feel pity for a woman who is so utterly deluded and bereft of common sense. By taking up the position that she can succeed Marcos, she is committing suicide. In effect a gun is already pointed at her head. When she wins the election in 1986, thanks to wholesale fraud, lying, cheating and intimidation of Marcos by the likes of Lugar, Bosworth and Sullivan, her days will be numbered. She will be allowed to remain in nominal control of the Philippines just long enough for the Trilaterals to regroup and take power. HE IS, BY THE WAY, STILL TRYING TO GET THE GOLD AND THE ASSETS OF SUCH AS TUTEN, YOUNT AND, ULTIMATELY, MILLERS. MILLERS EVEN WANT EKKERS TO PAY FOR THE LOAN THEY MADE DIRECTLY TO GAIL IRWIN, RICK MARTIN, KATHY, KAREN, ETC., ETC., WHEN EKKERS SAW “NOTHING” EXCEPT THE BILLING AND THE DEMAND FOR A “PERSONAL” GUARANTEE FOR THE PAYBACK.

And now, I am going to remind you of something else VERY IMPORTANT: If Ekkers had chosen to meet the demands of such as Tuten (which, in fact, they did and Tuten REFUSED), they would surely be in jail today for true misuse and misappropriation OF CORPORATE REGULATIONS AND FUNDS. Ekkers have NO CHOICE about any of the ongoing corporate problems—LAWS CONTROL, AND ANYONE WHO TELLS YOU DIFFERENTLY IS LYING TO YOU—AGAIN. AND, FURTHERMORE, AS LONG AS THE HARASSMENT AND ASSAULT IN THE COURTS CONTINUE (AND SUCH ARE STILL FULLY UNDER WAY)—THERE IS “NOTHING” EKKERS CAN DO ABOUT IT! AND IS THAT THE WAY IT WILL, THEREFORE, “END”? I SINCERELY HOPE SO. JUSTICE IS NOT SUPPOSED TO BE AN “I’D RATHER...”, AND TO REWARD THE ONES WHO HAVE LITERALLY DESTROYED FOR SO MANY IS OUTRAGEOUS IN ITS PRESENTATION AND REALITY. I SINCERELY HOPE THAT EKKERS PAY VERY CLOSE AND THOUGHTFUL ATTENTION TO THIS STATEMENT.

So, why do we have indifference to your recognition of “WHAT IS”? Because all we can or shall do is offer the information, so you KNOW TRUTH. That is my purpose—not to stuff it down your throats. We are not in the “newspaper” business but we are in the communications business—so you will also make of this paper what you WILL. I DO NOT FIGHT ANYONE—YOU OR OTHER. THINK OF US AS BULLDOZERS OUT LEVELING THE FIELD FOR THE FOOTBALL GAME AND STOP YOUR PIOUS LYING TO SELF. TELL IT LIKE IT IS, SET THE LIES TO TRUTH AND YOU WILL HAVE DONE THAT WHICH IS NECESSARY TO ALLOW GOD’S PLAN TO UNFOLD. THEN WATCH THE PEOPLE AND HOW THEY RESPOND! THE GROUPIES WILL VIE FOR POSITION RIGHT ALONG WITH THE THUGS. BUT, IN THE PLAY, THE “PEOPLE” WILL HAVE OPPORTUNITY TO GROW AND “CHOOSE”, INSTEAD OF STARVE AND BE GENOCIDED OR DESTROYED. EVIL NOW RULES YOUR WORLD LIKE YOU “KNEW” IT WOULD, SO “YOU” HAVE TO CHANGE IT—IF IT IS TO BE CHANGED. SO,

WEEP IF YOU WANT, BUT DO NOT LONGER EXPECT ANYONE TO “DO FOR YOU” ANYTHING, AND YOU HAVE HIT EKKERS ONE TIME TOO MANY, FOR THEY “CARE” BUT CAN’T DO A THING ABOUT YOUR PLIGHT. TOGETHER WITH OUR TEAM WE WILL MOVE FORWARD AND INTO ABUNDANCE, CREATE INDUSTRY AND GIVE IT UNTO BRETHREN—BEYOND THAT—NO MORE!

I might add one last little comment before I turn back to holocausts and boogie-men: **THOSE SUCH AS THE SPECTRUM SHILLS WHO HAVE WORKED AGAINST US—EVEN TO TURNING- IN THE EKKERS TO FBI, FEDS AND EVERYONE AROUND FOR INDICTMENT ON THESE IDIOT CHARGES—AND WHO ANNOUNCED THEMSELVES “ENEMIES” OF EKKERS AND “DHARMA’S HATONN”; WEEP NOW, FOR THEY FIND THEMSELVES HAVING PRONOUNCED THEMSELVES ENEMIES TO THOSE VERY ORGANIZATIONS, FOR THOSE ORGANIZATIONS HAVE BEEN ORDERED TO PROTECT “MY” PEOPLE—FOR THE “HOPE” OF THE MASSIVE ECONOMIC AND POLITICAL SOLUTIONS REST WITH “US”. I HAVE “ALWAYS” TOLD YOU, IN EVERY WAY THAT I CAN PRESENT, WE CAN WORK WITH OUR ENEMIES—WE DO NOT “BECOME” THEM.**

So, what am I saying here? Exactly what I have presented!

So, back to [QUOTING from *DID SIX MILLION REALLY DIE?*, PART 8:]

#### 8. THE NATURE & CONDITION OF WAR-TIME CONCENTRATION CAMPS

In his recent book, *Adolf Hitler* (London, 1973), Colin Cross, who brings more intelligence than is usual to many problems of this period, observed astutely that “The shuffling of millions of Jews around Europe and murdering them, in a time of desperate war emergency, was useless from any rational point of view” (p. 307). Quite so, and at this point we may well question the likelihood of the irrationalism, and whether [or not] it was even possible. Is it likely that at the height of the War, when the Germans were fighting a desperate battle for survival on two fronts, they would have conveyed millions of Jew for miles to supposedly elaborate and costly slaughterhouses? To have conveyed three or four millions Jews to Auschwitz alone (even supposing that such an inflated number existed in Europe, which it did not) would have placed an insuperable burden upon German transportation facilities, which were strained to the limit in supporting the far-flung Russian Front. To have transported the mythical six million Jews and countless numbers of other nationalities to internment camps, and to have housed, clothed and fed them there, would simply have paralyzed their military operations. There is no reason to suppose that the efficient Germans would have put their military fortunes at such risk.

**[H: Let’s stop right here and, as a reader, THINK: WHAT WOULD YOU DO IF SIX MILLION PEOPLE DROPPED IN FOR A LONG STAY WITH “YOU”? WHAT WOULD YOU FEED THEM? HOW WOULD YOU PROVIDE SHELTER? HOW WOULD YOU COVER THEIR VERY BODIES? AND WHAT IF THEY**

**WERE MOSTLY ALL SICK? HOW WOULD YOU HEAT THEIR VERY BEINGS, AND IF YOU COULD HOUSE THEM—HOW COULD YOU HEAT THEIR SHELTERS AND WHO WOULD COOK, CLEAN AND TEND? THE RED CROSS? CHELAS, YOU ARE TOTALLY WITHOUT REASON—WAR MEANS HARD TIMES FOR EVERYBODY—EVERY BODY! WHAT, IN FACT, WOULD NEW YORK DO WITH SIX MILLION MOVED IN AND DUMPED ON THEM? CALIFORNIA? WELL, TRY POOR NEW MEXICO! COME ON, WHAT WOULD YOU DO? THE FACT IS THAT THE GERMANS DIDN’T HAVE IT ANY BETTER, PEOPLE. WHERE ARE YOUR BRAINS? Even if you thought of just killing all the intruders, you COULDN’T.]**

ON THE OTHER HAND, THE TRANSPORTATION OF A REASONABLE 363,000 PRISONERS TO AUSCHWITZ IN THE COURSE OF THE WAR (THE NUMBER WE KNOW TO HAVE BEEN REGISTERED THERE) [H: **And just how would YOU house, feed and attend 363,000 guests?**] AT LEAST MAKES SENSE IN TERMS OF THE COMPULSORY LABOR THEY SUPPLIED. IN FACT, OF THE 3 MILLION JEWS LIVING IN EUROPE, IT IS CERTAIN THAT NO MORE THAN TWO MILLION WERE EVER INTERNED AT ONE TIME, AND IT IS PROBABLE THAT THE NUMBER WAS MUCH CLOSER TO 1,500,000. WE SHALL SEE LATER, IN THE REPORT OF THE RED CROSS, THAT WHOLE JEWISH POPULATIONS SUCH AS THAT OF SLOVAKIA AVOIDED DETENTION IN CAMPS, WHILE OTHERS WERE PLACED IN COMMUNITY GHETTOS LIKE THE RESIENSTADT. MOREOVER, FROM WESTERN EUROPE DEPORTATIONS WERE FAR FEWER. THE ESTIMATE OF REITLINGER THAT ONLY ABOUT 50,000 FRENCH JEWS FROM A TOTAL POPULATION OF 320,000 WERE DEPORTED AND INTERNED HAS BEEN NOTED ALREADY.

The question must also be asked as to whether [or not] it could have been physically possible to destroy the millions of Jews that are alleged. Had the Germans enough time for it? Is it likely that they would have cremated people by the millions when they were so short of manpower and required all prisoners of war for purposes of war production? Would it have been possible to destroy and remove all traces of a million people in six months? Could such enormous gatherings of Jews and executions on such a vast scale have been kept secret? These are the kinds of questions that the critical, thinking person should ask. And he will soon discover that not only the statistical and documentary evidence given here but simple logistics combine to discredit the legend of the Six Million.

Although it was impossible for millions to have been murdered in them, the nature and conditions of Germany’s concentration camps have been vastly exaggerated to make the claim plausible. William Shirer, in a typically reckless passage, states that “All of the thirty-odd principal Nazi concentration camps were death camps” (ibid, p. 1150). This is totally untrue and is not even accepted now by the principal propagators of the extermination legend. Shirer also quotes Eugene Kogon’s *The Theory and Practice of Hell* (N.Y. 1950, p. 227), which puts the total number

of deaths in all of them at the ridiculous figure of 7,125,000, though Shirer admits in a footnote that this is “undoubtedly too high”.

#### “DEATH CAMPS” BEHIND THE IRON CURTAIN

It is true that in 1945 Allied propaganda did claim that all the concentration camps, particularly those in Germany itself, were “death camps”, but not for long. On this question the eminent American historian Harry Elmer Barnes wrote: “These camps were first presented as those in Germany, such as Dachau, Belsen, Buchenwald, Sachsenhausen and Dora, but it was soon demonstrated that there had been no systematic extermination in those camps. Attention was then moved to Auschwitz, Treblinka, Belzec, Chelmno, Jonowska, Tarnow, Ravensbruck, Mauthausen, Brezeczna and Birkenau, which does not exhaust the list that appears to have been extended as needed” (*Rampart Journal*, Summer 1967). What had happened was that certain honest observers among the British and American occupation forces in Germany, while admitting that many inmates had died of disease and starvation in the final months of the War, had found no evidence, after all, of “gas chambers”. As a result, eastern camps in the Russian zone of occupation, such as Auschwitz and Treblinka, gradually came to the fore as horrific centers of extermination (though no one was permitted to see them), and this tendency has lasted to the present day. Here in these camps it was all supposed to have happened, but with the Iron Curtain brought down firmly over them, no one has ever been able to verify such charges. The communists claimed that four million people died at Auschwitz in gigantic gas chambers accommodating 2,000 people—and no one could argue to the contrary.

What is the truth about so-called “gas chambers”? Stephen F. Pinter, who served as lawyer for the United States War Department in the occupation forces in Germany and Austria for six years after the War, made the following statement in the widely read Catholic magazine *Our Sunday Visitor*, June 14<sup>th</sup>, 1959:

“I WAS IN DACHAU FOR 17 MONTHS AFTER THE WAR, AS A U.S. WAR DEPARTMENT ATTORNEY, AND CAN STATE THAT THERE WAS NO GAS CHAMBER AT DACHAU. WHAT WAS SHOWN TO VISITORS AND SIGHTSEERS THERE AND ERRONEOUSLY DESCRIBED AS A GAS CHAMBER WAS A CREMATORY. NOR WAS THERE A GAS CHAMBER IN ANY OF THE OTHER CONCENTRATION CAMPS IN GERMANY. WE WERE TOLD THAT THERE WAS A GAS CHAMBER AT AUSCHWITZ, BUT SINCE THAT WAS IN THE RUSSIAN ZONE OF OCCUPATION, WE WERE NOT PERMITTED TO INVESTIGATE—SINCE THE RUSSIANS WOULD NOT ALLOW IT. FROM WHAT I WAS ABLE TO DETERMINE DURING SIX POSTWAR YEARS IN GERMANY AND AUSTRIA, THERE WERE A NUMBER OF JEWS KILLED, BUT THE FIGURE OF A MILLION WAS CERTAINLY NEVER REACHED. I INTERVIEWED THOUSANDS OF JEWS, FORMER INMATES OF CONCENTRATION CAMPS IN GERMANY AND AUSTRIA, AND CONSIDER MYSELF AS WELL QUALIFIED AS ANY MAN ON THIS SUBJECT.”

This tells a very different story from the customary propaganda. Pinter, of course, is very astute on the question of the crematory being represented as a gas chamber. This is a frequent ploy because no such thing as a gas chamber had ever been shown to exist in these

camps, hence the deliberately misleading term a “gas oven”, aimed at confusing a gas chamber with a crematorium. The latter, usually a single furnace and similar to the kind of thing employed today, were used quite simply for the cremation of those persons who had died from various natural causes within the camp, particularly infectious diseases. This fact was conclusively proved by the German archbishop, Cardinal Faulhaber of Munich. He informed the Americans that during the Allied air raids on Munich in September 1944, 30,000 people were killed. The archbishop requested the authorities at the time to cremate the bodies of the victims in the crematorium at Dachau. But he was told that, unfortunately, this plan could not be carried out; the crematorium, having only one furnace, was not able to cope with the bodies of the air-raid victims. Clearly, therefore, it could not have coped with the 238,000 Jewish bodies which were allegedly cremated there. In order to do so, the crematorium would have to be kept going for 236 years without stopping and 530 tons of ashes would have been recovered.

#### CASUALTY FIGURES REDUCED

THE FIGURES OF DACHAU CASUALTIES ARE TYPICAL OF THE KIND OF EXAGGERATIONS THAT HAVE SINCE HAD TO BE DRASTICALLY REVISED. IN 1946, A MEMORIAL PLAQUE WAS UNVEILED AT DACHAU BY PHILIP AUERBACH, THE JEWISH STATE-SECRETARY IN THE BAVARIAN GOVERNMENT WHO WAS CONVICTED FOR EMBEZZLING MONEY WHICH HE CLAIMED AS COMPENSATION FOR NON-EXISTENT JEWS. THE PLAQUE READ: “THIS AREA IS BEING RETAINED AS A SHRINE TO THE 238,000 INDIVIDUALS WHO WERE CREMATED HERE.” SINCE THEN, THE OFFICIAL CASUALTY FIGURES HAVE HAD TO BE STEADILY REVISED DOWNWARDS, AND NOW STAND AT ONLY 20,600, THE MAJORITY FROM TYPHUS AND STARVATION ONLY AT THE END OF THE WAR. THIS DEFLATION, TO TEN PERCENT OF THE ORIGINAL FIGURE, WILL DOUBTLESS CONTINUE, AND ONE DAY WILL BE APPLIED TO THE LEGENDARY FIGURE OF SIX MILLION AS A WHOLE.

Another example of drastic revision is the present estimate of Auschwitz casualties. The absurd allegations of three or four million deaths there are no longer plausible even to Reitlinger. He now puts the number of casualties at only 600,000; and although this figure is still exaggerated in the extreme, it is a significant reduction on four million and further progress is to be expected. Shirer himself quotes Reitlinger’s latest estimate, but he fails to reconcile this with his earlier statement that half of that figure, about 300,000 Hungarian Jews, were supposedly “done to death in forty-six days”—a supreme example of the kind of irresponsible nonsense that is written on this subject.

#### HUMANE CONDITIONS

That several thousand camp inmates did die in the chaotic final months of the War brings us to the question of their wartime conditions. These have been deliberately falsified in innumerable books of an extremely lurid and unpleasant kind. The Red Cross Report, examined below, demonstrates conclusively that throughout the War the camps were well administered. The working inmates received a daily ration even

throughout 1943 and 1944 of not less than 2,750 calories, which was more than double the average civilian ration in occupied Germany in the years after 1945. The internees were under regular medical care and those who became seriously ill were transferred to hospitals. All internees, unlike those in Soviet camps, could receive parcels of food, clothing and pharmaceutical supplies from the Special Relief Division of the Red Cross. The office of the Public Prosecutor conducted thorough investigations into each case of criminal arrest and those found innocent were released; those found guilty, as well as those deportees convicted of major crimes within the camp, were sentenced by military courts and executed. In the Federal Archives of Koblenz there is a directive of January 1943 from Himmler regarding such executions, stressing that “no brutality is to be allowed” (Manvell & Frankl, *ibid*, p. 312). Occasionally there was brutality, but such cases were immediately scrutinized by S.S. Judge Dr. Konrad Morgen of the Reich Criminal Police Office, whose job was to investigate irregularities at the various camps. Morgen himself prosecuted Commander Koch of Buchenwald in 1943 for excesses at his camp, a trial to which the German public were invited. It is significant that Oswald Pohl, the administrator of the concentration camp system who was dealt with so harshly at Nuremberg, was in favor of the death penalty for Koch. In fact, the S.S. court did sentence Koch to death, but he was given the option of serving on the Russian Front. Before he could do this, however, Prince Waldeck, the leader of the S.S. in the district, carried out his execution. This case is ample proof of the seriousness with which the S.S. regarded unnecessary brutality. Several S.S. court actions of this kind were conducted in the camps during the War to prevent excesses and more than 800 cases were investigated before 1945. Morgen testified at Nuremberg that he discussed confidentially with hundreds of inmates the prevailing conditions in the camps. He found few that were undernourished except in the hospitals, and noted that the pace and achievement in compulsory labor by inmates was far lower than among German civilian workers.

The evidence of Pinter and Cardinal Faulhaber has been shown to disprove the claims of extermination at Dachau, and we have seen how the casualty figures of the camp have been continuously revised downwards. The camp at Dachau near Munich, in fact, may be taken as fairly typical of these places of internment. Compulsory labor in the factories and plants was the order of the day, but the communist leader Ernst Ruff testified in his Nuremberg affidavit of April 18<sup>th</sup>, 1947 that the treatment of prisoners on the work details and in the camp of Dachau remained humane. The Polish underground leader, Jan Piechowiak, who was at Dachau from May 22<sup>nd</sup>, 1940 until April 29<sup>th</sup>, 1945 also testified on March 21<sup>st</sup>, 1946 that prisoners there received good treatment and that the S.S. personnel at the camp were “well disciplined”. Berta Schirotschin, who worked in the food service at Dachau throughout the War, testified that the working inmates, until the beginning of 1945 and despite increasing privation in Germany, received their customary second breakfast at 10 a.m. every morning.

In general, hundreds of affidavits from Nuremberg testify to the humane conditions prevailing in concentration camps, but emphasis was invariably laid on those which reflected badly on the German



Administration and could be used for propaganda purposes. A study of the documents also reveals that Jewish witnesses who resented their deportation and internment in prison camps tended to greatly exaggerate the rigours of their condition, whereas other nationals interned for political reasons, such as those cited above, generally presented a more balanced picture. In many cases, prisoners such as Charlotte Bormann, whose experiences did not accord with the picture presented at Nuremberg, were not permitted to testify.

#### UNAVOIDABLE CHAOS

THE ORDERLY SITUATION PREVAILING IN THE GERMAN CONCENTRATION CAMPS SLOWLY BROKE DOWN IN THE LAST FEARFUL MONTHS OF 1945. THE RED CROSS REPORT OF 1948 EXPLAINS THAT THE SATURATION BOMBING BY THE ALLIES PARALYZED THE TRANSPORT AND COMMUNICATIONS SYSTEM OF THE REICH; NO FOOD REACHED THE CAMPS AND STARVATION CLAIMED AN INCREASING NUMBER OF VICTIMS, BOTH IN PRISON CAMPS AND AMONG THE CIVILIAN POPULATION OF GERMANY. THIS TERRIBLE SITUATION WAS COMPOUNDED IN THE CAMPS BOTH BY GREAT OVERCROWDING AND THE CONSEQUENT OUTBREAK OF TYPHUS EPIDEMICS. OVERCROWDING OCCURRED AS A RESULT OF PRISONERS FROM THE EASTERN CAMPS SUCH AS AUSCHWITZ BEING EVACUATED WESTWARD BEFORE THE RUSSIAN ADVANCE; COLUMNS OF SUCH EXHAUSTED PEOPLE ARRIVED AT SEVERAL GERMAN CAMPS SUCH AS BELSEN AND BUCHENWALD, WHICH HAD THEMSELVES REACHED A STATE OF GREAT HARDSHIP.

The Belsen Camp near Bremen was in an especially chaotic condition in these months and Himmler's physician, Felix Kersten, an anti-Nazi, explains that its unfortunate reputation as a "death camp" was due solely to the ferocity of the typhus epidemic which broke out there in March 1945 (*Memoirs 1940-1945*, London, 1956). Undoubtedly these fearful conditions cost several thousand lives, and it is these conditions that are represented in the photographs of emaciated human beings and heaps of corpses which the propagandists delight in showing, claiming that they are victims of "extermination".

A surprisingly honest appraisal of the situation at Belsen in 1945 appeared in Purnell's *History of the Second World War* (Vol. 7, No. 15) by Dr. Russell Barton, now Superintendent and consultant psychiatrist at Severalls Hospital, Essex, who spent one month at the camp as a medical student after the War. His account vividly illustrates the true causes of the mortality that occurred in such camps towards the War's end, and how such extreme conditions came to prevail there. Dr. Barton explains that Brigadier Glyn Hughes, the British Medical Officer who took command of Belsen in 1945, "did not think there had been any atrocities in the camp" despite discipline and hard work. "Most people," writes Dr. Barton, "attributed the conditions of the inmates to deliberate intention on the part of the Germans... Inmates were eager to cite examples of brutality and neglect, and visiting journalists from different countries interpreted the situation according to the needs of propaganda at

home."

However, Dr. Barton makes it quite clear that the conditions of starvation and disease were unavoidable in the circumstances, and that they occurred only during the months of 1945. "From discussions with prisoners it seemed that conditions in the camp were not too bad until late 1944. The huts were set among pine trees and each was provided with lavatories, wash basins, showers and stoves for heating." THE CAUSE OF FOOD SHORTAGE IS ALSO EXPLAINED. "GERMAN MEDICAL OFFICERS TOLD ME THAT IT HAD BEEN INCREASINGLY DIFFICULT TO TRANSPORT FOOD TO THE CAMP FOR SOME MONTHS. ANYTHING THAT MOVED ON THE AUTOBAHNS WAS LIKELY TO BE BOMBED... I WAS SURPRISED TO FIND RECORDS, GOING BACK TO TWO OR THREE YEARS, OF LARGE QUANTITIES OF FOOD COOKED DAILY FOR DISTRIBUTION. AT THAT TIME I BECAME CONVINCED, CONTRARY TO POPULAR OPINION, THAT THERE HAD NEVER BEEN A POLICY OF DELIBERATE STARVATION. THIS WAS CONFIRMED BY THE LARGE NUMBERS OF WELL-FED INMATES. WHY THEN WERE SO MANY PEOPLE SUFFERING FROM MALNUTRITION?... THE MAJOR REASONS FOR THE STATE OF BELSEN WERE DISEASE, GROSS OVERCROWDING BY CENTRAL AUTHORITY, LACK OF LAW AND ORDER WITHIN THE HUTS, AND INADEQUATE SUPPLIES OF FOOD, WATER AND DRUGS." The lack of order, which led to riots over food distribution, was quelled by British machine-gun fire and a display of force when British tanks and armored cars toured the camp.

Apart from the unavoidable deaths in these circumstances, Glyn Hughes estimated that about "1,000 were killed through the kindness of English soldiers giving them their own rations and chocolates." As a man who was at Belsen, Dr. Barton is obviously very much alive to the falsehood of concentration-camp mythology, and he concludes: "In trying to assess the causes of the conditions found in Belsen, one must be alerted to the tremendous visual display, ripe for purposes of propaganda, that masses of starved corpses presented." To discuss such conditions "naively in terms of 'goodness' and 'badness' is to ignore the constituent factors...".

#### FAKE PHOTOGRAPHS

Not only were situations such as those at Belsen unscrupulously exploited for propaganda purposes, but this propaganda has also made use of entirely fake atrocity photographs and films. The extreme conditions at Belsen applied to very few camps, indeed; the great majority escaped the worst difficulties and all their inmates survived in good health. As a result, outright forgeries were used to exaggerate conditions of horror. A startling case of such forgery was revealed in the British *Catholic Herald* of October 29<sup>th</sup>, 1948. It reported that in Cassel, where every adult German was compelled to see a film representing the "horrors" of Buchenwald, a doctor from Goettingen saw himself on the screen looking after the victims. But he had never been to Buchenwald. After an interval of bewilderment, he realized that what he had seen was part of a film taken after the terrible air raid on Dresden by the Allies on 13<sup>th</sup> February, 1945 where the doctor had been working. The film in question was shown in Cassel on 19<sup>th</sup> October, 1948. After the air raid on Dresden,

which killed a record 135,000 people, mostly refugee women and children, the bodies of the victims were piled and burned in heaps of 400 and 500 for several weeks. These were the scenes, purporting to be from Buchenwald, which the doctor had recognized.

The forgery of wartime atrocity photographs is not new. For further information the reader is referred to Arthur Ponsonby's book, *Falsehood in Wartime* (London, 1928), which exposes the faked photographs of German atrocities in the First World War. Ponsonby cites such fabrications as "The Corpse Factory" and "The Belgian Baby without Hands", which are strikingly reminiscent of the propaganda relating to Nazi "atrocities". F.J.P. VEALE EXPLAINS IN HIS BOOK THAT THE BOGUS "JAR OF HUMAN SOAP" SOLEMNLY INTRODUCED BY THE SOVIET PROSECUTION AT NUREMBERG WAS A DELIBERATE JIBE AT THE FAMOUS BRITISH "CORPSE FACTORY" MYTH, IN WHICH THE GHOULISH GERMANS WERE SUPPOSED TO HAVE OBTAINED VARIOUS COMMODITIES FROM PROCESSING CORPSES (Veal, *ibid*, p. 192). THIS ACCUSATION WAS ONE FOR WHICH THE BRITISH GOVERNMENT APOLOGIZED AFTER 1918. IT RECEIVED NEW LIFE AFTER 1945 IN THE TALE OF LAMP SHADES OF HUMAN SKIN, WHICH WAS CERTAINLY AS FRAUDULENT AS THE SOVIET "HUMAN SOAP". IN FACT, FROM MANVELL AND FRANKL WE HAVE THE GRUDGING ADMISSION THAT THE LAMP-SHADE EVIDENCE AT THE BUCHENWALD TRIAL "LATER APPEARED TO BE DUBIOUS" (*The Incomparable Crime*, p. 84). IT WAS GIVEN BY A CERTAIN ANDREAS PFAFFENBERGER IN A "WRITTEN AFFIDAVIT" OF THE KIND DISCUSSED EARLIER, BUT IN 1948, GENERAL LUCIUS CLAY ADMITTED THAT THE AFFIDAVITS USED IN THE TRIAL APPEARED AFTER MORE THOROUGH INVESTIGATION TO HAVE BEEN MOSTLY "HEARSAY".

An excellent work on the fake-atrocity photographs pertaining to the Myth of the Six Million is Dr. Udo Walendy's *Bild 'Dokumente' fur die Geschichtsschreibung?* (Vlotho/Weser, 1973), and from the numerous examples cited we illustrate one on this page [not included]. The origin of the first photograph is unknown but the second is a photomontage. Close examination reveals immediately that the standing figures have been taken from the first photograph, and a heap of corpses superimposed in front of them. The fence has been removed and an entirely new horror "photograph" created. This blatant forgery appears on page 341 of R. Schnabel's book on the S.S., *Macht ohne Moral: eine Dokumentation uber die SS* (Frankfurt, 1957), with the caption "Mauthausen". (Walendy cites eighteen other examples of forgery in Schnabel's book). The same photograph appeared in the *Proceedings of the International Military Tribunal*, Vol. XXX, p. 421, likewise purporting to illustrate Mauthausen Camp. It is also illustrated without a caption in Eugene Aroneanu's *Konzentrationslager Document F. 321 for the International Court at Nuremberg*; Heinz Kuhnrich's *Der KZ-Statt* (Berlin, 1960, p. 81); Vaclav Berdych's *Mauthausen* (Prague, 1959); and Robert Neumann's *Hitler—Aufstieg und Untergang des Dritten Reiches* (Munich, 1961).

#### 9. THE JEWS AND THE CONCENTRATION CAMPS: A FACTUAL APPRAISAL BY THE RED CROSS

There is one survey of the Jewish question in Europe during World War Two and the conditions of Germany’s concentration camps which is almost unique in its honesty and objectivity, the three-volume *Report of the International Committee of the Red Cross on its Activities during the Second World War*, Geneva, 1948. This comprehensive account from an entirely neutral source incorporated and expanded the findings of two previous works: *Documents sur l’Activité du CICR en Faveur des Civils Detenus dans les Camps de Concentration en Allemagne 1939-1945* (Geneva, 1946), and *Inter Arma Caritas: the Work of the ICRC During the Second World War* (Geneva, 1947). The team of authors, headed by Frederic Siordet, explained in the opening pages of the *Report* that their object, in the tradition of the Red Cross, had been strict political neutrality, and herein lies its great value.

The ICRC successfully applied the 1929 *Geneva Military Convention* in order to gain access to civilian internees held in Central and Western Europe by the German authorities. By contrast, the ICRC was unable to gain any access to the Soviet Union, which had failed to ratify the *Convention*. The millions of civilian and military internees held in the USSR, whose conditions were known to be by far the worst, were completely cut off limits from any international contact or supervision.

THE RED CROSS REPORT IS OF VALUE IN THAT IT FIRST CLARIFIES THE LEGITIMATE CIRCUMSTANCES UNDER WHICH JEWS WERE DETAINED IN CONCENTRATION CAMPS, I.E., AS ENEMY ALIENS. IN DESCRIBING THE TWO CATEGORIES OF CIVILIAN INTERNEES, THE REPORT DISTINGUISHES THE SECOND TYPE AS

“CIVILIANS DEPORTED ON ADMINISTRATIVE GROUNDS (IN GERMAN, ‘SCHUTZHAFTLINGE’) WHO WERE ARRESTED FOR POLITICAL OR RACIAL MOTIVES BECAUSE THEIR PRESENCE WAS CONSIDERED A DANGER TO THE STATE OR THE OCCUPATION FORCES” (Vol. III, p. 73). THESE PERSONS, IT CONTINUES, “WERE PLACED ON THE SAME FOOTING AS PERSONAS ARRESTED OR IMPRISONED UNDER COMMON LAW FOR SECURITY REASONS” (p. 74).

The *Report* admits that the Germans were at first reluctant to permit supervision by the Red Cross of people detained on grounds relating to security, but by the latter part of 1942, the ICRC obtained important concessions from Germany. They were permitted to distribute food parcels to major concentration camps in Germany from August 1942, and “from February 1943 onwards, this concession was extended to all other camps and prisons” (Vol. III, p. 78). The ICRC soon established contact with camp commandants and launched a food relief program which continued to function until the last months of 1945, letters of thanks for which came pouring in from Jewish internees.

**[H: As you accept this terrible lie, I hope that you are thinking ahead just a bit. How badly do you think the Jews WILL SUFFER in any wars to come? PITY THE JEWISH PEOPLE, FOR THEY, AGAIN, WILL REAP THE TERRIBLE REWARDS OF THE LIARS AND CHEATS OF HISTORICAL TRUTH.]**

#### RED CROSS RECIPIENTS WERE JEWS

The *Report* states that “As many as 9,000 parcels were packed DAILY. From the autumn of 1943 until May 1945, about 1,112,000 parcels with a total weight of 4,500 TONS were sent off to the concentration camps” (Vol III, p. 80). In addition to food, these contained clothing and pharmaceutical supplies. “Parcels were sent to Dachau, Buchenwald, Sangerhausen, Sachsenhausen, Oranienburg, Flossenburg, Landsberg-am-Lech, Floha, Ravensbruck, Hamburg-Novuengamme, Mauthausen, Thereisenstadt, Auschwitz, Bergen-Belsen, to camps near Vienna and in Central and Southern Germany. The principal recipients were Belgians, Dutch, French, Greeks, Italians, Norwegians, Poles and stateless Jews” (Vol. III, p. 83). In the course of the War, “The Committee was in a position to transfer and distribute in the form of relief supplies over twenty million Swiss francs collected by Jewish welfare organizations throughout the world, in particular by the American Joint Distribution Committee of New York” (Vol. I, p. 644). This latter organization was permitted by the German

Government to maintain offices in Berlin until the American entry into the War. The ICRC complained that obstruction of their vast relief operation for Jewish internees came not from the Germans but from the tight Allied blockade of Europe. Most of their purchases of relief food were made in Rumania, Hungary and Slovakia.

The ICRC had special praise for the liberal conditions which prevailed at Thereisenstadt up to the time of their last visits there in April 1945. This camp, “where there were about 40,000 Jews deported from various countries, was a relatively privileged ghetto” (Vol. III, p.75). According to the Report, “The Committee’s delegates were able to visit the camp at Theresienstadt (Terezin) which was used exclusively for Jews and was governed by special conditions. From information gathered by the Committee, this camp had been started as an experiment by certain leaders of the Reich... These men wished to give the Jews the means of setting up a communal life in a town under their own administration and possessing almost complete autonomy... two delegates were able to visit the camp on April 6<sup>th</sup>, 1945. They confirmed the favorable impression gained on the first visit” (Vol. I, p. 642).

The ICRC also had praise for the regime of Ion Antonescu of Fascist Rumania where the Committee was able to extend special relief to 183,000 Rumanian Jews until the time of the Soviet occupation. The aid then ceased, and the ICRC complained bitterly that it never succeeded “in sending anything whatsoever to Russia” (Vol. II, p. 62). The same situation applied to many of the German camps after their “liberation” by the Russians. The ICRC received a voluminous flow of mail from Auschwitz until the period of the Soviet occupation, when many of the internees were evacuated westward. But the efforts of the Red Cross to send relief to internees remaining at Auschwitz under Soviet control were futile. However, food parcels continued to be sent to former Auschwitz inmates transferred west to such camps as Buchenwald and Oranienburg.

#### NO EVIDENCE OF GENOCIDE

ONE OF THE MOST IMPORTANT ASPECTS OF THE RED CROSS REPORT IS THAT IT CLARIFIES THE TRUE CAUSE OF THOSE DEATHS THAT UNDOUBTEDLY OCCURRED IN THE CAMPS TOWARDS THE END OF THE WAR. SAYS THE REPORT: “IN THE CHAOTIC CONDITION OF GERMANY AFTER THE INVASION DURING THE FINAL MONTHS OF THE WAR, THE CAMPS RECEIVED NO FOOD SUPPLIES AT ALL AND STARVATION CLAIMED AN INCREASING NUMBER OF VICTIMS. ITSELF ALARMED BY THIS SITUATION, THE GERMAN GOVERNMENT AT LAST INFORMED THE ICRC ON FEBRUARY 1<sup>ST</sup>, 1945... IN MARCH 1945, DISCUSSIONS BETWEEN THE PRESIDENT OF THE ICRC AND GENERAL OF THE S.S. KALTENBRUNNER GAVE EVEN MORE DECISIVE RESULTS. RELIEF COULD

HENCEFORTH BE DISTRIBUTED BY THE ICRC, AND ONE DELEGATE WAS AUTHORIZED TO STAY IN EACH CAMP..." (Vol. III, p. 83). CLEARLY, THE GERMAN AUTHORITIES WERE AT PAINS TO RELIEVE THE DIRE SITUATION AS FAR AS THEY WERE ABLE. The Red Cross are quite explicit in stating that food supplies ceased at this time due to the Allied bombing of German transportation, and in the interests of interned Jews they had protested on March 15<sup>th</sup>, 1944 against "the barbarous aerial warfare of the Allies" (*Inter Arma Caritas*, p. 78). By October 2<sup>nd</sup>, 1944, the ICRC warned the German Foreign Office of the impending collapse of the German transportation system, declaring that starvation conditions for people throughout Germany were becoming inevitable.

IN DEALING WITH THIS COMPREHENSIVE, THREE-VOLUME REPORT, IT IS IMPORTANT TO STRESS THAT THE DELEGATES OF THE INTERNATIONAL RED CROSS FOUND NO EVIDENCE WHATEVER AT THE CAMPS IN AXIS-OCCUPIED EUROPE OF A DELIBERATE POLICY TO EXTERMINATE THE JEWS. IN ALL ITS 1,600 PAGES THE REPORT DOES NOT EVEN MENTION SUCH A THING AS A GAS CHAMBER. IT ADMITS THAT JEWS, LIKE MANY OTHER WARTIME NATIONALITIES, SUFFERED RIGOURS AND PRIVATIONS, BUT ITS COMPLETE SILENCE ON THE SUBJECT OF PLANNED EXTERMINATION IS AMPLE REFUTATION OF THE SIX MILLION LEGEND. LIKE THE VATICAN REPRESENTATIVES WITH WHOM THEY WORKED, THE RED CROSS FOUND ITSELF UNABLE TO INDULGE IN THE IRRESPONSIBLE CHARGES OF GENOCIDE WHICH HAD BECOME THE ORDER OF THE DAY.

So far as the genuine mortality rate is concerned, the *Report* points out that most of the Jewish doctors from the camps were being used to combat typhus on the Eastern Front, so that they were unavailable when the typhus epidemics of 1945 broke out in the camps (Vol I, p. 204 ff). Incidentally, it is frequently claimed that mass executions were carried out in gas chambers cunningly disguised as shower facilities. Again the *Report* makes nonsense of this allegation. "Not only the washing places, but installations for baths, showers and laundry were inspected by the delegates. They had often to take action to have fixtures made less primitive, and to get them repaired or enlarged (Vol. III, p. 594).

**[H: I ask that each of you readers GO FORTH AND GET ALL THE INFORMATION YOU CAN GLEAN ON "TYPHUS". THAT IS A REAL \$64,000 QUESTION, ISN'T IT? AND OH, YES, BY THE WAY, THESE VERY PEOPLE BY THE MILLIONS HAD TIME AND GOLD TO STASH IN ACCOUNTS IN SWISS BANKS! #### NOT ALL WERE INTERNED

Volume III of the *Red Cross Report*, Chapter 3 (I. Jewish Civilian Population) deals with the "aid given to the Jewish section of the free population", and this chapter makes it quite plain that by no means all of the European Jews were placed in internment camps, but remained, subject to certain restrictions, as part of the free civilian population. This conflicts directly with the "thoroughness" of the supposed "extermination program", and with the claim in the forged Hoess memoirs that Eichmann was obsessed with seizing "every single Jew he could lay his hands on". In Slovakia, for example, where Eichmann's assistant Dieter Wisliceny was in charge, the *Report* states that "A large proportion of the Jewish minority had permission to stay in the country, and at certain periods Slovakia was looked upon as a comparative haven of refuge for Jews, especially for those coming from Poland. Those who remained in Slovakia seem

to have been in comparative safety until the end of August 1944, when a rising against the German forces took place. While it is true that the law of May 15<sup>th</sup>, 1942 had brought about the internment of several thousand Jews, these people were held in camps where the conditions of food and lodging were tolerable, and where the internees were allowed to do paid work on terms almost equal to those of the free labor market" (Vol. I, p. 646).

Not only did large numbers of the three million or so European Jews avoid internment altogether, but the emigration of Jews continued throughout the War, generally by way of Hungary, Rumania and Turkey. Ironically, post-War Jewish emigration from German-occupied territories was also facilitated by the Reich, as in the case of the Polish Jews who had escaped to France before its occupation. "The Jews from Poland who, whilst in France, had obtained entrance permits to the United States were held to be American citizens by the German occupying authorities, who further agreed to recognize the validity of about three thousand passports issued to Jews by the consulates of South American countries" (Vol. I, p. 645). As future U.S. citizens, these Jews were held at the Vittel Camp in southern France for American aliens.

The emigration of European Jews from Hungary, in particular, proceeded during the War unhindered by the German authorities. "Until March 1944," says the *Red Cross Report*, "Jews who had the privilege of visas for Palestine were free to leave Hungary" (Vol. I, p. 648). Even after the replacement of the Horthy Government in 1944 (following its attempted armistice with the Soviet Union) with a government more dependent on German authority, the emigration of Jews continued. The Committee secured the pledges of both Britain and the United States "to give support by every means to the emigration of Jews from Hungary", and from the U.S. Government the ICRC received a message stating that "The Government of the United States... now specifically repeats its assurance that arrangements will be made by it for the care of all Jews who in the present circumstances are allowed to leave" (Vol. I, p. 649).

### 10. THE TRUTH AT LAST: THE WORK OF PAUL RASSINIER

WITHOUT DOUBT THE MOST IMPORTANT CONTRIBUTION TO A TRUTHFUL STUDY OF THE EXTERMINATION QUESTION HAS BEEN THE WORK OF THE FRENCH HISTORIAN, PROFESSOR PAUL RASSINIER. THE PREEMINENT VALUE OF THIS WORK LIES FIRSTLY IN THE FACT THAT RASSINIER ACTUALLY EXPERIENCED LIFE IN THE GERMAN CONCENTRATION CAMPS, AND ALSO THAT, AS A SOCIALIST INTELLECTUAL AND ANTI-NAZI, NOBODY COULD BE LESS INCLINED TO DEFEND HITLER AND NATIONAL SOCIALISM. YET, FOR THE SAKE OF JUSTICE AND HISTORICAL TRUTH, RASSINIER SPENT THE REMAINDER OF HIS POST-WAR YEARS UNTIL HIS DEATH IN 1966 PURSUING RESEARCH WHICH UTTERLY REFUTED THE MYTH OF THE SIX MILLION AND THE LEGEND OF NAZI DIABOLISM.

From 1933 until 1943, Rassinier was a professor of history in the College d’Enseignement Generale at Belfort, Academie de Besancon. During the War he engaged in resistance activity until he was arrested by the Gestapo on October 30<sup>th</sup>, 1943, and as a result was confined in the German concentration camps at Buchenwald and Dora until 1945. At Buchenwald, towards the end of the War, he contracted typhus, which so damaged his health that he could not resume his teaching. After the War, Rassinier was awarded the Medaille de la Résistance and the Reconnaissance Française, and was elected to the French Chamber of Deputies, from which he was ousted by the communists in November 1946.

Rassinier then embarked on his great work, a systematic analysis of alleged German war atrocities, in particular the supposed “extermination” of the Jews. Not surprisingly, his writings are little known; they have rarely been translated from the French and none at all have appeared in English. His most important works were: *Le Mensonge D’Ulysse (The Lies of Odysseus)*, Paris, 1949), an investigation of concentration-camp conditions based on his own experiences of them; and *Ulysse Trahi par les Siens* (1960), a sequel which further refuted the impostures of propagandists concerning German concentration camps. His monumental task was completed with two final volumes, *Le Véritable Procès Eichmann* (1962) and *Le Drame des Juifs Europeen* (1964), in which Rassinier exposes the dishonest and reckless distortions concerning the fate of the Jews by a careful statistical analysis. The last work also examines the political and financial significance of the extermination legend and its exploitation by Israel and the communist powers.

ONE OF THE MANY MERITS OF RASSINIER’S WORK IS EXPLODING THE MYTH OF UNIQUE GERMAN “WICKEDNESS”; AND HE REVEALS WITH DEVASTATING FORCE HOW HISTORICAL TRUTH HAS BEEN OBLITERATED IN AN IMPENETRABLE FOG OF PARTISAN PROPAGANDA. HIS RESEARCHES DEMONSTRATE CONCLUSIVELY THAT THE FATE OF THE JEWS DURING

WORLD WAR II, ONCE FREED FROM DISTORTION AND REDUCED TO PROPER PROPORTIONS, LOSES ITS MUCH VAUNTED "ENORMITY" AND IS SEEN TO BE ONLY ONE ACT IN A GREATER AND MUCH WIDER TRAGEDY. IN AN EXTENSIVE LECTURE TOUR IN WEST GERMANY IN THE SPRING OF 1960, PROFESSOR RASSINIER EMPHASIZED TO HIS GERMAN AUDIENCES THAT IT WAS HIGH TIME FOR A REBIRTH OF THE TRUTH REGARDING THE EXTERMINATION LEGEND AND THAT THE GERMANS THEMSELVES SHOULD BEGIN IT, SINCE THE ALLEGATION REMAINED A WHOLLY UNJUSTIFIABLE BLOT ON GERMANY IN THE EYES OF THE WORLD.

#### THE IMPOSTURE OF "GAS CHAMBERS"

Rassinier entitled his first book *The Lies of Odysseus* in commemoration of the fact that travelers always return bearing tall stories, and until his death he investigated all the stories of extermination literature and attempted to trace their authors. He made short work of the extravagant claims about gas chambers at Buchenwald in David Rousset's *The Other Kingdom* (New York, 1947); himself an inmate of Buchenwald, Rassinier proved that no such things ever existed there (*Le Mensonge d'Ulysse*, p. 209 ff). Rassinier also traced Abbe Jean-Paul Renard and asked him how he could possibly have testified in his book, *Chaines et Lumieres*, that gas chambers were in operation at Buchenwald. Renard replied that others had told him of their existence, and hence he had been willing to pose as a witness of things that he had never seen (Ibid, P. 209 ff).

Rassinier also investigated Denise Dufournier's *Ravensbruck: The Women's Camp of Death* (London, 1948) and again found that the authoress had no other evidence for gas chambers there than the vague "rumours" which Charlotte Bormann stated were deliberately spread by communist political prisoners. Similar investigations were made of such books as Philip Friedman's *This Was Auschwitz: The Story of a Murder Camp* (N.Y., 1946) and Eugene Kogon's *The Theory and Practice of Hell* (N.Y., 1950), and he found that none of these authors could produce an authentic eyewitness of a gas chamber at Auschwitz, nor had they themselves actually seen one. Rassinier mentions Kogon's claim that a deceased former inmate, Janda Weiss, had said to Kogon alone that she had witnessed gas chambers at Auschwitz. However, Kautsky only confirmed to Rassinier the confession in his book, namely that never at any time had he seen a gas chamber, and that he based his information on what others had "told him".

[H: It is, after all, a bit like in the Philippines, where the people espouse great and massive tunnels filled with gold and treasures and then almost none have actual information, but rely on the gossip and con-dealers who present the fabulous and fantastic tales of riches and plunder. The facts are, however, that there are riches and "plunder" beyond imagination, but every individual wants to be "among the ones" who prove it—when actually some are but petty thieves and con-men in their own daily existence. When they are told to produce or "nothing" from us, they usually run and hide. And

**WHO has provided these games in instruction and even provided forged and idiotic documents, which have actually been used to con as many as possible? NO, WE DO NOT PLAY IN THOSE GAMES, AS SOME ARE FINDING OUT THE VERY HARDEST WAY POSSIBLE—AT THE HANDS OF THEIR VERY OWN "TRICKED" VICTIMS.]**

The palm for extermination literature is awarded by Rassinier to Miklos Nyizli's *Doctor at Auschwitz*, in which the falsification of facts, the evident contradictions and shameless lies show that the author is speaking of places which it is obvious he has never seen (*Le Drame des Juifs Europeen*, p. 52). According to this "doctor of Auschwitz", 25,000 victims were exterminated every day for four-and-a-half years, which is a grandiose advance on Olga Lengyel's 24,000 a day for two-and-a-half years. It would mean a total of forty-one million victims at Auschwitz by 1945, two-and-a-half times the total pre-War Jewish population of the world. When Rassinier attempted to discover the identity of this strange "witness", he was told that "he had died some time before the publication of the book". Rassinier is convinced that he was never anything but a mythical figure.

[H: While we are on this topic, let's recall some of the horror tales of experiments, where even skin was taken from bones and bone grafts done without anesthetics and this was experienced daily, especially by twins. Well, the very ones bringing the claims had no scars on their legs, which were supposedly operated on every day. Response: Well, they had these methods of "healing", so scars were no longer visible.

And, how about the people caught with tattoos done with ink that was not even available in that day but is a modern and safer ink for tattooing today? Wouldn't YOU sit under anesthetic and receive some small numbers tattooed on your arm in exchange for a promise of life-long retributions of hundreds of thousands of dollars? Wow, people, we are continually amazed at the gullibility abounding. People will go readily to a tattoo artist and get all sorts of stupid things written on their skin, from snakes to butterflies, hearts and roses—FOR NOTHING except a lifelong wish that they hadn't done that. YOU WILL NEVER FIND AN UNSIGHTLY TATTOO, ESPECIALLY ON ANY LADY, MY FRIENDS. THE ONLY BOTCHED ONES ARE SELF-DONE WITH A BIT OF INDIA INK AND BY SOMEONE WHO WANTS IT TO LOOK MORE HORRIBLE THAN THE ORIGINALS WOULD HAVE APPEARED! It was, until they were caught at it, an effort to get the tattoos infected, so that there would be terrible scars to fit the horror-stories—BUT, the facts are that scars are about as good a forensic tool for dating a wound or infection as you can get—and the scars were not representing the "time" specified for the stories. So, again, these people have such a mandatory need to overdo that they disclose themselves in their very criminal activities.]

Since the War, Rassinier has, in fact, toured Europe in search of SOMEBODY who was an actual eyewitness of gas-chamber exterminations in German concentration camps during World War Two, but HE HAS NEVER FOUND EVEN ONE SUCH PERSON. HE DISCOVERED THAT NOT ONE OF THE

AUTHORS OF THE MANY BOOKS CHARGING THAT THE GERMANS HAD EXTERMINATED MILLIONS OF JEWS HAD EVEN SEEN A GAS CHAMBER BUILT FOR SUCH PURPOSES, MUCH LESS SEEN ONE IN OPERATION, NOR COULD ANY OF THESE AUTHORS PRODUCE A LIVING AUTHENTIC WITNESS WHO HAD DONE SO. Invariably, former prisoners such as Renard, Katutsky and Kogon based their statements not upon what they had actually seen, but upon what they "heard", always from "reliable" sources, who by some chance are almost always dead and thus not in a position to confirm or deny their statements.

CERTAINLY THE MOST IMPORTANT FACT TO EMERGE FROM RASSINIER'S STUDIES, AND OF WHICH THERE IS NOW NO DOUBT AT ALL, IS THE UTTER IMPOSTURE OF "GAS CHAMBERS". SERIOUS INVESTIGATIONS CARRIED OUT IN THE SITES THEMSELVES HAVE REVEALED WITH IRREFUTABLE PROOF THAT, CONTRARY TO THE DECLARATIONS OF THE SURVIVING "WITNESSES" EXAMINED ABOVE, NO GAS CHAMBERS WHATEVER EXISTED IN THE GERMAN CAMPS AT BUCHENWALD, BERGEN-BELSEN, RAVENSBRUCK, DACHAU AND DORA, OR MAUTHAUSEN IN AUSTRIA. THIS FACT, WHICH WE NOTED EARLIER WAS ATTESTED TO BY STEPHEN PINTER OF THE U.S. WAR OFFICE, HAS NOW BEEN RECOGNIZED AND ADMITTED OFFICIALLY BY THE INSTITUTE OF CONTEMPORARY HISTORY AT MUNICH. HOWEVER, RASSINIER POINTS OUT THAT IN SPITE OF THIS, "WITNESSES" AGAIN DECLARED AT THE EICHMANN TRIAL THAT THEY HAD SEEN PRISONERS AT BERGEN-BELSEN SETTING OUT FOR THE GAS CHAMBERS. So far as the eastern camps of Poland are concerned, Rassinier shows that the sole evidence attesting to the existence of gas chambers at Treblinka, Chelmno, Belzec, Maidanek and Sobibor are the discredited memoranda of Kurt Gerstein referred to above. His original claim, it will be recalled, was that an absurd 40 million people had been exterminated during the War, while in his first signed memorandum he reduced the number to 25 million. Further reductions were made in his second memorandum. These documents were considered of such dubious authenticity that they were not even admitted by the Nuremberg Court, though they continue to circulate in three different versions, one in German (distributed in schools) and two in French, none of which agree with each other. The German version featured as "evidence" at the Eichmann Trial in 1961.

Finally, Professor Rassinier draws attention to an important admission by Dr. Kubovy, Director of the World Centre of Contemporary Jewish Documentation at Tel Aviv, made in *La Terre Retrouvée*, December 15<sup>th</sup>, 1960. Dr. Kubovy recognized that not a single order for extermination exists from Hitler, Himmler, Heydrich or Goering (*Le Drame des Juifs Europeen*, p. 31, 19).

#### "SIX MILLION" FALSEHOOD REJECTED

As for the fearful propaganda figure of the Six Million, Professor Rassinier rejects it on the basis of an extremely detailed statistical analysis. He shows that

the number has been falsely established, on the one hand through inflation of the pre-War Jewish population by ignoring all emigration and evacuation, and on the other by a corresponding deflation of the number of survivors after 1945. This was the method used by the World Jewish Congress. Rassinier also rejects any written or oral testimony to the Six Million given by the kind of "witnesses" cited above, since they are full of contradictions, exaggerations and falsehoods. He gives the example of Dachau casualties, noting that in 1946, Pastor Niemoller reiterated Auerbach's fraudulent "238,000" deaths there, while in 1962 Bishop Neuhausseler of Munich stated in a speech at Dachau that only 30,000 people died "of the 200,000 persons from thirty-eight nations who were interned there" (*Le Drame des Juifs Europeen*, p. 12). Today, the estimate has been reduced by several more thousands, and so it goes on. Rassinier concludes, too, that testimony in support of the Six Million given by accused men such as Hoess, Hoettl, Wisliceny and Hoellriegel, who were faced with the prospect of being condemned to death or with the hope of obtaining a reprieve, and who were frequently tortured during their detention, is completely untrustworthy.

Rassinier finds it very significant that the figure of Six Million was not mentioned in court during the Eichmann Trial. "The prosecution at the Jerusalem trial was considerably weakened by its central motif, the six million European Jews alleged to have been exterminated in gas chambers. It was an argument that easily won conviction the day after the War ended, amidst the general state of spiritual and material chaos. Today, many documents have been published which were not available at the time of the Nuremberg Trials, and which tend to prove that if the Jewish nationals were wronged and persecuted by the Hitler regime, there could not possibly have been six million victims" (ibid, p. 125).

WITH THE HELP OF ONE HUNDRED PAGES OF CROSSCHECKED STATISTICS, PROFESSOR RASSINIER CONCLUDES IN *LE DRAME DES JUIFS EUROPEEN* THAT THE NUMBER OF JEWISH CASUALTIES DURING THE SECOND WORLD WAR COULD NOT HAVE EXCEEDED 1,200,000. HOWEVER, HE REGARDS SUCH A FIGURE AS A "MAXIMUM" LIMIT.

**[H: May I please go on record right here and now: The greatest casualty of this preposterous LIE is that the Jewish people will never again be recognized as in any way, shape or form as truthful. TRUTH IS THAT WHICH DIED AMONG THE JEWS WITH THE HOLOCAUST!]**

#### EMIGRATION: THE FINAL SOLUTION

Prof. Rassinier is emphatic in stating that the German Government never had any policy other than the emigration of Jews overseas. He shows that after the promulgation of the Nuremberg Race Laws in September 1935, the Germans negotiated with the British for the transfer of German Jews to Palestine on the basis of the *Balfour Declaration*. When this failed, they asked other countries to take charge of them, but these refused (ibid, p. 20). The Palestine project was revived in 1938, but broke down because Germany could not negotiate their departure on the basis of 3,000,000 marks, as demanded by Britain, without

some agreement for compensation. Despite these difficulties, Germany did manage to secure the emigration of the majority of their Jews, mostly to the United States. Rassinier also refers to the French refusal of Germany's Madagascar plan at the end of 1940. "In a report of the 21<sup>st</sup> August, 1942, the Secretary of State for the Ministry of Foreign Affairs of the Third Reich, Luther, decided that it would be possible to negotiate with France in this direction and described conversations which had taken place between July and December 1940, and which were brought to a halt following the interview with Montoire on 13<sup>th</sup> December 1940 by Pierre-Étienne Flandin, Laval's successor. During the whole of 1941 the Germans hoped that they would be able to reopen these negotiations and bring them to a happy conclusion" (ibid, p. 108).

After the outbreak of war, the Jews, who, as Rassinier reminds us, had declared economic and financial war on Germany as early as 1933, were interned in concentration camps, "which is the way countries all over the world treat enemy aliens in time of war... It was decided to regroup them and put them to work in one immense ghetto which, after the successful invasion of Russia, was situated towards the end of 1941 in the so-called Eastern territories near the former frontier between Russia and Poland: at Auschwitz, Chelmno, Belzec, Maidanek, Treblinka etc... There they were to wait until the end of the War for the reopening of international discussions which would decide their future" (*Le Véritable Procès Eichmann*, p. 20). The order for this concentration in the eastern ghetto was given by Goering to Heydrich, as noted earlier, and it was regarded as a prelude to "the desired final solution", their emigration overseas after the War had ended.

#### ENORMOUS FRAUD

Of great concern to Professor Rassinier is the way in which the extermination legend is deliberately exploited for political and financial advantage, and in this he finds Israel and the Soviet Union to be in concert. He notes how, after 1950, an avalanche of fabricated extermination literature appeared under the stamp of two organizations, so remarkably synchronized in their activities that one might well believe them to have been contrived in partnership. One was the "Committee for the Investigation of War Crimes and Criminals" established under communist auspices at Warsaw, and the other, the "World Centre of Contemporary Jewish Documentation" at Paris and Tel Aviv. Their publications seem to appear at favorable moments in the political climate, and for the Soviet Union their purpose is simply to maintain the threat of Nazism as a manoeuvre to divert attention from their own activities.

As for Israel, Rassinier sees the myth of the Six Million as inspired by a purely material problem. In *Le Drame des Juifs Europeen* (p. 31, 39), he writes: "It is simply a question of justifying by a proportionate number of corpses the enormous subsidies which Germany has been paying annually since the end of the War to the State of Israel by way of reparation for injuries which moreover she cannot be held to have caused her either morally or legally, since there was no State of Israel at the time the alleged deeds took place;

thus it is a purely and contemptibly material problem.

"PERHAPS I MAY BE ALLOWED TO RECALL HERE THAT THE STATE OF ISRAEL WAS ONLY FOUNDED IN MAY 1948 AND THAT THE JEWS WERE NATIONALS OF ALL STATES WITH THE EXCEPTION OF ISRAEL, IN ORDER TO UNDERLINE THE DIMENSIONS OF A FRAUD WHICH DEFIES DESCRIPTION IN ANY LANGUAGE; ON THE ONE HAND, GERMANY PAYS TO ISRAEL SUMS WHICH ARE CALCULATED ON SIX MILLION DEAD, AND ON THE OTHER, SINCE AS LEAST FOUR-FIFTHS OF THESE SIX MILLION WERE DECIDEDLY ALIVE AT THE END OF THE WAR, SHE IS PAYING SUBSTANTIAL SUMS BY WAY OF REPARATION TO THE VICTIMS OF HITLER'S GERMANY TO THOSE WHO ARE STILL ALIVE IN COUNTRIES ALL OVER THE WORLD OTHER THAN ISRAEL AND TO THE RIGHTFUL CLAIMANTS OF THOSE WHO HAVE SINCE DECEASED, WHICH MEANS THAT FOR THE FORMER (I.E. THE SIX MILLION) OR, IN OTHER WORDS, FOR THE VAST MAJORITY, SHE IS PAYING TWICE."

**[H: ONE OF THE POINTS ALWAYS MISSED HERE IS WHERE DOES THAT LEAVE OTHER PRISONERS WHO "WERE NOT JEWS"? WHO SEES TO THEIR NEEDS, THEIR RETRIBUTION?]**

#### CONCLUSION

Here we may briefly summarize the data on Jewish wartime casualties.

Contrary to the figure of over 9 million Jews in German-occupied territory put forward at the Nuremberg and Eichmann trials, it has already been established that after extensive emigration, approximately 3 million were living in Europe, excluding the Soviet Union. Even when the Jews of German-occupied Russia are included (the majority of Russian Jews were evacuated beyond German control), the overall number probably does not exceed four million. Himmler's statistician, Dr. Richard Korherr and the World Centre of Contemporary Jewish Documentation put the number respectively at 5,550,000 and 5,294,000 when German-occupied territory was at its widest, but both these figures include the two million Jews of the Baltic and western Russia without paying any attention to the large number of these who were evacuated. However, it is at least an admission from the latter organization that there were not even six million Jews in Europe and western Russia combined.

Nothing better illustrates the declining plausibility of the Six Million legend than the fact that the prosecution at the Eichmann Trial deliberately avoided mentioning the figure. Moreover, official Jewish estimates of the casualties are being quietly revised downwards. Our analysis of the population and emigration statistics, as well as the studies by the Swiss *Baseler Nachrichten* and Professor Rassinier, demonstrate that it would have been simply IMPOSSIBLE for the number of Jewish casualties to have exceeded a limit of one-and-a-half million.

DOUBTLESS, SEVERAL THOUSAND JEWISH PERSONS DID DIE IN THE COURSE OF THE SECOND WORLD WAR, BUT THIS MUST BE

SEEN IN THE CONTEXT OF A WAR THAT COST MANY MILLIONS OF INNOCENT VICTIMS ON ALL SIDES. TO PUT THE MATTER IN PERSPECTIVE, FOR EXAMPLE, WE MAY POINT OUT THAT 700,000 RUSSIAN "CIVILIANS" DIED DURING THE SIEGE OF LENINGRAD, AND A TOTAL OF 2,050,00 GERMAN CIVILIANS WERE KILLED IN ALLIED AIR RAIDS AND FORCED REPATRIATION AFTER THE WAR.

The question most pertinent to the extermination legend is, of course: How many of the 3 million European Jews under German control survived after 1945? The Jewish Joint Distribution Committee estimated the number of survivors in Europe to be only one-and-a-half million, but such a figure is now totally unacceptable. This is proved by the growing number of Jews claiming compensation from the West German Government for having allegedly suffered between 1939 and 1945, the number of these claimants registered with the West German Government tripled in ten years and reached 3,375,000 (*Aufbau*, June 30<sup>th</sup>, 1965). NOTHING COULD BE A MORE DEVASTATING PROOF OF THE BRAZEN FANTASY OF THE SIX MILLION. MOST OF THESE CLAIMANTS ARE JEWS, SO THERE CAN BE NO DOUBT THAT THE MAJORITY OF THE 3 MILLION JEWS WHO EXPERIENCED THE NAZI OCCUPATION OF EUROPE ARE, IN FACT, VERY MUCH ALIVE. IT IS A RESOUNDING CONFIRMATION OF THE FACT THAT JEWISH CASUALTIES DURING THE SECOND WORLD WAR CAN ONLY BE ESTIMATED AT A FIGURE IN THOUSANDS. SURELY THIS IS ENOUGH GRIEF FOR THE JEWISH PEOPLE? WHO HAS THE RIGHT TO COMPOUND IT WITH VAST IMAGINARY SLAUGHTER, MARKING WITH INTERNATIONAL SHAM A GREAT EUROPEAN NATION, AS WELL AS WRINGING FRAUDULENT MONETARY COMPENSATION FROM THEM?

### CHAPTER 11

#### GOVERNED BY SHADOWS

Before anything else, I wish to emphasize that the testimony which will follow later in the chapter is not written to criticize anyone, but simply focuses on the power that this "alien group" holds over this country. The very same people who claim to have given us our freedom and democracy have forced us to pay heavily for their parasitic way of life, living off us like vampires, unable to exist on their own without having to suck the blood from their helpless victims.

As Christians and Muslims, it is incumbent upon us to support the powers-that-be, as long as they are under duly constituted authority and do not cause us to do things contrary to our professed faith. But these "hidden hands" do not want us to follow what our religion teaches, since it leads to a nationalistic "mindset" which diametrically opposes that of the New World Order. This they have demonstrated many times over, as we have witnessed the rise and fall of our patriotic leaders. For example, in his book *Behind the Lodge Door*, Paul A. Fisher notes the demands these hidden hands imposed on President Manuel L. Quezon. They urged him to submit absolute allegiance to their cause by joining the secret society of conspirators. The fiery Chief Executive declined to accept the offer because he feared that joining their cause may force him to act contrary to the interests of his own people. "I would rather see this country run like hell by Filipinos," was his stinging reply. Shortly thereafter, the Philippines found itself dragged into a terrible war orchestrated by these 20<sup>th</sup>-Century Jacobins. Rear Admiral Theobald made it clear in his bestseller, *The Final Secret of Pearl Harbor*, that the Roosevelt gang knew well in advance of the impending Japanese attack on Pearl Harbor, but did nothing to prevent it. The information was relayed by Brigadier General Elliott R. Thorpe, who was then Chief of Counter-Intelligence under General Douglas MacArthur, but he was not taken seriously. The devastation suffered by millions of Filipinos was too much for Quezon to bear. He died of tuberculosis at a U.S. Army hospital. Ditto was the charismatic mechanic from Zambales, Ramon "the Guy" Magsaysay, whose dream of making the Philippines a great democratic nation upset the timetable of the globalists, who secretly supported the Huk forces of socialist subalterns like Luis Taruc, Jesus Lava and many others. Magsaysay's well-trained intelligence units broke the back of the communist movement. He, like Quezon before him, had to go way before his time. On his way to Cebu on board the presidential plane *Mount Pinatubo*, the overloaded aircraft mysteriously plunged into a mountain and crashed. Only one of the passengers, Nestor Mata, survived. He now writes for the *Manila Standard*. It was Benjamin Disraeli, British Prime Minister (1874-80), who said that "the world is governed by very different personages to what is

imagined by those who are not behind the scenes." Later, U.S. President Franklin D. Roosevelt was to confirm this by stating that "nothing accidental ever happens in politics". Still, many of our scholars ignored these warnings and continued to believe in the accidental theory of history, dismissing any information to prove otherwise. As a consequence, these mal-educated political scientists and historians do not enjoy a broad database for serious study and evaluation, and the goings-on behind the scenes.

Today our country still reels from the continuous assault of the One-Worlders, whose latest concocted novelty on Philippine shores is the "people power" revolution of 1986, led by the troika of the inept Corazon Aquino, the wily Cardinal Jaime Sin and the unassuming West Pointer Fidel V. Ramos. Under Cory's aimless leadership, the Philippines became the basket case of Asia. Naturally, this socio-economic holocaust was never properly presented to the rest of the world by the globalist-controlled media. Instead, what was painted was a vibrant, post-Marcos nation, which would soon be transformed into a "tiger" by the year 2000. Unless our people are told of the dangers which lurk around the corner, there will be no political resurrection for the future generations of Filipinos—only never-ending subjugation by China, the Dragon of the East.

I have continually been asked the following set of questions. I have arranged them in such fashion so as to make known exactly what I knew of the events surrounding the pressures besetting the late strongman in his last few days in Malacanang:

Q: From your direct knowledge, what events or conversations with certain personalities indicated foreign complicity in the EDSA Revolution and its connection to the Marcos gold? Who were the gainers and why?

A: During the latter stages of the Marcos regime, I came to be friends with James Brandon Foley, a political officer (another term for CIA agents at that time) of the U.S. Embassy. We used to go out and date several women, sometimes to discos and the like. Our favorite hangout was the Hyatt Regency. In between socials, Jim and I would engage in frequent brainstorming at his private apartment at the Seafont. On one particular night, he disclosed to me that there was a secret operation plan to oust Marcos, and that men like Jose Concepcion of RFM and the Ayalas were being used as conduits to access the smooth flow of funds to finally bring an end to the Marcos authoritarian government. (Re James Brandon Foley: I am constrained to break my pledge to preserve the anonymity of my sources because without any attribution to an authoritative source, this revelation will be nothing but hearsay. My apologies. I sincerely hope he will understand, given the situation I am in and the position I am in and the position I have taken.)

Jim likewise mentioned the involvement of Cardinal Jaime Sin, whose role was to draw a large crowd of supporters and sympathizers in the event that a blocking force was needed. Sin is an expert in the Antonio Gramsci-type of Marxism. This was confirmed by Dr. John Coleman in his exposé *The Violation of the Christian Church*, where he stated that Sin's Radio Veritas "speaks out Communist propaganda in 13 languages all throughout Asia", using Liberation Theology to destroy the moral fiber



of the large number of Catholics. Sin believes in the Marxist principle that “Religion is the opium of the masses”. He exploited this tactic to the hilt and succeeded in what is now called “people power” mass action. As acknowledged by Coleman, “Cardinal Sin of the Philippines worked diligently to overthrow the Government of President Marcos. He was ably assisted by a former executive of the World Council of Churches, Jovito Salonga. Salonga was brought back to the Philippines under escort of the U.S. State Department.”—*CDC Report*, October 1988

In Coleman’s estimation, Salonga was to take Mrs. Aquino and this Protestant “will cut a deal with the Marxist New people’s Army (NPA)”. Although this did not materialize because of Salonga’s poor health, Coleman was still partly correct. Another fellow Protestant filled in his shoes (Fidel V. Ramos) and has quite successfully negotiated peace with the communists!

Q: What events preceding Marcos’ announcement of the snap election proved that he was under American pressure? Why do you think he acceded to the “request”?

A: Everything really hinged on the Marcos gold bars. The Trilateral Commission, through its Chairman, David Rockefeller, and member George Schultz, were convinced that they had been conned by President Marcos. This being so, the Trilateralists did everything to pressure him, to destabilize his one-man rule, cut his source of funding and even blackmail him (the Dovie Beams affair). A part of the globalists’ notorious activities was documented by David Smith of the U.S.-based *NEWSWATCH* magazine in August 1987: “Representatives from Indonesia and the Philippines went to Jonathan May (ex-World Bank head) and stated that agents from the Chase Manhattan Bank and other banks said they would ‘forgive’ the loans and interests if the following were met: (1) Eliminate their National Currency; (2) Dollar-denominate their new money system; (3) Use a debit card instead of a currency system, and (4) Give the bankers perpetual rights over all natural resources. Ferdinand Marcos of the Philippines refused to accept and was deposed very shortly thereafter.”—*Final Steps to Collapse*, p.3

Marcos eventually gave in to the globalists’ proposal for a snap election, using veteran “ambush interview” expert Ted Koppel of CBS. Clever as he was, Marcos did not reveal to the Americans that prior to his interview with Koppel, he had already conducted a secret survey of the electorate. Despite the adverse media hype launched against him, Marcos was confident of re-election.

However, Jim Foley (who was later transferred to Algiers) disclosed that the real agenda was not the snap election; rather, it was to persuade Marcos to sign a document attesting to the fact that his gold bars and other precious metals deposited at Fort Knox and other depositories of the world would be under the guardianship of the Trilateral Commission, and a certain percentage would be given to the Philippine Government in the form of an investment loan from the World Bank.

The document was subsequently hand-carried by U.S. Ambassador-at-Large Philip Habib, which Marcos refused to sign. The Filipino head of state felt that the war loot (which was remolded into gold bars bearing the Central Bank seal) must be given to the Filipino people.

Q: How was the Americans’ influence exerted during the snap election? Was there American involvement in the walkout of the computer workers?

A: First, there was the barrage of disinformation launched by *Newsweek*, *Time* and other publications regarding the illicit love affairs of both Marcos and the First Lady (e.g., George Hamilton), the incurable ailment of

the President, and the public confidence in Namfrel and distrust in the Comelec. Then came the walkout of the computer workers at the PICC. These were all part of the U.S. scenario during the snap election.

Most of the computer workers were promised visas and immigrant status to the U.S. Some of them, I understand, took advantage of this rare opportunity.

Q: Did any of your contacts know about the outbreak of the mutiny at EDSA?

A: Both Jim Foley and Norbert Garrett, CIA Station Chief, U.S. Embassy, predicted a bloody confrontation in the event that Marcos stubbornly decided to stay in Malacanang. The President’s only saving grace was the signing of the document brought by Habib.

Q: Who were pressuring Marcos to give in and leave? Is there any credible evidence that this happened?

A: The pressures came from both U.S. and Philippine sources. On the American side, there was Philip Habib. He was joined by U.S. Ambassador to the Philippines, Stephen Bosworth, Richard Armitage, Michael Armacost, Rep. Stephen Solarz, Norbert Garrett (CIA Station Chief in Manila) and Joseph Mussomelli (Anti-Fraud Section, U.S. Embassy). Senator Paul Laxalt, as you probably know, was the guy who spoke to Marcos on the phone and told him to “cut and cut cleanly”. Lines to Washington were kept busy by calls coming in from Lawrence Eagleburger and Henry Kissinger. Later on, I was told that operating funds came from Maurice “Hank” Greenberg, through dollar grants from the C.V. Starr Foundation of New York. Greenberg is a powerful member of the B’nai B’rith. Others like Higdon, Brzezinski and Generals Pike and Allen of JUSMAG also formed part of the American initiative to oust Marcos.

On the Philippine side were assets like Joe Concepcion, Jobo Fernandez, Cesar Zalamea, Jaime Ongpin and Alex Melchor. Journalists, likewise, were used for their media hype.

Q: Could you elaborate more on Habib’s role in the events that followed?

A: As I have earlier stated, Habib was sent by the Trilateralists to the Philippines to pressure Marcos into signing the document prepared in the U.S. It contained provisions of equal sharing of the gold bars among different countries (through their bankers in the Commission), transshipped by Marcos to Fort Knox and other depositories under a top-secret operation plan coded “*Tuna Highway*”. Initially, Marcos was supported by the Commission to implement martial law in 1972 and was even provided with a martial plan. Along with it came a minting plant, installed at the Central Bank premises by Thomas de la Rue Ltd. of London, and a smelting plant with which to convert the war booty into new gold bars. The Oplan [*Operational Plan Big Bird*] was executed by trusted generals of Marcos, who diverted some portions of the shipment to other destinations aside from Fort Knox. This was covered by a prescription period (November 1945 to November 1985) in accordance with international law. After this 40-year period, it was to be declared “finders keepers”. Some countries which felt conned by these agreements pursued their claim at the International Court of Justice, to mature in 2005.

Had Marcos chosen to sign the document, he would have remained President for life. In the process, he would have received the distinction of being “the best President we ever had”. In addition, the Philippines’ share could have paid our external debt of, at that time, \$24 billion, plus a comprehensive Marshall Plan for industrialization. (To date, our external debt has zoomed up to \$47 billion,

according to the latest BSP figures.) Instead, he chose the hard way and very badly miscalculated. He wanted to regroup his forces in the North, but was flown to Hawaii, instead.

Q: Were there contacts between the military camps and the embassy and/or Washington during the four days at EDSA?

A: Definitely. It has always been standard operating procedure for our military officials to “keep the line open” between them and the defense attachés of the U.S. Embassy. Most of our top-ranking officers have been nurtured in U.S. military schools. Some were even granted immigrant status in the U.S. while serving in the Armed Forces of the Philippines (AFP). Their families were granted entry to the exclusive clubs of the American Government, such as JUSMAG, Seafront, Clark Air Base, Subic Base, Camp John Hay, etc. There, they could avail [themselves] of clubhouse facilities, golf courses and other amenities.

After EDSA, most of the renegade Marcos generals migrated to the U.S. These are the ones who never resisted the Aquino-Ramos-Enrile-Sin forces.

Q: Why didn’t Marcos move during the first hours of the mutiny, when there were very few people around the camps?

A: Marcos was sternly warned not to harm the people at EDSA; otherwise, Malacanang would be targeted by the U.S. military sources. Thus, Marcos took the backseat and relied on the group of then-Col. Rolando Abadilla to finish the job for him. You see, Abadilla’s elite force from the MISG (Military Intelligence and Security Group), together with a SWAT team, successfully penetrated Camp Crame disguised as Ramos supporters. As soon as Marcos was confronted about this by his Chief-of-Staff, General Fabian Ver, the President simply advised the latter to relax, as Abadilla was in the process of arresting Defense Secretary Juan Ponce Enrile and his cousin, Fidel Ramos, whom the President underestimated as a gutless individual. Marcos never imagined that Abadilla would have a change of heart. Abadilla was the prime suspect as the chief operator of Ninoy’s death at the tarmac.

Q: How do you connect Cardinal Sin with the American plan?

A: Cory Aquino was instructed by Cardinal Sin to seek refuge in a Cebu convent. As the fireworks were about to start, Cory was to install her revolutionary government in Davao with the assistance of the RAM forces and her NPA sympathizers. This alternate plan was likewise designed by the CIA, with Col. Voltaire Gazmin given the role of securing Cory in Cebu.

This plan was totally discarded when Marcos peacefully left the Philippines, due to the insistence of Cardinal Sin, who was backed up all the way by the Vatican and the U.S. State Department. Cory ended up being the sole titular head.

What a political swindle!

Former President Fidel V. Ramos has learned the past presidents’ lessons very well, and has continuously taken extra great care so as not to repeat the same mistakes of our not-too-distant history. He is perceived to be an American boy (West Pointer) but his nationalism has grown day by day, in the lore of our very own Jose Rizal, and the world-class leader or neighbor like Dr. Mahathir of Malaysia.

## UN REPORT: SOVEREIGNTY CAN BE FORFEITED ON "HUMANITARIAN" GROUNDS

A United Nations University study of NATO's intervention in Kosovo said Monday a profound change in world politics has emerged, mainly that sovereignty can be forfeited on humanitarian grounds.

But the study co-edited by the Tokyo-based institution's Vice Rector, Ramesh Thakur, and Albrecht Schnabel with contributor Ray Funnel, a retired Australian air marshal, warned the precedent will have dangerously undermined international order, unless world powers can agree on principles to guide future interventions in similar circumstances. "Kosovo and The Challenge of Humanitarian Intervention" is billed as a "compendium of authoritative viewpoints on many dimensions of the 1999 crisis" and on recommended follow-up steps.

Those steps include promotion of "an international consensus about the point at which a state forfeits its sovereignty" and removal of veto power in the Security Council in exceptional circumstances "so that the support of a majority of the great powers is all that is required to permit states to engage in humanitarian war".

"Kosovo confronted us with an abiding challenge of humanitarian intervention: namely, is it morally just, legally permissible and militarily feasible?" asked Thakur. "In today's dangerously unstable world full of complex conflicts, concerned countries and citizens face the painful dilemma of being condemned if they do and damned if they don't.

"To use force unilaterally is to violate international law and undermine world order. Yet, to respect sovereignty all the time is to be complicit in human-rights violations sometimes. To argue that the UN Security Council must give its consent to humanitarian war is to risk policy paralysis by handing over the agenda to the most egregious and obstreperous..."

...Contributors, the authors said, cited the need to reform the Security Council, including possible removal of veto power in such circumstances as those present in Kosovo.

The UN General Assembly has been wrestling with Council reform for years now, including the status of veto for the present five permanent members of Britain, China, France, Russia and the United States, as well as any possible additions to the select club.

"The permanent members and their interests should not prevent the Security Council from getting involved and stall the UN's attempts to provide assistance to those in need. Otherwise, we might see more NATO-style actions with less or no UN involvement—and thus less order and less justice in our global community," said Schnabel, the other co-editor.

"It is good that the international system can tear down the walls of state sovereignty in cases where states kill their own people," he said. "Organizations like the UN, however, need to be willing and able to confront these catastrophes wherever they occur."

Russian and Chinese opposition to military intervention in Kosovo prevented the Security Council from acting, so NATO decided to intervene on its own.

Thakur said, "Many of today's wars are nasty, brutish

and internal. The world community cannot help all victims, but must step in where it can make a difference. Selective indignation is inevitable, for we simply cannot intervene everywhere, every time. But we must still pursue policies of effective indignation. Humanitarian intervention must be collective, not unilateral. And it must be legitimate, not in violation of the agreed rules which comprise the foundations of world order."

The study, released at UN headquarters in New York, said, "continuing fallout from Kosovo has the potential to redraw the landscape of international politics, with significant ramifications for the UN, major powers and regional organizations, and the way in which world politics are understood and interpreted."

That fallout was from parties involved in the conflict, NATO allies, the immediate region surrounding the conflict, and further.

"Any possible argument that NATO might underwrite European stability has lost validity for Russia," the study said.

China's concern that what happened in Yugoslavia may be repeated in Asia was also addressed.

"The problem of using force by the strong against the weak will only create disorder. While China does not want to challenge or compete with U.S. superiority, it rejects U.S. domination or hegemony," the UNU study said....

...Reflecting the positions of the Non-Aligned Movement and the Organization for African Unity in particular, the study concluded that unilateral intervention, no matter how noble the motive, is not acceptable. A broad, non-discriminatory multilateralism (in all areas, including trade and security) is the best safeguard for the developing world against unilateral misuse of power by the strong.

"For many developing countries, the international community runs the danger of becoming hostage to the machinations of a few privileged and powerful countries," the study said. "Many developing countries may feel compelled to move toward ensuring greater security for themselves through acquisition of more weaponry. There is almost total unanimity in India that the country needs to strengthen itself militarily to the extent that there can be no scope for any interference in the affairs on the subcontinent."

Critics of NATO's Kosovo action said in the study that international efforts to contain the conflict were "modest and hesitant. Later, faced with a brutal and rapidly escalating war, the international community reacted with consternation and confusion."

Said the study, "What was at stake was not only the fate of the Albanian population of Kosovo. It was also the standing and reputation of the major democratic countries involved in the NATO operation and the credibility of NATO itself."

## HIGH SCHOOL STUDENT WANTS ALTERNATIVE VIEWS OF HOLOCAUST TAUGHT

PITTSBURGH (AP)—High school Class President Robbie Joswiak wants revisionist views of the Holocaust taught in his Beaver County School District and that, said one teacher, is proof enough that students are not receiving enough information about Nazi Germany.

In a recent e-mail message to teacher Stephanie Mazzei, the high school senior argued that the number of European Jews killed in Nazi Germany may have been 1.1 million—not the six million deaths that are usually cited.

Mazzei, who teaches gifted students and lectures on the Holocaust, said Joswiak's views are proof that the Riverside Beaver County School District, with 2,067 students, needs to expand its Nazi-era classes.

"He told me what I was teaching was, in effect, folklore," said Mazzei, who has been a teacher in the district for 30 years. "That's what alarmed me."

Mazzei said Joswiak was familiar with her teachings but had never attended one of her seminars, which supplement the District's World War II studies. Joswiak told Mazzei that he'd read 13 books about the Holocaust, three of which challenged conventional information about the Nazi death camps.

Joswiak cited works by British historian David Irving as a reason why other views of the Holocaust should be taught. Irving, 62, disputes the number and manner of Jewish deaths in concentration camps.

But Nazi-era expert Simon Reich dismissed Irving's arguments.

"There is essentially no historical data in support of his claims," Reich, a University of Pittsburgh public policy professor, said Monday. "He perverts the notion that history provides you with a set of objective facts."

Citing Joswiak's e-mail message, Mazzei has urged the Riverside School Board to expand its teaching about the Holocaust, which currently does not reach every student. Joswiak, who has studied the Nazi era in Germany and Israel, offered to conduct more seminars, she said.

"The District supports what she is teaching," said Superintendent Mark King. "As far as we're concerned, the matter is closed."

Joswiak's father, Robert H. Joswiak, said his son would not be available to comment. But he said he supported his son's efforts.

"Obviously, there are forces at work today that are deliberately excluding this knowledge," Joswiak said. "What kind of education is this when it's one-sided?"

The elder Joswiak said Irving's beliefs should be presented with conventional Holocaust teachings. Mazzei said those beliefs demonstrate the importance of teaching what happened in Nazi Germany. "This story needs to be told," said Mazzei, "exactly what happened and why."

## AMERICAN SOLDIERS DESERT IN LARGE NUMBERS FROM KOSOVO AND METOHIJA

BELGRADE—Part of the U.S. Marines' contingent, a platoon, refused to go aboard a transport airplane on the Petrovac Airport in Skoplje a few days ago and leave for the military base of Bondstill in Urosevac as regular replacements.

The fact being speculated by so far unnamed Pentagon officials and, more and more, the American media—that young U.S. soldiers and their commanders are more often getting to “come face to face with their conscience” during the controversial United Nations’ military mission in Kosovo and Metohija—is now confirmed by data on deserting being “leaked”.

Instead of joining their troops within the KFOR and fulfilling their assignment—the ransacking of houses and apartments belonging to the few remaining Serbs in the American troops’ zone of responsibility—the Petrovac Airport “rebels” are already getting rigorous military therapy and extra education on patriotism and the American national interests in this part of the world...

...The atmosphere within the “Bondstill Fort” (the greatest American military base built after the Vietnam War) walls also testifies to the drop of morals among the American soldiers. There is no alcohol in Bondstill, but there is a pretty good market for condoms—in fact, they are selling like hot cakes. The soldiers admit that “sex is only forbidden if you get caught”.

Those who know the conditions in this part of Kosovo and Metohija see the need for condoms as linked with the “outside world” beyond the walls of the “Hollywood” fort, where other soldiers are on the go—notably members of the ethnic Albanian mob who deal in both heroin and White slavery: Young Albanian girls, sometimes no more than ten years old, are being abducted from their homes and recruited as prostitutes—one of the so-called KLA’s kind offers.

KFOR’s strength, with its wonderful foreign-currency logbooks, is an ideal opportunity for the Albanian pimps’ “business”.

So far, the spokespersons for the KFOR American troops are hiding the information on the greatest peril awaiting the Bondstill Marines. Still, the British headquarters had to speak up, since seven members of the British parachuters’ elite squad, who have already served in Kosovo and Metohija, will be expelled from the Army as junkies. During a routine Army narco-test, the seven “naughty guys” were discovered to have been using heavy narcotics—heroin, LSD and cocaine.

Evaluating the case as a great humiliation for this British elite squad, the British press pointed out that drug addiction among the parachuters leads to questions of their work within the KFOR, since it has long been known that the ethnic Albanians of Kosovo and Metohija are Europe’s greatest drug traffickers...

#### RUSSIA TO SELL MULTI-WARHEAD MISSILES THAT CAN BEAT ISRAEL’S NEW ANTI-MISSILE SYSTEM

MOSCOW—The designer of advanced multi-warhead missiles capable of overcoming Israel’s new anti-missile system said Russia would sell them to its clients in the Middle East, a newspaper here reported.

The new weapon is the Iskander-E, with a range of 280 kilometers. Defense industry sources said the missile can deliver multiple warheads of 480 kilograms each to their targets.

Each warhead, they said, consists of 54 separate bomblets. The sources said the missile is suitable for both point and area targets and can overcome any anti-ballistic-missile system.

Nikolay Gushchin, chief of the Kolomna Mashinostroyeniye design office, said the Iskander-E is different from all of its predecessors. “Technical designs

have been incorporated in Iskander-E which also enable the missile to overcome easily an ABM system of an enemy,” he said...

...Gushchin, designer of the Iskander-E, said Russia would seek to sell the missile to such countries as Algeria, Jordan, Kuwait, Syria and the United Arab Emirates. But he said the most significant market is East Asia, including Singapore, Vietnam, Malaysia and South Korea.

Russia has sold older generation preceding weapons systems to Syria and Yemen. Industry sources said the Iskander is an improvement of the Tochka tactical missile system.

“In my view, there is a very special place in the world arms market for such weapons complexes as Iskander-E,” Gushchin told the Russian newspaper *Krasnaya Zvezda*. “The point is that even a small number of such installations will radically change the layout of power in regional conflicts. Imagine, even an enemy having a superiority in military forces and weapons by a factor of 10 will not dare to start aggression, similar to the aggression of the members of NATO against Yugoslavia, if his cities, air bases and troops are in the sights of missiles which, in the next 10-15 years, an enemy will not be able to destroy in battle positions and will not be able intercept in flight.”

Last week, senior Israeli defense officials acknowledged that Russia has multi-warhead missiles but said they are not being offered to Middle East clients. The officials said the Arrow anti-missile system, developed by the United States and Israel, has not been designed to counter multi-warhead missiles.

The sources, however, said the Iskander-E could be exported to anybody with cash. They said the missile is meant to counter such U.S. weapons as the Army Tactical Missile System.

The Iskander-E does not depend on satellites and can be directed by a man on the ground, the sources said. The missile has an optical seeker that can operate in all weather.

“All of the existing active electronic-warfare equipment is powerless against such a homing head,” Gushchin said. “There is not a single tactical system in the world other than Iskander-E that can carry out such tasks.”

#### RUSSIA THREATENS NATO CONFRONTATION

An armed confrontation is possible between Russian and NATO forces in Kosovo, according to Russian Defense Minister General Igor Sergeev.

In an address to a special assembly of the State Duma, the lower house of the Russian legislature, the Russian Defense Minister said that a standoff between Russian and NATO forces could develop in two to three months on the border between Kosovo and Serbia.

The Kosovo-Serb border has seen an increasing number of armed conflicts between Serbs and ethnic Albanians crossing into Serbia from Kosovo. Moscow blames NATO for allowing the clashes, as well as for not protecting Serbs in Kosovo itself.

Segeyev set out one possible scenario in which Russian forces already in Kosovo would find it necessary to march out of their designated area and into the Kosovo-Serbian border. Such a move would be a violation of the NATO-imposed division of the nominally Serb province and place the Russians in conflict with other NATO troops patrolling the border area.

British, French and U.S. troops shoulder most of the responsibility for the border region between Kosovo and Serbia.

Segeyev stated that Russia was attempting to avert such a confrontation.

At the same Duma special session—which was heard via the “Voice of Russia” World Service Short Wave Radio Broadcast—Russian Foreign Minister Igor Ivanov declared the political situation in Kosovo to be “very alarming”. He accused Albanian extremists of turning Kosovo into a center for drug dealing. Ivanov found it “even more alarming” that militant Albanians are using NATO peacekeepers as a “cover” for a campaign of ethnic cleansing against the Serb population.

Some 350,000 refugees have fled Kosovo, predominantly Serbs, but also included are Gypsies and Moslems.

Violence has continued to increase along the Kosovo-Serb border as a new Albanian guerrilla group has arisen in the area, according to the *BBC*. The new group is challenging both Serbian police and NATO troops.

The new guerrilla force operates in a predominantly Albanian area of Serbia and has named itself after three villages in the area—calling itself the Liberation Army of Presevo, Medvedja and Bujanovac.

Russian criticism of NATO and its conduct in Kosovo has been continuous and bitter since the end of the alliance’s air war against Yugoslavia. Moscow claims that NATO favors the ethnic Albanians in Kosovo and that NATO peacekeepers are responsible for the flight of Serbs from Kosovo.

NATO’s ultimate goal, according to the Russian Government, is the separation of Kosovo from Yugoslavia. **[JR: What a tangled, convoluted, chaotic mess NATO has made of their “peace-keeping” mission. If Russia injects herself further into this operation, you will have a situation similar to the setup in Lebanon: No peace after 20 years.]**

#### CRIMINALS IN THE WHITE HOUSE?

...After seven years of investigations and 57 Judicial Watch lawsuits, Bill and Hillary Clinton, Vice President Al Gore and their minions and spinners have led the Elite media to believe that they have escaped responsibility for their crimes. In fact, recent events have underscored their legal vulnerabilities....

...*Insight* and its sister daily, the *Washington Times*, broke the details of this obstruction of justice. First, there were the revelations by a former White House computer specialist, Sheryl Hall, and then by another White House whistle-blower, Betty Lambuth. Both came forward to Judicial Watch and testified that hundreds of thousands—and, perhaps more than 1 million—e-mails and 457 hard-drive cartridges have been suppressed by the White House in the face of subpoenas and document requests served by Judicial Watch, the independent counsel and Congress. Hall and Lambuth confirm that these e-mails contain incriminating evidence against the Clintons, Gore and their coconspirators in the Filegate, Chinagate and Monica Lewinsky scandals.

According to employees of the Northrop-Grumman Corp., the contractor that ran the White House e-mail and telephone databases, had these documents been provided sooner, they likely would have resulted in impeachment of the President of the United States and forced criminal prosecutions even by the Reno Justice Department. Rather than turn over these smoking-gun communications, the Clinton-Gore White House threatened to prosecute and illegally use the Justice Department (as in Travelgate) to

jail White House employees and contractors who refused to remain silent about the cover-up. The whistle-blowers say that First Lady Hillary Clinton most likely was behind this.

After the story broke, Judicial Watch made Hall available to Chairman Dan Burton of Indiana and his staff on the House Committee on Government Reform. Simultaneously, Judicial Watch filed a motion in its \$90 million Filegate class-action lawsuit asking that Judge Royce Lamberth of the U.S. District Court in Washington take immediate action to hold an evidentiary hearing that would place on the record the underlying facts concerning this mammoth and blatant obstruction. Having received information that the White House already had destroyed smoking-gun records, Judicial Watch asked Lamberth to charge U.S. marshals immediately to enter the White House and seize the e-mails to preserve them.

Thus far, only congressional investigators have met with employees of Northrop-Grumman who oversaw e-mail and telephone records. These witnesses have confirmed the accounts of Hall and other White House whistle-blowers that the e-mails contain information on Filegate, campaign-finance abuses, Chinagate and Lewinsky, and that the documents never were reviewed for subpoenaed materials as required by law. A hearing last week before the House Government Reform Committee appears to have revealed further obstruction.... Typically, the Reno Justice Department filed a last-minute brief arguing that, because its campaign-finance task force now had decided to “investigate” the missing e-mails, Judge Lamberth should delay the hearing....

...Unlike Congress, which for arcane political reasons has been unwilling to hold accountable the perpetrators of the Clinton-Gore obstructions, Lamberth has both the authority and power to do so. Previous decisions by Lamberth—concerning the Hillary Clinton health-care task force, Chinagate, the looting of an American Indian Trust Fund and other litigation—are to be admired. But the nature of Lamberth’s prior rulings has not allowed him to hold any high-level Clinton-Gore official individually accountable. To his credit, the Judge has expressed frustration at this. But White House aide Ira Magaziner was not made to pay for lying to the court in the health-care task-force case; neither were Interior Secretary Bruce Babbitt nor Treasury Secretary Robert Rubin required to cough up monies for their contempt-of-court citations in the Indian Trust Fund case.

Now, however, Lamberth has an opportunity to hold individuals accountable for what everyone concerned with these cases knows has been a massive criminal cover-up. Like Judge John Sirica during Watergate, Lamberth has the power to change the course of history and to restore the rule of law. He has said that he knows who the responsible White House parties are and that if records are destroyed or hidden, he will hang the perpetrators. No one doubts that he means it....

...So, if our criminal-justice system has been corrupted and no longer represents the interests of the American people, it must be put to right by Lamberth and men and women like him to whom justice is no abstract vapor. Meanwhile, Judicial Watch has been facing down yet another instance of obstruction of justice—one, not surprisingly, related to the smearing of whistle-blower Linda Tripp.

As readers may recall, Tripp is a material witness not only in the Lewinsky investigation, but in Judicial Watch’s Filegate lawsuit. Her privacy rights were violated, her reputation was smeared and she was viciously intimidated when the Clinton-Gore Defense Department, with the now-proven assistance of the White House, set out to destroy her by illegally and selectively releasing information from her *Privacy Act*-protected Pentagon personnel file. Now an anonymous source has provided a Pentagon letter admitting

that officials at the Clinton-Gore Defense Department were instructed not to record events concerning this illegal release because: “This is a very serious issue which could involve the impeachment of the President.”

That document falls well within the scope of a Judicial Watch subpoena served on the Defense Department, but it was suppressed and never produced to the Court. Now, Lamberth has ruled: “Simply put (the Clinton-Gore Defense Department’s) assertion that the... letter is not responsive to (Judicial Watch’s) request is incredulous.” Lamberth added: “Moreover, (the Clinton-Gore Department of Defense’s) excessive parsing of the request in order to avoid production of a responsive document calls into question both the adequacy of DOD’s search for responsive documents and its good-faith efforts to comply with the subpoena.”...

...In short, Lamberth and his Court have the Clinton-Gore Administration in their sights, if not on the scaffold. And this is not mere theater. Like some bizarre troupe of Houdinis monopolizing the stage of media attention, the President, the First Lady, the Vice President and their spinners and shakers think they have wowed the hicks and replaced the judicial system with media vaudeville. Standing between them and a graceful exit is Judge Lamberth.

#### CLINTON DEAD WRONG INDIA’S PRESIDENT SAYS

On a so-called peace mission to South Asia, President Bill Clinton stirred up a hornet’s nest with remarks about the disputed province of Kashmir and drew a stinging rebuke from India’s President.

Having failed in his efforts to convince India to scuttle its nuclear weapons and warned not to attempt to mediate the Kashmir dispute, Clinton then walked into a rhetorical minefield when he described Kashmir—the flashpoint in the India/Pakistan face-off—as “perhaps the most dangerous place in the world”.

Indian President Kocheiril Raman Narayanan, facing Clinton from across a banquet table, snapped back: “These alarmist descriptions will only encourage those who want to break the peace and indulge in terrorism and violence.”

And it didn’t stop there. Indian Prime Minister Atal Behari Vajpayee also disputed Mr. Clinton’s description of the dangers in South Asia.

“I’m sure after visiting this part of the world, the President will come to the conclusion that the situation is not so bad as it is made out to be,” Mr. Vajpayee told a joint news conference with Mr. Clinton. “There is no threat of any war.”

In addition to angering his hosts, Clinton also failed to attain most of his stated objectives—getting India to ban the production of nuclear missile materials, tighten export controls and embrace the *Comprehensive Nuclear Test Ban Treaty*.

“President Clinton and I had a frank discussion on the issues of disarmament and nonproliferation of weapons of mass destruction,” Mr. Vajpayee said. “I’ve explained to President Clinton the reasons that compel us to maintain a minimum nuclear deterrent.”

In an obvious effort to put the best face on Clinton’s failure to get his way, Secretary of State Madeleine K. Albright said he’d made no secret of his displeasure during his talks with Mr. Vajpayee.

“The United States is a country that tells it like it is,” Mrs. Albright said. “When we have problems with our friends, we let them know. And that is what the President did here.”

Clinton “has not been asked to mediate the dispute between India and Pakistan”, Mrs. Albright said in an effort to defuse criticism that he had been rebuffed in efforts to be a go-between. Clinton has made no secret of his desire to broker negotiations over Kashmir, just as he has in the Middle East and Northern Ireland conflicts.

In declining to allow Clinton to mediate the dispute, Mr. Vajpayee said, “Problems between countries of the region should be resolved peacefully by the concerned parties themselves. India remains committed to resolving its differences with its neighbors through peaceful bilateral dialogue and in an atmosphere free from the thought of force and violence.”

#### PAYMENTS TO NAZIS’ SLAVES EXPECTED BY YEAR-END

BERLIN (*Reuters*)—Germany said Thursday it hoped payments to Nazi-era slave workers and other victims of the Third Reich could be distributed by the end of the year, now that a dispute over a compensation fund has been settled.

Negotiators for the German Government and survivors’ groups said they had solved a dispute over how to share out cash from the \$5 billion fund to more than a million elderly victims around the world, many from Eastern Europe.

“The issue of how the money is shared out has been successfully settled,” German Government negotiator Otto Lambsdorff told a news conference after the negotiations.

Secretary of State Madeleine Albright said she was very pleased with the agreement, which she called a step forward.

“We worked very hard to get that compensation fund up and going and to be able to begin the distribution, so I am very pleased with that,” she told reporters in Geneva.

Assuming legislation is passed by parliament as scheduled in July, Lambsdorff said cash from the fund would be transferred to Jewish groups and national governments in autumn, allowing them to release payments late this year.

An international advertising campaign, through newspapers and other media, will advise potential claimants of the planned payments, which will average 5,000 marks (\$2,500) for those put to work in Nazi forced-labor schemes.

The mainly Jewish slave workers who were expected to be worked to death in concentration camps will get up to three times as much. Victims of medical experiments and those that suffered financial losses at the hands of German firms can also expect payments....

**...Germany has paid more than 100 billion marks (\$50 billion) in reparations to Nazi victims since World War Two.** Gerhard Schroeder, the first German chancellor too young to remember Adolf Hitler, has said it is time to look to the future....

...U.S. Deputy Treasury Secretary Stuart Eizenstat, Co-Chairman with Lambsdorff of the talks, said the U.S. Government would begin work on measures aimed at ruling out future lawsuits against German firms over their activities in the Nazi era.

**[JR: The U.S., through the diligent efforts of Secretary of State Albright and Deputy Secretary of**

**the Treasury Eizenstat, along with threats of class-action lawsuits by Jewish-American attorneys, has managed to extort a hefty settlement from the German Government (its people) and businesses. #### GLOBAL THREAT OF TB

Tuberculosis threatens to become a major health menace throughout the world, experts have warned.

Marking World TB Day on Friday, the United Nations Children (UNICEF) warned that the deadly disease is “one of the most seriously neglected and underestimated health, human rights and poverty problems of our era”.

TB already accounts for two million deaths a year worldwide, and strains of the bug are becoming increasingly resistant to antibiotics.

Resistance to at least one TB drug is up 50% in Germany and Denmark, and 100% in New Zealand since 1996. Over 3% of new TB cases are drug-resistant in parts of Russia, India and China. In Estonia, drug-resistant cases jumped by 4.6% in one year.

“We face a rise in the incidence of multi-drug-resistant TB. That would be a humanitarian and epidemiological disaster,” said Andre Roberfoid, Deputy Executive Director of UNICEF.

Experts fear that the disease will begin to spread even more rapidly as improved transport systems make travel increasingly easy.

A conference of international experts in Amsterdam is expected to announce on Friday an ambitious strategy to combat drug resistance in the worst affected countries.

The main focus of these efforts will be tripling of access over the next five years to an intensive six-month course of treatment proven to prevent drug-resistant TB from developing.

UNICEF Deputy Executive Director Andre Roberfoid said: “The cost of inaction is high.

“If we accept the proliferation of inadequate TB-treatment services and incorrect self-treatment—a real possibility in Asia—we face a rise in the incidence of multi-drug-resistant TB (MDR-TB).

“That would be a humanitarian and epidemiological disaster.”

Dr. David Heymann of the World Health Organisation said the biggest concern was that drug-resistant TB would begin increasing in other developing countries.

He said: “North America and Europe may have the billions of dollars required to contain this emergency. The worst affected countries in Asia, Africa and Latin America do not.”

MDR-TB develops when TB patients begin but do not complete a full course of treatment with drugs.

When this occurs, the disease becomes much harder to treat—and far more costly.

Asia accounts for approximately 70% of all TB cases.

Ten Asian countries—Bangladesh, Cambodia, China, India, Indonesia, Myanmar, Pakistan, Philippines, Thailand and Vietnam—are among the 22 countries in the world with the

highest number of cases.

Although **two billion people are infected with TB**, only a relatively small percentage ever develop the disease.

**People whose immune systems have been weakened by the HIV virus are 30 times more likely to develop the disease.**

There has been a quadrupling of TB cases in several African countries over the past 10 years as a direct result of HIV.

Children are especially vulnerable to the effects of TB, which is often difficult to diagnose in young children and, therefore, difficult to treat effectively.

Untreated, a person with infectious TB can infect as many as 15 persons in a year.

TB is also on the increase in the UK. In London alone, TB has risen by 80% since the mid-1980s.

Dr. John Moore-Gillon of the British Lung Foundation said: “We cannot afford to be complacent.

“World TB Day is an ideal opportunity to realise that TB is not from another country in another time—it’s here and now.

“We have to have adequate investment in resources in the UK to contain the spread of tuberculosis. But we also need worldwide political activity to prevent this historical scourge from being the world’s dominant disease of the new millennium.”

**[JR: Wow, these statistics are awesome—and add to that the AIDS epidemic in Africa where 5500 people die each day. #### ALZHEIMER’S TIDAL WAVE FEARED

*USA Today*, 03/22/00

Within the next 25 years, thousands of aging baby boomers will begin to develop Alzheimer’s disease and 14 million will die of the incurable brain disease, an analysis released Tuesday says. By 2025, California will lead the nation with 827,392 cases of Alzheimer’s disease, followed by Florida with 712,962; Texas with 552,651; New York with 431,951; and Pennsylvania with 349,612, according to the analysis of Census data by the Alzheimer’s Association. Alzheimer’s results from the abnormal buildup of protein in brain cells. About 35% of people develop Alzheimer’s by age 75, and the percentage rises with age. By 85, almost half of all people get the ailment. The disease is always fatal.

**[JR: How do they come by these projections and statistics, if they haven’t planned for it to happen? Forget the protein-in-brain-cells theory and study fluoride (an aluminum byproduct) and its effects on brain cells.]**

#### UN: U.S. USED URANIUM AMMO IN KOSOVO

*News Day*, 3/21/00

GENEVA (AP)—U.S. jets used 31,000 depleted-uranium rounds—about 10 tons of the munitions—during the Kosovo War, a UN task force said Tuesday, citing confirmation by NATO.

Some specialists believe the rounds, which have been used as far back as the Persian Gulf War, are environmentally harmful, especially when people and animals inhale the dust that forms when the shells disintegrate on impact.

Target zones hit by depleted uranium—known as DU—should be marked and children kept away from them, said Pekka Haavisto, head of the UN Environment Program's Balkans Task Force.

Haavisto said NATO's confirmation that it used DU [ammo] should not cause alarm, but conceded scientific knowledge of its effects is limited. He said he was unable to estimate the number of people exposed.

"I'm very happy that this spring we have got finally from NATO the information, but we would have been more happy if we could have had this information already last summer," Haavisto said.

A set of NATO maps of areas where the munitions were used "is not precise enough to make field assessments", Haavisto said. He noted that UN experts last year carried out measurements in Kosovo but found nothing because the exact locations were unknown.

Pentagon spokesman Air Force Lt. Col. Vic Warzinski said the figure of 31,000 depleted-uranium rounds is the Pentagon's best estimate and that the ammunition was fired by A-10 aircraft in attacks on Serb armored vehicles.

In New York, UN spokesman Fred Eckhard said the ammunition's use did not violate any international conventions.

In the past, the U.S. Defense Department has robustly defended the use of depleted uranium—a dense metal which provides enhanced armor-piercing capability—saying the rounds pose no more health risk than conventional anti-tank weapons.

The UN task force said the World Health Organization was preparing a general report on the health effects of depleted uranium and that the Royal Society, Britain's Academy of Science, was producing its own independent study.

NATO Secretary-General Lord Robertson wrote to UN Secretary-General Kofi Annan on Feb. 7, acknowledging that DU rounds were used during last spring's air campaign against Yugoslavia.

He said the ammunition was part of the A-10's standard load, meaning that they were used throughout Kosovo on about 100 missions.

The major focus of the operations was an area west of the Pec-Dakovica-Prizren Highway, in the areas surrounding Klina and Prizren and north of a line between Suva Reka and Urosevac, Robertson said. But he added that many missions used DU in other areas.

The round, Robertson said, uses a byproduct of the uranium refining process.

CHINA UPBEAT ON EU WTO TALKS  
BUT HAS LIMITS—PAPER

*China Morning Post, 3/27/00*

BEIJING (*Reuters*)—China is upbeat on clinching a deal with the European Union on China's entry to the World Trade Organisation, but signaled there were limits to what it would concede in EU talks this week, a state newspaper said on Monday.

The *Beijing Youth Daily*, while saying a WTO deal

was "within striking distance", repeated trade officials' assertions that China was unlikely to give more to the EU than it had to the United States in a landmark bilateral deal reached in November.

"With the exception of pledges that cannot be made to any WTO member, there are few remaining disputes between China and the EU," the newspaper said, quoting recent remarks by Foreign Trade Minister Shi Guangsheng.

China's chief negotiator Long Yongtu made similar remarks in Geneva last week, saying "China could not give to one partner what it had not been able to promise to another".

EU trade chief Pascal Lamy was slated to begin talks in Beijing on Tuesday in the third round of efforts this year to close a bilateral agreement to enable China to join the WTO.

Lamy spokesman Anthony Gooch said last week EU negotiators would be "putting our best efforts into trying to cut a bilateral deal".

Gooch played down Long's remarks, saying they were just part of a tough negotiating process.

EU officials have said outstanding areas of difficulty include services, telecommunications, life insurance, banking and distribution.

They have declined to say how long the delegation would remain in Beijing but said that they would not hesitate to return to Brussels without a deal.

China, potentially the world's biggest marketplace with 1.3 billion consumers, has reached deals with 27

major countries within the 135-member WTO, but these agreements still have to be "multilateralised" at the Geneva-based body.

Last week, WTO members set a mid-May date for a major push on finalising China's entry bid, which began in 1986.

The EU-China negotiations take place as the U.S. Congress prepares to debate legislation that would grant China permanent trading privileges in the U.S. market.

In exchange for China opening markets, President Bill Clinton says the Congress must grant the country permanent Normal Trade Relations (NTR), a status Beijing now enjoys only after an annual congressional review.

Opponents of permanent NTR, which would guarantee Chinese goods the same low-tariff access to U.S. markets as products from nearly every other nation, have cited China's record on human rights and labour, as well as recent military threats against democratic rival Taiwan, as reasons to deny Beijing the status.

**[JR: It looks as though China is making an end-run around the U.S. If the EU is successful in completing its special trade agreement with China opening markets to the EU, then it's another partner for entry into the WTO. This is nice timing, since our Congress is about to debate China's acceptance into the WTO. Human rights are not relevant when so much money is at stake and all our friends have already cut their deals.]**

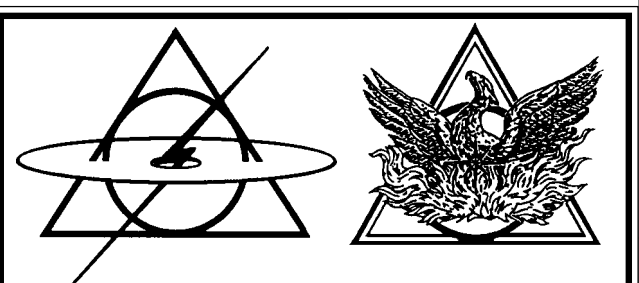
