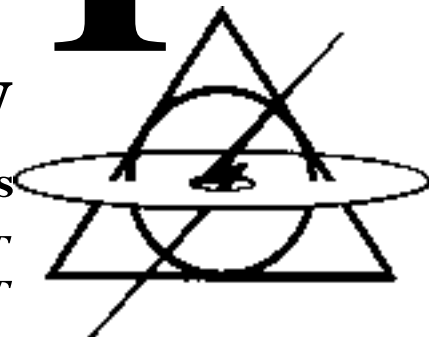

THIRTEENTH AMENDMENT—REDUX

The REAL and ORIGINAL Thirteenth Amendment to the *Constitution of the United States* came into being at a time when there were two very different types of LAWYERS in the country: there were the “common” lawyers and then there were those who served the British Crown, who were “entitled” to affix the suffix, “esquire”. Well, say the opponents of goodness and truth, “esquire” was not one of the recognized “titles of nobility” and so, they “reason”, this amendment would not have precluded attorneys from holding office. The PROBLEM with that line of reasoning is that it fails to consider either the true INTENT of the Thirteenth Amendment or its entire SCOPE. Yes, we covered this previously but obviously it needs to be pointed out AGAIN (reprinted from previous issues, emphasis added):

The missing Amendment is referred to as the “title of nobility” Amendment, but the second prohibition against “honour” (honor), may be more significant.

The archaic definition of “honor” (as used when the 13th Amendment was ratified) meant anyone “obtaining or having an advantage or privilege over another”. A contemporary example of an “honor” granted to only a few Americans is the privilege of being a judge: Lawyers can be judges and exercise the attendant privileges and powers; non-lawyers CAN NOT.

By prohibiting “honors”, the missing Amendment prohibits any advantage or privilege that would grant some citizens an unequal opportunity to achieve or exercise political power. Therefore, the second meaning (intent) of the 13th Amendment is to ensure political equality among all American citizens, by prohibiting anyone, EVEN GOVERNMENT OFFICIALS, from claiming or exercising a special privilege or power (an “honor”) over other citizens.

This interpretation is quite true, little ones, and would be the key concept in the 13th Amendment. Why? Because, while “titles of nobility” may no longer apply in today’s political system, the concept of “honor” remains relevant.

For example, anyone who had a specific “immunity” from lawsuits which were not afforded to all citizens, would be enjoying a separate privilege, an “honor” and would therefore forfeit his right to vote or hold public office. Think of the “immunities” from lawsuits that your judges, lawyers, politicians, and bureaucrats currently enjoy. As another example, think of all the “special interest” legislation your government passes: “special interests” are simply euphemisms for “special privileges” (honors).

Have you ever tried to sue a judge for malfeasance? We’ll let this subject rest at this point but KNOW, citizen, that just getting this issue out in the open for evaluation will CHANGE EVERYTHING. What you do or don’t about it is entirely up to you!

MORE SPACE WARS EXACTLY ONE MONTH LATER

Just after the last update was written a fresh report of brightly flaming objects in the night sky was received. We’ll cite from a number of sources to provide the best terrestrial view we can of this event. (All emphasis in the following citations has been added to the original articles.)

In an article captioned, “Flaming Falling Objects Reported in 4 States” on February 4 (exactly one month after the January 4 event), *Associated Press* first reported that the National Weather Service had “received calls about the **flaming objects** from people in Iowa, Illinois and Wisconsin” and “Missouri’s state highway patrol also said it’s gotten dozens of calls.”

On February 5, Chad Douglas reported for KHQA Channel 7: “Dozens of people in Missouri and Southern Illinois Sunday night saw **flaming objects falling from the sky ... Balls of fire** were seen streaking across the sky from Wisconsin to Missouri last night ... Several calls were also made in our area ranging from loud noises to **fireballs shooting across the sky.**”

On February 5, Greenbay’s WBAY Channel 2 reported: “Local law enforcement officials say they received calls about **balls of fire the size of airplanes** just before 8 o’clock Sunday night ... Some said the **long streaks of fire** looked like an airplane falling out of the sky.”

On February 6, staff writer Tom Barton of the *Des Moines Register* reported:

Michael Kucharek, chief of current operations for NORAD and U.S. Northern Command public affairs, said the command center received reports around 11 p.m. of people, including a military pilot, witnessing **streaks of bright light** shoot across the night sky.

“Preliminary reports indicate it was from a meteor. **We know it wasn’t man-made [RK: Oh, really? HOW could he “know” that? WHY deny something which was not even alleged? This denial amounts to an admission that it WAS man-made.]**, and we had no reports that it hit ground,” Kucharek said.

... Local law enforcement officials in Iowa, Illinois, Wisconsin and Missouri received calls throughout the night of **airplane-sized balls of fire** falling from the sky.

“One lady thought it was a plane crash and saw two pieces coming down,” said J.J. Minshall, a dispatcher with the Dallas County Sheriff’s Office. “We had about four people call in, saying they saw a **big orange flash** in the sky.”

Also on February 6, Steve Lord of Chicago’s *Courier News* provided these additional details: “Just before 8 p.m., a motorist on Kirk Road in Kane County reported seeing **fire streaking across the sky...**” The event was attributed to some kind of apparently unscheduled “meteor shower”. “Meteor showers are hundreds of thousands of miles away,” the [unnamed] West Chicago fire spokesman said. “They look like a shooting star, only wilder, I think.”

Wilder—indeed. Do these descriptions sound like “a” (ONE, SINGULAR, as reported by the Northern Command spokesperson in several of these pieces) METEOR or even, as some elaborated, a “meteor shower”?

Curiously, based on the states from which sightings were registered, this latest event seems to have had a **North-South orientation**, the same as the last event, which occurred farther to the West, over the states of Wyoming, Nebraska, Colorado, Kansas and New Mexico. North-South, just like the January 4 event involving, probably, a circum-polar-orbiting satellite (the kind which flies over ANTARCTICA); “streaks of fire”, “streaks of bright light”, “fire streaking across the sky”; AND **EXACTLY ONE MONTH AFTER THE JANUARY 4 EVENT.**

You don’t suppose someone gave someone else some kind of an ultimatum, do you, along the lines of,

“You’ve got one month to bring it down or we’ll bring it down for you”? For now, at least, this must remain in the realm of speculation but it certainly appears possible—with both events taking place in plain view over the continental United States—that there is a message in here.

Maybe, just maybe, Russian Defense Minister Sergei Ivanov had a point to make in an interview with *RIA Novosti* on **February 6**, when he said Russia “is vehemently opposed to the militarization of outer space”. Please consider the **TIMING** of these statements from Mr. Lavrov relative to the events described above (emphasis added):

“It is not China that opened up Pandora’s box,” he said.

He ... said a clear distinction should be made between doing so for self-defense and to intimidate other nations.

“The use of outer space for security and defense purposes is one thing, and the placement of weapons there is quite another,” he said. “The latter is absolutely **unacceptable** in our view, as it makes the global security situation unpredictable.”

Notwithstanding all of the foregoing, NASA has gone ahead with the launch of the new THEMIS series of satellites: five satellites deployed from a single booster rocket. What is THEMIS? The acronym stands for **Time History of Events and Macroscale Interactions during Substorms**. The NOMINAL mission is to “find” the explosive point of origin of the aurorae—so what does “TIME HISTORY OF EVENTS” have to do with that?

We have known for some time that “they” have had the ability to see into the future. What they have seen, however, is something we have known all along: GOD WINS. No matter what they try, everything ends up playing out according to God’s script!

Not surprisingly, Themis is also a mythological figure, the “Goddess of Justice” symbolized by the blind lady with the sword and scales of justice; daughter of Gaia and Uranus (earth and sky).

According to an article by Micha F. Lindemans:

“Themis is ... the personification of divine right order of things as sanctioned by custom and law. She has oracular powers and it is said that she [built] the oracle at Delphi. ... Themis is depicted as a stern looking woman, blindfolded and holding a pair of scales and a cornucopia. The Romans called her Justitia.”

God is known for both Mercy and Justice, though most would rather experience the former than the latter. When, oh when, are the leaders of the World going to WAKE UP? Actually, the recent speech by Russian Federation President Vladimir Putin offers some hope that they are doing so “already” (as that term is used in the Philippines).

PRESIDENT PUTIN’S SPEECH MUNICH CONFERENCE ON SECURITY POLICY

On February 10, less than one week after the February 6 event in the skies over the United States, Russian President Vladimir Putin delivered a scathing speech, face-to-face with Mr. Gates of the United States and “politicians, military officials, entrepreneurs and experts from more than 40 nations”. Numerous articles have been written incorporating certain citations from Mr. Putin’s speech and some of those are noteworthy. But thanks to the Internet, we have obtained the full text of that speech and there are other

portions, besides those broadly cited, which are certainly deserving of attention and analysis. All emphasis in the citations which follow is mine.

Early in his speech, Mr. Putin said, “It is well known that international security comprises much more than issues relating to military and political stability. **It involves the stability of the global economy, overcoming poverty, economic security and developing a dialogue between civilisations.**”

This statement appears—to me, at least—to contain within it an implicit acknowledgment of things “such as” the Global Alliance (THE solution to issues of “economic security”) AND relations with our Cosmic Brothers (else why use the word “Civilisations”—British spelling, editors, please leave as-is—instead of “nations”? In the next breath he references the “**universal** ... character of security ... ‘security for one is security for all’”.

A little further along, he interrupts his dismissal of the “unipolar world” concept to make the forthright declaration: “... democracy is the power of the majority in light of the interests and opinions of the minority.” Or, as one might say, it’s two foxes and a chicken voting to decide what’s for dinner and who gets to do the dishes. In the current environment, however, it’s worse still because the VOTERS have been mind-controlled to such an extent that the outcome is whatever the BANKERS want it to be.

“What is even more important is that the model [of a unipolar, democratic World] itself is flawed because at its basis there is and can be **no moral foundations** for modern civilisation.” Indeed!

[RK: GLOBAL ALLIANCE IS THE SOLUTION but it looks like we’ll have to wait for ONE of these “leaders” to ACCEPT GOD’S GIFT TO MANKIND in order to ESTABLISH those MORAL FOUNDATIONS which are lacking at present.]

Here is a substantial extract from the most widely cited portion of Mr. Putin’s speech, which you can compare against the impressions you might have had from other sources:

Unilateral and frequently illegitimate **[RK: ILLEGAL under EVERY form of LAW]** actions have not resolved any problems. Moreover, they have caused new human tragedies and created new centres of tension. Judge for yourselves: wars as well as local and regional conflicts have not diminished. Mr. Teltschik mentioned this very gently. And no less people perish in these conflicts—even more are dying than before. Significantly more, significantly more!

Today we are witnessing an almost uncontained hyper use of force—military force—in international relations, force that is plunging the world into an abyss of permanent conflicts. As a result we do not have sufficient strength to find a comprehensive solution to any one of these conflicts. Finding a political settlement also becomes impossible. We are seeing a greater and greater disdain for the basic principles of international law. And independent legal norms are, as a matter of fact, coming increasingly closer to one state’s legal system. One state and, of course, first and foremost the United States, has overstepped its national borders in every way. This is visible in the economic, political, cultural and educational policies it imposes on other nations. Well, who likes this? Who is happy about this? ...

And of course this is extremely dangerous. It results in the fact that no one feels safe. I want to emphasise this—no one feels safe! Because no one can feel that international law is like a stone wall

that will protect them. **[RK: Most “Western” media interpreted this remark as “a stone wall to hide behind”, which, of course, has vastly different implications.]** Of course such a policy stimulates an arms race.

The force’s dominance inevitably encourages a number of countries to acquire weapons of mass destruction. Moreover, significantly new threats—though they were also well-known before—have appeared, and today threats such as terrorism have taken on a global character.

I am convinced that we have reached that decisive moment when we must seriously think about the architecture of global security.

At the ROOT of all of these problems you will find the PARASITES of the BANKING SYTEM, which is based on something-for-nothing, funny-money, debt slavery.

Mr. Putin pointed out that India and China have a combined GDP in excess of that of the United States and the larger BRIC group (Brazil, Russia, India and China) surpasses the cumulative GDP of the EU. “And according to experts this gap will only increase in the future.”

It sounds like “non-Western” countries are INEXORABLY gaining the upper hand, “security”-wise. And so, of course, the only answer which the “Western” countries (think British Commonwealth-U.S.-EU-Israel—the real “axis of evil”) have for that is WAR!

Mr. Putin lectures, “The use of force can only be considered legitimate if the decision is sanctioned by the UN. And we do not need to substitute NATO or the EU for the UN.” The only problem with that is: the bankers have no qualms at all in using any or all of the above to retain CONTROL over the situation, no matter what the cost is in human lives—and as far as the depopulation agenda goes—the more the better!

“Otherwise the situation will simply result in a dead end, and the number of serious mistakes will be multiplied. Along with this, it is necessary to make sure that international law have a **universal** character both in the conception and application of its norms.”

There he goes with the use of “universal” again, instead of merely “global”. OF COURSE he is aware of the desirability of joining with our Cosmic relatives. As we have been told on many occasions, **a very good working relationship exists between Space Command (our Celestial Brothers) and the pilots of those thousands of Russian cosmospheres.**

“Russia strictly adheres to and intends to further adhere to the Treaty on the Non-Proliferation of Nuclear Weapons as well as the multilateral supervision regime for missile technologies. The principles incorporated in these documents are **universal** ones.

“In connection with this I would like to recall that in the 1980s the USSR and the United States signed an agreement on destroying a whole range of small- and medium-range missiles **but these documents do not have a universal character.**”

Next comes the part NO ONE in the mainstream media covered, “somehow”, and in this writer’s opinion this statement relates DIRECTLY to the events of January 4 and February 4:

“At the same time, it is impossible to sanction the appearance of new, destabilising high-tech weapons. Needless to say it refers to measures to prevent a new area of confrontation, especially in outer space. Star wars is no longer a fantasy—it is a reality.”

A little further along, after discussing the sand in the bed-sheets between Russia and its American “friends”, Mr. Putin gets back to the ECONOMIC

issue. But we have to ask: Where do the Rothschilds and the other BANKERS fit into this picture?

“Today many talk about the struggle against poverty. What is actually happening in this sphere? On the one hand, financial resources are allocated for programmes to help the world’s poorest countries—and at times substantial financial resources. But to be honest—and many here also know this—linked with the development of that same donor country’s companies. And on the other hand, developed countries simultaneously keep their agricultural subsidies and limit some countries’ access to high-tech products.

“And let’s say things as they are—one hand distributes charitable help and the other hand not only preserves economic backwardness but also reaps the profits thereof. The increasing social tension in depressed regions inevitably results in the growth of radicalism, extremism, feeds terrorism and local conflicts. And if all this happens in, shall we say, a region such as the Middle East where there is increasingly the sense that the world at large is unfair, then there is the risk of global destabilisation.”

But of course, that is precisely the POINT of those who do not wish to relinquish control. WAR makes for CHAOS and out of that they would attempt to establish ORDER, THEIR ORDER. Along the way, they get the “benefit” of depopulation along with eradication of those who would not make willing slaves. Marvelous, isn’t it?

We (of GLOBAL ALLIANCE) are quite pleased with Mr. Putin’s speech and we feel encouraged by his closing remarks which, on the face of things, ENDORSE our position:

In conclusion I would like to note the following. We very often—and personally, I very often—hear appeals by our partners, including our European partners, to the effect that Russia should play an increasingly active role in world affairs.

In connection with this I would allow myself to make one small remark. It is hardly necessary to incite us to do so. Russia is a country with a history that spans more than a thousand years and has practically always used the privilege to carry out an independent foreign policy.

We are not going to change this tradition today. At the same time, we are well aware of how the world has changed and we have a realistic sense of our own opportunities and potential. And of course we would like to interact with responsible and independent partners with whom we could work together in constructing a fair and democratic world order that would ensure security and prosperity not only for a select few, but for all.

Thank you for your attention.

Well, you have our attention, Mr. Putin, for whatever that may be worth to you and all our relations at this specific moment. It seems there have been great losses of bees in the United States recently, with many beekeepers losing anywhere from 40% to 80% of their colonies. Curiously, no dead bees are found near the abandoned colonies; they are simply ‘disappearing’.

‘Synthetic Telepathy’: Rape of the MIND

Over the last two decades we have had many revelations from former members of the military and intelligence community but curiously, very little from the scientists and other intellectuals. That started to change several years ago but the information only dribbles into our hands over time and then we are often pressed for space to cover the material adequately. Note that much of what is described in the following paper is DECADES old technology!

The foregoing article pointed out the significance of a particular frequency which appears to be in use to modify the MINDS of Americans. There are many, many frequency tools being employed these days to accomplish that which writer John Kaminski called “Mindlock” in his recent series. “WHY DON’T PEOPLE SEEM TO ‘GET IT’”, we ask. The answer, in many cases, is that our sleeping brothers and sisters on this placement are literally IN A TRANCE.

Herein we are going to make use of substantial excerpts from a paper written by Richard Alan Miller in 2001 entitled, “SYNTHETIC TELEPATHY AND THE EARLY MIND WARS”. His email address is given as drram@magick.net and a website is listed as www.nwbotanicals.org. Full contact information is provided at the end of this article.

Taking a step behind the scenes of “black ops” research is for most of us limited to speculations. Miller began working in that “X-Files” world in the 60s and has amazing experiences and conclusions to share. An original team-member, “man-in-black”, Miller’s research in the field of Parapsychology & Paraphysics began as a graduate physicist working 10 years with Army Intel/Pentagon.

With that introduction, we’ll jump into his paper at the point where he begins to discuss the concept of ‘Synthetic Telepathy’.

[QUOTING:]

“SYNTHETIC TELEPATHY”

In 1975, researcher A. W. Guy stated that “one of the most widely observed and accepted biologic effects of low average power electromagnetic energy is the auditory sensation evoked in man when exposed to pulsed microwaves.”

He concluded that at frequencies where the auditory effect can be easily detected, microwaves penetrate deep into the tissues of the head, causing rapid thermal expansion (at the microscopic level only) that produces strains in the brain tissue.

An acoustic stress wave is then conducted through the skull to the cochlea, and from there, it proceeds in the same manner as in conventional hearing. It is obvious that receiver-less radio has not been adequately publicized or explained because of national security concerns.

Today, the ability to remotely transmit microwave voices inside a target’s head is known inside the Pentagon as “Synthetic Telepathy”. According to Dr. Robert Becker, “Synthetic Telepathy has applications in covert operations designed to drive a target crazy

with voices or deliver undetected instructions to a programmed assassin.”

This technology may have contributed to the deaths of 25 defense scientists variously employed by Marconi Underwater and Defense Systems, Easems and GEC. Most of the scientists worked on highly sensitive electronic warfare programs for NATO, including the Strategic Defense Initiative. It is claimed that directed energy weapons might have been used to literally drive these men to suicide and 291 accidents.

... The significance of *Embryonic Holography* now becomes more understandable. For example, the specific frequency bands (0.3-3.0 Hz) are so flat as to appear almost 2-dimensional to most biological processes on a semi-quantum mechanical level. This means that these frequencies can be seen as “scalar” in their possible interaction with specific brain processes.

What these frequencies really are, however, are actual holograms of specific thoughts. They have a third component of detail (much like the patented P300 wave). This means that a hybrid form of brain fingerprinting is now possible. And, once these “images” are stored (usually in a very sophisticated super-cooled computer), similar responses can be fed back to the person, inducing virtually any state desired (via entrainment protocols). ...

Cloning the Emotions

By using these computer-enhanced EEGs, scientists can identify and isolate the brain’s low-amplitude “emotion signature clusters”, synthesize them and store them on another computer. In other words, by studying the subtle characteristic brainwave patterns that occur when a subject experiences a particular emotion, scientists have been able to identify the concomitant brainwave pattern and can now duplicate it.

These clusters are then placed on the Silent Sound[TM] carrier frequencies and will silently trigger the occurrence of the same basic emotion in another human being!

Regarding system delivery and applications, there is a lot more involved here than a simple subliminal sound system. There are numerous patented technologies that can be piggybacked individually or collectively onto a carrier frequency to elicit all kinds of effects.

There appear to be two methods of delivery with the system. One is direct microwave induction into the brain of the subject, limited to short-range operations. The other, as described above, utilizes **ordinary radio and television carrier frequencies**.

Far from necessarily being used as a weapon against a person, the system does have limitless positive applications. However, the fact that the sounds are subliminal makes them virtually undetectable and possibly dangerous to the general public.

In more conventional use, the Silent Sounds Subliminal System might utilize voice commands, e.g., as an adjunct to security systems. Beneath the musical broadcast that you hear in stores and shopping malls

may be a hidden message that exhorts against shoplifting. And while voice commands alone are powerful, when the subliminal presentation system carries cloned emotional signatures, the result is overwhelming.

Free-market uses for this technology are the common self-help tapes, positive affirmation, relaxation and meditation tapes, as well as methods to increase learning capabilities. But **there is strong evidence that this technology is being developed toward global mind control.**

The secrecy involved in the development of the electromagnetic mind-altering technology reflects the tremendous power that is inherent in it. **To put it bluntly, whoever controls this technology can control the minds of men—all men.**

There is evidence that the U.S. Government has plans to extend the range of this technology to envelop all peoples, all countries. This can be accomplished, and is being accomplished, by utilizing the nearly completed HAARP project for overseas areas and the GWEN network now in place in the U.S. ...

Mind Reading Devices

Alan Yu, a former lieutenant colonel in the Taiwan National Defense Department, says that **the United States has not only developed an operational mind control machine, but has also distributed models for use by allied countries. [Ed: Perhaps it makes more sense now as to why “they” are so strongly promoting the concept of DEMOCRACY!?!]** Yu states that such machines pose a great threat to human rights and the American way of life. He calls the device the “Mind Reading Machine” (Mind Machine).

Yu writes that there are two sources of information detailing the existence of the Mind Reading Machine. The first evidence: In the 1970s, the *South China Morning Post* reported that the University of Maryland had invented a Thought Reading Machine. The original purpose of this invention was to help authorities investigate severe car accidents. It was to be used on people who were severely injured to get their accounts of how the accidents occurred.

In the spring of 1984, Yu was a lieutenant colonel serving in the National Defense Department of Taiwan. At that time, Yu read a classified document from the department that he serviced under. The document said the Military Police Department of Taiwan had purchased several of the Mind Reading Machines from the United States. (In Taiwan, it was called Psychological Language Machine.)

The document was a request to the United States for parts to repair several malfunctioning machines. The machine allegedly uses microwaves to deliver spoken messages directly to the human brain, as well as using radio waves to hypnotize people or change their thoughts. Yu reports that before he left, **this machine had become the most effective weapon for the security departments of Taiwan.**

In 1993, *Defense News* announced that the Russian government was discussing with American counterparts the transfer of technical information and equipment known as “Acoustic Psycho-correction”. The Russians claimed that this device involves the transmission of specific commands via static or white noise bands into the human subconscious without upsetting other intellectual functions.

Demonstrations of this equipment have shown encouraging results after exposure of less than one minute and have produced the ability to alter behavior on unwilling subjects. A U.S. Department of Defense medical engineer claimed in 1989 that the U.S. and Israel had regularly used microwaves to condition and control the minds of Palestinians.

Unclassified ELF-Type Weapons

Remote physical manipulation: Not covered in this document. At time of writing, that technology appears to be classified.

Transmission methods for neuro-effective signals: This includes pulsed microwave (i.e., like radar signals) and ultrasound and voice-FM (transmitted through the air); also known as "Synthetic Telepathy".

While transmission of speech, dating from the early 1970s, was the first use of pulsed microwave, neuro-effective signals can now cause many other nerve groups to become remotely actuated. That specific technology is classified.

Pavlovian hypnotic triggers: A [Pavlovian] hypnotic trigger is a phrase or any sensory cue that the subject is programmed to involuntarily act in a certain way. MKULTRA survivors can still be triggered from programming done decades ago.

One of the main goals of the institutional/drug/child abuse phases of the CIA MKULTRA atrocities (1950s through 1970s) was to implant triggers using a "twilight state" (half-conscious) medication and tape-recorded hypnosis. The ultimate goal was to have the acting out of Pavlovian triggers erased from the victim's memory.

These triggers are now planted using either of the above two transmission methods, but with the words moved up just above (or near the top of) the audible frequency range. The result is that hypnotic triggers are planted without the subject being aware. This technology was used in the Gulf War as "Silent Sound".

Through-wall surveillance methods: This includes top end of microwave (near infrared), and the so-called "millimeter wave" scanning. This method uses the very top end of the microwave radio signal spectrum just below infrared. To view small objects or people clearly, the highest frequency that will penetrate non-conductive or poorly-conductive walls is used.

Millimeter wave scanning radar can be used in two modes: The first is passive (no radiated signal) and uses background radiation already in the area to be scanned. It is totally undetectable. The active system uses a (low power millimeter wave) "flashlight" attached to the scanner.

Thought reading: Thought reading can be classed as a form of "through wall surveillance" technology. In the unclassified and commercial realms, it is called thru-skull microwave reading, and magnetic skull-proximity reading.

Brain entrainment: This involves moods and sleep states, the reverse of biofeedback. The low frequency electrical brain rhythms are characteristics of various moods and states of sleep. Not only can they now be read out using biofeedback equipment or EEG machines, but also radio, sound, contact electrodes, or flashing lights. These moods and sleep states can be generated or at least encouraged using brain entrainment devices.

Brain entrainment signals cannot carry voice, which is a much higher frequency range. Brain entrainment can, however, be used to "set up" a target to make him/her more susceptible to hypnosis.

Implantation: (no longer required)

Specific ELF Weapons

Ultrasound and Voice-FM: Main advantage in mind control work is that it can carry verbal hypnosis, more potent than simple biorhythm entrainment. An example is Chicago's Airport Terminal connection tunnels and their "Keep Walking".

Steady tone, near the high end of hearing range (15,000 Hz). Hypnotist's voice, varying from 300 to 4,000 Hz, fed into a frequency modulator, where the

voice controls the frequency. Output is now a steady tone, sounding like tinnitus, but with hypnosis embedded. While the brain can hear and understand, the ear only hears a "tone" or a "rush".

Through-Wall Radar: Millimeter wave through clothing, through-luggage is currently in use at airports. Millimeter wave scanners can be purchased from: Millivision Corp., Northampton, MA, www.millivision.com.

Thought Readings: Thought reading is an enhanced version of computer speech recognition, with EEG waves being substituted for sound waves. The easiest "thought" reading is actually remote picking up of the electro-magnetic activity of the speech-control muscles.

When we say words to ourselves, silently, or, read a book, we can actually feel the slight sensations of those words in our vocal muscles—all that is absent is the passage of air. Coordinated speech signals are relatively strong and relatively consistent.

We are "fed" hypnotic signals to force consistent "neutral" content (but of different character than prior to becoming test subjects) in dreams. These forced, neutral content ("bland" content) dreams occur every single night and may represent the experimenters' efforts to have our experiences portray themselves in such dreams, in effect, mining our experiences.

www.raven1.net/elecvisn.htm confirms the ability of current unclassified technology to actually see what a living animal sees, electronically. It is therefore extremely likely that these forced dreams can be displayed on the experimenters' screens in an adjacent apartment or adjacent house (which are made obvious to the involuntary experimentee).

Implants: Implants can either receive instructions via radio signals, passing them to the brain. Or, can be interrogated via external radio signals to read brain activity at a distance. Since implants for beneficial purposes are actively being promoted by NIH, it is obvious they will not disappear any time soon.

Thermal Gun, Seizure Gun, and Magnetophosphene Gun: Evokes a visual response and is thought to be centered in the retina (as seen in the movies *Goldeneye*, *Broken Arrow*, *Escape From LA*, and *Eraser*). camera to accomplish just that.

The idea calls for measuring the time delay and intensity of millimeter wave energy that radiates naturally. At millimeter wavelengths, people are good emitters, while metals are very poor. Dielectric objects, such as plastics, ceramics and powdered drugs, are somewhere in between.

Clothing and building materials, such as wallboard, are virtually transparent.

Some Important Historical Developments:

Brain-Wave Detection: Some 40-odd years ago, university professor F. Cazzamalli started publishing papers on the subject of brain-wave detection [using radio signals] and implied that he had detected radiations from the mind. ...

Later he told an astounded world that his subjects would hallucinate when under the influence of his "oscillatori telegrafica", its frequency being around 300 MHz at the time. ...

Tom Jaski, a noted science writer and engineer duplicated some of Cazzamalli's work with a modern low-power oscillator that was swept from 300 MHz to 600 MHz. Cell phones start at over 900 MHz.

His subjects could not see the dial. They were told to sound off as soon as they felt something unusual. At a certain frequency range—varying between 380 MHz and 500 MHz—the subjects repeatedly indicated points with exact accuracy in as many as 14 out of 15 trials. At these "individual" frequencies, the same subjects announced having experienced pulsing sensations in the brain, ringing in the ears, and an odd desire to *bite* the experimenters.

The oscillator's output power was only a few *milliwatts*, while the oscillator itself was located several feet away from the subjects. Any experimenters out there want to try this? Milliwatts are quite safe for short-term experiments. Kids' walkie-talkies are 50 to 100 milliwatts, for example.

LIDA Machine: 1960 Soviet device that bombards brains with low-frequency radio waves. Now with Dr. Ross Adey, Chief of Research, Veterans Hospital, Loma Linda, CA.

Low frequency square wave modulation of a radio frequency field. It was developed by L. Rabihev and his colleagues in Soviet Armenia, for "the treatment of neuropsychic and somatic disorders, such as neuroses, psychoses, insomnia, hypertension, stammering, bronchial asthma, and asthenic and reactive disturbances" (U.S. Patent # 3,773,049).

The radio frequency field has a nominal carrier frequency of 40 MHz and a maximum output of approximately 40 watts. The E-field is applied to the patient on the side of neck through two disc electrodes approximately 10 cm in diameter. The electrodes are located at a distance of 2 to 4 cm from the skin.

The radio signal appears to be the primary cause of the sleep/trance effect. Optimal repetition frequencies are said to lie in the range from 40 to 80 pulses per minute. ...

EC-130E Commando Solo: Primary function is "Psychological operations broadcasts". Air Force Mission statement: Commando Solo conducts psychological operations and civil affairs broadcasts missions in the standard AM, FM, HF, TV and military communications bands.

It was called EC-121, known at the time as the Coronet Solo, and was used in Operation Urgent Fury. Volant Solo was during Operation Just Cause.

The Commando Solo aircraft and earlier generations of this design have participated in the following missions: Operation *Urgent Fury* (Grenada, October-November 1983, January-June 1985); Operation *Just Cause* (Panama, late December 1989); Operation *Desert Shield* (Kuwait, Iraq, from August

The 'God' That Serves Elite Jews

THE "GOD" THAT SERVES ELITE JEWS

Last week I noted that the Soviets razed thousands of churches but spared synagogues.

If Communists considered religion "the opium of the masses", why didn't they include Judaism? Do Christians and Jews worship the same God? Is there an affinity between Communism and Judaism?

Perhaps the Jewish elite has a different God. A reader, "George", knew the heiress of a rich Jewish banking family, "not the Rothschilds, although her family dwelled in a palace neighbouring the Rothschilds".

"Leah was one of my classmates in the Geneva University (Switzerland) where I was studying psychology ... She was an attractive blue-eyed blond lady. ... As she was wearing a Star of David, I asked if she was a believer. She answered 'yes and no' and added that she believed in a god of the Jews who was serving the Jews rather than served by them. I immediately asked whether she was speaking of an *egregore* ... Her only response was 'yes' and she broke that conversation. Never again did we mention the subject."

According to Wikipedia, "*egregore*" is an occult concept representing a "thought form" or "collective group mind", an autonomous psychic entity made up of, and influencing, the thoughts of a group of people. The symbiotic relationship between an *egregore* and its group has been compared to the more recent, non-occult concepts of the corporation (as a legal entity) and the meme."

George speculates that elite Jews created the Jewish God as their "*egregore*", i.e. an instrument of their collective will, i.e. their desire to vanquish the heathens and rule supreme.

"Could it be possible that the ancient Levite priests found a way to create a supernatural entity from the collective mind of the tribe of Judah? them" thinking in the *Talmud* and the *Old Testament*. For example: *Isaiah* 60:12 ("... The nation and kingdom that will not serve [Israel] shall perish; yea, those nations shall be utterly wasted"); *Isaiah* 61:5-6 ("... Strangers shall stand and feed your flocks ... : Ye shall eat the riches of the Gentiles ...") Lysson continues:

"The ethnocentric hostility of the Jews—consistently commented on by the peoples who have encountered them over the millennia—can be traced ultimately to the origins of Judaism as set forth in the *Torah*, e.g., *Genesis* 9:25 ('Cursed be Canaan; a servant of servants shall he be unto his brethren'); *Exodus* 17:14-16 and 34:12-13 ; *Numbers* 24:8 ('God ... shall eat up the nations his enemies, and shall break their bones, and pierce them through with his arrows'), 25:6-13 (wherein God commends Phineas for his initiative in running a javelin through both parties to a marriage of Jew and gentile), 31:7-19 and 33:50-56; and *Deuteronomy* 2:33-35 ('[on God's command] we ... utterly destroyed the men, and the women, and the little ones, of every city, we left none to remain'), 3:4-7, 7:1-5 ('thou shalt ... utterly destroy them'), 7:14-26 ('thine eye shall have no pity'), 20:10-17 ('thou shalt save alive nothing that breatheth') and 25:19."

"Anti Semitism"

It doesn't take a genius to recognize that this "*egregore*" is the cause of anti Semitism. Jewish leaders use anti Semitism to manipulate Jews who are taught they are reviled for no reason. The real reasons for anti Semitism are hidden. As Nicholas Lysson points out, the most damning passages of the *Talmud* are toned down or not translated. Information about the "*Arendar*" system is suppressed. This system caused the massacre of perhaps 250,000 Jews by the Ukrainian Cossack Bohdan Khmelnytsky in 1648-1654:

"The Jews at the time of the massacres were serving the Polish *szlachta* (nobility) and Roman Catholic clergy on their Ukrainian *latifundia* as *arendars*—toll-, rent- and tax-farmers, enforcers of *corvee* obligations, licensees of feudal monopolies (e.g., on banking, milling, storekeeping, and distillation and sale of alcohol), and as anti-Christian scourges who even collected tithes at the doors of the peasants' Greek Orthodox churches and exacted fees to open those doors for weddings, christenings and funerals. They had life and death powers over the local population (the typical form of execution being impalement), and no law above them to which that population had recourse ... the *arendars* leased estates for terms of only two or three years and had every incentive to wring the peasants mercilessly, without regard to long-term consequences."

Jews are still told that these pogroms were due to gratuitous hatred. Thus the *egregore* dynamic is perpetuated as ordinary Jews support Zionist policies. For example, they clamour to bomb Iran, regardless of the disastrous consequences for humanity.

GREENSPAN REPORTEDLY BRIBES & AIDS BUSH IN GOLD SWINDLES (PART 1)

As the founder/Chairman of our group, Citizen’s Committee to Clean Up the Courts, since 1963, I have been imprisoned some eight times in four decades, not for committing crimes, but for so-called “contempt of court”, for refusing to reveal the identity of long-reliable sources of high-level corruption data turned over to us on the sly. Our sources, cross-checked with others and backed up by over one million documents already in our possession have enabled us, over a period of decades, to set off what some describe as the biggest judicial bribery scandals in U.S. history.

Briefly stated, this includes the downfall we caused in 1969, of Illinois’ highest tribunal, the Illinois Supreme Court, with half the high court being put to the wall. In the 1970s, our work led to the jailing for bribery of the highest-level sitting federal judge in U.S. history, a federal appeals judge in Chicago who had also been former State Governor and his aide, former head of the Illinois Department of Revenue, the tax collectors. 7th Circuit Federal Appeals Judge Otto Kerner, Jr. went on all the media and said, “Skolnick is a liar.” Kerner died an ex-convict, convicted as I accused him to his face, as is our long-time policy. From 1983 to 1993, our work set off a series of scandals, by which 20 local judges and 40 lawyers were sent to prison for bribery, including the Chief Judge of the Traffic Court, who in a taped interview said, “Mr. Skolnick, you are imagining things, there is no corruption in this courthouse.”

The Federal Reserve wire-transfer data, which is also corroborated by matters already in our possession, among other things, confirms the following:

1. That George Herbert Walker Bush, starting back at the time he was Vice President and continuing long thereafter, reportedly corruptly benefited from billions and billions of dollars transferred at the behest, of among

cohesion and survival. Jews acknowledge this. Are they saying that, without its “*egregore*” i.e. its predatory agenda, Jews would have no corporate *raison d’etre*? Of course this secret is kept from the rank-and-file, as in Freemasonry which Rakowsky said is designed to bring about “the triumph of Communism”.

The Communist Egregore

The greatest mass slaughter in history was not the Jewish holocaust but the Ukrainian *Holodomor*. By Stalin’s own estimate, ten million Ukrainians died, mostly at the hands of Bolshevik Jews.

Lysson’s account suggests that this was the result of a centuries-long feud in which Jews failed to accept their common humanity with non-Jews. This continues as the murderous record of the 20th century is overshadowed by Jewish losses, as if only Jews were human.

The *Holodomor* took place because the Bolsheviks confiscated all the grain. Lysson writes: “A quarter of the rural population, men, women and children, lay dead or dying in a great stretch of territory with some forty million inhabitants, like one vast Belsen. The rest, in various stages of debilitation, had no strength to bury their families or neighbours. [As at Belsen] well-fed squads of police or party officials supervised the victims.”

The extermination of the Ukrainian Kulaks was directed from the Kremlin where the Bolshevik leadership lived in family apartments and maintained a fraternal atmosphere suffused by collectivist idealism i.e. their *egregore*. This is how historian Simon Sebag Montefiore, the scion of a British elite Jewish family, describes the scene during the *Holodomor*. Of course he doesn’t mention that most of the main players were Jews.

“The Party was almost a family business. Whole clans were members of the leadership ... This pitiless fraternity lived in a sleepless frenzy of excitement and activity, driven by adrenalin and conviction. Regarding themselves like God on the first day, they were creating a new world in a red-hot frenzy ...” (Stalin: *The Court of the Red Tsar*, p. 40, 45)

Conclusion

The Soviets didn’t raze synagogues because Communism was an expression of the Jewish “*egregore*”. Christians and Jews apparently do not worship the same God. The Christian God represented by Jesus is universal love and brotherhood. The Jewish God has been supplanted by a Cabalistic *egregore* that “serves” elite Jews. Bush used a top U.S. official to mislead Saddam into thinking the U.S. would not intervene in this local quarrel with the former British colony. Bush was the one, on behalf of U.S. oil-drilling interests, that helped develop the Kuwaiti oilfields, following the 1961 relinquishing of British sovereignty. In its simplest form, the 1990-91 Persian Gulf War was a falling out of private business partners.

The result of this treachery? Great loss of life of ordinary soldiers. Upwards of 150 thousand young Iraqis died in the conflict—some buried alive by U.S. war bulldozers. President Bush ordered U.S. warplanes to shoot in the back, the retreating Iraqi soldiers proceeding under a white flag of surrender. It was the most horrendous murder of surrendering troops in world history. The German massacre of some 80 U.S. troops surrendering in World War II during the Battle of the Bulge was a small matter by comparison. (Our public-access Cable TV Program in 1991 was about the only TV Show in America that dared discuss this matter.)

Following the Persian Gulf War, some 15,000 U.S. troops died from the mysterious malady called Gulf War Syndrome (GWS), which the Pentagon denies is happening. Ex-GIs continue to die from the strange ailments, and the total deaths and debilitating diseases amount to more than 20 percent as casualties of all the Americans serving in the military in the Persian Gulf in 1990-91—more than 100 thousand American soldiers as casualties.

Having been apparently massively bribed and aided in corrupt deeds over a period of years, the Elder Bush owed Alan Redspan and others important favors. Bush has been a potentate in one form or another with Canadian Barrick Gold. The Bank of England, jointly with the Queen of England—who reportedly shared accounts with the Elder Bush at Coutts Bank, London, and three or more major financial entities—orchestrated a vicious attack on gold in 1999. Together, they drove down the price of gold to about 252 dollars per ounce—more than 30 dollars per ounce BELOW THE COST OF PRODUCTION of the most efficient gold mines, such as in Canada.

Reportedly helping this unlawful attack on gold, gold mines, and gold mine workers, forbidden by U.S. Anti-Trust Laws, have been the following, among others:

(a) Goldman Sachs, one of the world’s largest bond and gold trading houses. Cynics, knowing these facts, call them “Goldman Sucks”. Goldman Sachs has been so much into short selling deals of gold that, in the October 1999 gold crisis, they were reportedly

considering invoking the contract provision called “*Force Majeure*”, used to avoid complying with a contract because of wars, hurricanes, revolutions and such. The Federal Reserve has through various dirty tricks bailed out Goldman Sachs repeatedly.

(b) Bank of America, big in foreign-exchange trading, called ForEx, (long ago called Bank of Italy, in America) they were reportedly part of the “knock down the price of gold” group.

(c) Bank of England, jointly with the Queen of England, offering for auction or sale gold that neither one apparently really owns, but is actually a huge gold hoard stolen upon the downfall of the Soviet regime and whisked away to Dutch custody at a Swiss airport for speedy transport wheresoever requested. Bank of America is owned jointly by the Vatican, the Jesuits and the Rothschilds. Joining them in recent years as major owners, have reportedly been the Japanese mafia, the Yakuza, big in the U.S. dope traffic, and owning most every bank in California.

The purpose of the gold attack was to drive down the price of gold, among other things, to help bail out six hedge funds that have been more than a trillion dollars underwater in derivatives gambling that is asset swaps. The bankrupt hedge funds, when gold is low-priced, can obtain gold loans for as little as one percent interest. Were the hedge funds disaster scenario to be more public, it might set off a meltdown of the financial system of the Western world.

Reportedly at the behest of Bush, Barrick became part of a complicated trick of forward leasing of gold. A sort of short selling of gold. Thus sold short has been more than ten thousand tons of gold—more than four years of total world gold production. Gold has been called by some, “The Killer Yellow Metal”, for the type of situations it can cause. In February 2000, Barrick, Bush and the anti-gold gang reportedly again sought to stop the precious metal from going up to a more fair market price, such as 600 dollars per ounce.

Final Warning: Part 13a

We continue with our serialization of author David Allen Rivera's Final Warning: A History of the New World Order. In this installment we begin Chapter 9 of the original text, dealing primarily with the Trilateral Commission.

[QUOTING, emphasis added:]

CHAPTER NINE READY TO SPRING THE TRAP THE TRILATERAL COMMISSION

[Editor's note: The FINAL paragraphs of this 39-page chapter dovetail perfectly with the MIND CONTROL aspects covered elsewhere in the current issue, so we have excerpted and put them right up front, slightly inset from the rest of the text.]

In 1999, Warner Brothers released a little movie called *The Matrix*. Not considered a major project, it was shot in Australia to save money. Expectations were not high for this edgy sci-fi action film, however, after its opening, it was quite clear that its writers, the Wachowski Brothers had struck gold by tapping into the collective intellectual consciousness of a nation that was preparing to enter a new millennium. Most movies are made to entertain, and are fairly straight forward in their approach, but *The Matrix* challenged its viewers. Incredibly unique was the fact that different people, who saw it, had different interpretations of its meaning.

The plot revolves around Neo, a computer hacker (played by Keanu Reeves) who discovers that the world he lives in is nothing more than a computer simulation that is being fed into his brain as his body rests in a pod, in the real world, along with endless numbers of others, providing the energy that sustains the machines that run the world.

When I read the original script, there were lines in there that did not appear in the movie. For instance, “Anthony” (whose name was changed to Choi in the movie) says to DuJour about Neo: “I told you, honey, he may look like just another geek but this here is all we got left standing between Big Brother (a term from George Orwell's book *1984*) and the New World Order.” Also, in a chatroom called “The Matrix”, we find the following comments:

Quark: “The Matrix is a euphemism for the government.”

Superastic: “No, the Matrix is the system controlling our lives.”

It's not hard to see that these lines were removed, so the movie wouldn't come across as being a political commentary that was intended to convey their contention that we are living in the “Matrix”, which is being controlled in the real world by the boys in the New World Order.

Especially revealing is the scene in the movie when Neo meets Morpheus (Lawrence Fishburne), the leader of the resistance, at the Lafayette Hotel, and tells him what the Matrix is:

“The Matrix is everywhere. It is all around us. Even now, in this very room. You can see

it when you look out your window, or when you turn on your television. You can feel it when you go to work, when you go to church, when you pay your taxes. It is the world that has been pulled over your eyes, to blind you from the truth.”

Applying the Wachowski's innuendo to our current situation, we find that they have described a system of ‘Command and Control’ that has been able to so dominate and overwhelm that we have been completely deceived into believing a lie.

In the movie, Neo is unplugged from the Matrix, enabling him to see the real world. It is my hope that with the knowledge you gain from reading this book, you will be ‘unplugged’ from the Matrix, and begin to see for yourself that things aren't what they seem. That the world you thought you were living in—doesn't really exist.

In July 1944, during World War II, economist John Maynard Keynes of England, and Harry Dexter White of the United States, organized the United Nation's Monetary and Financial Conference (or Bretton Woods Conference) in Bretton Woods, New Hampshire, to lay out a plan for stabilizing the world economy. The *General Agreement on Tariffs and Trade* was signed; and the International Bank for Reconstruction and Development (World Bank) and International Monetary Fund were established. In the early 1960s, the American economy began declining, and the international situation became unbalanced again. On August 15, 1971, President Nixon announced a new economic policy. The dollar was devalued, and its convertibility to gold was suspended. He initiated a 90-day wage price freeze, stimulative tax and spending cuts, and placed a temporary 10% tariff on most U.S. imports. Japan and Western Europe were pressured into relaxing their trade barriers, in order to give the United States more access to them; and Japan, South Korea, Hong Kong, and Taiwan were requested to decrease the flow of goods and textiles into the country. These moves offered relief to the country's economic woes, but was an indication that Nixon was retreating from the global policies which were formulated during the 1960s.

This series of drastic changes in the U.S. international policy motivated David Rockefeller (a Director of the Federal Reserve Bank of New York, and head of the Illuminati in the U.S.), who, after attending the Bilderberg Conference and consulting with Zbigniew Brzezinski, wanted to “bring the best brains in the world to bear on problems of the future”. Speaking at the Chase Manhattan International Financial Forums in London, Brussels, Montreal, and Paris, he proposed the creation of an International Commission of Peace and Prosperity (which would later become the Trilateral Commission) in early 1972. At the 1972 Bilderberger meeting, the idea was widely accepted, but elsewhere, it got a cool reception. According to Rockefeller, the organization could “be of help to government by providing measured judgment”.

Zbigniew Brzezinski, a professor at Columbia

University, and a Rockefeller advisor, who was a specialist on international affairs, left his post to organize the group with Henry Owen (a Foreign Policy Studies Director with the Brookings Institution), George S. Franklin, Robert Bowie (of the Foreign Policy Association and Director of the Harvard Center for International Affairs), Gerard Smith (Salt I negotiator, Rockefeller in-law, and its first North American Chairman), Marshall Hornblower, William Scranton (former Governor of Pennsylvania), Edwin Reischauer (a professor at Harvard), and Max Kohnstamm (European Policy Centre). Brzezinski was the author of the book *Between Two Ages*, which was published in 1970, in which he called for a new international monetary system, and it was considered to be the 'Bible' of the Trilateralists. On page 72, he said: "Marxism is simultaneously a victory of the external, active man over the inner, passive man and a victory of reason over belief." He called for "deliberate management of the American future" (pg. 260), a "community of nations" (pg. 296), and a "world government" (pg. 308). He became its first Director (1973-76), drafted its Charter, and became its driving force.

Funding for the group came from David Rockefeller, the Charles F. Kettering Foundation, and the Ford Foundation.

Journalist Bill Moyers (a CFR member), wrote about the power of David Rockefeller in 1980: "David Rockefeller is the most conspicuous representative today of the ruling class, a multinational fraternity of men who shape the global economy and manage the flow of its capital ... Private citizen David Rockefeller is accorded privileges of a head of state ... He is untouched by customs or passport offices and hardly pauses for traffic lights." In his 1979 book *Who's Running America?*, Thomas Dye said that Rockefeller was the most powerful man in America.

In July 1972, Rockefeller called his first meeting, which was held at Rockefeller's Pocantico compound in New York's Hudson Valley. It was attended by about 250 individuals who were carefully selected and screened by Rockefeller and represented the very elite of finance and industry.

Within a year, after their first full meeting of the Executive Committee in Tokyo, the Trilateral Commission, considered to be an off-shoot of the Bilderberger group, was officially initiated, holding biannual meetings. Because of a heavy cross-membership, some researchers have said that they appear to be an inner circle of the Council on Foreign Relations (and also have ties to the Atlantic Institute for International Affairs, which was established in 1961 as "a sort of public arm of NATO") and represent a union of experts and transnational elite from the three noncommunist industrial regions of the world: North America, Japan, and Western Europe (excluding Austria, Greece, and Sweden). Rockefeller saw the need for such a private consultation among these three democratic areas. With the demise of the Bretton Woods system, they believed an overhaul was needed. The theory was that America's role should be diminished and made equal to the Common Market and Japan because together, the three represented 70% of the world's trade.

In 1973, David Rockefeller met with 27 heads of state, including representatives from the Soviet Union and China; and in 1974, had a meeting with Pope Paul VI, who afterward called for the nations to form a world government.

A Trilateral Commission Task Force Report, presented at the 1975 meeting in Kyoto, Japan, called *An Outline for Remaking World Trade and Finance*, said: "Close Trilateral cooperation in keeping the peace, in managing the world economy, and in

fostering economic development and in alleviating world poverty, will improve the chances of a smooth and peaceful evolution of the global system." Another Commission document read: "The overriding goal is to make the world safe for interdependence by protecting the benefits which it provides for each country against external and internal threats which will constantly emerge from those willing to pay a price for more national autonomy. This may sometimes require slowing the pace at which interdependence proceeds, and checking some aspects of it. More frequently however, it will call for checking the intrusion of national government into the international exchange of both economic and non-economic goods." In other words, they were promoting world government by encouraging economic interdependence among the superpowers.

This little-known organization is actually controlled by the Rockefellers, who oversee its activities and provide guidance for their policies. Their membership consists of over 300 members (with membership ceilings of 107 from North America, 150 from Western Europe, and 117 from Pacific-Asian), is made up of top bankers, industrialists, businessmen, labor leaders, scholars, politicians, senators and governors. They only consider people interested in promoting close international cooperation, especially among non-communist industrial nations, which actually means they advocate a one-world government. Many Cabinet level officers, and advisors, from the Kennedy Administration to the Clinton Administration have served on the Commission.

There is a Chairman (former Speaker of the House Thomas S. Foley is the current North American Chairman), Deputy Chairman, and Director for each of the three areas, as well as a 44 member Executive Committee, with such recognizable names as: C. Fred Bergsten (former U.S. Assistant Secretary of the Treasury for International Affairs), Zbigniew Brzezinski, Joseph S. Nye, Jr. (Dean of the John F. Kennedy School of Government at Harvard University, and former U.S. Assistant Secretary of Defense for International Security Affairs), and Paul Volcker (former Chairman of the Federal Reserve, and a former North American Chairman of the Trilateral Commission, 1991-2001).

An analysis of one of their three-year budgets of \$1.67 million, indicated that \$644,000 came from foundations, \$530,000 from corporations, \$220,000 from individual contributors, \$180,000 from the Rockefeller Brothers Fund, \$150,000 from David Rockefeller's personal account, \$100,000 from the Rockefeller Foundation and \$84,000 from investment income.

The Commission holds an annual three-day meeting, rotated among the three areas, to discuss the world monetary situation, and other economic and military issues; and sometimes have regional meetings. The meetings are closed to the public, and the media is denied access. ...

The Commission has some of its members in such branches of the media as: *New York Times*, *Washington Post*, *Wall Street Journal*, *Minneapolis Star and Tribune*, *Los Angeles Times*, *Chicago Sun Times*, *Kyodo News Service*, *Japan Times*, *La Stampa*, *Die Ziet*, *Financial Times*, *Columbia Broadcasting (CBS-TV)*, *The Economist*, *Japan Broadcasting Corp.*, *Time*, *Associated Press* and *United Press International*.

A good example of how the Trilateral Commission influences the media could be seen in the January 15, 1981 episode of the ABC-TV show *Barney Miller*. A man was arrested for breaking into the offices of the Commission and when he was taken to the 12th Precinct, he began ranting and raving about

how the Commission was attempting to set up an "international community" and how they eventually wanted to take over the world. The character, William Klein (played by Jeffrey Tambor) was made to look like a fool, and upon leaving the squad room, Detective Sgt. Arthur Dietrich (played by Steve Landesberg) said: "Well, I think you have some very valid criticisms of the Commission, and I'm certainly gonna bring them up at the next meeting." After Dietrich tells the man he was a Trilateral member, which he wasn't, the man reacted: "Oh God, no..." The character was made to look like a paranoid maniac, reminiscent of the McCarthy era. This was only one of the many propaganda pieces that was used to make the Commission look just like any other organization. This is the principle that the Illuminati has used for years to slant the news, so that the public will accept their views.

In the late 1800s, at an annual dinner of the American Press Association, John Swinton, an editor at the *New York Times*, said:

"There is no such thing, at this date, of the world's history, in America, as an independent press. You know it and I know it. There is not one of you who dares to write your honest opinions, and if you did, you know beforehand that it would never appear in print. I am paid weekly for keeping my honest opinions out of the paper I am connected with. Others of you are paid similar salaries for similar things, and any of you who would be so foolish as to write honest opinions would be out on the streets looking for another job. If I allowed my honest opinions to appear in one issue of my paper, before twenty-four hours my occupation would be gone. The business of the journalist is to destroy truth; to lie outright; to pervert; to vilify; to fawn at the feet of mammon, and to sell his country and his race for his daily bread. You know it and I know it and what folly is this toasting an independent press? We are the tools and vassals for rich men behind the scenes. We are the jumping jacks, they pull the strings and we dance. Our talents, our possibilities, and our lives are all the property of other men. We are intellectual prostitutes."

David Rockefeller said in a *Saturday Evening Post* article he wrote to defend his group: "My point is that far from being a coterie of international conspirators with designs on covertly ruling the world, the Trilateral Commission is, in reality, a group of concerned citizens interested in fostering greater understanding and cooperation among international allies." However, those who have penetrated the inner workings of the organization say the real purpose of the Commission is to take over all key policy-making positions in the government. Antony Sutton wrote in the *Trilateral Observer* that **the Trilateralists have rejected the U.S. Constitution and the democratic political process; and their objective is to obtain the wealth of the world for their own use, under the guise of "public service", and to have, ultimately, a one-world socialist government, with them in control.** ...

Sen. Barry Goldwater wrote in his book, *With No Apologies*:

"In my view, the Trilateral Commission represents a skillful, coordinated effort to seize control and consolidate the four centers of power: political, monetary, intellectual and ecclesiastical. All this is to be done in the interest of creating a more, peaceful, more productive world community. What the Trilateralists truly intend is the creation of a worldwide economic power superior to the political governments of the nation-states involved. They believe the abundant materialism they propose

to create will overwhelm existing differences. As managers and creators of the system they will rule the future.” ...

Craig S. Karpel wrote in his November 1977, *Penthouse* magazine article (first of three)—“Cartergate: The Death of Democracy”:

“The presidency of the United States and the key cabinet departments of the federal government have been taken over by a private organization dedicated to the subordination of the domestic interests of the United States to the international interests of the multinational banks and corporations. It would be unfair to say that the Trilateral Commission dominates the Carter Administration. The Trilateral Commission is the Carter Administration.” ...

During his acceptance speech, after winning the nomination at the Democratic National Convention, Carter attacked the “unholy, self-perpetuating alliances (that) have been formed between money and politics ... a political and economic elite who have shaped decisions and never had to account for mistakes nor to suffer from injustice. When unemployment prevails, they never stand in line for a job. When deprivations results from a confused welfare system, they never do without food, or clothing or a place to sleep. When public schools are inferior or torn by strife, their children go to exclusive private schools. And when bureaucracy is bloated and confused, the powerful always manage to discover and occupy niches of special influence and privilege.” Now the trap was set, and America fell for it, hook, line, and sinker.

After Carter beat Ford, Hamilton Jordan, his chief aide, said: “If, after the inauguration, you find Cy Vance (former President of the Rockefeller Foundation) as Secretary of State and Zbigniew Brzezinski as head of National Security, then I would say we have failed.” In an interview with *Playboy* magazine, Jordan said he would quit if they were appointed. They were—he didn’t.

Brzezinski had become Carter’s biggest influence. Henry Kissinger had called Brzezinski his “distinguished presumptive successor”. It was Brzezinski who said: “The approaching two-hundredth anniversary of the *Declaration of Independence* could justify the call for a national constitutional convention to re-examine the nation’s formal institutional framework. Either 1976 or 1989—the two-hundredth anniversary of the *Constitution*—could serve as a suitable target date culminating a national dialogue on the relevance of existing arrangements...”

When James Earl Carter took the oath of office, he said that the “United States will help erect ... a world order.” This self-proclaimed “outsider” filled many of his administrative posts with establishment insiders from the Rockefeller Foundation, the Brookings Institution and Coca Cola. Extracted from Coke were George Ball, Clark Clifford, Samuel P. Huntington, Marshall Shulman, Richard Gardner, Henry Owen, Robert Roosa and J. Paul Austin. Because of the extent to which he used the company when he was governor, he called the Coca-Cola company, his “own State Department”.

The Trilateral Commission had accomplished its goal of controlling the Presidency, and it heralded that fact by making Jimmy Carter *Time* magazine’s Man of the Year in January 1977. The Editor-in Chief for *Time* was Hedley Donovan, a Rhodes Scholar and member of the Commission. ...

U.S. News and World Report reported: “The Trilateralists have taken charge of foreign policy-making in the Carter Administration, and already the immense power they wield is sparking some controversy. Active or former members of the Trilateral Commission now head every key agency involved in mapping U.S. strategy for dealing with the

rest of the world.” Being dominated by the chief advisors of the Commission, almost every aspect of Carter’s foreign policy reflected a Trilateral viewpoint. They took advantage of Carter’s ignorance of foreign policy, which became a series of concessions to Cuba, Panama, Red China and Russia:

1) The Panama Canal was given away by the Carter Administration in a treaty negotiated by Sol Linowitz of the Commission. The reason—Marxist Panamanian leader Omar Torrijos owed the International Bankers \$2 billion in loan payments, so income received from the Canal could help pay them back. The U.S. also guaranteed a 5-year program of loans and credits, which amounted to \$295 million; and a 10 year, \$50 million arms sale agreement to bolster the defense of the Canal.

2) Carter’s withdrawal of a large number of troops from South Korea opened the area up for possible communist aggression from North Korea.

3) The Carter Administration granted full diplomatic relations with Red China, so American industry could begin trade with the communist government. When Carter broke off diplomatic relations with the government of Taiwan, Sen. Goldwater said at a news conference: “I have no idea what motivated him other than the Trilateral Commission, composed of bankers in this country and others, want to expand big business ... He did it for the big banks of the world—Chase Manhattan and the French bankers and for companies like Coca-Cola.” In May 1989, George Bush would bestow favored-nation trade status to China.

4) In Africa, the Carter Administration was soft on the spread of Marxism.

5) Carter pledged his support for communist-dominated Hungary, and gave its dictator, Janos Kadar, the priceless Crown of St. Stephen (the founder and patron saint of Hungary) which the U.S. had in its possession since 1945.

In a 1978 meeting with 200 Trilateralists at the White House, Carter said that if the Commission had been in existence after World War I, they would have prevented World War II. However, we know that they were in existence after World War I and precipitated World War II. In his book *Why Not the Best*, Carter said: “Membership on this Commission has provided me with a splendid learning opportunity, and many other members have helped me in my study of foreign affairs.” Carter’s membership in the organization was the only foreign policy experience he had, and that was limited to attending a couple of conferences in Europe and Japan. Congressman John Anderson, himself a member, said that Carter became a member just to improve his image. Carter’s indoctrination made him a willing pawn in furthering the goals of the Trilateral Commission. In a personal letter to the Commission, who was meeting in Tokyo, Japan, in January 1977, he wrote: “We share economic, political, and security concerns that make it logical we should seek ever increasing cooperation and understanding. And this cooperation is essential not only for our three regions, but in the global search for a more just and equitable world order.”

The Commission, which operates in literal secrecy, made news in the fall of 1979 when David Rockefeller, Henry Kissinger and John J. McCloy (former President of the Ford Foundation, former President of the World Bank, Chairman of the Chase Manhattan Bank, former High Commissioner to Germany, and on the Advisory Board of *Foreign Affairs* magazine) pressured Carter into allowing the deposed Shah of Iran (who had financial dealings with the Chase Manhattan) into the country for medical treatment. The move caused the Iranian government, under the leadership of the

Ayatollah Khomeini, to storm the American Embassy, and hold 52 American hostages for nearly 1-1/2 years. Carter’s inadequacy in dealing with this situation certainly cost him the election.

The Presidential election of 1980 saw two other former Trilateralists running for President. Jimmy Carter was running for re-election, and Illinois Republican, Rep. John Anderson, was running as an Independent. Republican George Bush had resigned his post on the Council on Foreign Relations because they were “too liberal”, however, he didn’t resign his seat on the Commission. The son of Sen. Prescott Sheldon Bush (R-CT, who during the 1930s was on the Board of Directors of Union Banking Corporation of New York, who helped finance the Nazis), had been born in Maine, raised in Connecticut, and was a two-term Republican Representative from Houston, Texas; became Ambassador to the UN in 1971; Chairman of the Republican National Committee; and from 1976-77, served as Director of the CIA. George Bush was associated with the international banking firm of Brown Brothers, Harriman and Company (who helped finance the growth of the Soviet Union); and attended Yale, where he was a member of the secret organization known as “The Order” (or “Skull and Bones”). This group also had as members: William F. Buckley, Jr., McGeorge Bundy, Winston Lord (former Chairman of the CFR) and other CFR members, who allegedly make up a powerful inner circle that controls the CFR.

On March 17, 1980, during the campaign, Ronald Reagan was asked if he would allow Trilateral Commission members to serve in his cabinet, and he responded by saying: “I don’t believe that the Trilateral Commission is a conspiratorial group but I do think its interests are devoted to international banking, multinational corporations and so forth. I don’t think that any Administration of the U.S. Government should have the top nineteen positions filled by people from any one group or organization representing one viewpoint. No, I would go in a different direction.”

After a bitter Primary fight between the two, Reagan chose Bush to be his Vice Presidential running mate, over the likes of Rep. Philip Crane from Illinois, and Sen. Jack Kemp from New York. Reagan had originally wanted former President Ford to be his Vice-President, however, Ford wanted the power to appoint people to the National Security Council and the Cabinet. He also wanted to prepare “position papers” on foreign policy matters. This situation would have been almost like a co-Presidency, making Reagan more of a figurehead, which he refused to be, so his only other option was Bush.

Manchester Union Leader publisher William Loeb made the Commission a campaign issue during the New Hampshire Primary by saying: “It is quite clear that this group of extremely powerful men is out to control the world.” He accused them of advocating a “world order in which multinational corporations ... can thrive without worrying about so-called national interests”. During the campaign, Reagan attacked Carter’s ties to David Rockefeller and other Trilateral financiers; while Edwin Meese, a Reagan advisor, said that Trilateral influence was responsible for a “softening of defense”.

Although Reagan appeared to be anti-Commission, it was only a front. Reagan’s Campaign Manager, William J. Casey (former Chairman of the Securities and Exchange Commission, who Reagan later appointed as Director of the CIA) was a Trilateralist. His campaign was controlled by such Trilateralists as David Packard, George H. Weyerhaeuser, Bill Brock, Anne Armstrong, Philip M. Hawley, William A. Hewitt, Caspar Weinberger, and others who were CFR

members. Reagan had the personal support of David Rockefeller, and belonged to the elitist Bohemian Grove Club in Northern California.

The Bohemian Grove is the site of an annual two-week (including the 3 weekends) summer retreat on a 2,700 acre redwood estate about 75 miles north of San Francisco (near the town of Monte Rio), along the Russian River. It was established in 1872 by five reporters of the San Francisco Examiner as a social club "to help elevate journalism to that place in the popular estimation to which it is entitled". By 1878, when the first Grove-fest took place, reporters were being pushed out. *Newsweek* (August 2, 1982) called it "...the world's most prestigious summer camp". There is a \$2,500 initiation fee, and annual dues of \$600. Nearly every Republican President since Calvin Coolidge has been a member of this conservative clan. President Herbert Hoover called it the "greatest men's party on Earth". Among its 2,000 members are other high level government officials, and the very elite of America's corporate power, who sit on a variety of organizations such as the Trilateral Commission, CFR and the Committee for Economic Development.

Among their members: Alexander Haig, Caspar Weinberger, Richard Nixon, Henry Kissinger, George P. Shultz, Newt Gingrich, Stephen Bechtel, Jr., Alan Greenspan, Gerald R. Ford, Jack Kemp, Dwight D. Eisenhower, Colin Powell, William F. Buckley, Jr., Merv Griffin, Joseph Coors, Edward Teller, Malcolm Forbes, Ronald Reagan, A. W. Clausen, George H. W. Bush, William French Smith, Richard Cheney and William E. Simon.

They "own 25-30% of all privately held wealth in America, own 60-70% of the privately held corporate wealth ... direct the large corporations and foundations, and dominate the federal government in Washington". The bottom line is that it is "one of the most influential meetings of the powers-that-be" and a setting for policy-making on specific issues; and not the all-male social club they purport to be. ...

In June of 1993, the *Washington Times* reported: "Presidential counselor David Gergen resigned yesterday from the all-male Bohemian Club, three days after saying he would not run around naked at its annual Bohemian Grove encampment and insisting he would not quit. White House spokeswoman Dee Dee Myers announced the resignation along with Mr. Gergen's departure from 17 other interest groups, charities and public boards ranging from the Trilateral Commission, the Bilderberg Group and Council on Foreign Relations." ...

Reagan's 59-member "transition team" who would pick, screen, and propose appointees for major administrative posts, consisted of 28 CFR members, 10 Bilderbergers and 10 Trilateralists, including CFR members William Simon (former Secretary of Treasury under Nixon and Ford), Alexander Haig, George P. Shultz (former Secretary of Treasury under Nixon), Donald Rumsfeld (former Secretary of Defense under Ford), Alan Greenspan (former Chairman of the Council of Economic Advisors) and Henry Kissinger; and Trilateralists, William Casey and Anne Armstrong.

A note about George Pratt Shultz—his father was Dr. Birl Earl Shultz, who from 1918-23 was Personnel Director of the American International Corporation in New York, which was located in the same building as the Federal Reserve Bank of New York. They had offered \$1,000,000 in credits to the Bolsheviks during the Russian Revolution. Shultz was a close friend of Armand Hammer's father, Julius Hammer, co-founder of the U.S. Communist Party. George was a member of the Pratt family, who were related to the Rockefellers, and who donated the Pratt mansion to the CFR. According to *The Oregonian* (1/3/87), George Shultz was quoted as saying: "The New Age has already dawned, and a new financial World Order is fast taking shape." ...

Seemingly, Reagan was the Establishment's candidate all along, because he played ball with them. Republican Presidential candidate (during the 1980 Primary) John Connally said that if he was elected, he wouldn't appoint any Trilateralists to his Administration. His campaign quickly ran out of steam—and money. ...

The Commission had suggested that Iran, Saudi Arabia, Brazil, and Mexico (did become a member in 1994) be brought into the Organization for Economic Cooperation and Development (OECD), an association of 24 (now 30) rich industrial nations (including all 15 countries of the European Community) founded in 1961 to encourage world trade, economic progress, and to aid underdeveloped nations. The move was considered by one Brazilian diplomat, as "an attempt to buy us out" and not an "attempt to build new understanding." ...

Winston Lord, U.S. Ambassador to China during the Reagan Administration and Assistant Secretary of State for Asian and Pacific Affairs under Clinton—a CFR member, is reported to have said: "The Trilateral Commission doesn't run the world, the Council on Foreign Relations does that!"

REGIONAL GOVERNMENT

On April 21, 1935, the *New York Times* magazine published a plan in which the states would merge into new units called Federal Regions that would be controlled from Washington, DC. In 1959, Nelson Rockefeller called for an Advisory Commission on Intergovernmental Relations (ACIR), which became a federally-funded Rockefeller think-tank within Congress to prepare a working formula for the concept. The ACIR analyzed information produced by the Public Administration Clearing House (also known as the "1313") and translated it into legislation to develop regional government, which would usurp the power of the local government. The Clearing House, located at the Rockefeller-controlled University of Chicago, represented a group of 26 private organizations which had been infiltrating local government agencies to usurp their power and authority. Some of these organizations are: National Association of Counties, National League of Cities, U.S. Conference of Mayors, American Public Works Association, Public Personnel Association, National Association of Attorney Generals, and the National Governors Conference. Their purpose was to train and place a "new administrative class" in every level of government, which would replace elected officials.

On March 27, 1969, as published in the *Federal Register*, under the direction of his Illuminati advisers, President Nixon announced the "Restructuring of Government Service Systems", which called for the merging of states into eight federally-controlled regions.

An Executive Order, when decreed by the President, is printed in the *Federal Register*, and then becomes law 15 days later. After Bill Clinton signed Executive Order #13083, Presidential Aide Paul Begala was overheard saying: "Stroke of a pen, law of the land. Kinda cool."

Executive Order #11647 was signed by Nixon on February 10, 1972, establishing Federal Regional Councils for the "development of closer working relationships between major Federal grant-making agencies of State and local government". In each of the ten standard Federal Regions, there was to be a council made up of the directors of the regional offices of: Dept. of Labor; Dept. of Health, Education, and Welfare; Dept. of Housing and Urban Development; Secretarial Representative of the Dept. of Transportation; Office of Economic Opportunity; Environmental Protection Agency; and the Law Enforcement Assistance Administration. The President was to designate one member of each Council as the Chairman.

This Executive Order was unconstitutional because Article IV of the *U.S. Constitution* prohibited the merging of the states, and guaranteed a government represented by elected officials. However, regional government was accepted, because it brought with it, revenue-sharing funds.

Here is how the Ten Regions are organized (with the regional offices in parenthesis):

- 1) Maine, Vermont, New Hampshire, Massachusetts (Boston), Connecticut, Rhode Island
- 2) New York (New York), New Jersey, Virgin Islands, Puerto Rico
- 3) Pennsylvania (Philadelphia), Maryland, Delaware, West Virginia, Virginia, District of Columbia
- 4) Kentucky, Tennessee, North Carolina, Mississippi, Alabama, Georgia (Atlanta), South Carolina, Florida
- 5) Minnesota, Wisconsin, Michigan, Illinois (Chicago), Indiana, Ohio
- 6) New Mexico, Oklahoma, Texas (Dallas-Ft. Worth), Arkansas, Louisiana
- 7) Nebraska, Iowa, Kansas (Kansas City), Missouri
- 8) Montana, North Dakota, South Dakota, Wyoming, Utah, Colorado (Denver)
- 9) Arizona, Nevada, Hawaii, California (San Francisco), American Samoa, Guam, N. Mariana Islands, Marshall Islands, Micronesia
- 10) Idaho, Washington (Seattle), Oregon, Alaska

... In addition to dividing the country into Ten Federal Regions, the government has also been making plans for the establishment of a literal dictatorship, which among other things, will freeze prices and wages, close the Stock Exchange, and regulate the amount of money you can withdraw from your checking and savings account. The following Presidential Executive Orders will accomplish this:

- #10312 (12-10-51) Gives Government the power to take over all radio stations.
- #10346 (04-17-52) All Federal Departments and Agencies are required to prepare civil defense plans.
- #10995 (02-16-62) Gives Government the power to take over all communications and media.
- #10997 (02-16-62) Gives Government the power to take over all energy and power sources such as electricity, petroleum and natural gas.
- #10998 (02-16-62) Gives Government the power to take over farms, farm machinery, and food sources; including production, manufacturing, processing, distribution, and retailing.
- #10999 (02-16-62) Gives Government the power to take over all modes of transportation, seaports, highways, etc.
- #11000 (02-16-62) Gives Government the authority to mobilize citizens into work forces under Government supervision.
- #11001 (02-16-62) Gives Government the power to take over all health, welfare and educational functions.
- #11002 (02-16-62) The Postmaster General will be responsible for registering all Americans.
- #11003 (02-16-62) Gives Government the power to take over all airports and aircraft.
- #11004 (02-16-62) Gives Government the power to take over housing and financial institutions, to relocate communities, to erect new housing with public funds, to declare areas to be abandoned because they are unsafe, and to establish new locations for the population.
- #11005 (02-16-62) Gives Government the power to take over all railroads, inland waterways, and public storage facilities.
- #11051 (09-27-62) Authorization for Executives Orders to be put into effect during times of international, economic, or financial crisis, and for the Office of Emergency Planning to carry them out.
- #11310 (10-11-66) Gives Government the power to use all prisons to administer medical treatment, for mass feeding, and housing.
- #11490 (10-28-69) was amended by the 36-page

Executive Order #11921 (6-11-76), which consolidated the following Executive Orders: #10312, #10346, #10997-#11005, #11087-#11095, and #11310. It assigned emergency preparedness functions to most Federal Departments and Agencies to assure the "continuity of the Federal Government".

On the heels of these provisions that would initiate martial law, a meeting arranged by Nelson Rockefeller, was held from April 5-8, 1976 in Philadelphia with representatives from the Center for the Study of Democratic Institutions, the League of Women Voters, the National Council of Churches, National Urban League, NAACP, United Auto Workers, Common Cause, and various other University professors and governmental experts, to study our present *Constitution* to see if it could be modernized and improved.

On January 30, 1976, came the announcement of "A Declaration of Interdependence", a document which endorsed a one-world government. The announcement was made at a meeting held at Philadelphia's Independence Hall, which was sponsored by the World Affairs Council (and had stemmed from a five point program they had announced in September, 1975). The meeting was funded with a \$100,000 grant from the Pennsylvania Bicentennial Committee. The document, written by CFR member Henry Steele Comsmager began with this sentence: "Two centuries ago our forefathers brought forth a new nation; now we must join with others to bring forth a new world order." It was signed by 24 U.S. Senators and 80 U.S. Representatives, such as: Sen. Alan Cranston (D-CA, CFR), Sen. Jacob Javits (R-NY), Sen. Hubert Humphrey D-MN), Sen. George McGovern (D-SD), Sen. William Proxmire (D-WI), Sen. Charles Mathias (CFR), Sen. Claiborne Pell (CFR), Rep. Paul Simon, Rep. Patricia Schroder, Rep. Louis Stokes, Rep. Les Aspin (Secretary of Defense under Clinton), Rep. John B. Anderson (R-IL) and Rep. Morris K. Udall (D-AZ).

Political Power and The Rule of Law

With the elections over and the 110th Congress settling in, the media have been reporting *ad nauseam* about who has assumed new political power in Washington. We're subjected to breathless reports about emerging power brokers in Congress; how so-and-so is now the powerful chair of an important committee; how certain candidates are amassing power for the 2008 elections, and so on. Nobody questions this use of the word "power", or considers its connotations. It's simply assumed, in Washington and the mainstream media, that political power is proper and inevitable.

The problem is that politicians are not supposed to have power over us—we're supposed to be free. We seem to have forgotten that freedom means the absence of government coercion. So when politicians and the media celebrate political power, they really are celebrating the power of certain individuals to use coercive state force.

Remember that one's relationship with the state is never voluntary. Every government edict, policy, regulation, court decision, and law ultimately is backed up by force, in the form of police, guns, and jails. That is why political power must be fiercely constrained by the American people.

The desire for power over other human beings is not something to celebrate, but something to condemn! The 20th century's worst tyrants were political figures, men who fanatically sought power over others through the apparatus of the state. They wielded that power absolutely, without regard for the rule of law.

Our constitutional system, by contrast, was designed to restrain political power and place limits on the size and scope of government. It is this system, the rule of law, which we should celebrate—not political victories.

Political power is not like the power possessed by those who otherwise obtain fame and fortune. After all, even the wealthiest individual cannot force anyone to buy a particular good or service; even the most famous celebrities cannot force anyone to pay attention to them. It is only when elites become politically connected that they begin to impose their views on all of us.

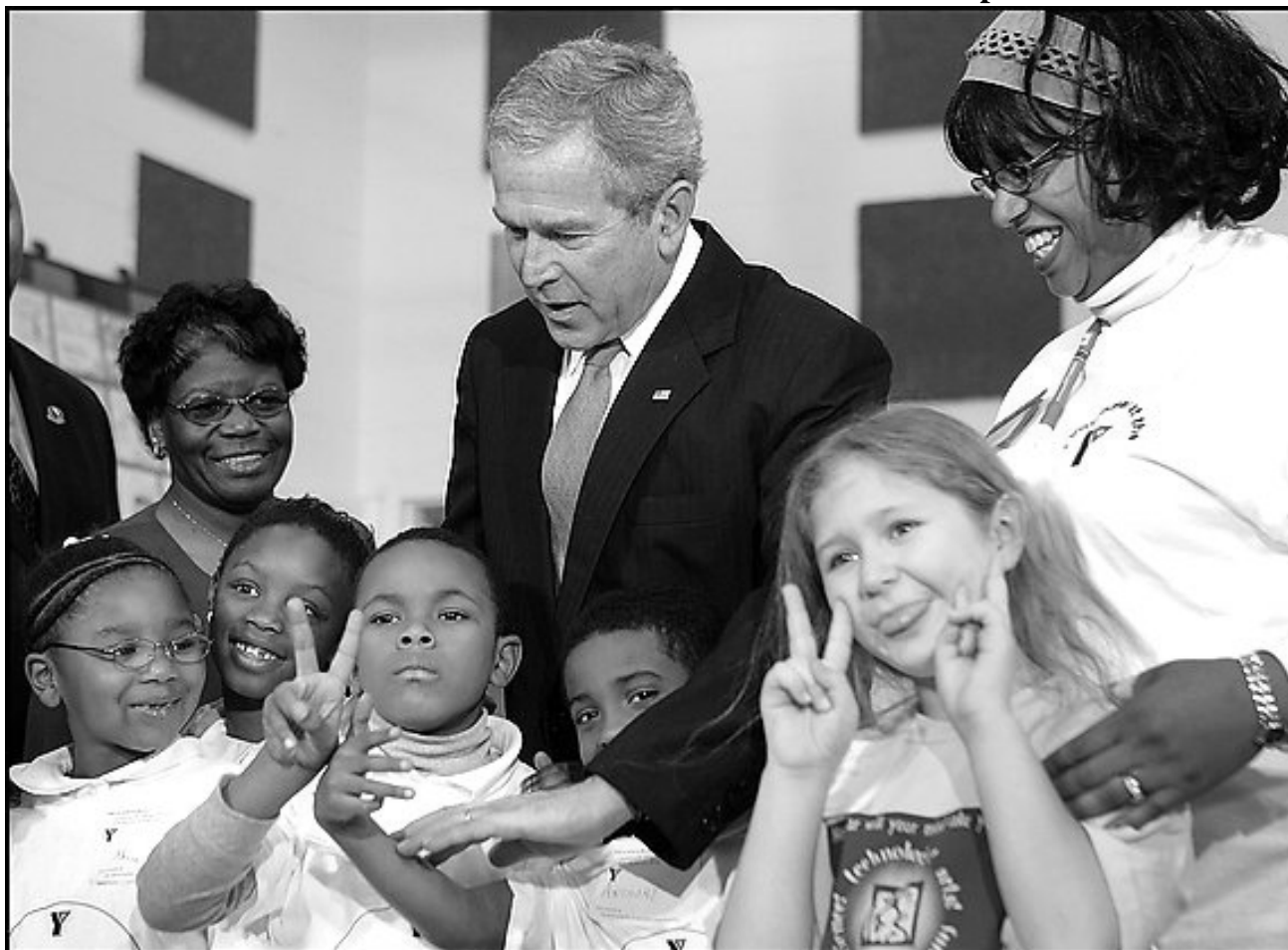
In a free society, government is restrained—and therefore political power is less important. I believe the proper role for government in America is to provide national defense, a court system for civil disputes, a criminal justice system for acts of force and fraud, and little else. In other words, the state as referee rather than an active participant in our society.

Those who hold political power, however, would lose their status in a society with truly limited government. It simply would not matter much who occupied various political posts, since their ability to tax, spend, and regulate would be severely curtailed. This is why champions of political power promote an activist government that involves itself in every area of our lives from cradle to grave. They gain popular support by promising voters that government will take care of everyone, while the media shower them with praise for their bold vision.

Political power is inherently dangerous in a free society: it threatens the rule of law, and thus threatens our fundamental freedoms. Those who understand this should object whenever political power is glorified.

NEVADA CORPORATIONS:

When Is A Corporation NOT "Doing Business"?

Budget's "Tip of the Week" #15:

Operating in a Foreign Jurisdiction Without Having to Qualify the Corporation

Since most people who form Nevada corporations reside in jurisdictions other than Nevada, one of the first questions that needs to be addressed is how to properly use the corporation while they themselves operate from within their home state (or country). Is it necessary to register or qualify the Nevada corporation to do business within their jurisdiction? Often it is—especially if there is a physical presence involving employees—but there are often many useful exceptions to the rule.

Let's look at the exemptions from qualification in the State of California—which is generally known for both its stringent regulations and its repressive taxation—to see what "loopholes" exist. You should look up the regulations in your own particular jurisdiction but as a general rule they will tend to be quite similar.

Business Exempt from Qualification in the State of California

Without excluding other activities which may constitute transacting business, a foreign corporation shall not be considered to be transacting business solely by reason of carrying on any one or more of the following activities:

- 1) A foreign corporation shall not be considered to be transacting intrastate business merely because its subsidiary transacts intrastate business.
- 2) Maintaining or defending any action or suit or administrative action.
- 3) Holding meetings of its board or shareholders or carrying out other activities concerning its internal affairs.
- 4) Maintaining bank accounts.
- 5) Maintaining offices or agencies for the transfer, exchange or registration of its securities.
- 6) **Effecting sales through independent contractors.**
- 7) **Soliciting or procuring orders either by mail or through employees or agents or otherwise where such orders require acceptance without this state before becoming binding contracts.**
- 8) Creating evidences of debt or mortgages on real property.
- 9) Conducting an isolated transaction within a period of 180 days and not in the course of a number of repeated transactions of like nature.

We have highlighted number 6 because this provision is used by an increasing number of businesses in the area of consulting. When the consultant is an independent contractor and the income is earned by a Nevada corporation, the corporation has no presence in the foreign jurisdiction, only the contractor does. So, the contractor must pay home-state tax on his income but the corporation earns its income in Nevada. There can be tremendous tax savings if the contractor lives modestly and draws only what is needed to meet living expenses. Note: It is essential that the corporation exists "at arm's length" from the contractor.

Where the business is more product-related rather than service-related, provision number 7 can come into play. Just ensure that the orders generated require acceptance from Nevada before becoming binding contracts!
